Report on Race Meeting held at Gawler Racecourse

RACE 1: TAB MAIDEN PLATE - 1200 Metres

The start of this event was delayed approximately five minutes.

FLEURIEU FLIPPER (J. Potter) - lost its position on jumping away when tightened between LIGHTS OF BROADWAY, which shifted out and LAKEHURST, which shifted in. Raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

FOURTH FORCE (C. Jones) - raced wide without cover throughout the event.

SEAFARING (NZ) (S. Logan) - raced keenly in the early and middle stages of the event.

SEGAL (A. Chung) - kicked in the near fore knee by another runner on arrival at the barriers. Underwent a pre-race veterinary examination and ruled unfit to race. Acting on this advice Stewards withdrew SEGAL at 12.10 pm.

LAKEHURST (L. Neindorf) - lost its near fore plate en route to the barrier and required Farrier attention. Underwent a pre-race veterinary examination and passed fit to race. Shifted in on jumping away onto FLEURIEU FLIPPER.

FREEDOM DAY (E. Wong) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by E. Wong and noted that he did not use his whip over the final 100 metres of the event.



RACE 1: TAB MAIDEN PLATE - 1200 metres (cont'd)

KAMALANI (NZ) (K. Crowther) – proved difficult to load. Co-trainer, Mr G. Kent, was advised the filly was now required to load without delay in an Official Barrier Trial or Approval to Race jump-out prior to a future race start. Jumped away awkwardly.

LIGHTS OF BROADWAY (T. Voorham) – shifted out on jumping away onto FLEURIEU FLIPPER. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by T. Voorham and noted that she used it on four occasions over the final 100 metres of the event.

RACE 2: THE TERRACE FUNCTION CENTRE THREE-YEARS-OLD MAIDEN PLATE - 1100 Metres

BLUE LUNA (E. Wong) – in the vicinity of the 900 metres shifted in slightly onto HOT SPARKY. Rider was reminded of his obligations when shifting ground. Laid in under pressure in the straight.

HOT SPARKY (E. Boyd) – near the 900 metres had to take hold when tightened between BLUE LUNA, which shifted in slightly at the same time as SMILING FROM ABOVE, shifted out slightly.

KINGSLEY (J. Doyle) – approaching the 900 metres appeared to clip heels and fell dislodging its rider. J Doyle was examined by First Care Medical personnel and declared unfit to fulfil her remaining engagement. J Doyle was advised that she would require a Medical Certificate of Fitness before engaging in any form of riding. An inquiry into this incident was adjourned to a date and time to be fixed. A post-race veterinary examination revealed that the gelding had fractured its near fore radius and was humanely euthanised.

NIGHT CRUISER (J. Toeroek) – a post-race veterinary examination revealed no visible abnormalities.

SIR ARMINIUS (R. Hurdle) – laid in under pressure in the straight.

APOLLO GIRL (J. Potter) – hampered approaching the 900 metres when avoiding the fallen horse and rider.

BARBRA'S WISH (C. Jones) – hampered approaching the 900 metres when avoiding the fallen horse and rider.

DENMANSURA (B. Price) – hampered approaching the 900 metres when avoiding the fallen horse and rider.

SMILING FROM ABOVE (A. Chung) – near the 900 metres shifted out slightly onto HOT SPARKY. Rider was reminded of his obligations when shifting ground.

APACHE KISS (S. Logan) – hampered approaching the 900 metres when avoiding the fallen horse and rider.

RACE 3: LJ HOOKER REAL ESTATE MAIDEN PLATE - 1500 Metres

DON'T TEST ME (S. Logan) – a post-race veterinary examination revealed no visible abnormalities.

FAMILY ADDITION (P. Gatt) – a post-race veterinary examination revealed no visible abnormalities.

OUTPOUR (K. Crowther) – at the entrance to the straight had to be steadied momentarily when BELLAVARDO (NZ) shifted out. A post-race veterinary examination revealed no visible abnormalities.

STRIKE AWARD (R. Hurdle) – laid out under pressure in the straight.

ALASKAN STORM (L. Neindorf) – laid in under pressure in the straight.

BELLAVARDO (NZ) (T. Voorham) – slow to begin. At the entrance to the straight shifted out to improve and in doing so shifted onto OUTPOUR. Rider was reprimanded under AR131(a).



RACE 3: LJ HOOKER REAL ESTATE MAIDEN PLATE - 1500 Metres (cont'd)

KATE'S REBEL (A. Chung) - jumped away awkwardly.

PERISSEUO (B. Vorster) - raced keenly in the early and middle stages and raced wide without cover throughout the event.

Following the running of this event, rider P. Gatt stood himself down from his remaining engagements due to a pre-existing injury. P. Gatt was advised that he would require a Medical Certificate of Fitness before engaging in any form of riding.

RACE 4: COOPERS BREWERY CLASS 1 PLATE - 2112 Metres

FAST DEALER (D. Tourneur) - in the vicinity of the 1400 metres improved onto the heels of CHROMATICA when the pace slackened.

HARRY HOT PANTS (C. Murray) - had to be steadied in the vicinity of the 1400 metres when the pace slackened and had to be steadied.

AITCH D'AMICO (R. Hurdle) - in the vicinity of the 2000 metres shifted in, in an attempt to obtain cover and in doing so clipped the heels of ARISTOCAT. Had to be steadied in the vicinity of the 1400 metres when the pace slackened. Rider explained that he had settled further back than anticipated; however, the gelding had never travelled and in his opinion had not handled the track conditions. A post-race veterinary examination revealed the gelding to be lame in the near hind leg. Trainer, Mr B. Cozamanis was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

DANRENA (S. Logan) - between the 1600m and 1400m reduced the speed of her mount resulting in a number of runners racing behind DANRENA having to take action. Rider was reprimanded and advised of her obligations in accordance with AR131(d) in reducing the pace. Laid out under pressure in the straight. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by S. Logan and noted that she used it on three occasions over the final 100 metres of the event.

CHROMATICA (NZ) (J. Eaton) - raced keenly in the early and middle stages of the event. Obligated to alter course in the vicinity of the 200 metres when DANRENA shifted out.

OH SHOW (B. Vorster) - jumped away awkwardly and was slow to begin. Raced keenly in the early and middle stages of the event. In the vicinity of the 1400 metres improved onto the heels of SOUTHERN SWOOP when the pace slackened and was obliged to take hold.

SOUTHERN SWOOP (T. Voorham) - in the vicinity of the 1400 metres improved onto the heels of FAST DEALER when the pace slackened and had to be steadied.

RICH FANTASY (S. Fawke) - in the vicinity of the 1400 metres had to be steadied when the pace slackened.

RACE 5: CORNERSTONE STUD BENCHMARK 62 HANDICAP - 1706 Metres

OURKHANI (A. Chung) - slow to begin. Approaching the winning post had to be momentarily steadied when tightened onto ALLUSION by CARRY THE MUSKET.

ALLUSION (J. Opperman) - laid out under pressure in the straight.

AZZUREOUS (D. Tourneur) - jumped away awkwardly.

AMMO AMOR (S. Metcalfe) - raced wide without cover throughout the event. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by S. Metcalfe and noted that she used it on five occasions over the final 100 metres of the event.





RACE 5: CORNERSTONE STUD BENCHMARK 62 HANDICAP - 1706 Metres (cont'd)

CARRY THE MUSKET (E. Wong) - laid in under pressure over the concluding stages of the event. Approaching the finish shifted in onto OURKHANI. Rider was reminded of his obligations when his mounts commence to shift ground.

RACE 6: GC & J CONSTRUCTIONS FILLIES & MARES BENCHMARK 58 HANDICAP
- 1100 Metres

The start of this event was delayed approximately four minutes.

BON PEGASUS (S. Callow) - contacted near the 900 metres by PHILLYVONNE and taken out across the heels of PROUD MARY.

SUNNY GREEN (C. Murray) - slow to begin and had difficulty obtaining clear ground in the straight.

HONEY GO LIGHTLY (S. Fawke) - in the vicinity of the 900 metres shifted in onto PHILLYVONNE, which was forced to be steadied. Rider was severely reprimanded under AR131(a) and advised, in future, to ensure he is sufficiently clear prior to shifting ground.

MAGIC DELTA (D. Tourneur) - hung out throughout the event and rounding the home turn shifted out into the running line of RUSTYDUSTYSUNSHINE.

L'IL PIPER (R. Hurdle) - Stewards received a request from Trainer, Mr J. Hyam, that the mare be withdrawn due to the track downgrade. Stewards accepted this request and declared L'IL PIPER a late scratching at 2:17 pm.

PHILLYVONNE (E. Boyd) - in the vicinity of the 900 metres had to be steadied when HONEY GO LIGHTLY shifted in and as a result shifted out and contacted BON PEGASUS.

PROUD MARY (A. Chung) - a post-race veterinary examination revealed no visible abnormalities.

THE PUBLIKIN (J. Potter) - raced wide without cover throughout the event.

RUSTYDUSTYSUNSHINE (C. Rawiller) - inconvenienced at the entrance to the straight when MAGIC DELTA shifted out.

HATEECH (J. Opperman) - lost its off hind plate en route to the barriers. As the Farrier was unable to replace the off hind plate, permission was granted for the near hind plate to be removed and the mare to race bare behind.

RACE 7: KINGSFORD HOTEL BENCHMARK 54 HANDICAP - 1506 Metres

ABIT RATTLEY (E. Boyd) - a post-race veterinary examination revealed no visible abnormalities.

DANCING STREAM (E. Wong) - raced wide without cover throughout the event. Laid in under pressure in the straight.

MODRIC (C. Rawiller) - Rider was reprimanded under AR132(7)(a)(i) in that he used his whip in consecutive strides prior to the 100 metres.

FIGHT FOR FREEDOM (J. Toeroek) - shifted out at the entrance to the straight to improve and in doing so took GRAVITY out onto the heels of DANCING STREAM. Rider was reminded of his obligations when shifting ground.

GARRIRE (L. Neindorf) - in the vicinity of the 1000 metres had to be steadied and lost ground when INDIAN MO shifted in. Laid out under pressure in the straight.

ZOUSTORM (J. Potter) - raced keenly in the early and middle stages of the event. In the vicinity of the 1000 metres had to be steadied off the heels of GARRIRE.

GRAVITY (E. Annells) - had to be momentarily steadied at the entrance to the straight when taken out onto the heels of DANCING STREAM by FIGHT FOR FREEDOM.





RACE 7: KINGSFORD HOTEL BENCHMARK 54 HANDICAP - 1506 Metres (cont'd)

OREGON TRAIL (S. Fawke) - slow to begin.

DANAYI (D. Caboche) - underwent a pre-race veterinary examination upon arrival at the barriers and was found to be lame in the off hind leg and was ruled unfit to race. Acting on this advice Stewards withdrew DANAYI at 3.40 pm. Trainer, Mrs J. Virgin was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

INDIAN MO (A. Jordsjo) - in the vicinity of the 1000 metres shifted in onto GARRIRE, which had to be steadied. Rider was severely reprimanded and advised, in future, to ensure that she was sufficiently clear prior to commencing to shift ground. A post-race veterinary examination revealed no visible abnormalities.

RACE 8: PURE WINE CO BENCHMARK 58 HANDICAP - 1200 Metres

SHORT STORIES (S. Callow) - jumped away awkwardly. In the vicinity of the 300 metres was hampered when its hind quarters were contacted by PIVOTAL FORCE. Laid in under pressure in the straight. Near the 100 metres shifted in onto PIVOTAL FORCE. Rider was severely reprimanded under AR131(a).

CASTLE OF KINGS (NZ) (B. Price) - laid in under pressure in the straight.

DOMINATION (C. Jones) - shifted out slightly near the 300 metres and contacted PIVOTAL FORCE. A post-race veterinary examination revealed no visible abnormalities.

FIELD HUNTER (C. Rawiller) - a post-race veterinary examination revealed no visible abnormalities.

PIVOTAL FORCE (J. Toeroek) - in the vicinity of the 300 metres was hampered when contacted by DOMINATION and taken out onto the hind quarters of SHORT STORIES. Inconvenienced in the vicinity of the 100 metres when SHORT STORIES shifted in.

SPEARS (S. Fawke) - in the vicinity of the 700 metres laid out and became awkwardly placed on the heels of FIELD HUNTER. A post-race veterinary examination revealed no visible abnormalities.

BETTA EDDIE (J. Potter) - raced keenly in the middle stages of the event.

TRUE AIM (D. Tourneur) - near the 100 metres was forced to race in restricted room for a short distance when PIVOTAL FORCE was taken in. A post-race veterinary examination revealed the filly to be lame in the near hind leg. Trainer, Mr J. O'Connor, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.
