

Racing SA Ltd Stipendiary Stewards' Report

Report on Race Meeting held at Quorn Racecourse
by the Quorn Racing Club on Saturday, 20 August
2022

RIDER CHANGES:

RACE 1: MAX CRANES/ SALT BUSH PASTORAL SERVICES/ QUANDONG CAFE/ GEODIG
HAULAGE BENCHMARK 60 HANDICAP - 1200 Metres

MAID IN MILAN (L. Overall) - jumped away awkwardly. Raced keenly in the early and middle stages of the event. Hung out rounding the turn from the 900m until 700m.

RACE 2: GLANVILLE HOTEL/ TRANSCONTINENTAL HOTEL/ CROMBIE'S BULK HAULAGE/
BURY PLUMBING MAIDEN PLATE - 1200 Metres

JESTER MONTY (F. Atkinson) - dislodged its rider en route to barrier. Rider, F. Atkinson was examined by the First Care Medical personnel and would require further assessment before she could be passed fit to ride. Acting on this advice Stewards declared JESTER MONTY a late scratching at 1.26 pm. Stewards ordered that the monies invested on JESTER MONTY prior to the time of its withdrawal be subject to the deductions of 28 cents in the dollar for the win. Trainer, Mr S Bates was advised that a warning had been placed on the gelding with regards to its pre-race behaviour.

RACE 3: T&C DISTRIBUTORS AUSTRALIA/ CARLING FUEL DISTRIBUTORS/ P&C MARTIN
CONTRACTORS BENCHMARK 64 HANDICAP - 1400 Metres

VEGAS DESTINY (NZ) (J. Doyle) - slow into stride.

MISS ELEGANCE (A. Livesey) - rider accidentally dropped her whip near the 150m.

ONWARD (B. Wong) - underwent a pre-race veterinary examination as the gelding is a 12 year old and was deemed suitable to race. A post-race veterinary examination revealed no visible abnormalities.

Following the running of this event after ongoing assessment by First Care Medical personnel and the Doctor on course, rider F. Atkinson was passed fit to fulfil her remaining engagements.

RACE 4: HAWKER EARTHMOVERS/ LKM HAIR DESIGNER/ REX DAVIES CRASH REPAIRS/ NUTRIEN AG SOLUTIONS BM54 TROPHY - 1400 Metres

CRAZY CULPRIT (L. Overall) - jumped away awkwardly, shifted in and bumped SOUTHERN MAGNOLIA (NZ). A post-race veterinary examination revealed no visible abnormalities.

SOUTHERN MAGNOLIA (NZ) (B. Wong) - on jumping away was bumped by CRAZY CULPRIT, which shifted in. Raced keenly in early and middle stages of the event.

JAMCRA (NZ) (A. Livesey) - jumped away awkwardly and shifted out onto CHICK IN CHARGE.

CHICK IN CHARGE (K. Sardelic) - on jumping lost its position when tightened onto SOUTHERN MAGNOLIA (NZ) when JAMCRA (NZ) shifted out.

RACE 5: OZ MINERALS CARRAPATEENA CUP - 1900 Metres

HARBOURING (A. Livesey) - rider explained in relation to the gelding's disappointing performance, that HARBOURING made the first turn awkwardly and did not handle the track conditions in today's event. A post-race veterinary examination revealed no visible abnormalities.

PAULO PACE (L. Overall) - following the running of Race 3, rider L. Overall notified Stewards he would be unable to make the declared weight of 56.0 kg. After receiving submissions from Trainer, Miss K. Mckerlie that L. Overall had ridden the gelding last start and the only available rider was not suitable to the horse due to its racing manners, Stewards permitted L. Overall to ride PAULO PACE 1.0 kg above its original declared weight, resulting in the gelding carrying 57.0 kg. Rider pleaded guilty to a charge under AR190(3) and was fined \$200.

FIABLE (NZ) (K Sardelic) - when questioned regarding the improved performance, Trainer, Miss K. Mckerlie explained that the mare raced three wide without cover last start and after minimal work during the week benefited from the softer track conditions.

GALAXY FALLS (B. Wong) - near 1400m became unbalanced and lost ground.

SWANKYTOFF (A. Lindsay) - jumped away awkwardly. Laid in under pressure in straight.

RACE 6: TAB CORP/ ROXBY EARTHMOVING/ RJC EVANS & CO/ BA CORE BENCHMARK 54 TROPHY - 1100 Metres

VENDETTA (L. Overall) - a post-race veterinary examination revealed no visible abnormalities.

GIVEPEACE A CHANCE (M. Henderson) - bumped near the 300m and taken wider by CASE CLOSED, which shifted out.

CASE CLOSED (F. Atkinson) - near the 300m shifted out to obtain clear running and bumped GIVEPEACE A CHANCE. Rider was reminded of her obligations under AR131(a) for careless riding and was advised to take greater care when shifting ground in future.

SHANE (B. Wong) - slow to begin.
