

Racing SA Ltd Stipendiary Stewards' Report

Report on Race Meeting held at Gawler Racecourse
by the Gawler & Barossa Jockey Club on
Wednesday, 24 August 2022

TRACK: Heavy 8 (Rain affected track that horses will get into)
Downgraded to a Heavy 9 at 12.52 pm retrospective to Race 1
(Wet track getting into a squelchy area)

RAIL: Out 3 metres 800 metres to 400 metres, out 2 metres remainder

RACE 1: LJ HOOKER THREE-YEARS-OLD AND OVER MAIDEN PLATE - 1500 Metres

CONSISTENT CHOICE (F. Atkinson) - weakened from the 600m, commenced to hang out and shortly after tightened FOXY EAGLE onto THE SNOW BURNER, resulting in FOXY EAGLE losing ground.

PAY UP (R. Hurdle) - arrived on course 15 minutes late. Trainer, Mr L. McMahon was warned under LR8.9.2 for failing to arrive on course by the prescribed time. Raced in the last five days, underwent a pre-race veterinary examination and was deemed suitable to race

UNCLE LEO (T. Pannell) - Stable representative for Trainer W Clarcken advised Stewards prior to the event of a change of tactics in that he would instruct his rider to attempt to take up a forward position in the event. Horse settled on pace. When questioned in relation to the performance of the gelding, which weakened from the 500m, the rider was unable to offer any excuses. A post-race veterinary examination revealed no visible abnormalities.

FOXY EAGLE (A. Livesey) - slow to begin. Near the 600m improved into a run between CONSISTENT CHOICE and THE SNOW BURNER and was then tightened by CONSISTENT CHOICE, which hung out when weakening. As a consequence the mare, which was having its first race start, over-reacted and lost ground.

HOSTESS SUSIE (J. Potter) - slow into stride. Hung in, in the straight.

MELODY SHINE (S. Callow) - slow into stride.

RUPPAPUMPUM (NZ) (A. Lindsay) - slow to begin.



RACE 2: HOLDFAST INSURANCE BROKERS THREE-YEARS-OLD AND OVER COLTS, GELDINGS
& ENTIRES MAIDEN PLATE - 1200 Metres

FAMOUS PRINCE (J. Potter) - shifted out abruptly at the start and bumped MAJESTIC MOSHE. Raced keenly in the middle stages of the event.

FREDDY FREELoader (L. Neindorf) - hung in, in the straight. Lost its off fore plate during the event.

HONKY TONK RIO (R. Hurdle) - lost its near fore plate during the event.

MAJESTIC MOSHE (J. Maund) - bumped at the start by FAMOUS PRINCE, which shifted out abruptly.

VICTORY TIME (J. Toeroek) - raced wide rounding the home turn.

SIR KINGSFORD (B. Vorster) - when questioned in relation to the gelding's performance, the rider advised that it raced very greenly. A post-race veterinary examination revealed the gelding to have cardiac arrhythmia. Co-trainers Mr. G. & Mrs. N Searle and Mrs B. Callanan were advised the results of an ECG are to be forwarded to the Racing SA Veterinary Surgeon and a Veterinary Clearance would be required prior to the gelding performing satisfactorily in an Official Barrier Trial.

SERBIAN PRINCE (E. Annells) - jumped away awkwardly and lost ground at the start. Raced keenly in the early and middle stages of the event. Raced wide for the majority of the event.

SUPERB TIME (K. Sardelic) - jumped away awkwardly and lost ground at the start.

RACE 3: KINGSFORD HOTEL THREE-YEARS-OLD AND OVER FILLIES & MARES MAIDEN PLATE
- 1200 Metres

ALPINE FUN (J. Holder) - jumped away awkwardly, shifted in and bumped TEQUILA SUNSET.

ARCTIC FLORA (F. Atkinson) - held up for clear running and lost ground between the 500m and 400m behind DIVINE WATERS, which was weakening.

DIVINE JOURNEY (J. Toeroek) - underwent a pre-race veterinary examination as it had not raced for over one year and was deemed suitable to race.

DIVINE WATERS (A. Lindsay) - rider reported that the mare raced keenly in the early and middle stages, hung out throughout the event and proved difficult to ride. Trainer, Mr D. Page was advised that a warning had been placed on the mare in relation to its racing manners.

EXALTED DAME (E. Boyd) - difficult to load. Trainer, Mr J. O'Connor was advised that a warning had been placed on the mare in relation to its barrier manners. Slow to begin.

TEQUILA SUNSET (C. Jones) - jumped out at the start and bumped ALPINE FUN.

SEATTLE GRACE (K. Crowther) - rider explained when questioned in relation to the horse's performance, that the filly raced very greenly and did not handle today's track conditions.

SONIC WAVE (T. Voorham) - lost its off fore plate during the event. A post-race veterinary examination revealed abnormal respiratory noises consistent with a displaced palate. Co-trainer, Mr A. Gluyas was advised the results of an endoscopic examination and a Veterinary Clearance would be required prior to presenting the filly for a future jump-out, trial or race.

JUST JAZZ (S. Metcalfe) - Stewards granted Trainer, Mr J. Macmillan permission for the gelding to race unshod behind.

Correct weight was delayed to allow rider, J. Holder (ALPINE FUN), dead heated for first, to view the official photo finish image.





RACE 4: CONTRACT ENGINEERING SA RATING 0 - 58 HANDICAP - 1200 Metres

STRYKE IN STYLE (T. Pannell) - a post-race veterinary examination revealed the gelding to be lame in the near foreleg (4/5). Trainer, Mr J. Macmillan was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start. Trainer advised the gelding will be retired.

NOT A SINGLE BID (J. Eaton) - raced in the last five days, underwent a pre-race veterinary examination and was deemed suitable to race. Shifted in slightly near the 700m and momentarily tightened OBELOS (GB). Rider was advised to exercise greater care when shifting ground.

WINE FROM TEARS (J. Doyle) - laid out under pressure in the straight. Rider was advised to make a greater effort, in future, to keep her mounts straight.

OBELOS (GB) (R. Hurdle) - raced in the last five days, underwent a pre-race veterinary examination and was deemed suitable to race. Had to be eased momentarily near the 700m when tightened slightly by NOT A SINGLE BID. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: COOPERS BREWERY BENCHMARK 54 HANDICAP - 1100 Metres

KUNGKA MARU (A. Livesey) - was held up approaching the 200m behind BROMELIA (NZ) and to inside of BETTA EDDIE, resulting in the mare having to be eased and shift out across the heels of BETTA EDDIE to improve.

WRITTEN IN HISTORY (L. Overall) - underwent a pre-race veterinary examination and was deemed suitable to race.

BETTA EDDIE (E. Wong) - lost its off fore plate during the event. Laid in under pressure over the final 100m. Rider was reminded to make a greater effort to keep his mounts straight in future.

HILUMIERE (K. Crowther) - tightened on jumping by BROMELIA (NZ) and lost ground.

MORPHETT ROAD (C. Jones) - jumped away awkwardly and lost ground.

BROMELIA (NZ) (S. Logan) - jumped away awkwardly, shifted out and then shifted in and away from KUNGKA MARU, resulting in HILUMIERE being tightened.

RACE 6: GBJC LIFE MEMBERS CUP BENCHMARK 58 HANDICAP - 2100 Metres

I NEED A DRINK (T. Pannell) - rider explained when questioned with regards to the performance of the horse, that the gelding raced three wide without cover until the 1500m, however then travelled well until the 400m, where it commenced to give ground for no apparent reason. A post-race veterinary examination revealed no visible abnormalities. Trainer Mr R. Jolly advised the gelding would now be spelled.


NEVA DOUBT US (T. Voorham) - raced in the last five days, underwent a pre-race veterinary examination and was deemed suitable to race.

NATIVE BLUE (M. Collett) - raced three wide without cover from the majority of the event.

SWANKYTOFF (J. Benbow) - raced in the last five days, underwent a pre-race veterinary examination and was deemed suitable to race.

CONQUEST OF TEARS (D. Caboche) - a post-race veterinary examination of the mare, which finished well back, revealed no visible abnormalities.

RAPID RIDE (E. Wong) - fractious en route to the start, underwent a pre-race veterinary examination and was deemed suitable to race.



SILENT KHAN (B. Vorster) - rider was unable to offer any explanation for the gelding's disappointing performance. A post-race veterinary examination revealed no visible abnormalities.

RACE 7: CORNERSTONE STUD BENCHMARK 54 HANDICAP - 1700 Metres

A KNIGHT IN PARIS (J. Holder) - slow to begin. Near the 400m had to be checked away from the heels of TIZA, which was weakening.

JACK'S A CRACKER (J. Eaton) - raced in the last five days, underwent a pre-race veterinary examination and was deemed suitable to race.

RED SEQUOIA (J. Toeroek) - rider reported the horse failed to handle the track conditions.

JAMCRA (NZ) (R. Hurdle) - raced in the last five days, underwent a pre-race veterinary examination and deemed suitable to race.

TRIANGULUM (A. Livesey) - raced wide in the early stages and worked forward to sit outside the leader near the 1200m.

SAWTELL (NZ) (S. Logan) - underwent a pre-race veterinary examination on arrival on course as it raced on Wednesday, 17 August 2022 and was deemed suitable to race. A post-race veterinary examination revealed no visible abnormalities.

TIZA (S. Callow) - slow to begin. Raced keenly in the early and middle stages of the event. Raced wide without cover for the majority of the race.
