
Racing SA Ltd Stipendiary Stewards' Report

Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Saturday, 27 August 2022



TRACK: Soft 6 at 1:28 pm Upgraded to a Soft 5 at 3.21pm retrospective to Race 7

(Moist but not a badly affected track) (Track with a reasonable amount of give in it)

RAIL: Out 3 metres Entire Circuit, Sectional 604 metres

RACE 1: THE FOTOBASE GROUP HANDICAP - 1250 Metres

ALPHA FLIGHT (B. Price) - raced keenly in the early and middle stages of the event.

PARTY PRINCESS (T. Voorham) - jumped away awkwardly and was slow to begin. A post-race veterinary examination revealed no visible abnormalities.

MORE REWARD (B. Vorster) - laid out under pressure in the straight.

RACE 2: UNIQ STONE HANDICAP - 1950 Metres

ICHIBANSAN (J. Holder) - slow to begin. Rider reported that on pulling up and on return to scale, the gelding had its tongue over the bit. A post-race veterinary examination revealed no visible abnormalities.

GOLDEN CRUSADER (FR) (T. Pannell) - laid out under pressure in the straight.

PRINCE JOFRA (B. Price) - near the 1800m had to be steadied when tightened between ALL HARD WOOD, which shifted out slightly and RAPID RAISER, which shifted in slightly.

RAPID RAISER (L. Neindorf) - a post-race veterinary examination revealed no visible abnormalities.

EXALTED RUTH (S. Logan) - raced wide without cover throughout the event.

COVERED CALL (S. Callow) - rider reported the gelding made excess respiratory noise on pulling on up. A post-race veterinary examination revealed no visible abnormalities.





RACE 3: SPRING CARNIVAL AT MORPHETTVILLE - 1000 Metres

COURAGEOUS HEARTS (J. Holder) – inconvenienced on jumping away when contacted by THROWAPARTY. Laid in under pressure in the straight.

THROWAPARTY (C. Jones) - jumped away awkwardly and shifted out onto COURAGEOUS HEARTS. Raced greenly in the early and middle stages of the event. Near the 700m was inconvenienced when MADDISON MISS shifted in.

FREE VINO (L. Neindorf) - had difficulty obtaining clear ground from the entrance to the straight until near the 200m.

MADDISON MISS (C. Murray) - raced greenly in the early and middle stages of the event. Raced wide without cover throughout the event. Near the 700m shifted in onto THROWAPARTY. Rider reminded of his obligations when shifting ground.

RICHANA (P. Gatt) - raced keenly in the early and middle stages of the event. Rider became concerned with the mare's action near the 100m and dismounted the mare after passing the winning post. A post-race veterinary examination revealed the mare to be lame in the off hind leg (4/5). Trainer, Mr D. Jolly, was advised that a Veterinary Clearance was required prior to a future jump out, trial or race start.

DAUNTING DECISION (B. Vorster) - raced keenly in the early and middle stages of the event. Laid out under pressure in the straight.

RICH LADY (K. Crowther) - raced keenly in the early and middle stages of the event. Near the 100m was inconvenienced when tightened between DAUNTING DECISION, which laid out and COURAGEOUS HEART, which laid in.

RACE 4: HAPPY 80TH NONNO PIPPO HANDICAP - 1250 Metres

BIG MAN AT NIGHT (T. Pannell) – inconvenienced on jumping away when tightened onto SPACE FORCE by YARDSTICK.

SPACE FORCE (R. Hurdle) – underwent a pre-race veterinary examination and was deemed suitable to race. Inconvenienced on jumping away when taken out by BIG MAN AT NIGHT onto BLUDOG. Rider reported it was his intention to settle further forward however, after being inconvenienced on jumping away, he settled further back than anticipated.

YARDSTICK (J. Eaton) - jumped away awkwardly and shifted out onto BIG MAN AT NIGHT. Raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

BENEVOLENT (IRE) (B. Price) - a post-race veterinary examination revealed no visible abnormalities.

INKA DINKA (S. Fawke) - laid out rounding the home turn and under pressure in the straight.

PARISIENNE MONDE (K. Crowther) - inclined to lay in under pressure in the straight.

BLUDOG (P. Gatt) - hampered on jumping away when SPACE FORCE was taken out.

RACE 5: VALE BUSHY TRENOWDEN HANDICAP - 1300 Metres

NOTTARIS (S. Metcalfe) - laid out under pressure in the straight. A post-race veterinary examination revealed the gelding had bled from both nostrils. Trainer, Ms K. Evans, was advised that as this was the gelding's first bi-lateral bleed, NOTTARIS was now suspended from racing for a period of three months in accordance with AR79(4) and would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future race.

BON PEGASUS (R. Hurdle) - raced keenly in the early and middle stages of the event. Raced wide without cover throughout the event.

RACE 5: VALE BUSHY TRENOWDEN HANDICAP - 1300 Metres

ENLIST (J. Eton) - laid out under pressure in the straight.

MYSTIC STORM (S. Callow) - raced keenly in the early and middle stages of the event. Laid out under pressure in the straight.

JIVE BABY (T. Pannell) - held up from the entrance to the straight until near the 200m and then had difficulty obtaining clear ground until approaching the 100m.

RACE 6: FRESH KITCHEN SOLUTIONS HANDICAP - 1550 Metres

HARBOURMASTER (M. Aitken) – inside the 300m was momentarily disappointed when attempting a tight run between SHORT STORIES and ANOTHER FREE GLASS. Laid out under pressure in the straight and near the 100m shifted out onto ANOTHER FREE GLASS. Rider was severely reprimanded and advised in future to make a greater effort to keep his mounts straight.

CELESTIAL ILLUSION (S. Logan) – inconvenienced shortly after the start when ZIGGI ROCKS was taken out.

YANACOCHA (J. Potter - dipped on jumping away.

ZIGGI ROCKS (R. Hurdle) – underwent a pre-race veterinary examination on arrival on course and was deemed suitable to race. Inconvenienced on jumping away when taken out onto CELESTIAL ILLUSION.

MAVETTE (S. Fawke) - jumped away awkwardly.

ANOTHER FREE GLASS (B. Vorster) - slow to begin. Inconvenienced near the 100m by HARBOURMASTER.

TURFITT (L. Neindorf) – shifted out on jumping away and contacted ZIGGI ROCKS. Held up from the entrance to the straight until near the 200m.

BRAZEN EAGLE (J. Maund) - raced keenly in the early and middle stages of the event.

RACE 7: EMR MARBLE & GRANITE HANDICAP - 1000 Metres

WHIPCRACKER WAY (T. Voorham) - shifted out on jumping away onto TITANS.

HANKSTAR (E. Boyd) - slow to begin.

MORIALTA (B. Vorster) - jumped away awkwardly and was slow into stride.

TITANS (T. Pannell) – inconvenienced on jumping away when contacted by WHIPCRACKER WAY. Rider explained that due to the interference at the start, he had settled further back than he had anticipated. He added the gelding travelled well in the middle stages however, had not let down when asked for an effort. A post-race veterinary examination revealed the gelding was lame in the off hind leg (2/5). Co-Trainer A. Freedman was advised that a Veterinary Clearance is required prior to a future jump out, trial or race.

WOTUWANT (L. Neindorf) - slow to begin.

YOUNG JIMMY (K. Crowther) - jumped away awkwardly and was slow to begin. Trainer Mr D. Dodson was advised a warning had been placed on the gelding in relation to its barrier manners. A post-race veterinary examination revealed a poor post recovery and that the gelding was exhibiting signs of heat stress. First aid administered. Trainer Mr D. Dodson was advised that a Veterinary Clearance is required prior to a future jump out, trial or race.



KONG (J. Holder) - raced wide without cover throughout the event.

RACE 8: GRAND SYNDICATES - JOIN TEAM GRAND TODAY! HANDICAP - 1400 Metres

THE STAGER (L. Lafferty) - near the 1100m shifted in onto SAMESYN, which was hampered when tightened and taken in onto SHOPSTER, which was inconvenienced when tightened. Rider was severely reprimanded and advised in future to ensure she was sufficiently clear prior to shifting ground.

HEYWOOD (C. Rawiller) - laid out under pressure in the straight.

JACKS ON ICE (J. Toeroek) – rider explained that the gelding had only travelled fairly and when asked for effort, failed to let down and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

CLASSY KENNY (S. Logan) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

SHOPSTER (E. Wong) – raced keenly in the early and middle stages of the event. Near the 1100m was inconvenienced when tightened by SAMESYN, which had been taken in.

SAMESYN (T. Voorham) – raced fiercely in the early and middle stages of the event and near the 1100m was inconvenienced when tightened onto SHOPSTER by THE STAGER. Raced wide without cover throughout the event.

SALT BAY (NZ) (T. Pannell) - had difficulty obtaining clear ground from the entrance to the straight until near the 300m.

SHEZ BETTY (C. Jones) - jumped away awkwardly and was slow to begin.

RACE 9 - LEON MACDONALD STAKES - 1400 Metres

JUST FOLK (M. Julius) – jumped away awkwardly and shifted out. Raced keenly in the early and middle stages of the event. Near the 700m shifted out slightly onto DALASAN. Approaching the 600m was inconvenienced when taken out onto DALASAN by SO SAY ANGEL. Laid out from the entrance to the straight until near the 150m when it shifted out and contacted DALASAN. Approaching the finish was inconvenienced when taken in onto NEXT DIMENSION (NZ) by DALASAN.

DALASAN (J. Holder) – inconvenienced near the 700m when taken wider by JUST FOLK. Approaching the 600m was hampered when JUST FOLK was taken out into its running line by SO SAY ANGEL. Near the 150m became unbalanced when contacted by JUST FOLK. Laid in over the concluding 100m and near the 50m, shifted in onto JUST FOLK, which was inconvenienced when taken in onto NEXT DIMENSION (NZ), forcing its rider to take hold when tightened onto ZOULAH. Rider was found guilty of a charge of careless riding under AR131(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday 3 September and to conclude at midnight on Saturday 14 September 2022: a period of five meetings. A post-race veterinary examination revealed no visible abnormalities.

GRINZINGER STAR (NZ) (S. Fawke) - slow to begin and shortly after was momentarily inconvenienced when MASTER CHUM shifted out slightly.

OH MO (B. Vorster) – slow to begin. Inclined to lay out under pressure in the straight. Near the 30m shifted out abruptly contacting ZOULAH. After making contact with ZOULAH the gelding's hindquarters were turned in and as a result OH MO shifted out further resulting in ZOULAH having to be checked. Rider was reprimanded. In arriving at this decision stewards took into account that B. Vorster had made an attempt to straighten his mount almost immediately following it shifting out abruptly near the 30m. A post-race veterinary examination revealed no visible abnormalities.

NEXT DIMENSION (NZ) (J. Toeroek) – jumped away awkwardly and shifted in brushing ZOULAH. Approaching the finish rider was forced to take hold when tightened onto ZOULAH by JUST FOLK which had been taken in by DALASAN.



SO SAY ANGEL (J. Benbow) - approaching the 600m shifted out onto JUST FOLK which was inconvenienced and taken out onto DALASAN. Rider reminded of obligations when shifting ground.

RACE 9 - LEON MACDONALD STAKES - 1400 Metres (Cont'd)

AGREEABLE (T. Pannell) - inside the 100m shifted in to the inside of OH MO to obtain clear ground.

ZOULAH (K. Crowther) – had to be checked and lost its position approaching the finish when tightened onto NEXT DIMENSION (NZ) by OH MO, which shifted out abruptly. A post-race veterinary examination revealed no visible abnormalities.

Correct weight was delayed to allow M. Julius (JUST FOLK), placed second with Trainer Mr J. Julius, J. Toeroek (NEXT DIMENSION (NZ)), placed fourth with Trainer Ms P. Trenwith and K. Crowther (ZOULAH) placed fifth, to view the official vision over the concluding stages. After doing so, M. Julius (JUST FOLK) lodged an objection against DALASAN (J. Holder) being declared the winner, alleging interference approaching the finish. J. Holder rider of DALASAN advised stewards that in the event the protest was upheld, he wished to lodge a counter protest against JUST FOLK (M. Julius) alleging interference near the 150m. After considering the evidence, acting on their own observations and viewing the official vision, Stewards *dismissed* the objection. As a consequence stewards were not required to consider the counter protest lodged by J. Holder (DALASAN).

RACE 10: VALE KEN SMITH AM HANDICAP - 1250 Metres

MONTIGN (S. Logan) – inside the 200m shifted out to improve and in doing so made heavy contact with COOL MAGNUM. Rider reprimanded and advised to be mindful of her angle of approach when attempting runs in future.

HE'S EXCLUSIVE (NZ) (T. Pannell) - contacted on jumping away. Laid out under pressure in the straight.

WINGS OF PASTRAMI (T. Voorham) - raced keenly in the early and middle stages. Difficulty obtaining clear ground from the entrance to the straight until inside the 200m.

HINTO BLUE (NZ) (L. Lafferty) - held up at the entrance to the straight and shifted out in an attempt to improve and contacted COOL MAGNUM. Shortly after, shifted out when insufficiently clear of COOL MAGNUM which was inconvenienced when taken out onto SOMEWHAT FABULOUS, which was inconvenienced when taken out into the running line of ENCHANTINGLY, forcing its rider to take hold and alter course. Rider pleaded guilty to a charge of careless riding under AR131(a) in that she shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 4 September and to conclude at midnight on Sunday, 11 September 2022: a period of three meetings.

DEEVINE (J. Holder) – laid out under pressure in the straight and proved difficult to ride out. A post-race veterinary examination revealed no visible abnormalities.

OUR DEEP AGENDA (S. Callow) - raced keenly in the early and middle stages. Difficulty obtaining clear ground from the entrance to the straight until near the 200m when it was able to alter course to the inside of MONTIGN.

CLASSY BANNER (P. Gatt) - shifted out on jumping away and contacted HE'S EXCLUSIVE. Raced wide without cover throughout the event. Momentarily steadied near the 200m when it became awkwardly placed on the heels of ENCHANTINGLY, which had been taken out.

COOL MAGNUM (J. Maund) – shifted out shortly after the start onto ENCHANTINGLY. Raced keenly in the early and middle stages. Contacted by HINTO BLUE at the entrance to the straight and then shortly after, was inconvenience when taken out onto SOMEWATT FABULOUS by HINTO BLUE. Hampered and became unbalanced inside the 200m when contacted by MONTIGN.

ENCHANTINGLY (J. Benbow) – inconvenienced on jumping away. Raced keenly in the early and middle stages. Approaching the 200m was forced to take hold and alter course when SOMEWHAT FABULOUS was taken out into its running line. A post-race veterinary examination revealed no visible abnormalities.



SOMEWATT FABULOUS (J. Toeroek) - inconvenienced approaching the 200m when taken out into the running line of ENCHANTINGLY by COOL MAGNUM.
