

Racing SA Ltd Stipendiary Stewards' Report

Report on Race Meeting held at Morphettville Parks
Racecourse by the South Australian Jockey Club on
Saturday, 10 September 2022

TRACK: Soft 6 (Moist but not a badly affected track)

RAIL: Out 6 metres entire

WEATHER: Fine

RACE 1: SIMONE MONTGOMERIE HANDICAP - 1400 Metres

ANPHINA (T. Pannell) - inconvenienced over the concluding 200m when taken wider by MORE REWARD.

MERCHANT BOSS (J. Benbow) - near the 1000m shifted in onto MORE REWARD, which was forced to be steadied. Rider was reprimanded and advised in future to ensure he has sufficiently clear prior to shifting ground. Stewards took into account the racing manners of MERCHANT BOSS near the 1000m in arriving at this decision.

PARTY PRINCESS (J. Holder) - jumped away awkwardly.

MORE REWARD (B. Vorster) - near the 1000m had to be steadied when MERCHANT BOSS shifted in. Laid out under pressure in the straight and over the concluding 200m inconvenienced ANPHINA when taking that filly wider.


RACE 2: SAJA SUPPORTS THE NJT HANDICAP - 1000 Metres

SOLAR GALE (B. Price) - laid out under pressure in the straight. Contacted at the finish by DARING MOVE, which shifted out. Rider pleaded guilty to a charge under AR132(6)(b) in that he used his whip in an action that raised his arm above shoulder height and was reprimanded. Stewards advised B. Price that in normal circumstances this breach would have resulted in a fine however took into consideration that although the stewards had determined on 20 August 2022 he was required to attend the Riders Advisory Group in relation to his whip action that had yet to occur. Stewards undertook to follow up with the Riders Advisory Group to ensure that they meet in relation to this matter as soon as practicable.

OKAY TO PAY (S. Callow) - jumped away awkwardly. Rider reported the mare had only travelled fairly in the early and middle stages of the event, however was under pressure earlier than she had anticipated. She added the mare hung out in the straight and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

DEEVINE (J. Holder) - reared on jumping away and was slow into stride.

DARING MOVE (B. Vorster) - laid out under pressure in the straight. Approaching the finish, shifted out abruptly and contacted SOLAR GALE.



RACE 3: MELANIE TYNDALL MAIDEN PLATE - 1300 Metres

The start of this event was delayed approximately six minutes in an attempt to avoid a clash with an interstate event.

ALMARHOE (S. Fawke) - contacted on jumping away.

COMMANDER MEROO (T. Pannell) - raced wide without cover throughout the event.

I'M A MILLENNIAL (E. Wong) - stood flat-footed and was slow to begin. Raced keenly in the middle stages of the event. Laid out under pressure in the straight.

LILICIA (R. Hurdle) - jumped away awkwardly, shifted in and bumped ALMARHOE. Had difficulty in obtaining clear ground from the entrance to the straight until near the 250m. A post-race veterinary examination revealed the mare to be lame in the off hind leg (2/5). Trainer, Mr P. Nolan, was advised that a Veterinary Clearance was required prior to a future jump out, trial or race start.

IMBIBE (B. Vorster) - rider accidentally had his whip struck from his hand by the whip of T. Pannell near the 50m.

AXESTOCK GIRL (NZ) (S. Logan) - fractious behind the barriers, reared and dislodged the rider. S. Logan was examined by the First Care Medical Personnel and passed fit to ride. Co-Trainers Mr J. Dunn & Ms K. Bishop was advised that a warning had been placed on the mare in relation to its pre-race manners.

RACE 4: SYDNEY ROBERT MCDONALD MEMORIAL HANDICAP - 1950 Metres

PRINCE JOFRA (B. Price) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed a slow recovery.

TRUMPSTA (S. Callow) - raced keenly in the early and middle stages of the event.

EXALTED RUTH (S. Logan) - laid out rounding the home turn.

CHELIMO (T. Voorham) - Trainer Mr P. Nolan advised Stewards of a change in tactics in that he would advise the rider to attempt to settle further forward. Horse led.

RACE 5: CAITLIN FORREST HANDICAP - 1550 Metres

NEXT DIMENSION (NZ) (J. Eaton) - laid in under pressure in the straight.

SHORT STORIES (B. Price) - rider explained the gelding travelled well in the early and middle stages of the event however, when asked for an effort did not respond to his riding and was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

PALANI (B. Vorster) - rider reported the gelding made excess respiratory noise during the event and on pulling up. A post-race veterinary examination revealed no visible abnormalities.

RACE 6: SCOTT LECKEY HANDICAP - 1250 Metres

LAFARGUE (J. Holder) - rolled in shortly after the start onto MISS PARMIGIANA. Raced wide without cover throughout the event.

BUBBLE OVER (L. Neindorf) - laid in under pressure in the straight. Near the 250m shifted in slightly onto PARISIENNE MONDE.

PARISIENNE MONDE (K. Crowther) - had difficulty obtaining clear ground from the entrance to the straight until near the 250m when it forced to ease slightly and alter course to the outside of BUBBLE OVER, which rolled in.

ETERNAL BLAZE (S. Fawke) - raced keenly in the early and middle stages of the event.





RACE 6: SCOTT LECKEY HANDICAP - 1250 Metres (Cont'd)

BLUDOG (B. Vorster) - Trainer Mr R. Balfour advised Stewards of a change in tactics in that he would instruct his rider to attempt to obtain a more forward position. Settled midfield.

MISS PARMIGIANA (E. Wong) - shortly after the start was inconvenienced when LARFARGUE shifted in.

RACE 7: HAPPY 80TH RON BANNEAR HANDICAP - 1300 Metres

LORD VLADIVOSTOK (NZ) (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

WINGS OF PASTRAMI (T. Voorham) - raced wide without cover throughout the event.

MORIALTA (K. Crowther) - rider reported the gelding had shortened up in its action over the concluding stages and on pulling up. A post-race veterinary examination revealed cardiac arrhythmia. Trainer Mr S. Padman advised the results of an ECG are to be forwarded to the Racing SA Veterinary Surgeon and a Veterinary Clearance would be required prior to the gelding performing satisfactorily in an Official Barrier Trial.

RACE 8: DONATE AT NJT.ORG.AU HANDICAP - 1250 Metres

KONG (E. Wong) - shifted out on jumping away onto TOORAK WARRIOR. Laid out under pressure in the straight brushing with EYES NEVER LIE on a number of occasions.

RIALTOR (L. Neindorf) - near the 200m had to be checked to avoid the heels of COOL MAGNUM, which shifted in.

COOL MAGNUM (J. Maund) - inside the 1000m shifted in and away from RIALTOR onto CHEEKY GRACE. Raced keenly in the early and middle stages of the event. Near the 200m shifted in when insufficiently clear of RIALTOR, which was forced to check to avoid its heels. Rider pleaded guilty to a charge of careless riding under AR131(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on 11/9/22 and to conclude at midnight on 18/9/22: a period of three meetings.

I'M A LEGEND (B. Vorster) - a post-race veterinary examination revealed signs of colic. First aid administered. Co-Trainer Ms A. Downing was advised that a Veterinary Clearance was required prior to a future jump out, trial or race start.

EYES NEVER LIE (J. Holder) - contacted by KONG on a number of occasions in the straight.

TOORAK WARRIOR (K. Crowther) - inconvenienced on jumping away.

CLASSY KENNY (S. Fawke) - made the turn near the 900m extremely awkwardly shifted out and then raced erratically and fiercely until near the 600m.

CHEEKY GRACE (S. Callow) - inside the 1000m had to be steadied momentarily when COOL MAGNUM shifted in and away from RIALTOR. Became awkward in its action near 100m and fell dislodging its rider. Rider was examined by the First Care Medical Personnel and transported to hospital for further observation. On arrival of the Veterinary Surgeon CHEEKY GRACE was found to be deceased resulting from cardio respiratory failure. A post mortem blood sample was obtained for analysis.

RACE 9: JAGGER WATCHES HANDICAP - 1000 Metres

DASKULYA (E. Wong) - raced wide without cover throughout the event.

DESTINY'S REPUBLIC (E. Boyd) - jumped away awkwardly and shifted in contacting MANAGE THE CYCLE and then back out onto SUPER SHARP.

SEA WITNESS (E. Annells) - laid out under pressure over the concluding 100m.



RACE 9: JAGGER WATCHES HANDICAP - 1000 Metres (Cont'd)

LAKEHURST (B. Vorster) - rider accidentally dropped his whip inside the 100m. A post-race veterinary examination revealed no visible abnormalities.

MANAGE THE CYCLE (L. Neindorf) - contacted on jumping away.

SUPER SHARP (J. Holder) - inconvenienced shortly after the start.
