RACE 1: TRANS AUSTRALIAN BENCHMARK 58 HANDICAP - 1000 Metres

COMRADE BILL (K. Crowther) - rider reported she had concerns with the gelding's action behind. A post-race veterinary examination revealed no visible abnormalities.

GLENFERRIE GIRL (H. Grace) - jumped away awkwardly and shifted in.

GIALLO (J. Eaton) - slow to begin.

RACE 2: NARACOORTE REFRIGERATION BENCHMARK 64 HANDICAP - 1100 Metres

SMART ELISSIM (D. Yendall) - raced three wide without cover for the majority of the event.

HI SMOKEY (B. Price) - bumped at the start by MONTRE, which shifted out.

MONTRE (S. Metcalfe) - underwent a pre-race veterinary examination as it is over 10 years of age and was deemed suitable to race. Shifted out at the start and bumped HI SMOKEY. A post-race veterinary examination revealed no visible abnormalities.

RACE 3: TEYS NARACOORTE ASSET TEAM MAIDEN HANDICAP - 1100 Metres

ZIRCONIUM (J. Opperman) – rider reported the gelding raced greenly throughout and in the straight he was concerned with the horse's action and as a result, he did not ride ZIRCONIUM out fully to the line. A post-race veterinary examination revealed no visible abnormalities.

ROLL THE DRUMS (S. Fawke) – rider reported that he had concerns regarding the gelding's action from the 400m and did not place it under pressure thereafter, resulting in ROLL THE DRUMS finishing a distant last. Trainer Mr S. Irlam advised ROLLE THE DRUMS worked well leading into today's event. However, he was very disappointed with the gelding's performance and the horse would now be spelled. A post-race veterinary examination revealed no visible abnormalities.

SWEET ROCK CANDY (J. Eaton) - slow to begin. Following the declaration of acceptances Trainer Mr. M. Hickmott made a gear application to add blinkers to the mare's race gear. Stewards accepted this request and acting under AR206(2) fine Mr. Hickmott \$200.

CENTREFOLDSTAR (H. Grace) – crowded on jumping away. Rider reported the mare weakened noticeably in the final 100m and he was of the opinion that the mare got its tongue over the bit. A post-race veterinary examination revealed a slow recovery.

DISCO TALK (K. Crowther) - slow to begin.

BONANSKI (J. Maund) - shifted in at the start and crowded DAN'S ECHO onto CENTREFOLDSTAR, resulting in DAN'S ECHO losing ground. Raced wide without cover for the majority of the race. Hung in from the 500m.

FINAL JEDI (C. Puls) – rider explained the mare hang in, in the straight and approaching the winning post had to be steadied away from the heels of CENTREFOLDSTAR, which was losing ground forward of it.

BLOOMIN' CRAFTY (E. Annells) - slow to begin. Raced wide without cover from the 800m.

DAN'S ECHO (E. Wong) - crowded on jumping away between CENTREFOLDSTAR and BONANSKI, which shifted in. Laid in under pressure in the straight.

RACE 4: TEYS NARACOORTE COMPLEX MAIDEN PLATE - 1430 Metres

RAIDAWAY (B. Price) - re-saddled prior to be loaded into the barriers. Slow to begin.

SALUTE THE CANNONS (E. Annells) - rider reported the gelding hang in from the 500m and proved difficult to ride.

MIZZ BEEBEEFF (M. Collett) - rider reported the mare was under pressure from the 400m and in her opinion, did not back up from the previous weeks race on 18 September 2022.

PRINCESS OF SUSSEX (H. Grace) – reared over while parading, dislodging its jockey and momentarily becoming loose. Rider examined by the First Care Medical Personnel and was deemed fit to ride. Underwent a pre-race veterinary examination and was deemed suitable to race. Trainer Ms A. Hinch was advised a warning had been placed on the mare in relation to its pre-race behaviour.

RACE 5: MYALL PLUMBING BENCHMARK 54 HANDICAP - 1200 Metres

READY FOR ACTION (J. Maund) - Underwent a pre-race veterinary examination as it is over 10 years of age and was deemed suitable to race. Slow to begin. Rider reported the gelding was unable to stay in contact with the main body of the field for the majority of the race despite being under pressure however, commenced to make ground in the straight and in his opinion, may be better suited over a longer distance. A post-race veterinary examination revealed no visible abnormalities.



MANDJAR (E. Boyd) - underwent a pre-race veterinary examination as it is over 10 years of age and was deemed suitable to race. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: MYALL PLUMBING BENCHMARK 54 HANDICAP - 1200 Metres (Cont'd)

LOCKTOBA ROCKS (S. Metcalfe) - jumped away awkwardly.

RACE 6: GRAROCK PLUMBING BENCHMARK 64 HANDICAP - 2000 Metres

I'LL BE GONE (D. Yendall) – raced keenly in the early stages of the event due to the lack of pace and raced wide without cover from the 1200m. Rider reported the gelding was under pressure from the 800m and may have come to the end of its campaign.

FAST FOILS (NZ) (K. Walters) – tailed the field in the early stages however, due to the lack of speed, improved forwards from the 1400m to sit outside the leader near the 1100m. Trainer Mr W. Walters was fined \$100 under AR206(3) as he presented the gelding to race without wearing visors, which is part of its approved gear. As another set of visors were unable to be found, the gelding raced without visors.

DARKEN UP (NZ) (E. Boyd) - underwent a pre-race veterinary examination as the horse is over 10 years of age and was deemed suitable to race. A post-race veterinary examination revealed no visible abnormalities.

TRIANGULUM (E. Wong) - held up for clear running from the 400m until the 300m behind WE WANT FRANKIE and to the inside of FAST FOILS (NZ).

RACE 7: KERKOF CONCRETE BENCHMARK 68 HANDICAP - 1430 Metres

O'REILLY MCLUKE (NZ) (H. Grace) - raced keenly in the early stages of the event.

DETNAW (L. Overall) - raced keenly in the early stages of the event. Shifted ground when placed under pressure in the straight.

RACE 8: DONNA'S ELECTRICAL RATING 0 - 58 HANDICAP - 1430 Metres

ENZED BEER (NZ) (M. Collett) - laid out under pressure in the straight.

SCOTTISH SOLDIER (S. Fawke) – rider reported the gelding failed to handle today's track conditions. A post-race veterinary examination revealed the gelding exhibited signs of atrial fibrillation. Trainer Mr S. Irlam was advised the results of an ECG are to be forwarded to the Racing SA Veterinary Surgeon and a Veterinary Clearance would be required prior to performing satisfactorily in an Official Barrier Trial.

ENLIST (J. Eaton) – held up for clear running from the 400m until inside the 100m behind D'ISLES and to the inside of KHESHIG (NZ).

TUFF CAT (S. Metcalfe) - underwent a pre-race veterinary examination as it had not raced in over a year and was deemed suitable to race. Raced keenly in the early stages of the event and got its head up when being restrained.

LAST DREAM (NZ) (K. Walters) - raced keenly in the early stages of the event. Shifted out near the 250m and inconvenienced O'MIZZNA. Rider was advised to exercise more care in future.

O'MIZZNA (L. Annells) - raced wide without cover for the majority of the race. Near the 250m was inconvenienced and had to be eased away from the heels of LAST DREAM (NZ), which shifted out.
