### RACE 1: THE FOTOBASE GROUP HANDICAP - 1000 Metres

DOC O'CONNOR (A. Kelly) - inconvenienced when contacted on jumping away. Raced keenly in the early and middle stages of the event. Laid out under pressure in the straight.

HALLSTATT (L. Neindorf) - shifted out on jumping away onto ROCKSTAR MEGGSY. Near the 150m had to be momentarily steadied when it laid in slightly onto the heels of DOC O'ÇONNOR.

LANCELOTTO (T. Voorham) - jumped away awkwardly and as a result, was slow into stride. Rider reported it was her intention to settle in or outside the lead however, after jumping away awkwardly, she was obliged to settle further back than intended.

DEREK'S REGRET (D. Caboche) - raced greenly during the event. Near the 700m rolled out slightly onto LYNDA'S LEGACY. A post-race veterinary examination revealed no visible abnormalities.

ROCKSTAR MEGGSY (J. Benbow) - hampered on jumping away when tightened onto DOC O'CONNOR by HALLSTATT.

LYNDA'S LEGACY (J. Potter) - raced greenly during the event. Near the 700m shifted in and shortly after, shifted out and away from DEREK'S REGRET, over reacted and shifted wider on the track. A post-race veterinary examination revealed the filly to be lame in the near foreleg (2/5). Co-Trainer, Mr G. Lesnikowski, was advised that a Veterinary Clearance was required prior to a future jump out, trial or race start.



## RACE 2: CANADIAN CLUB HANDICAP - 1300 Metres

DEEVINE (L. McNeil) - near the 1000m had to be momentarily steadied.

PALATIAL PRINCE (B. Vorster) - raced keenly in the early stages while being restrained.

EAST INDIAMAN (T. Voorham) - near the 1000m shifted in onto DEEVINE, which had to be momentarily steadied. Rider was severely reprimanded under AR131(a) and advised in future to ensure she is sufficiently clear prior to shifting ground.

SHINSEKI (B. Price) - slow to begin. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$100. In determining penalty Stewards had regard for the totality of the use of the whip by B. Price and noted that he used it on 10 occasions over the concluding 100 metres of the event.

# RACE 3: THOMAS FARMS MAIDEN PLATE - 1300 Metres

The start of this event was delayed approximately two minutes owing to a delay with the Exhibition Gallop.

ROCK DEE JAY (L. Neindorf) - near the 1000m shifted in onto DUAL FUEL (NZ), which was forced to be steadied. Rider was reprimanded under AR131(a) and advised in future to ensure he is sufficiently clear prior to shifting ground.

BASE OF FIRE (J. Holder) - raced keenly in the early and middle stages of the event and made the turn near the 1000m awkwardly.

ZYRIAN (R. Hurdle) - shifted out on jumping away onto PRETTY RELIABLE (NZ).

PRETTY RELIABLE (NZ) (B. Vorster) - inconvenienced on jumping away.

SHANA TIME (NZ) (D. Caboche) - slow to begin. Raced keenly in the early and middle stages of the event.

WANALOAN (J. Benbow) - raced keenly in the early and middle stages of the event.

OUR SELECTION (NZ) (S. Logan) - dislodged its rider on return to scale and galloped riderless for a short distance before being captured. A post-race veterinary examination revealed the gelding to be lame in both hind legs (2/5). Co-Trainer, Mrs S. Jaensch, was advised that a Veterinary Clearance was required prior to a future jump out, trial or race start. Rider examined by the First Care Medical Personnel and passed fit to fulfil her remaining engagements.

DUAL FUEL (NZ) (A. Jordsjo) - near the 1000m had to be steadied when ROCK DEE JAY shifted in. Difficulty obtaining clear ground from the entrance to the straight until near the 200m.

KILLIAKO (K. Crowther) - raced keenly in the early and middle stages of the event.

### RACE 4: ADELAIDE GALVANISING INDUSTRIES HANDICAP - 2400 Metres

SMILING ASSASSIN (K. Crowther) - at the entrance to the straight had to be steadied when HASTA LA FIORENTE was taken out into its running line.

SOUS LES NUAGES (IRE) (B. Vorster) - held up from the entrance to the straight until near the 200m.

EXALTED RUTH (L. Lafferty) – reared over en route to the barrier dislodging its rider. Returned to the mounting yard, underwent a pre-race veterinary examination and was reported that the mare had tenderness over the back and lame in both hind legs (1/5). Acting on this advice, Stewards withdrew EXALTED RUTH at 1.30pm. Trainer Mr G. Lynch was advised that a Veterinary Clearance was required prior to a future jump out, trial or race start.

## RACE 4: ADELAIDE GALVANISING INDUSTRIES HANDICAP - 2400 Metres (Cont'd)

DIXIE WHISTLER (L. Neindorf) - at the entrance to the straight laid out slightly onto HASTA LA FIORENTE, which was taken out.

MUNTHAM MISSILE (J. Eaton) - laid out over the concluding 200m. Lost its near fore plate during the event. A post-race veterinary examination revealed no visible abnormalities.

HASTA LA FIORENTE (J. Benbow) - raced keenly in the early and middle stages of the event. At the entrance to the straight was taken out into the running line of SMILING ASSASSIN by DIXIE WHISTLER.

SO BENE (S. Logan) - difficulty obtaining clear ground at the entrance of the 100m. Rider reported it was inclined to lay in, in the straight.

HALLAROSTE (P. Gatt) - Stewards permitted P. Gatt to ride the gelding 0.5 kg over its declared weight of 54kg. Reared on jumping away. Raced keenly in the early and middle stages of the event.

SAWTELL (NZ) (A. Jordsjo) - rider reported the gelding was inclined to lay out throughout the event. A post-race veterinary examination revealed general soreness to all four limbs (2/5).

WE'LL MEET AGAIN (NZ) (E. Boyd) - jumped away awkwardly and was slow into stride. A post-race veterinary examination revealed the gelding to be lame in the off fore leg (3/5). First aid administered. Trainer, Ms J. Street, was advised that a Veterinary Clearance was required prior to a future jump out, trial or race start.

## RACE 5: ARAMIS HANDICAP - 1250 Metres

KONG (L. McNeil) - taken in shortly after the start onto NANA DULCE by OUR DEEP AGENDA.

OUR DEEP AGENDA (L. Lafferty) - shortly after the start shifted in onto KONG.

MR MARATHON MAN (GB) (B. Price) - raced keenly in the middle stages of the event. Laid out under pressure in the straight.

MCCAIN (A. Kelly) - slow to begin.

COMMANDER MEROO (L. Neindorf) - rider reported the gelding travelled well in the early and middle stages of the event however, when asked to improve from near the 600m, felt uncomfortable in its action and for this reason, he did not ride the gelding out in his normal manner. A post-race veterinary examination revealed no visible abnormalities.

NANA DULCE (E. Wong) - shortly after the start lost its position when tightened onto TIME RULER (NZ) by KONG.

TIME RULER (NZ) (T. Pannell) - rider explained the gelding travelled well in the early and middle staged of the event however, when asked for an effort at the entrance to the straight, did not respond to his riding and was disappointing. He added that in his opinion, the gelding may not have handled the good track. A post-race veterinary examination revealed no visible abnormalities.

# RACE 6: THE JUNCTION HANDICAP - 1250 Metres

DANAUSTAR (P. Gatt) – rider reported that the gelding travelled well in the early and middle stages however, when asked to quicken near the 600m, failed to respond and was disappointed to the finish. A post-race veterinary examination revealed the gelding to be lame in the off hind leg (2/5). Co-Trainer, Mr C. Maher, was advised that a Veterinary Clearance was required prior to a future jump out, trial or race start.

PICARGO (T. Pannell) - jumped away awkwardly.

LAFARGUE (J. Holder) - jumped away awkwardly contacting SAMESYN

MAY BE FATE (B. Vorster) - jumped away awkwardly and shifted in brushing MY KHALIFA.



# RACE 6: THE JUNCTION HANDICAP - 1250 Metres (Cont'd)

OUTPOST (T. Voorham) - held up from the entrance to the straight until inside the 100m.

MY KHALIFA (L. Neindorf) - contacted on jumping away.

SAMESYN (J. Benbow) - hampered on jumping away when contacted by LAFARGUE. Raced wide without cover throughout the event. Raced keenly in the middle stages of the event. Rider reported that the mare raced fiercely in the middle stages and then hung out in the straight and proved difficult to ride. A post-race veterinary examination revealed no visible abnormalities.

#### RACE 7: FURPHY HANDICAP - 1550 Metres

FRANCE'S BOY (E. Wong) - raced keenly in the early stages while being restrained. Near the 1000m had to be steadied when WICKED ADDICTION shifted in.

MORTY (L. Lafferty) - jumped away awkwardly and was slow to begin.

WICKED ADDICTION (T. Pannell) - near the 1000m shifted in onto FRANCE'S BOY, which had to be steadied. Rider was severely reprimanded under AR131(a). Laid out under pressure in the straight.

EXALTED FIRE (B. Price) - held up from the entrance to the straight until approaching the 200m. Laid out under pressure in the straight.

ALLUSION (B. Vorster) - laid out under pressure in the straight.

FLIGHT DECK (NZ) (L. Neindorf) - a post-race veterinary examination revealed no visible abnormalities.

WRITTEN IN HISTORY (T. Voorham) - jumped away awkwardly.

## RACE 8: GRAND SYNDICATES - JOIN TEAM GRAND TODAY! HANDICAP - 1400 Metres

LORD VLADIVOSTOK (NZ) (T. Pannell) - laid out under pressure in the straight.

BOLD STAR (L. Neindorf) - jumped away awkwardly.

SPLASH SOME CASH (J. Maund) - raced keenly in the early and middle stages of the event.

SEBONNA (E. Boyd) - jumped away awkwardly. Near the 700m became awkward in its action for a short distance.

LAKE'S FOLLY (B. Price) - inconvenienced near the 700 m when WINGS OF PASTRAMI rolled in.

WINGS OF PASTRAMI (P. Gatt) - Stewards permitted P. Gatt to ride the mare 0.5 kg over its declared weight of 54kg. Near the 700m rolled in onto LAKE'S FOLLY, which was inconvenienced.

Correct weight was delayed to allow Co-Trainer Mr D. Moyle to view the vision for third place.

# RACE 9: MRALD FAMILY HANDICAP - 1400 Metres

VENUSIAN (L. Lafferty) - raced keenly in the middle stages of the event. Near the 1000m was forced to take hold to avoid the heels of SEMYORKA, which shifted in. Near the 300m was momentarily steadied when it shifted in and away from STADIUM OF LIGHT (NZ).

WHEELS OF COURAGE (L. Neindorf) - had difficulty obtaining clear ground for a short distance at the entrance to the straight.

SEMYORKA (D. Caboche) - Near the 1000m shifted in when insufficiently clear of VENUSIAN forcing its rider to take hold. Rider pleaded guilty to a charge of careless riding under AR131(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 9 October and to conclude at midnight on Wednesday, 19 October 2022: a period of four meetings.

# RACE 9: MRALD FAMILY HANDICAP - 1400 Metres (Cont'd)

HILUMIERE (K. Crowther) - slow to begin.

JAY PEE BEE (NZ) (S. Fawke) - jumped away awkwardly.

# RACE 10: SPRING RACING CARNIVAL AT MORPHETTVILLE - OCTOBER 8TH - NOVEMBER 5TH HANDICAP - 1000 Metres

GLOCK (L. Lafferty) - jumped away awkwardly.

TANNER (S. Fawke) - jumped away awkwardly and shortly after was contacted by TRYGVE.

EL SALTO (J. Holder) - jumped away awkwardly. Held up from the entrance to the straight until the 150m.

POINT BLAZE (L. McNeil) - a post-race veterinary examination revealed no visible abnormalities.

TRYGVE (T. Voorham) - jumped away awkwardly, shifted out and contacted TANNER.

RODEO (C. Murray) - raced keenly in the early and middle stages of the event. Held up from the entrance to the straight until inside the 200m.

THE MAGISTRATE (B. Price) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

SEA WITNESS (J. Benbow) - raced wide without cover throughout the event.
