## RACE 1: CROSER THREE-YEAR-OLD MAIDEN PLATE - 1050 Metres

The start of this event was delayed by two minutes

BRINICLE (B. Vorster) - approaching the 100m shifted out slightly and brushed COLD CASE, which shifted in slightly.

CAPTAIN JOOLIAN (K. Crowther) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

COLD CASE (J. Toeroek) - raced wide without cover throughout the event. Approaching the 100m shifted in slightly and brushed BRINICLE, which shifted out slightly.

SIR GRUMPY (S. Logan) - Trainer Mr S. Drewitt was advised a warning had been placed on the gelding in relation to being difficult to load. Rider reported SIR GRUMPY was inclined to hang out throughout the event.

SPANISH STROLL (J. Holder) - had difficulty obtaining clear ground from the entrance to the straight until near the 200m.

WALLY WEST (J. Benbow) - Trainer Mr J. O'Connor was advised a warning had been placed on the gelding in relation to being difficult to load. Raced wide without cover throughout the event.

ZUFASTA (L. Neindorf) Trainer Mr G. Richards was advised a warning had been placed on the gelding in relation to being difficult to load. Laid in under pressure in the straight.

## RACE 2: PIMMS MAIDEN PLATE - 1200 Metres

FLEURIEU FLIPPER (C. Murray) - jumped away awkwardly. Laid out under pressure in the straight. Rider reported the gelding laid out throughout the event.



## RACE 2: PIMMS MAIDEN PLATE - 1200 Metres (Cont'd)

IMPERIAL SEAL (J. Benbow) - jumped away awkwardly, shifted in and contacted SCORPION KING. Laid out over the concluding 500m.

SEAFARING (NZ) (S. Logan) - Stewards questioned Trainer Mr J. Lynch regarding the reason the gelding did not arrive on course two hours prior to the appointed starting time. After considering his explanation Mr J. Lynch was reprimanded under AR165 and advised in future he would be required to contact Stewards in the event he was going to be late on course.

SIPSMITH (J. Holder) - fractious in the gates and kicked out on a number of occasions. A late scratching by order of Stewards at 12.32pm on veterinary advice as SIPSMITH sustained multiple lacerations to both hind legs. Trainer Mr B. Bogarts was advised the gelding would be required to trial to the satisfaction of the Stewards prior to accepting for a future race. Trainer Mr Bogarts was also advised that a Veterinary Clearance was required prior to a future jump out, trial or race start.

CLASSIC HOLLY (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

FORTIS IN ARMIS (J. Eaton) - at the entrance to the straight shifted out in an attempt to improve between the heels of IMPERIAL SEAL and SECOND TO NUN, was disappointed and obliged to alter its course when SECOND TO NUN held its line.

SCORPION KING (B. Vorster) - inconvenienced on jumping away when tightened between IMPERIAL SEAL, which shifted in and ASTROMANCER, which shifted out. Laid in under pressure in the straight. A post-race veterinary examination revealed the gelding to be lame in the off hind leg (2/5). Co-Trainer, Mr R. Jolly, was advised that a Veterinary Clearance was required prior to a future jump out, trial or race start.

ASTROMANCER (K. Crowther) - shifted out on jumping away onto SCORPION KING.

SECOND TO NUN (B. Price) - near the 300m was momentarily inconvenienced when contacted by FORTIS IN ARMIS, which shifted out in an attempt to improve.

## RACE 3: DAVID BALFOUR HANDICAP - 2000 Metres

EL GLADIADOR (NZ) (L. Lafferty) - raced keenly in the early and middle stages of the event.

SEBONNA (E. Wong) - slow to begin. Laid in under pressure in the straight.

WETAKEMANHATTAN (B. Price) - a post-race veterinary examination revealed no visible abnormalities.

MELODY MAN (K. Crowther) - raced keenly in the middle stages of the event.

STOCKED AND LOADED (NZ) (A. Jordsjo) - jumped away awkwardly and was slow to begin.

WHITCHETY GRUB (E. Boyd) - jumped away awkwardly and was slow to begin. Trainer Mr M. White was questioned win relation to gear fitted to the horse which is not approved in accordance with the National Gear Register. Trainer was reprimanded under AR206(1) and advised if he presented runners with similar gear in future, stronger action would be taken.

YESUGEI (NZ) (D. Tourneur) - D. Tourneur replaced J. Potter in this event owing to his late arrival on course, After considering his explanation and his exemplary record J. Potter was reprimanded under AR128(1).

## RACE 4: ROMEO'S FOODHALL HANDICAP - 1550 Metres

EXALTED FIRE (B. Price) - raced keenly in the early and middle stages of the event.

WICKED ADDICTION (J. Opperman) - a post-race veterinary examination revealed no visible abnormalities.



#### RACE 4: ROMEO'S FOODHALL HANDICAP - 1550 Metres (Cont'd)

CHARM SLINGA (NZ) (R. Hurdle) - inconvenienced on jumping away when contacted by INDY MAGIC.

OH NO GEORGE (T. Pannell) - near the 100m became held up for a number of strides when awkwardly placed on the heels HULUMIERE.

REALITY CHECK (J. Toeroek) - raced keenly in the early and middle stages of the event.

DASH IT (D. Tourneur) - a post-race veterinary examination revealed a slow recovery.

INDY MAGIC (J. Holder) - shifted in on jumping away and contacted CHARM SLINGA (NZ).

HILUMIERE (J. Potter) - slow to begin. Laid out under pressure in the straight.

#### RACE 5: ROMEO'S FOODLAND HANDICAP - 1200 Metres

EXTREME THRILL (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

LEFT HAND MAN (J. Benbow) - near 150m was forced to take hold and lost its position when tightened on to I AM BENE by RUSHAWAY LAD.

TYPHOON HARMONY (D. Tourneur) - near the 150m the gelding was accidentally struck across the head by the whip of B. Price.

HIDDEN LEGEND (B. Price) - laid in throughout the event. A post-race veterinary examination revealed no visible abnormalities.

RUSHAWAY LAD (T. Voorham) - near the 150m was initially taken out by CENTREFIELD and then shifted out under-riding onto LEFT HAND MAN, which was forced to take hold and when tightened onto I AM BENE. Rider was severely reprimanded under AR131(a) and advised in future to make a greater effort to keep her mounts straight.

CENTREFIELD (E. Wong) - near the 150m shifted out onto RUSHAWAY LAD. Rider reminded of his obligations when shifting ground. A post-race veterinary examination revealed a slow respiratory recovery with thumps. First aid administered.

#### RACE 6: ANTONIO & ELISABETH ROMEO HANDICAP - 1500 Metres

KAZIO (C. Rawiller) - shifted out on jumping away onto TURFITT. Laid in under pressure in the straight.

CROWN MINT (J. Toeroek) - a post-race veterinary examination revealed no visible abnormalities.

SAVILLE (R. Hurdle) - jumped away awkwardly.

SHORT STORIES (B. Price) - slow to begin. Difficulty obtaining clear ground from the entrance to the straight until inside the 200m. Laid out under pressure in the straight.

STADIUM OF LIGHT (T. Pannell) - Trainer Mr M. Hickmott reported on return to its stall that the gelding appeared to have chocked down during the event.

BLUE BEAR (E. Annells) - laid out throughout the event. Lost its position on jumping away when tightened between TURFITT and OUR DEEP AGENDA. A post-race veterinary examination revealed no visible abnormalities.

TURFITT (L. Neindorf) - taken out on jumping a way onto BLUE BEAR by KAZIO.



#### RACE 7: GRAND SYNDICATES HANDICAP - 1800 Metres

KALAMON (E. Wong) - laid out rounding the home turn and under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.



## RACE 7: GRAND SYNDICATES HANDICAP - 1800 Metres (Cont'd)

TAKUMI (IRE) (B. Vorster) - slow to begin. Laid in under pressure over the concluding stages of the event. Trainer Mr A. Purcell was advised a warning had been placed on the gelding in relation to being slow to begin.

PITRAIN (M. Collett) - raced keenly in the early and middle stages of the event.

MAGICAL RIDE (J. Holder) - approaching the 1600m shifted in when insufficiently clear of SIRMAZE which was forced to race in restricted room for a number of strides and then obliged to be restrained to avoid the heels of MAGICAL RIDE. Rider pleaded guilty to a charge of careless riding under AR131(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 29 October and to conclude at midnight on Wednesday, 2 November 2022: a period of three meetings.

QUEBECOIS (J. Eaton) - raced keenly in the early and middle stages of the event.

KENTUCKY RULER (J. Potter) - jumped away awkwardly. Raced fiercely in the early and middle stages of the event.

SIRMAZE (A. Jordsjo) - near the 1600m was forced to race in restricted room for a number of strides and then had to be restrained to avoid the heels of MAGICAL RIDE.

## RACE 8: LOCALI BY ROMEO'S HANDICAP - 1050 Metres

The start was delayed approximately one minute to avoid a clash with an interstate race.

LARKHAM (E. Wong) - raced keenly in the early and middle stages of the event. Lost it's off fore plate during the event.

VIDUKA (C. Rawiller) - a post-race veterinary examination revealed no visible abnormalities.

SMOKIN VAL (L. Lafferty) - raced wide without cover throughout the event. Laid out under pressure in the straight.

JAMES THE GREAT (B. Price) - raced keenly in the early and middle stages of the event.

FRANCINE (L. Neindorf) - near the 900m shifted in when insufficiently clear of THE MAGISTRATE which was forced to race in restricted room for a number of strides and then obliged to be restrained to avoid the heels of FRANCINE. Rider pleaded guilty to a charge of careless riding under AR131(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 29 October and to conclude at midnight on Wednesday, 2 November 2022: a period of three meetings.

RICH GINA (B. Vorster) - lost its position on jumping away when tightened between JAMES THE GREAT which shifted out slightly and FRANCINE, which shifted in slightly.

THE MAGISTRATE (T. Voorham) - near the 900m was forced to race in restricted room for a number of strides and then obliged to be restrained to avoid the heels of FRANCINE. At the entrance to the straight attempted to improve into a tight run to the outside of FRANCINE and in doing so, contacted VIDUKA, which held its line resulting in the gelding becoming disappointed for that run and held up until inside the 200m.

THE GOV (J. Opperman) - jumped away awkwardly. Near the 300m was disappointed when it commenced to improve to the inside of THE MAGISTRATE, which rolled back in slightly after being disappointed for a run, resulting in being held up inside the 200m. A post-race veterinary examination revealed no visible abnormalities.

## RACE 9: CANADIAN CLUB HANDICAP - 1200 Metres

The start of the event was delayed approximately two minutes due to the saddle of PICARGO having to be re-adjusted on arrival at the barriers.





RACE 9: CANADIAN CLUB HANDICAP - 1200 Metres (Cont'd)

SPIN THE REWARD (E. Wong) - near the 900m shifted out slightly at the same time as ADDICTIONS laid in slightly resulting in the gelding becoming awkwardly placed on heels until near the 700m.

PICARGO (C. Rawiller) - saddle had to be re-adjusted at the barriers. Rider pleaded guilty to a charge under AR132(6)(b) in that he used his whip in an action that raised his arm above shoulder height and was reprimanded.

ADDICTIONS (J. Eaton) - raced keenly in the early and middle stages of the event. Rider reported her mount hung in throughout the event. A post-race veterinary examination revealed a slow recovery.

COOL MAGNUM (S. Logan) - rider reported he mount was awkward rounding the home turn and when placed under pressure did not respond to her riding. A post-race veterinary examination revealed no visible abnormalities.

SASKATOON (J. Toeroek) - raced keenly in the early and middle stages of the event.

METRO LEGEND (B. Vorster) - raced wide without cover throughout the event.

MAY BE FATE (J. Benbow) - jumped away awkwardly. Held up from the entrance to the straight until inside the 100m.

RACE 10: CANADIAN CLUB HANDICAP - 1200 Metres

The start of this event was delayed approximately nine minutes after KOMACHI became cast.

THANASI (J. Opperman) - jumped away awkwardly and shifted out. Raced wide without cover throughout the event.

ULTIMATE VICTORY (E. Wong) - a post-race veterinary examination revealed no visible abnormalities.

KOMACHI (IRE) (B. Price) - became fractious after being loaded and became cast, resulting in a significant delay. KOMACHI (IRE) was a late scratching by order of Stewards at 5.37pm on veterinary advice. Trainer Mr M. Pegus was advised that the gelding be required to prove tractable in the barriers at an Official Barrier Trial or a Victorian Jump Out prior to accepting for a future race.

MCCAIN (L. Neindorf) - slow to begin.

KAYSERI (NZ) (D. Tourneur) - Stewards declared the gelding a late scratching on veterinary advice at 3.46pm as KAYSERI (NZ) was found to be lame in the off hind leg (3/5) on arrival on course.

CLASSY KENNY (S. Logan) - commenced to hang out severely near the 800m and approaching the 700m shifted out contacting TWICE FORGOTTEN. Near the 600m shifted out abruptly contacting RECREANT, which was inconvenienced when taken out onto BAMYAN BUDDHA. A post-race veterinary examination revealed no visible abnormalities. Co-Trainer Mr J. Hickmott was advised the gelding would be required to be tractable in an Official Barrier Trial prior to accepting for a future race.

L'IL PIPER (J. Benbow) - bucked shortly after the start resulting in the rider losing the use of his near side iron for some distance before the mare was eased out of the event. Trainer Mr J. Hyam was advised that the mare be required to trial to the satisfaction of the Stewards in an Official Barrier Trial prior to accepting for a future race.
