RACE 1: ZOBEL FINANCE NARACOORTE BENCHMARK 66 HANDICAP - 1200 Metres

ROHLON DRUNK (B. Wong) - raced keenly in the early and middle stages of the event. Rider accidentally dropped her whip approaching the 100m.

ULTIMATE VICTORY (D. Tourneur) - underwent a pre-race veterinary examination and was deemed suitable to race. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: NARACOORTE RADIATORS MAIDEN HANDICAP - 1430 Metres

RAIDAWAY (J. Potter) - crowded and lost ground at the start between DUKE OF ANJOU and SON OF AKEED which shifted out.

JUST JAZZ (S. Logan) - near the 1200m got its head up when being restrained.

SON OF AKEED (A. Livesey) - jumped awkwardly, shifted out and crowded RAIDAWAY onto DUKE OF ANJOU.

SWISS TIME (B. Price) - laid in near the 400 metres and became momentarily unbalanced.

RACE 3: HANSEN PRINT MAIDEN PLATE - 1200 Metres

HASTA LA MISSILE (D. Tourneur) - raced keenly in the early and middle stages of the event.

SPANISH COURAGE (J. Potter) - shortly after the start shifted in and bumped MAI TIME. Rider reported the gelding raced greenly and hung in for the majority of the event.

RACE 3: HANSEN PRINT MAIDEN PLATE - 1200 Metres (Cont'd)

YOUR OUTATOUCH (J. Opperman) - raced wide without cover for the majority of the event. A post-race veterinary examination revealed no visible abnormalities.

CHIQ MAGNET (C. Puls) - laid out in the straight.

MAI TIME (B. Wong) - shortly after the start was bumped by SPANISH COURAGE.

MIZZ BEEBEEFF (M. Collett) - Co-Trainer Mr J. Jaensch advised Stewards of a change in tactics in that he would instruct his rider to ride the mare further back. Settled back.

RACE 4: BEELINE CAR & TRUCK WASH FILLIES & MARES BENCHMARK 58 HANDICAP - 1100 Metres

LOCKTOBA ROCKS (A. Livesey) - raced wide without cover for the majority of the event.

HAARPING (B. Price) - underwent a pre-race veterinary examination as the mare has not raced since November 2021 and was deemed suitable to race.

RACE 5: SOUTH EAST MARINE & MOTOR CYCLES BENCHMARK 68 HANDICAP - 1430 Metres

GIGGLON (A. Lindsay) - raced keenly in the early stages and got its head up when being restrained. Near the 400m shifted out when insufficiently clear of KHESHIG, which was steadied. Rider was reprimanded under AR131(a) for careless riding.

SESAR (B. Price) - raced keenly in the early stages and got its head up when being restrained. Raced wide without cover for the majority of the event.

VICTORY BANDIT (M. Collett) - raced keenly in the early stages and got its head up when being restrained.

KHESHIG (NZ) (S. Fawke) - underwent a pre-race veterinary examination as it raced on 24 October 2022 and was deemed suitable to race. Raced keenly in the early stages of the event. Near the 400m was momentarily steadied to avoid the heels of GIGGLON which shifted out.

RACE 6: LOCAL TRAINERS BENCHMARK 60 HANDICAP - 2000 Metres

The start of this event was delayed by two minutes.

HASTA LA FIORENTE (D. Tourneur) - jumped away awkwardly and bumped with NATIVE BLUE. Raced keenly in the early and middle stages of the event.

DARKEN UP (NZ) (K. Walters) - a post-race veterinary examination revealed no visible abnormalities.

NATIVE BLUE (M. Collett) - jumped away awkwardly and bumped with HASTA LA FIORENTE. Rider reported the gelding did not handle the track conditions in today's event.

O'MIZZNA (A. Lindsay) - re-saddled on arrival at the barriers.

RACE 7: HAGE TRACTORS COLTS, GELDINGS & ENTIRES BENCHMARK 54 HANDICAP - 1100 Metres

MISTA HOLYFIELD (B. Wong) - jumped away awkwardly.

COMRADE BILL (K. Crowther) - underwent a pre-race veterinary examination as it raced on 26 October 2022 and was deemed suitable to race.

TARASQUE (C. Puls) - rider reported the gelding did not handle the track condition in today's event.

RACE 7: HAGE TRACTORS COLTS, GELDINGS & ENTIRES BENCHMARK 54 HANDICAP - 1100 Metres (Cont'd)

SOLAAZEM (T. Voorham) - underwent a pre-race veterinary examination and was deemed suitable to race. A post-race veterinary examination revealed no visible abnormalities.

ARACHNATTACK (B. Price) - held up from the 600m until the 250m behind MONTRE and to the inside of COMRADE BILL. Rider reminded of his obligations to ride his horse out to the finish under AR131(b).

MONTRE (S. Fawke) - underwent a pre-race veterinary examination and was deemed suitable to race. Rider and Trainer Mr C. Stewart were questioned in relation to the gelding taking a more forward position than at its most recent starts. Rider explained that he was advised to be in a forward position. Trainer explained that he had given similar instructions in the two previous starts but due to circumstances the gelding was unable to obtain a more forward position. A post-race veterinary examination revealed no visible abnormalities.
