RACE 1: CANADIAN CLUB HANDICAP (HEAT OF TAB REBEL RAIDER SERIES) - 1250 Metres

TRAITORS' GATE (J. Benbow) - laid out near the 1000m and again when rounding the home turn. Rider reported on return to scale that the gelding felt uncomfortable in its action on pulling up. A post-race veterinary examination revealed no visible abnormalities.

KILLIAKO (K. Crowther) - jumped away awkwardly.

PRETTY RELIABLE (NZ) (B. Vorster) - raced keenly in the early and middle stages of the event. Rider reported the filly over-raced in the early and middle stages and in his opinion, would be better suited in a race with more tempo in the early stages. A post-race veterinary examination revealed no visible abnormalities.

SECOND TO NUN (B. Price) - raced keenly in the early and middle stages of the event.

ARUGAMAMA (J. Holder) - raced keenly in the early and middle stages of the event.

RACE 2: CHALK HILL WINES HANDICAP (HEAT OF TAB SKYBEAU SERIES) - 2250 Metres

OATH OF OMERTA (J. Eaton) - rider reported the gelding raced fiercely in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

HALLAROSTE (K. Crowther) - jumped away awkwardly. Laid out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

SPACE EQUITY (D. Caboche) - held up for a short distance near the 300m and was obliged to alter course to the outside of other runners to obtain clear ground.



RACE 3: TWILIGHT RACES AT MORPHETTVILLE - FRIDAY DECEMBER 16TH MAIDEN PLATE - 1000 Metres

The start of this event was delayed by approximately four minutes to avoid a clash with an interstate event.

FIELD OF STEEL (J. Holder) - jumped away extremely awkwardly and was slow into stride.

IMPERIAL SEAL (J. Benbow) - turned its head just prior to the start being affected resulting, in the gelding jumping away awkwardly and being slow into stride. Raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed cardiac arrhythmia. Trainer Mr B. Cozamanis was advised the results of an ECG are to be forwarded to Racing SA's Veterinary Surgeon and a Veterinary Clearance would be required prior to the gelding performing satisfactorily in an Official Barrier Trial.

MINT MEMORY (A. Jordsjo) - raced wide without cover throughout the event.

ENCHANTING EAGLE (P. Gatt) - slow to begin.

WAKANJEJA (K. Crowther) - jumped away awkwardly.

Correct weight was delayed to allow J. Benbow (IMPERIAL SEAL) to view the vision of the start.

RACE 4: PFD FOODS HANDICAP - 1550 Metres

EXALTED FIRE (B. Price) - raced keenly in the early and middle stages of the event. Laid out rounding the home turn and under pressure in the straight.

GETOUTTHEWAY (M. Lloyd) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

GOOD APPROACH (K. Crowther) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed the gelding to be lame in the near foreleg (3/5). Trainer, Mr M. Seyers, was advised that a Veterinary Clearance was required prior to a future jump out, trial or race start.

MOUNTAIN RANGE (J. Holder) - raced keenly in the early and middle stages of the event.

BLUE BEAR (D. Caboche) - rider pleaded guilty to a charge under AR132(6)(b) in that he used his whip in an action that raised his arm above shoulder height and was reprimanded.

AITCH D'AMICO (J. Benbow) - raced wide without cover throughout the event. Inclined to lay in under pressure in the straight.

RACE 5: PIMMS HANDICAP (HEAT OF TAB GYTRASH SERIES) - 1000 Metres

The start of this event was delayed by approximately two minutes to avoid a clash with an interstate event.

ALLEBOOM (J. Toeroek) - contacted on jumping away and taken onto DARING MOVE. Near the 300m was inconvenienced when contacted by MAGIC MAX for a number of strides.

CHAMPAGNE DREAMS (K. Crowther) - jumped away awkwardly.

SOLAR GALE (J. Eaton) - slow to begin and shortly after was unable to maintain its position when DARING MOVE was taken in.

DARING MOVE (B. Vorster) - taken into the running line of SOLAR GALE in on jumping away by ALLEBOOM. Laid out under pressure in the straight.

RUSHAWAY LAD (J. Benbow) - shifted in on jumping away and bumped ALLEBOOM.

GREAT DIVINER (P. Gatt) - Stewards permitted P. Gatt to ride the gelding 0.5 kg over its declared weight of 54 kg. Jumped away awkwardly and was slow into stride.

RACE 5: PIMMS HANDICAP (HEAT OF TAB GYTRASH SERIES) - 1000 Metres (Cont'd)

MAGIC MAX (D. Tourneur) - near the 300m shifted out to improve and in doing so, made contact with ALLEBOOM for a number of strides. Rider was reprimanded and advised in future to ensure there was sufficient room prior to attempting runs.

RACE 6: HAPPY 90TH BIRTHDAY RICHARD BUTLER HANDICAP - 1300 Metres

The start of this event was delayed by approximately three minutes initially to avoid a clash with an interstate event and then due to WINE FROM TEARS becoming cast.

OUR DEEP AGENDA (J. Opperman) – jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

DAZZLING PROSPECT (S. Logan) - inconvenienced on jumping away.

RECREANT (B. Price) - a post-race veterinary examination revealed no visible abnormalities.

TAVIKAT (NZ) (J. Benbow) - raced keenly in the early and middle stages of the event.

PARISIENNE MONDE (K. Crowther) - jumped away awkwardly and shifted in onto DAZZLING PROSPECT.

PERFECT COMMAND (J. Eaton) - raced wide without cover throughout the event.

WINE FROM TEARS (J. Holder) – reared after being loaded into the barrier structure. Got its off foreleg over the adjoining partion and became cast. Underwent a pre-race veterinary examination and was deemed unsuitable to race. A late scratching at 3.35pm by order of Stewards on veterinary advice. Trainer Mr C. Bieg was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race and that the gelding would be required to perform to the Stewards satisfaction in an Official Barrier Trial or an approval jump out prior to accepting for a future race.

POSSUM BORN (M. Lloyd) - raced keenly in the early and middle stages of the event.

TWICE FORGOTTEN (D. Caboche) - raced keenly in the early and middle stages of the event.

RACE 7: CROSER HANDICAP - 1550 Metres

CALL ME SHAMUS (T. Voorham) - slow to begin.

OH MO (K. Crowther) - momentarily held up at the entrance to the straight and altered course to the inside of BOLD STAR to obtain clear ground.

TERRITORY TITAN (J. Lorensini) - laid out under pressure over the concluding 200m.

RITRATTO (J. Benbow) - jumped away awkwardly, shifted in contacting HOPON HARRY.

HANKSTAR (D. Tourneur) - raced fiercely in the early and middle stages of the event. Near the 1000m shifted out taking UNLACED (NZ) wider. A post-race veterinary examination revealed the gelding to be lame in the off hind leg (2/5). Trainer, Mr P. Nolan, was advised that a Veterinary Clearance was required prior to a future jump out, trial or race start.

UNLACED (NZ) (B. Price) - near the 1000m was inconvenienced when taken wider by HANKSTAR and forced to race without cover for the remainder of the event.

HOPON HARRY (J. Holder) - contacted on jumping away.

RACE 8: FURPHY HANDICAP - 1000 Metres

The start of this event was delayed approximately five minutes.

SASKATOON (B. Vorster) - raced keenly in the early and middle stages of the event. Had difficulty obtaining clear ground until the entrance to the straight until approaching the 100m.





TRYGVE (J. Holder) - approaching the finish had to be steadied when awkwardly placed between the heels of MR MARATHON MAN and THE GOV, which was taken out.

LITTLE RICH BOY (J. Maund) - a post-race veterinary examination revealed no visible abnormalities.

TANJA'S DREAM (L. McNeil) – shortly after the start commenced to buck and dislodged its rider near the 900m. Rider was examined by the First Care Medical Personnel and ruled unfit to fulfil his remaining engagment. Trainer Mr G. Kluske was advised the mare would be required to perform to the Stewards satisfaction in an Official Barrier Trial prior to accepting for a future race.

THE MAGISTRATE (T. Voorham) - raced wide without cover throughout the event. Laid out under pressure in the straight. Approaching the finish shifted out onto THE GOV.

THE TRANCE FACTOR (D. Caboche) - slow to begin.

STAR ESPRESSO (P. Gatt) - lost its near fore plate en route to the barriers. Re-fitted by the Farrier. Underwent a pre-race veterinary examination and was deemed suitable to race.

SAMESYN (J. Benbow) - raced wide without cover throughout the event. Laid out under pressure in the straight. Rider reported the mare laid out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

THE GOV (J. Toeroek) - taken out approaching the finish onto TRYGVE by THE MAGISTRATE.

LONRODEX (K. Crowther) - laid out under pressure in the straight.

RIZSKI (D. Tourneur) - underwent a pre-race veterinary examination as it raced on 1 November 2022 and was deemed suitable to race.

RACE 9: FLEURIEU MILK COMPANY HANDICAP - 1400 Metres

LEFT HAND MAN (T. Voorham) - rider reported the gelding travelled well in the early and middle stages of the event however, when asked for an effort at the entrance to the straight, did not respond to her riding and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

NEXT DIMENSION (NZ) (A. Lindsay) - Stewards acceded to a gear request from Trainer P. Trenwith to add bar plates on in front.

MY KHALIFA (M.Lloyd) - hung in under pressure in the straight.

COOL MAGNUM (J. Maund) - raced keenly in the early and middle stages of the event.

METRO LEGEND (B. Vorster) - rider reported the gelding raced keenly in the early and middle stages.

FALLOW (D. Tourneur) - raced wide without cover throughout the event. Rider reported the gelding travelled well in the early and middle stages however was under pressure near the 600 m and had not finished the event off as he had anticipated. A post-race veterinary examination revealed no visible abnormalities.

MAY BE FATE (J. Benbow) - a post-race veterinary examination revealed no visible abnormalities.
