RACE 1: ECO CLEAN MAIDEN PLATE - 1200 Metres

The start of this event was delayed approximately one minute.

LEVEE (C. Murray) - made heavy contact with a perimeter fence in the pre-parade ring. Underwent a pre-race veterinary examination on arrival at the barriers and was deemed suitable to race.

VARIARA (E. Boyd) - on jumping away bumped with JUSTICA'S BONUS, which shifted out.

JUSTICA'S BONUS (B. Wong) - jumped away awkwardly, shifted out and bumped VARIARA. Laid in, in the straight. Approaching the finish was awkwardly placed on the heels of POCKET PENNY and was unable to ridden out.

SHIPWRECK (K. Sardelic) - inside the 800m raced tight and in restricted room between JUSTEDEE and BIG GIRL HELGA for a number of strides. A post-race veterinary examination revealed no visible abnormalities.

SIR GRUMPY (B. Price) - provided difficult to load. Trainer, Mr S. Drewitt was advised that the gelding was now required to load without delay in an Official Barrier Trial or Approval to Race jump-out prior to a future race start.

BIG GIRL HELGA (T. Voorham) - raced keenly in the early and middle stages of the event. Near the 400m dipped. Hung in under pressure in the straight.

BUILDING CASTLES (E. Wong) - underwent a pre-race veterinary examination on arrival at the barriers and was found to be lame in the near foreleg (2/5). Acting on this advice BUILDING CASTLES was declared a late scratching at 2.01 pm. Co-trainer, Mr J. Dunn was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

MISS MOOCHA (K. Crowther) - late scratching by order of the Stewards at 7:40am acting on confirmed advice from Trainer, Mr D. Carrison that the mare was exhibiting signs of colic and would be unsuitable to race. As the final list of scratching's had not been released, Stewards permitted, under AR58, JUSTEDEE (first emergency) to take its place in the field. Trainer, Mr D. Carrison was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

POCKET PENNY (J. Doyle) - inclined to lay out under pressure in the straight.

JUSTEDEE (K. Crowther) - underwent a pre-race veterinary examination as the gelding had not raced for one year and was deemed suitable to race. Laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: CARLTON UNITED BREWERY MAIDEN HANDICAP (1) - 1350 Metres

THE LOCKSMITH (T. Voorham) - jumped away awkwardly. Got its head up and raced ungenerously in the early stages of the event. Rider reported that the gelding raced greenly throughout the event.

MIS GUIDED CHOICE (D. Caboche) - laid in under pressure in the straight.

ALMARHOE (S. Fawke) - jumped away awkwardly and shifted out.

ROKUN (J. Doyle) - jumped away awkwardly and shifted out.

ROWDY DIVA (A. Livesey) - slow to begin. Trainer, Mr S. Drewitt, was advised that a warning had been placed on the mare in relation to the way it began.

SUBUKI (E. Boyd) - as the start was affected got its near hind leg up on the barrier partition and as a result jumped away very awkwardly and was slow to begin.

SWANNIE (E. Annells) - hung in from near the 600m for the remainder of the event. A post-race veterinary examination revealed no visible abnormalities.





RACE 3: BENDIGO COMMUNITY BANK PORT LINCOLN MAIDEN HANDICAP (2) - 1350 Metres

CLUB RAIDER (C. Murray) - jumped away awkwardly. Raced ungenerously in the early stages of the event. Rounded the home turn very wide.

TUFF OPERATOR (S. Fawke) - at the entrance to the straight was taken out by ZIGGING AROUND, which shifted out abruptly onto AXESTOCK GIRL (NZ), which had to be steadied and was taken wider.

FORGIVING (K. Sardelic) - on jumping away bumped with SECOND LAST CHANCE.

INOTELL (K. Crowther) - near the 400m was awkwardly placed between BEERS ON BILL, which rolled out and AKUBRA BLACK, which rolled in. Approaching the finish bumped with RAMBLER GAMBLER, which shifted out.

ANGRY ANT (B. Price) - near the 1000m shifted in and out abruptly and was awkward in its action. Rider reported that the gelding raced greenly throughout the event.

AXESTOCK GIRL (NZ) (A. Livesey) - shortly after the start lost its position when tightened onto CLUB RAIDER as FORGIVING was taken out. At the entrance to the straight was obliged to be steadied when taken wider by TUFF OPERATOR, which was taken out by ZIGGING AROUND.

BEERS ON BILL (D. Caboche) - a post-race veterinary examination revealed no visible abnormalities.

RAMBLER GAMBLER (F. Atkinson) - approaching the finish shifted out and bumped INOTELL. Rider was reminded of her obligations under AR131(a) and was advised to straighten her mounts when they commence to shift ground.

SECOND LAST CHANCE (T. Voorham) - jumped away awkwardly, shifted out and bumped FORGIVING. Approaching the 1200m attempted to buck and lost some ground. Raced keenly and ungenerously in the middle stages of the event. Trainer, Mr B. Jones was advised that a warning had been placed on the mare in relation to its racing manners.

ZIGGING AROUND (E. Wong) - jumped away awkwardly. At the entrance to the straight when hanging out, shifted out abruptly onto TUFF OPERATOR, which was taken out onto AXESTOCK GIRL (NZ), which was obliged to be steadied when tightened onto SECOND LAST CHANCE. During the incident the rider dropped his near side rein momentarily. Rider was reminded of his obligations under AR131(a).

RACE 4: DEMPSEY'S SADDLERY & FEED SUPPLIES BENCHMARK 58 HANDICAP - 1350 Metres

AHSO (E. Wong) - raced wide without cover in the early stages of the event.

MARINA (S. Fawke) - near the 400m hung out and shifted out onto SPINOLA BAY, which was inconvenienced.

FESTIVAL OF LIGHT (K. Crowther) - raced ungenerously in the early and middle stage of the event.

PRESCIENT (B. Price) - on jumping away was taken out by SWING IT SISTER.

AUGUSTA ROCK (A. Livesey) - on jumping away lost its position when tightened onto SINO WITNESS as PRESCIENT was taken out. Inclined to lay in under pressure in the straight.

SPINOLA BAY (J. Doyle) - stewards permitted the mare to race without visors in this event. Near the 400m was obliged to be steadied when tightened onto AHSO as MARINA, which was hanging out, shifted out.

AXECAPITAL (NZ) (E. Boyd) - near the 100m was awkwardly placed on the heels of SASSY MANEUVER which shifted out and was obliged to shift to the inside of that mare.

SWING IT SISTER (T. Voorham) - jumped away awkwardly, shifted out and took PRESCIENT out.

SASSY MANEUVER (L. Annells) - near the 100m shifted out onto AXECAPITAL (NZ) which was obliged to alter course to its inside.



RACE 5: MCDONALDS BENCHMARK 52 HANDICAP - 1250 Metres

BLUDOG (K. Crowther) - at the entrance to the straight was disappointed for a run between ODDSOCK and MISS PARMIGIANA and was obliged to shift in to obtain clear running.

VALLEY RATTLER (K. Sardelic) - a post-race veterinary examination revealed no visible abnormalities.

THE MASTER (S. Fawke) - shortly after the start shifted in.

BONIFACE (NZ) (B. Wong) - hung in under pressure in the straight.

SCOUT'S HONOUR (T. Voorham) - slow to begin.

TAJAVEDO (E. Boyd) - slow to begin.

HIGHLY RIGHTEOUS (J. Doyle) - approaching the 200m raced in restricted room for a short distance between SCOUT'S HONOUR and BONIFACE (NZ), which was hanging in.

RACE 6: LINCOLN ESTATE BENCHMARK 66 HANDICAP - 1750 Metres

The start of this event was delayed approximately one minute to avoid a clash with an interstate event (Warwick).

FEARLESS AL (C. Murray) - a post-race veterinary examination revealed no visible abnormalities.

MOUNT MADEIRA (NZ) (E. Wong) - held up for clear running from rounding the home turn until approaching the 200m.

ALLUSION (K. Crowther) - held up for clear running for a short distance at the entrance to the straight. Near the 150m was inconvenienced when taken in by GIVEPEACE A CHANCE. A post-race veterinary examination revealed a slower than normal post-race recovery and a minor laceration consistent with being galloped on behind.

GIVEPEACE A CHANCE (E. Boyd) - near the 150m rolled in and inconvenienced ALLUSION which was taken in. When questioned regarding her riding of the gelding near the 200m, E Boyd explained that she received a call from a rider to her outside and she attempted to straighten her mount, in doing so over corrected, and rolled in onto ALLUSION. A post-race veterinary examination revealed no visible abnormalities.

NEAR MAGIC (E. Annells) - over raced in the early and middle stages of the event.

VANCOUVER VELVET (B. Wong) - held up for clear running from inside the 400m until shortly after the entrance to the straight.

RACE 7: BK & BJ SOUTHAM BENCHMARK 58 HANDICAP (1) - 1000 Metres

The start of this event was delayed approximately three minutes partially owing to MESSERSCHMITT having to have its cross over noseband re-fitted after being loaded.

ARCHERY BUTTS (K. Sardelic) - rider reported that the gelding laid out throughout the event and proved difficult to control. A post-race veterinary examination revealed no visible abnormalities.

MESSERSCHMITT (E. Wong) - jumped away awkwardly. Had difficulty obtaining clear ground over the concluding 100m when racing between STRAWBERRY SWING and EXPRESS MASTER (NZ). A post-race veterinary examination revealed no visible abnormalities.

STRAWBERRY SWING (F. Atkinson) - laid in under pressure in the straight.

EXPRESS MASTER (NZ) (K. Crowther) - raced wide without cover throughout the event.





RACE 7: BK & BJ SOUTHAM BENCHMARK 58 HANDICAP (1) - 1000 Metres (cont'd)

DEFACTOR (B. Wong) - proved difficult to load. Trainer, Mr T. Montgomerie was advised that the gelding was now required to load without delay in an Official Barrier Trial or Approval to Race jump-out prior to a future race start. Raced keenly in the early stages of the event. Near the 800m rolled in onto PERFECT ZED.

SEGAL (S. Fawke) - after being loaded got its leg up on the barrier partition. Underwent a pre-race veterinary examination and was deemed suitable to race. Slow to begin. Near the 800m was very awkwardly placed between the heels of ISA SECRET and PERFECT ZED, which shifted in when being restrained. Held up for clear running from near the 150m until the finish.

PERFECT ZED (E. Boyd) - near the 800m was obliged to be restrained when awkwardly placed on the inside of DEFACTOR, which was racing keenly and rolled in and as a result PERFECT ZED shifted in onto SEGAL.

ISA SECRET (T. Voorham) - held up for clear running from inside the 200m until the finish and was untested to the line when racing between MAIDEN GRACE and ATTACK THE PIN, which both commenced to weaken.

CHASING STARS (B. Price) - raced wide without cover throughout the event.

RACE 8: TAB BENCHMARK 58 HANDICAP (2) - 1000 Metres

The start of this event was delayed approximately three minutes owing to LITTLE MISS RICH being difficult to load.

A THOUSAND DEGREES (A. Livesey) - approaching the 600m was awkwardly placed on the heels of ARCHIE'S A STAR, which shifted out at the same time A THOUSAND DEGREES when racing keenly, shifted out onto DUCHESS NICCI, which was obliged to be checked and lost its position when tightened onto VIRTUE (NZ). Rider was severely reprimanded under AR131(a) and advised, in future circumstances, that she should not pass her problems onto someone else.

QUIERO (F. Atkinson) - shortly after the start was tightened between VIRTUE (NZ) and LITTLE MISS RICH. A post-race veterinary examination revealed no visible abnormalities.

LITTLE MISS RICH (B. Price) - unruly en route to the barriers and proved difficult to load. Stable representative, Ms. K. Halliday was advised that a warning had been placed on the gelding in relation to its pre-race behaviour and being difficult to load.

VIRTUE (NZ) (D. Caboche) - a post-race veterinary examination revealed a slower than normal post-race recovery.

ARCHIE'S A STAR (K. Sardelic) - approaching the 600m was awkwardly placed on the heels of RIVERSIDE ROCK and shifted out taking A THOUSAND DEGREES wider.

STAR PARFAIT (E. Wong) - raced ungenerously in the early stages of the event and was awkward in its action.

STORM VOYAGER (S. Fawke) - laid in, in the straight.

DUCHESS NICCI (E. Boyd) - approaching the 600m was obliged to be checked and lost its position when awkwardly placed on the heels of A THOUSAND DEGREES, which shifted out when racing keenly at the same time ARCHIE'S A STAR shifted out in front of it.

General

Stewards questioned rider, S. Fawke in relation to his dual engagement in this event on STORM VOYAGER and DUCHESS NICCI. S. Fawke explained that his manager had taken a ride on STORM VOYAGER and he had also taken a ride on DUCHESS NICCI. He was unaware that his manager had accepted another ride in the event. After considering the explanation and his unblemished record S. Fawke was reprimanded under LR18.1.4 for being dually engaged in this event.





RACE 9: DK QUARRIES CLASS TWO HANDICAP - 1210 Metres

The start of this event was delayed approximately one minute.

CROWNED KING (E. Wong) - jumped away awkwardly and shifted in onto COMPARDY. Inside the 1000m was obliged to be steadied and lost its position when tighten onto HE'S ABEL as GOODARCHIE was taken in. Approaching the 400m raced in restricted room and tight to the inside of TALLU. A post-race veterinary examination revealed no visible abnormalities.

TALLU (K. Sardelic) - inside the 1000m raced in restricted room to the inside of STRIP CLUB, rolled in onto GOODARCHIE, which was inconvenienced and taken in onto CROWNED KING, which was obliged to be steadied and lost its position when tightened onto HE'S ABEL. Rider was severely reprimanded under AR131(a) and advised, in future to attempt to make a greater effort to keep his mounts straight. Near the 900m was inconvenienced and obliged to shift to the outside of STRIP CLUB which shifted in. Approaching the 400m raced in restricted room and tight between CROWNED KING on its inside and ORIEDOS, which had improved to its outside. When questioned in relation to the gelding's performance rider reported that his instructions were to be positive out of the barriers but not lead. He added that after permitting STRIP CLUB to cross for a position in the lead near the 900m, the gelding raced flat. He further stated that TALLU raced off the bridle from near the 600m and was disappointing to the finish.

SPACE FORCE (S. Fawke) - jumped away awkwardly, shifted out and contacted OUR JOURNEYMAN.

ZAKYBREE (A. Livesey) - jumped away awkwardly.

STRIP CLUB (E. Annells) - near the 900m shifted in onto TALLU, which was inconvenienced and obliged to shift out. Rider was severely reprimanded under AR131(a) and advised, in future to take greater care when shifting ground.

OUR JOURNEYMAN (B. Wong) - on jumping away was tightened onto COMPARDY as SPACE FORCE shifted out.

COMPARDY (E. Boyd) - on jumping away bumped with CROWNED KING, which shifted in and OUR JOURNEYMAN. Shortly after was inconvenienced and lost ground when tightened between CROWNED KING and OUR JOURNEYMAN, which both shifted ground and thereafter over raced for a short distance.

GOODARCHIE (K. Crowther) - inside the 1000m was inconvenienced and taken in by TALLU onto CROWNED KING.

HE'S ABEL (B. Price) - approaching the 400m was awkwardly placed inside the heels of CROWNED KING, was obliged to be steadied and lost its position. A post-race veterinary examination revealed no visible abnormalities.
