RACE 1: TAB REBEL RAIDER SERIES FINAL - 1200 Metres

ROCKSTAR MEGGSY (J. Holder) - contacted and tightened at the start.

KLABEL (NZ) (J. Toeroek) - awkward to begin and near the 900m shifted in and hampered DECLARED for a short distance.



## RACE 1: TAB REBEL RAIDER SERIES FINAL - 1200 Metres (cont'd)

ZUFASTA (L. Neindorf) - laid in, in the straight. Rider explained that the gelding raced plain in its manner and when asked for an effort failed to let down and was dour, and for that reason he did not ride his mount out to the finish in his usual manner over the concluding stages. A post-race veterinary examination revealed no visible abnormalities.

COLD CASE (B. Vorster) - awkward to begin, shifted out and contacted ROCKSTAR MEGGSY and tightened that horse onto ZUFASTA.

DECLARED (B. Price) - raced keenly in the early stages of the event and near the 900m was hampered for a short distance by KLABEL (NZ), which shifted in.

HAYZEE FANTAYZEE (K. Crowther) - laid out over the concluding stages.

#### RACE 2: 2022 SA HALL OF FAME - KEN & HELEN SMITH - 1800 Metres

BOOLCUNDA KING (B. Vorster) - inclined to lay in over the concluding stages and inside the 100m was momentarily inconvenienced by COMFORT GIRL, which shifted out momentarily when under pressure. A post-race veterinary examination revealed no visible abnormalities. Co-trainer, Mr P. Blanch, reported that the gelding would now be spelled.

PITRAIN (M. Collett) - shortly after the start was tightened between CRYPTO CURRENCY, which maintained its line, and BOOLCUNDA KING, which was taken out by COMFORT GIRL, which shifted out. Raced keenly for a short distance near the 1000m.

COMFORT GIRL (E. Wong) - shifted out at the start taking BOOLCUNDA KING out. Shifted out sharply when under pressure inside the 100m and momentarily inconvenienced BOOLCUNDA KING.

# RACE 3: 2022 SA HALL OF FAME - TAJ ROSSI - 1200 Metres

SEA WITNESS (J. Holder) - raced keenly in the early stages of the event.

OBI (P. Gatt) - momentarily inconvenienced at the start.

EXALTED MAXINE (B. Price) - raced keenly in the early stages of the event. Rider reported that the mare made a breathing noise near the winning post. A post-race veterinary examination revealed the mare to be lame in the near foreleg. Trainer, Mr B. Holtham, was advised that a Veterinary Clearance would now be required prior to a future jump-out, trial or race.

ULTIMATE VICTORY (D. Tourneur) - rider reported that the gelding felt awkward in its action during the event. Laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities. Co-trainer, Mr P. Blanch, advised that the gelding would now be spelled.

CLASSY KENNY (J. Maund) - held up for clear running from near the 500m until near the 300m and thereafter from approaching the 200m had difficulty obtaining clear running until near the 150m where it was obliged to shift out to obtain clear running.

SUGGESTIVE MISS (B. Vorster) – slow to begin. Held up from near the 200m and was unable to obtain clear running room and as a consequence SUGGESTIVE MISS was unable to be fully tested to the finish. Rider reported that he had difficulty obtaining clear running in the straight.

RIZSKI (J. Eaton) - began awkwardly and shifted out onto OBI, which was taken out onto ULTIMATE VICTORY.

#### RACE 4: TAB SKYBEAU SERIES FINAL - 2500 Metres

The start of this event was delayed approximately one minute.

SEBONNA (L. McNeil) - near the 1100m shifted out taking TOYETIC a little wider.

# RACE 4: TAB SKYBEAU SERIES FINAL - 2500 Metres (cont'd)

MELODY MAN (K.Crowther) – became fractious in its raceday stall and got its legs up on a partition. Underwent a pre-race veterinary examination, was found have multiple abrasions, a suspected injury to its pelvis and to be lame in the near hind leg and was deemed unsuitable to race. Acting on this advice MELODY MAN was declared a late scratching by order of Stewards at 12.36 pm. Trainer, Mr J. Stephens, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start. MELODY MAN was referred to the Morphettville Equine Clinic or further assessment and treatment.

WOLF PRINCE (B. Price) - raced keenly in the early stages and near the 2000m became awkward on the heels of SEBONNA for several strides. Continued to race keenly for some distance thereafter.

MAKE IT A DOUBLE (P. Gatt) - Stewards permitted P. Gatt to ride the gelding 0.5 kg over its declared weight of 54.0 kg.

SALUTE THE STARS (T. Voorham) - became fractious in its barrier stall after being loaded and got its leg up in the barrier stall. Underwent a pre-race veterinary examination and was deemed suitable to race. Was very awkward to begin.

SPACE EQUITY (D. Caboche) - raced keenly in the early stages of the event.

TOYETIC (B. Vorster) - was very awkward to begin, and near the 1100m was taken a little wider by SEBONNA, which shifted out slightly.

### RACE 5: TAB RIZIZ SERIES FINAL - 1100 Metres

SMOKIN' VAL (M. Lloyd) – slow to begin. Raced very keenly in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities. Trainer, Mr J. O'Connor, advised Stewards on Thursday, 17 November 2022 that on return to stable the mare presented with an apparent injury to its left eye with marked swelling to the eye, indicative of the eye being struck with a clod from the racing surface.

SASKATOON (J. Toeroek) - awkward to begin, shifted in and contacted OLD TIME ROCK. Raced keenly in the early stages of the event.

TRYGVE (J. Holder) - raced keenly in the early stages of the event.

OLD TIME ROCK (J. Opperman) - awkward to begin, shifted out and contacted SASKATOON.

JEAN VALJEAN (C. Murray) - awkward to begin. A post-race veterinary examination revealed no visible abnormalities.

THE GOV (L. Neindorf) - raced wide without cover throughout the event.

# RACE 6: TAB VIDDORA SERIES FINAL - 1200 Metres

CALLA DREAM (M. Lloyd) - required to be resaddled on arrival at the barriers.

CHOSEN BLONDE (L. McNeil) - a post-race veterinary examination revealed no visible abnormalities.

POINT BLAZE (B. Price) - rider reported that the mare did not travel during the event and was disappointing in its performance. A post-race veterinary examination revealed no visible abnormalities.

SOMEWATT FABULOUS (P. Gatt) - underwent a pre-race veterinary examination and deemed suitable to race. Slow to begin.

HEAVY ROTATION (T. Voorham) - required to be resaddled on arrival at the barriers. Rider reported that the mare did not appear to handle the soft track conditions today.

## RACE 6: TAB VIDDORA SERIES FINAL - 1200 Metres (cont'd)

CHEH CHARLEE (L. Neindorf) - which had stepped onto a marker cone en route to the barriers. underwent a pre-race veterinary examination on arrival at the barriers and was deemed suitable to race.

#### RACE 7: TAB GYTRASH SERIES FINAL - 1200 Metres

I AM BENE (B. Vorster) – rider explained that the mare travelled well; however, never let down in the straight. A post-race veterinary examination revealed the mare to be lame in the off hind leg. Trainer, Mr A. Clarken, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

DIAMONDS (C. Murray) - held up from the entrance to the straight until near the 200m where it was obliged to shift in to obtain clear running.

AIGUILETTE (E. Wong) - awkward to begin.

LEGLESS LADY (J. Eaton) - became fractious in the barriers and got a leg up after being loaded. Underwent a pre-race veterinary examination and was deemed suitable to race. Awkward and slow to begin. Rider reported that the mare did not stretch out during the event and felt uncomfortable in its action. A post-race veterinary examination revealed no visible abnormalities.

GREAT DIVINER (L. Neindorf) - inclined to lay in, in the straight.

HOWL (P. Gatt) - Stewards permitted P. Gatt to ride the gelding 0.5 kg over its declared weight of 54.0 kg.

KEEP READING (K. Crowther) - raced keenly in the early stages of the event.

MAGIC MAX (D. Tourneur) - raced very keenly in the early stages of the event.

## RACE 8: TAB HAPPY TRAILS FINAL - 1600 Metres

BOLD STAR (M. Lloyd) - near the 300m shifted out momentarily inconveniencing TERRITORY TITAN.

CALL ME SHAMUS (B. Vorster) - slow into stride. A post-race veterinary examination revealed no visible abnormalities.

TERRITORY TITAN (T. Voorham) - near the 300 metres was inclined to lay in, shifted in and was momentarily inconvenienced by BOLD STAR, which shifted out to improve.

# RACE 9: 2022 SA HALL OF FAME - GOLD GURU - 1600 Metres

VICTORY BANDIT (D. Caboche) - raced keenly in the early stages of the event.

BALLROOM DANCER (B. Price) - laid in, in the early part of the straight.

MUG'S GAME (J. Potter) - raced keenly in the early stages of the event.

SCARLET RIVER (B. Vorster) - raced keenly in the early stages of the event.

FIGHT FOR FREEDOM (J. Holder) - Stewards permitted J. Holder to ride the gelding 0.5 kg over its declared weight of 54.0 kg. Raced keenly in the early stages of the event.

ENLIST (K. Crowther) - laid in over the concluding stages of the event. A post-race veterinary examination revealed no visible abnormalities.
