**RACE 1: GATEWAY TO CHRISTMAS SATURDAY 17TH DECEMBER MAIDEN PLATE –  
1100 Metres**

**ARTY MISS** (L. Neindorf) – rider explained that the mare raced flat throughout the event and never let down. A post-race veterinary examination revealed no visible abnormalities.

**FOXY FEMME** (B. Vorster) – got its head up whilst being restrained in the early and middle stages of the event.

**CRACKING CHEVAL** (F. Atkinson) – fractious in the barriers. Trainer, Mr A. Justice, was advised that a warning had been placed on the filly.

**TAHNEE TREASURE** (E. Boyd) – laid in, in the straight. Rider explained that after being awkward away the filly raced greenly throughout the event and laid out from the 400 metres. A post-race veterinary examination revealed no visible abnormalities.

**RACE 2: HOLDFAST INSURANCE BROKERS MAIDEN PLATE - 1100 Metres**

**BUTTS** (J. Maund) – near the 300m was contacted by FAMOUS KNIGHT, which shifted out to obtain clear ground.

**PIERRE DE LUNE** (L. Neindorf) – laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.



## **RACE 2: HOLDFAST INSURANCE BROKERS MAIDEN PLATE - 1100 Metres (cont'd)**

**SIPSMITH** (P. Gatt) – bumped on jumping away by FAMOUS KNIGHT, which shifted out. Near the 300m shifted out to gain clear running.

**TAN TAT BEAU** (E. Wong) – raced keenly in the early and middle stages of the event and in the vicinity of the 800m raced in restricted room between PIERRE DE LUNE and FAMOUS KNIGHT for a short distance.

**FAMOUS KNIGHT** (J. Potter) – jumped away awkwardly, shifted out and bumped SIPSMITH. At the entrance to the straight became held up for clear running between BUTTS and FAMOUS KNIGHT. Near the 300m shifted out to obtain clear ground and contacted BUTTS.

**IKNOWHATYOU'REDOING** (J. Toeroek) – rider reported that the gelding was inclined to run out and away from other runners throughout the event.

**MAGIC AND MORE** (J. Holder) – jumped away awkwardly. Near the 300m was obliged to alter course to the inside of SIPSMITH, which shifted out.

**WICHITA LINEMAN** (C. Murray) – laid out from the 800m.

**SHADOW OF FOOLS** (T. Voorham) – rider reported the gelding laid out throughout the event.

## **RACE 3: ADELAIDE PLAINS BLOODSTOCK MAIDEN PLATE – 1500 Metres**

**FAMOUS PRINCE** (J. Potter) – reared on jumping away. Raced wide without cover throughout the event.

**QUIETLY SPOKEN (NZ)** (A. Lindsay) – jumped away awkwardly.

**STREET CULTURE** (C. Murray) – near the 300m was inconvenienced by LORD GEORGE, which laid in.

**LORD GEORGE** (L. Neindorf) – laid in, in the straight.

**YEAH WHATEVER** (P. Gatt) – slow to begin. A post-race veterinary examination revealed no visible abnormalities.

**COLOUR ME GONE** (A. Livesey) – a post-race veterinary examination revealed no visible abnormalities.

**LET'S PRANCE** (J. Eaton) – slow to begin. Near the 400m became held up on the heels of STREET CULTURE and to the inside of TABLE OF DREAMS. Near the 300m became disappointed when attempting a run to the inside of STREET CULTURE. Inside the 200m was again disappointed when attempting a run to the outside of STREET CULTURE and inside TABLE OF DREAMS and was unable to be tested to the line.

**SEPORIA** (K. Crowther) – held up from the entrance to the straight until able to shift out into clear running approaching the 200m.

**CAMBERWOOD** (E. Wong) – inclined to lay out in the straight.

Correct weight for this event was delayed to allow C. Murray (STREET CULTURE), placed fifth, and trainer, Ms N. Irwin, to view the official vision in the straight.



## **RACE 4: COOPERS BREWERY BENCHMARK 58 HANDICAP – 1200 Metres**

**ARCHERY BUTTS** (A. Livesey) - jumped away awkwardly.

**GRANDMA GAIL** (D. Tourneur) – a post-race veterinary examination revealed no visible abnormalities.

**ICE GHOST** (B. Vorster) – vicinity of the 1100m obliged to be steadied to avoid the heels of L'IL PIPER which shifted in.

**L'IL PIPER** (R. Hurdle) – raced keenly in the early and middle stages of the event. Vicinity of the 1100m shifted in and inconvenienced ICE GHOST. Rider was severely reprimanded under AR131(a) and advised to take greater care when shifting ground. Approaching the 900m raced in restricted room for a number of strides to the inside of SAND CAT which shifted in, before being obliged to be steadied and lose its position, whilst being steadied shifted out taken LIGHTS OF BROADWAY wider on the track. Laid out under pressure in the straight.

**LIGHTS OF BROADWAY** (J. Holder) – 900m taken wider by L'IL PIPER. Approaching the 100m was obliged to be steadied after improving onto the heels of L'IL PIPER, which laid out.

**SAND CAT** (S. Fawke) – vicinity of the 900m shifted in when insufficiently clear of L'IL PIPER, forcing that mare to race in restricted room before having to be steadied and lose its position. Rider pleaded guilty to a charge of careless riding under AR131(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Friday, 25 November and to conclude at midnight on Wednesday, 30 November 2022: a period of three meetings.

Correct weight for this event was delayed to allow J. Holder (LIGHTS OF BROADWAY), placed third, and co-trainer, Mr L Macdonald, to view the official vision.

## **RACE 5: IRONGATE AUSTRALIA CLASS TWO HANDICAP - 1100 Metres**

**VERSETTO** (D. Tourneur) - which had not raced since February 2021, underwent a pre-race veterinary examination and was deemed suitable to race. Jumped away awkwardly. Laid in in the straight and was unable to be fully tested over the final 50m of the event. Proved difficult to load. Trainer, Mrs N. Irwin was advised the gelding was now required to load without delay in an Official Barrier Trial or Approval to Race jump-out prior to a future race start.


**JUSTAKIDD** (R. Hurdle) - 200m momentarily steadied when racing in restricted room for a short distance between YEAH YEAH NAH and SPANISH STROLL which rolled out.

**BAJAN BELLE** (A. Livesey) – jumped away awkwardly.

**SPANISH STROLL** (K. Crowther) – rider reported the saddle had slipped to the off side at the entry to the home straight placing her at a disadvantage for the remainder of the event as she was unable to test the mare over the final 100m.

**FREEDOM DAY** (E. Wong) – laid out in the straight.

## **RACE 6: TRIMBOLI SERVICES RATING 0 - 56 HANDICAP – 2100 Metres**



**HALLAROSTE** (K. Crowther) – jumped away awkwardly shifted in and bumped VINO DECASA NOSTRA. Rider explained after jumping away awkwardly and settling further back than normal the gelding settled well in the early and middle stages.



## **RACE 6: TRIMBOLI SERVICES RATING 0 - 56 HANDICAP – 2100 Metres (cont'd)**

**KEYSOR** (T. Voorham) – rider explained the gelding never travelled throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**VINO DECASA NOSTRA** (S. Logan) – bumped on jumping away by HALLAROSTE.

**REBEL LEE** (J. Holder) – contacted on jumping away. Held up for clear running from the 400m until 200m.

**SWANKYTOFF** (R. Hurdle) – jumped away awkwardly.

**BRIABELLA** (P. Gatt) - laid in in the straight.

**SHE'S FULL OF IT** (J. Potter) – jumped away awkwardly and shifted in and contacted the hindquarters of REBEL LEE.

## **RACE 7: MATRIX SOLAR SOLUTIONS BENCHMARK 56 HANDICAP – 1500 Metres**

**FOX GEM** (T. Pannell) – rider was dislodge behind the barriers when the gelding became fractious, lost its footing and stumbled over. T Pannell was examined by the 1<sup>st</sup> care medical personal and passed fit to fulfil his engagement. FOX GEM underwent a pre-race veterinary examination and was deemed suitable to race. Trainer Mr J. Macmillian was advised a warning had been placed on the gelding in relation to its pre-race behaviour.

**REALITY CHECK** (B. Vorster) – Rider explained the gelding never travelled and he had become concerned with its action rounding the home turn and for that reason did not ride REALITY CHECK out in his normal manner. A post-race veterinary examination revealed no visible abnormalities.

**WARRANTYTE ROAD** (F. Atkinson) – rider reported the gelding laid out throughout the event.

**DINGABLEDINGA** (J. Toeroek) – laid in from the 400m until the 200m. Laid out under pressure over the final 100m.

**CARRY THE MUSKET** (E. Wong) – laid in in the straight

**DECIBELLES** (D. Caboche) – raced very keenly in the early and middle stages of the event.

**THE SNOW BURNER** (J. Maund) – rider explained that the gelding never travelled in the early and middle stages of the race and after placing THE SNOW BURNER under pressure inside the 800m he had become concerned with its action in the vicinity of the 600m and eased THE SNOW BURNER out of the event. A post-race veterinary examination revealed no visible abnormalities. Co-Trainer Mr J. Hickmott was advised that the result of an ECG and a Veterinary Clearance would be required prior to trialling and the gelding must perform to Stewards' satisfaction in an Official Barrier Trial prior to accepting for a future race.
