# RACE 1: THE JUNCTION PLATE - 1100 Metres

VALIDATED (D. Tourneur) - inconvenienced shortly after the start when tightened between AMELIA VALENTINA and OUR SHINING STAR. Inside the 300m laid in and became awkwardly placed on the heels of LA DEFENSE, which shifted out slightly. Continued to lay in under pressure for the remainder of the straight.

AMELIA VALENTINA (J. Maund) - inconvenienced shortly after the start when tightened onto VALIDATED by EMMOOKI MAGIC. Laid out rounding the turn approaching the 600m and got its head up for a number of strides.

DIVINE MISTRESS (T. Voorham) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

EMMOOKI MAGIC (D. Tootell (Snr)) – shifted out shortly after the start onto AMELIA VALENTINA. A post-race veterinary examination revealed no visible abnormalities.

PRIMED MELODY (J. Potter) - shifted out abruptly shortly after the start. Race wide without cover throughout the event. A post-race veterinary examination revealed an abnormal upper respiratory tract noise. Trainer, Mr B. Lear, was advised that a Veterinary Clearance including the results of an endoscopy were required prior to a future jump-out, trial or race.

#### RACE 2: OPTIONS CRAFT LIQUOR MERCHANTS PLATE - 1250 Metres

COTE DES BAR (J. Opperman) - raced wide without cover throughout the event. Lost its near fore plate during the event. A post-race veterinary examination revealed no visible abnormalities.

CHARLESFORT (D. Tourneur) - laid in under pressure over the concluding 150m of the event.

TAPINFORPAR (J. Holder) - hung in under pressure in the straight.



# RACE 2: OPTIONS CRAFT LIQUOR MERCHANTS PLATE - 1250 Metres (cont'd)

ALL CLUBS (C. Murray) - raced keenly in the early and middle stages of the event.

FEAT OF FURY (J. Potter) - slow to begin.

ENCHANTING EAGLE (P. Gatt) - jumped away awkwardly. Raced keenly in the early and middle stages of the event.

WANDJINA GAL (T. Voorham) - jumped away awkwardly. Held up from the entrance to the straight until near the 200m. Saddle shifted back shortly after straightening placing the rider at a disadvantage for the remainder of the event.

#### RACE 3: HAPPY 70TH ELISABETH TUCKFIELD HANDICAP - 2250 Metres

WOLF PRINCE (A. Jordsjo) - raced wide without cover from near the 1600m.

AFRICAN AWESOME (J. Holder) - laid in under pressure in the early stages of the straight. Laid out under pressure over the concluding 150m.

CHARTIN (NZ) (T. Pannell) - a post-race veterinary examination revealed the gelding to be lame in the near hind leg (3/5). Co-trainers, Mr G. Richards & Mr D. Moyle, were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

SVANEKE (J. Toeroek) - raced keenly in the middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

SO BENE (S. Logan) - near the 200m shifted in onto QUEBECOIS. Rider accidentally dropped her whip near the 150m. Near the 100m raced in restricted room for a short distance between COMFORT GIRL and WOLF PRINCE, which had been taken out by WHITCHETY GRUB.

WHITCHETY GRUB (P. Gatt) - raced keenly in the early and middle stages of the event. Near the 100m shifted out and away from AFRICAN AWESOME onto WOLF PRINCE.

QUEBECOIS (K. Crowther) – near the 200m had to steady momentarily and alter course when SO BENE shifted in.

ROBE RAIDER (J. Eaton) - approaching the 100m was obliged to momentarily steady and alter course to the inside of AFRICAN AWESOME, which laid out.

WE'LL MEET AGAIN (NZ) (E. Boyd) – jumped away awkwardly. A post-race veterinary examination revealed the gelding to be lame in the off foreleg (3/5). Trainer, Ms J. Streets, was advised that a comprehensive Veterinary Clearance and findings of an ultrasound were required prior to nominating for a future jump-out, trial or race.

SOARLIKEANEAGLE (S. Fawke) - near the 400m became awkwardly placed on the heels of SVANEKE for a short distance.

# RACE 4: HAIGH'S CHOCOLATES HANDICAP - 1400 Metres

The start of this event was delayed approximately one minute to avoid a clash with an interstate event.

PUDDING (NZ) (J. Toeroek) - raced keenly in the early and middle stages of the event.

TEXAN WINDSTORM (E. Wong) - jumped away awkwardly. Laid in under pressure in the straight.

AUSSIE SOJOURN (D. Tourneur) - jumped away awkwardly and shifted in contacting FLEURIEU FLIPPER.



#### RACE 4: HAIGH'S CHOCOLATES HANDICAP - 1400 Metres (cont'd)

FLEURIEU FLIPPER (C. Murray) - hampered on jumping away when contacted by AUSSIE SOJOURN and ALPINE BEAU. Rider advised that it was his intention to settle further forward; however, after being hampered on jumping away he was unable to comply with his instructions. A post-race veterinary examination revealed no visible abnormalities.

TAVIKAT (NZ) (J. Holder) - hung in under pressure in the straight and proved difficult to ride out.

ALPINE BEAU (J. Maund) - jumped away awkwardly and shifted out making heavy contact with FLEURIEU FLIPPER. A post-race veterinary examination revealed no visible abnormalities.

# RACE 5: GARY RADFORD MEMORIAL RACE - 1400 Metres

The start of this event was delayed approximately one minute owing to the blinkers having to be replaced on TONGSAI BOSS.

LAKE'S FOLLY (E. Wong) - held up from near the 400m until approaching the 200m.

BLAZERRO (K. Crowther) - raced keenly in the early and middle stages.

MY KHALIFA (T. Pannell) – had difficulty obtaining clear ground from the entrance to the straight until approaching the 200m. Laid out under pressure over the concluding 100m of the event.

NEXT DIMENSION (NZ) (D. Tourneur) - raced keenly in the early and middle stages. At the entrance to the straight was inconvenienced when contacted by KONG.

KONG (J. Opperman) - shifted out at the entrance to the straight to obtain clear ground and in doing so made contact with NEXT DIMENSION (NZ). A post-race veterinary examination revealed the gelding to be lame in the near hind leg (2/5). Trainer, Mr R. Balfour, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

RESIDUE (J. Toeroek) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

TONGSAI BOSS (D. Caboche) - required to have its blinkers replaced at the barriers.

### RACE 6: GRAND SYNDICATES HANDICAP - 1000 Metres

ALLEBOOM (E. Wong) - a post-race veterinary examination revealed no visible abnormalities.

SPANISH HEIRLOOM (S. Logan) - jumped away awkwardly and was slow to begin. Raced keenly in the early and middle stages of the event.

AADELAD (A. Lindsay) - raced wide without cover throughout the event.

KARACASU (J. Toeroek) - a post-race veterinary examination revealed the gelding to be lame in the near foreleg (1/5). Co-trainers, Mr R. Jolly & Miss C. Jolly, were advised that a Veterinary Clearance was required prior to a future jump-out, trial or race start.

SUPER CONTENDER (GB) (D. Tourneur) - rider reported that the gelding travelled well in the early and middle stages; however, when asked for an effort at the entrance to the straight, failed to respond to his riding and in his opinion may have choked down. A post-race veterinary examination revealed no visible abnormalities.

# RACE 7: ZONTE'S FOOTSTEPS HANDICAP - 1550 Metres

I'M KENNY (E. Wong) - inconvenienced when taken wider in the straight by GOOD GIRL BELLA.

MAGNOSSIVA (J. Potter) - rider reported that in his opinion the gelding did not handle today's underfoot conditions. Lost its near hind plate in during the event. A post-race veterinary examination revealed no visible abnormalities.

#### RACE 7: ZONTE'S FOOTSTEPS HANDICAP - 1550 Metres (cont'd)

LORD WONDER (NZ) (J. Holder) - laid out under pressure in the straight and near the 100m shifted out onto RECREANT. Rider reprimanded.

GOOD GIRL BELLA (S. Fawke) - following the declaration of acceptances Trainer, Mr J. Searle, made a gear application to add blinkers to the mare's race gear. Stewards accepted this request and acting under AR206(2) fined Mr Searle \$200. Laid out under pressure in the straight.

RECREANT (K. Crowther) - near the 100m had to be steadied momentarily when tightened onto AITCH D'AMICO by LORD WONDER (NZ). A post-race veterinary examination revealed no visible abnormalities.

JUST JAZZ (S. Logan) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

Correct weight for this event was delayed to allow J. Holder (LORD WONDER (NZ)), placed second, to view the official vision in the straight.

# RACE 8: LEGACY CLUB OF SOUTH AUSTRALIA & BROKEN HILL INC HANDICAP - 1250 Metres

MR MARATHON MAN (GB) (J. Opperman) - raced wide without cover throughout the event. Inconvenienced near the 50m when taken in by TUPOLEU.

BRAY STREET BOSS (T. Pannell) - rider stated that he was disappointed with the gelding's performance but he could offer no other explanation. The a post-race veterinary examination revealed no visible abnormalities.

MISS LANGTRY (S. Logan) – Stewards' acceded to a request from Ms T. Cox representing trainer, Mr D. Jolly, that the mare be declared a late scratching due to the track being downgraded at 3.41 pm

TAKSHAKA (D. Tourneur) – rider explained that in his opinion the colt did not handle today's track conditions. A post-race veterinary examination revealed the colt to be lame in the off hind leg (2/5). Co-trainers, Mr C. Maher and Mr D. Eustace, were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

TUPOLEU (E. Wong) - inclined to lay in under pressure in the straight and near the 50m shifted in onto MR MARATHON MAN (GB).

### RACE 9: LOGI-TECH HANDICAP - 1000 Metres

WOTUWANT (J. Holder) - inconvenienced on jumping away when contacted by MR HAVE A CHAT. Raced keenly in the early and middle stages of the event. Raced wide without cover throughout the event.

GRAND HOST (P. Gatt) - laid in under pressure in the straight.

MR HAVE A CHAT (S. Logan) - jumped away awkwardly, shifted out and contacted WOTUWANT.

SABERMETRIC (T. Pannell) – rider explained that the gelding travelled well in the early and middle stages; however, when asked of an effort near the 500m failed to respond to his riding. He added that in his opinion he had found himself in the inferior part of the track due to his barrier draw. A post-race veterinary examination revealed no visible abnormalities.

MY RUBY (C. Murray) - jumped away awkwardly. Race keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.
