# Racing SA Ltd Stipendiary Stewards' Report

Report on Race Meeting held at Ceduna Racecourse by the Ceduna Racing Club on Saturday, 3 December 2022

RACE 1: OTR MAIDEN PLATE - 1200 Metres

AKUBRA BLACK (J. Doyle) - laid in, in the straight.

DR CHOCCY (J. Hampson) - jumped away awkwardly.

TOMMY TOMATO (M. Collett) - jumped away awkwardly.

ISLAND PLEA (E. Annells) - became fractious in its barrier shortly after being loaded. Underwent pre-race veterinary examination and was deemed unsuitable to race. Acting on this advice Stewards declared ISLAND PLEA a late scratching at 2:17pm. Stewards ordered that monies invested on ISLAND PLEA prior to the time of its withdrawal be subject to the deductions of 31 cents in the dollar for the win and 21 cents in the dollar for the place. Trainer, Mrs S. Ratsch, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start and also advised that a warning had been placed on the gelding in relation to its barrier manners.

TYPAR (F. Atkinson) - jumped away awkwardly.

LEMON TART (D. Tootell (Snr)) - underwent a pre-race veterinary examination as the mare had not raced since May 2021 and was deemed suitable to race.



# RACE 2: NUMERICAL REAL ESTATE BENCHMARK 54 TROPHY HANDICAP - 1000 Metres

ANOTHER BIT (J. Hampson) - rider reported that the gelding hung out in the straight.

WAR CHEVAL (D. Tootell (Snr)) - jumped away awkwardly.

# RACE 2: NUMERICAL REAL ESTATE BENCHMARK 54 TROPHY HANDICAP - 1000 Metres (cont'd)

TOUGH LASSIE (F. Atkinson) – inside the 400m was disappointed for a run between GEANDGE which rolled out slightly and KNICKERBOCKERGLORY. As a result was momentarily held up and obliged to alter course to the inside of GEANDGE to obtain clear running.

SOMETHING FOXY (R. Milnes) - laid in under pressure in the straight.

DUCHESS NICCI (M. Vassallo) - jumped away awkwardly shifted in onto SHANE.

KNICKERBOCKERGLORY (H. Yuen) – a post-race veterinary examination revealed the mare to be lame in the near foreleg (3/5). Trainer, Mr D. Oxlade, was advised that Veterinary Clearance would be required prior to a future jump-out, trial or race.

SHANE (E. Annells) – on jumping away was hampered and lost its position when DUCHESS NICCI shifted in. A post-race veterinary examination revealed the mare to be lame in the near fore leg (2/5). Trainer, Mr M. White, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

## RACE 3: CEDUNA FOODLAND BENCHMARK 58 HANDICAP - 1300 Metres

A THOUSAND DEGREES (B. Wong) - jumped away awkwardly and as a result lost ground.

THE ALBION (NZ) (J. Doyle) - laid out under pressure in the straight.

ART MUSIC (M. Collett) – upon arrival at the barriers underwent a pre-race veterinary examination and was deemed suitable to race. A post-race veterinary examination revealed no visible abnormalities.

DAVEEDO (E. Annells) – laid out from 600m until near 500m. Rider reported that gelding travelled well in early stages; however, when crossed near the 600m, did not appreciate the kick back and raced ungenerously; however, when able to gain clear running raced trackable in the straight.

SPENCER GULF (M. Vassallo) - jumped away awkwardly and as a result lost ground. Laid in, in the straight.

# RACE 4: CURTIS'S NEW HOLLAND THEVENARD CUP - 1600 Metres

FESTIVAL OF LIGHT (B. Wong) – inside 200m was inconvenienced when PIERRE BIZEL shifted out and was obliged to shift out to obtain clear running.

MARINA (D. Tootell. (Snr)) – lost its near hind plate during the event. A post-race veterinary examination revealed no visible abnormalities.

RAMBLER GAMBLER (R. Milnes) - slow into stride.

PIERRE BIZEL (E. Annells) – inside 200m shifted out onto FESTIVAL OF LIGHT, which was inconvenienced. Rider was severely reprimanded under 131(a) and advised to take greater care in future.

Correct weight for this event was delayed to allow both trainers of the dead-heat for first Mr. D. Courtney (GIVEPEACE A CHANCE) and Mrs S. Ratsch (PIERRE BIZEL) to view the official photo. After viewing the official photo both parties were satisfied with the decision. Correct weight was further delayed to allow B. Wong (FESTIVAL OF LIGHT) rider of third placegetter to view the vision in the straight. After doing so, B. Wong lodged a protest against PIERRE BIZEL (E. Annells), placed dead-heat for first on grounds of alleged interference near the 200m. After considering the evidence, on viewing the official footage and acting on their own observations, Stewards upheld the protest and amended the result to:

SHE'S FULL OF IT (E. Annells) - slow to begin. Laid out rounding the home turn.
