Report on Race Meeting held at Bordertown Racecourse by the Bordertown Racing Club on Sunday, 11 December 2022

RACE 1: CREASER CONSTRUCTIONS MAIDEN PLATE - 1100 Metres

The start of this event was delayed approximately two minutes.

OF THE FIELD (J. Lorensini) – approaching the finish was inconvenienced as SWISS TIME, which was hanging in, shifted in.

SWISS TIME (S. Logan) - approaching the finish, when hanging in, shifted in onto OF THE FIELD, which was inconvenienced.

CHIPSON (D. Tourneur) - from near the 100m until approaching the finish raced in restricted room and was unable to improve when racing between TESTA DEXTA and ALL CLUBS.

TENTERK (A. Lindsay) - jumped away very awkwardly and shifted in abruptly onto COMANCHE QUEEN, which lost its position. Laid out under pressure in the straight and near the 200m shifted out and inconvenienced MIZZ BEEBEEFF.

COMANCHE QUEEN (E. Annells) - on jumping away lost its position when tightened onto TESTA DEXTA as TENTERK shifted in abruptly.

MIZZ BEEBEEFF (E. Boyd) - near the 200m was inconvenienced when TENTERK, which was laying out, shifted out.

OUR GYPSY WOMAN (K. Crowther) - difficult to load. Proved fractious in its barrier after being loaded. Trainer, Mr D. Jolly, advised that a warning had been placed on the mare. Jumped away awkwardly and as a result was slow to begin.

RACE 2: HARPERS PARCEL FREIGHT MAIDEN HANDICAP - 1300 Metres

The start of this event was delayed approximately one minute.

COME OFF IT CLIVE (B. Price) - jumped away awkwardly.

RACE 2: HARPERS PARCEL FREIGHT MAIDEN HANDICAP - 1300 Metres (cont'd)

HASTA LA WIZARD (D. Tourneur) - near the 1200m took charge of its rider, got its head up when being restrained and shortly after dipped and got its head down, and as a result was awkwardly placed on the heels of LEOLAINE. Hung in under pressure in the straight.

PHAROAHLEESE (S. Logan) - dislodged its rider on return to the mounting yard. S. Logan was examined by the First Care Medical personnel and was passed fit to fulfil her remaining engagements. Stewards deemed it impractical for S. Logan to weigh in as she was being examined falling her being dislodged. Acting under AR208(3), the Stewards were satisfied S. Logan weighed out correctly and that she carried the correct weight during the event and therefore correct weight was declared.

ZAC'S BACK (J. Potter) - on jumping away bumped with BOADICEA.

BOADICEA (J. Lorensini) - jumped away awkwardly, shifted out and bumped ZAC'S BACK. Raced keenly in the early and middle stages of the event.

ONYA PAL (T. Voorham) - held up for clear running over the final 100m when racing between PATANDMICK and PLUCKSEY DUBH.

LEOLAINE (S. Callow) - shortly after jumping away dipped. Rider explained that the mare was disappointing in the event and was very one-paced. A post-race veterinary examination revealed no visible abnormalities.

PATANDMICK (E. Wong) - approaching the 1000m commenced to race fiercely behind other runners until inside the 800m where it was able to gain clear racing room.

RACE 3: BRANDT BENCHMARK 54 HANDICAP - 1300 Metres

GRENADO (NZ) (S. Callow) – near the 1200m became awkwardly placed and tightened between the heels of SCOTTISH SOLDIER and BUT BEAUTIFUL. Near the 800m raced tight to the inside of GOODNESS GRACIE for a number of strides. Near the 300m raced in restricted room to the inside of O'MIZZNA for a short distance.

SAUSALITO (J. Opperman) - laid in under pressure in the straight.

SCOTTISH SOLDIER (S. Fawke) – on jumping away was inconvenienced by GRAVITY, which shifted out. Rider reported that the gelding travelled well in the early and middle stages; however, near the 150m put in an awkward stride and did not feel comfortable in its action for the remainder of the event and commenced to weaken quickly. A post-race veterinary examination revealed no visible abnormalities.

PAINTED ON (J. Potter) - raced wide without cover in the early stages.

GRAVITY (T. Voorham) - on jumping away shifted out and inconvenienced SCOTTISH SOLDIER.

PALE ALE (B. Wong) - jumped away awkwardly and shifted out.

GREY VITALITY (E. Wong) - at the entrance to the straight was awkwardly placed on the heels of GRAVITY and shifted out, thereafter hung in for the remainder of the event and proved difficult to ride out.

HURRICANE SONNY (A. Lindsay) - underwent a pre-race veterinary examination on arrival on course and was deemed suitable to start. A post-race veterinary examination revealed no visible abnormalities.

PRINCESS PANCAKES (A. Livesey) - jumped away awkwardly and shifted out.

RACE 4: BORDERTOWN PUMPS & REFRIGERATION BENCHMARK 68 HANDICAP - 1300 Metres

RUNBRO (E. Annells) - slow into stride.

WINGS OF PASTRAMI (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

LEBANESE TRADER (S. Callow) – raced fiercely in the early and middle stages of the event. Near the 900m, when racing fiercely and being restrained, was obliged to be checked and lost its position as CALL IT A HUNCH shifted in.

VICTORY CLUB (J. Opperman) - slow into stride. Near the 200m bumped with STAR EXPRESSO, which shifted out.

CALL IT A HUNCH (B. Wong) - near the 900m shifted in onto LEBANESE TRADER, which was racing fiercely, was obliged to be checked and lost its position. In assessing the incident Stewards noted the racing manners of LEBANESE TRADER. Rider severe reprimanded under AR131(a) for careless riding and advised to take greater care when she shifts ground in future.

STAR ESPRESSO (F. Atkinson) - held up for clear running from the entrance to the straight until near the 200m where it shifted out and bumped with VICTORY CLUB.

RACE 5: BORDER BLINDS & CURTAINS BENCHMARK 58 HANDICAP - 1100 Metres

The start of this event was delayed approximately two minutes.

VALAROC (C. Munro) - a post-race veterinary examination revealed no visible abnormalities.

WONAEAMIRRI (S. Fawke) - hung out rounding the home turn.

TURF DECISION (D. Tourneur) - slow to begin. Laid in under pressure in the straight.

GYPSY CROWN (K. Crowther) - on jumping away lost its position when tightened onto MAGICOURT as INDIAN GAZELLE shifted in. Over-raced in the early and middle stages of the event.

INDIAN GAZELLE (E. Annells) - jumped away awkwardly and shifted in onto GYPSY CROWN, which lost its position. Raced wide without cover throughout the event. Shifted about under pressure in the straight.

TURF TAPPER (J. Lorensini) - difficult to load. Trainer, Mr S. Cahill, was advised that a warning had been placed on the gelding.

FERGIE (E. Finnegan) - raced keenly in the early and middle stages of the event.

RACE 6: O'CONNORS CASE IH PLATE - 2000 Metres

The start of this event was delayed approximately five minutes.

DUKE OF ANJOU (K. Walters) - near the 1700m became awkwardly placed on the heels of AIR TIME and shifted out taking BOILING POINT wider on the track. Near the 1600m dipped and shifted out taking BOILING POINT wider. Raced wide and without cover from near the 1200m. Near the 200m, when hanging in, shifted in and hampered BOILING POINT. Rider was severely reprimanded under AR131(a) and advised to take greater care in future. A post-race veterinary examination revealed no visible abnormalities.

KING OF AVALON (NZ) (E. Wong) - slow to begin approximately four to five lengths. Held up for clear running when rounding the home turn. Held up for clear running for a short distance near the 100m.

BOILING POINT (D. Tourneur) - near the 1700m was taken wider by DUKE OF ANJOU, which shifted out. Near the 1600m was taken wider by DUKE OF ANJOU. Near the 200m was hampered as DUKE OF ANJOU, which was hanging in, shifted in.

RACE 6: O'CONNORS CASE IH PLATE - 2000 Metres (cont'd)

I AM HERA SINGH (C. Murray) – fractious after being loaded in the barrier. Underwent a pre-race veterinary examination and was deemed unsuitable to start. Acting on this advice Stewards declared I AM HERA SINGH a late scratching at 4.17 pm. Trainer, Ms R. Day, was advised that the gelding would now be required to complete either an Official Barrier Trial or Approval to Race jump-out to the satisfaction of the Stewards prior to accepting for a future race.

LUSHFIELDS (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

AKTOLGALI (J. Maund) - fractious in its barrier after being loaded. Underwent a pre-race veterinary examination and was deemed unsuitable to start. Acting on this advice Stewards declared AKTOLGALI a late scratching at 4.18 pm. Co-trainer, Mr J. Hickmott, was advised that a warning had been placed on the gelding in relation to its barrier manners.

RACE 7: WOOLSHED INN BORDERTOWN CUP BENCHMARK 75 HANDICAP - 2000 Metres

The start of this event was delayed approximately one minute owing to an interstate delay (Sunshine Coast).

RITRATTO (R. Hurdle) - held up for clear running from near the 400m until approaching the 200m.

GOLIOTUS (E. Boyd) - laid out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

DR DEE DEE (K. Crowther) - raced wide without cover from the 1000m.

SESAR (B. Price) - jumped away awkwardly and was slow to begin.

NEVA DOUBT US (T. Voorham) - rider reported that the gelding raced flat in today's event and did not let down as she had anticipated.

RACE 8: BORDERTOWN STONE SUPPLIES BENCHMARK 60 HANDICAP - 1550 Metres

I'M KENNY (E. Wong) - Laid out rounding the home turn and under pressure in the straight. THANASI (J. Opperman) - laid in under pressure in the straight.

CARAK (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

CHAR (D. Tourneur) - held up for clear running from near the 400m until approaching the 200m where it shifted out and hampered THINEISTHEKINGDOM. Rider was severely reprimanded under AR131(a) and advised to take greater care when shifting ground in future.

HAMSLETTE (J. Lorensini) - held up for clear running from the 400m until approaching the 200m when racing between I'M KENNY and CARAK, and was obliged to shift to the inside of I'M KENNY to obtain clear ground.

THINEISTHEKINGDOM (B. Price) - approaching the 200m was hampered as CHAR shifted out.

DAZZLING PROSPECT (A. Jordsjo) - laid in under pressure in the straight.

ENRICO PALLAZZO (A. Livesey) - slow to begin.
