

Racing SA Ltd Stipendiary Stewards' Report

Report on Race Meeting held at Port Lincoln
Racecourse by the Port Lincoln Racing Club on
Friday, 9 December 2022

RACE 1: GRAND TASMAN HOTEL THREE-YEAR-OLD MAIDEN PLATE - 1210 Metres

DANORO PRINCE (J. Doyle) - slow to begin and then lost further ground when hampered by SIR TOOP on its outside.

I'M A DEXSTAR (D. Caboche) - shifted out at the start and hampered SUVARNAH.

JUSTICA'S BONUS (T. Voorham) - laid out rounding the home turn and in the straight.

SIR DALAPENA (E. Annells) - raced wide without cover throughout the event. Rider reported that the gelding raced greenly throughout the event.

SIR TOOP (E. Wong) - began awkwardly, shifted in and hampered DANORO PRINCE.

TANE TOA (NZ) (R. Milnes) - began awkwardly with its head up. Raced wide without cover for the majority of the event.

SUVARNAH (C. Murray) - tightened and lost ground at the start between JUSTICA'S BONUS and I'M A DEXSTAR, which shifted out. Hung in, in the straight.

RACE 2: BK & BJ SOUTHAM MAIDEN PLATE (1) - 1000 Metres

ANGRY ANT (E. Wong) - stumbled at the start.

AYLLA'S PRIDE (D. Caboche) - slow to begin and then tightened between JUSTEDEE and LOOKING AT YOU KID, which shifted out.

JUSTEDEE (R. Hurdle) - had to be re-saddled on arrival at the barriers.



RACE 2: BK & BJ SOUTHAM MAIDEN PLATE (1) - 1000 Metres (cont'd)

SWIFT TERCEL (A. Livesey) - buffeted at the start between FORGIVING and SUBJUGATE, which shifted out.

BUILDING CASTLES (R. Milnes) - shifted in when placed under pressure over the concluding stages of the event. Rider was advised that she is expected to make a far greater effort to keep her mounts straight in future.

FORGIVING (S. Fawke) - lost ground shortly after the start when hampered by SWIFT TERCEL.

LOOKING AT YOU KID (B. Price) - began awkwardly and hampered AYLLA'S PRIDE. Trainer, Mr B. Holtham was advised that the mare has a lateral excursion of the off foreleg at a gallop and a warning had been placed on the mare in relation to its action. He was further advised that the Racing SA Stewards will continue to monitor the mare's action in any future event.

POCKET PENNY (J. Doyle) - near the 350m became awkwardly placed on the heels of REBEL ATTACK. When questioned in relation to the mare's performance, rider explained that in her opinion it is better suited over more ground. She added that the mare travelled well for the majority of the event; however, near the 350m became awkwardly placed on the heels of REBEL ATTACK but did not finish the race off as expected once cleared. A post-race veterinary examination revealed no visible abnormalities.

REBEL ATTACK (A. Jordsjo) - near the 50m had to be steadied to avoid the heels of BUILDING CASTLES, which shifted in abruptly.

SUBJUGATE (H. Yuen) - began awkwardly, shifted out and bumped SWIFT TERCEL. Weakened noticeably from the 400m. A post-race veterinary examination revealed no visible abnormalities. Trainer, Ms J. Stoetzer notified the Stewards that it would be her recommendation to the owners to retire the mare.

RACE 3: THE MARINA HOTEL MAIDEN PLATE (2) - 1000 Metres

DANIEL MY BROTHER (E. Wong) - laid out in the straight.

LEVEE (A. Jordsjo) - rider reported that the gelding began well and as a result raced further forward than expected.

NATION HERO (A. Livesey) - rider reported that the gelding raced keenly in the early stages of the event and near the 800m had to be steadied to avoid the heels of VON GEORGE, which shifted in.

VON GEORGE (R. Hurdle) - approaching the 800m, when racing keenly, shifted in and tightened NATION HERO, which had to be steadied and as a result, SET THE BAR LOW, which was following had to be restrained.

BIG GIRL HELGA (T. Voorham) - raced wide without cover for the majority of the event. A post-race veterinary examination revealed no visible abnormalities.

SET THE BAR LOW (S. Fawke) - as the start was effected the mare turned its head to the side and as a result lost ground. Rider reported that as a result of the slow start the mare raced further back than expected and was also not suited by the tempo in today's event. Restrained near the 800m away from the heels of NATION HERO.

SWANNIE (H. Yuen) - proved fractious in the parade ring and was reluctant to parade to the barriers. As a result, the mare was declared a late scratching by order of the Stewards at 3:17 pm. Trainer, Ms J. Stoetzer was advised that the mare must perform to the Stewards satisfaction in an Official Barrier Trial prior to a future race. Ms J. Stoetzer advised that it would be her recommendation to the owners that the mare be retired.



RACE 4: K&K COOLING BENCHMARK 68 HANDICAP - 1750 Metres

FEARLESS AL (C. Murray) - at the request of its rider, the gelding underwent a pre-race veterinary examination upon arrival at the barriers and was deemed suitable to race.



RACE 4: K&K COOLING BENCHMARK 68 HANDICAP - 1750 Metres (cont'd)

FORAOISE (B. Price) - rider reported that the gelding raced flat. Co-Trainer, Mr J. Dunn advised that it was his intention to freshen up the gelding prior to its next race.

MOUNT MADEIRA (NZ) (A. Jordsjo) - raced keenly in the early stages of the event. Tightened and checked near the 100m between SHINSEKI, which shifted in and ROAR, which shifted out.

SHINSEKI (A. Livesey) - raced keenly in the early stages of the event. Hung in, in the straight. Rider pleaded guilty to a charge of careless riding under AR131(a) in that she failed to make a sufficient effort to prevent her mount from shifting in near the 100m, which resulted in MOUNT MADEIRA (NZ) being tightened in onto ROAR and MOUNT MADEIRA (NZ) having to be checked. Rider was suspended from riding in races for a period to commence midnight Saturday, 17 December 2022 and to conclude midnight Saturday, 24 December 2022, a period of three meetings. In determining penalty, Stewards took into account A. Livesey's very good record and her guilty plea.

ROAR (E. Annells) - rider pleaded guilty to a charge of careless riding under AR131(a) in that she shifted out approaching the 100m when insufficiently clear of MOUNT MADEIRA (NZ) and tightened that runner onto SHINSEKI and as a result MOUNT MADEIRA (NZ) had to be checked. Rider was suspended from riding in races for a period to commence midnight Wednesday, 14 December 2022 and to conclude midnight Sunday, 18 December 2022, a period of three meetings. In determining penalty, Stewards took into account E. Annells's very good record and her guilty plea.

RACE 5: GORDON PETERSON MEMORIAL RATING 0 - 56 HANDICAP (1) - 1250 Metres

MELMAC (R. Hurdle) - back legs slipped at the start, resulting in the gelding beginning awkwardly and losing ground. Rider reported that as a result of the slow start, the gelding raced further back than expected.

PRESCIENT (B. Price) - rider reported that the gelding hung out throughout the event and proved difficult to ride.

GOODARCHIE (K. Crowther) - rider reported that the gelding hung in when placed under pressure in the straight.

BONIFACE (NZ) (E. Wong) - slow to begin.

SPINOLA BAY (A. Jordsjo) - held up for clear running between the 350m and 150m behind PRESCIENT.

ONWARD (S. Fawke) - underwent a pre-race veterinary examination and was deemed suitable to race. Rider reported that the gelding hung out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

MISS HENDRIX (D. Caboche) - reared as the start was effected and as a result lost ground.

SCOUT'S HONOUR (C. Murray) - began awkwardly, shifted out and bumped the side of its barrier and as a result lost ground.

RACE 6: PORT LINCOLN REAL ESTATE RATING 0 - 56 HANDICAP (2) - 1250 Metres

PERFECT VOYAGE (T. Voorham) - when questioned in relation to the gelding's performance, rider explained she is of the opinion that the gelding would be better suited over the shorter distance of 1000m. A post-race veterinary examination revealed no visible abnormalities.

TWO ODD SOX (R. Hurdle) - rider pleaded guilty to a charge of careless riding under AR131(a) in that he shifted out near the 300m when insufficiently clear of STRIP CLUB and tightened that runner onto CELERITATE REGEM and as a result STRIP CLUB had to be checked. Rider was suspended from riding in races for a period to commence midnight Saturday, 17 December 2022 and to conclude midnight Saturday, 24 December 2022, a period of three meetings. In determining penalty, Stewards took into account R. Hurdle's good record and his guilty plea.



RACE 6: PORT LINCOLN REAL ESTATE RATING 0 - 56 HANDICAP (2) - 1250 Metres (cont'd)

ZAKYBREE (A. Livesey) - rider reported that the mare laid out in the straight.

ANGEL'S WISH (A. Jordsjo) - slow to begin.

CELERITATE REGEM (J. Doyle) - near the 400m was bumped by STRIP CLUB.

STRIP CLUB (E. Annells) - shifted out near the 400m and bumped CELERITATE REGEM and as a result became unbalanced. Near the 300m was tightened and had to be checked between CELERITATE REGEM and TWO ODD SOX, which shifted out. A post-race veterinary examination revealed no visible abnormalities.

RACE 7: Q MECHANICAL RATING 0 - 56 HANDICAP - 1000 Metres

FRENCH ROCK (R. Milnes) - stumbled near the 300m.

FREE WILMA (A. Livesey) - began awkwardly, shifted out, bumped the side of its barrier and as a result lost ground. Near the 100m was momentarily held up.

ATTACK THE PIN (S. Callow) - stumbled on leaving the barriers.

RACE 8: JP CABINETS BENCHMARK 68 HANDICAP - 1000 Metres

TIME WARRIOR (R. Hurdle) - raced wide without cover for the majority of the event.

MESSERSCHMITT (A. Livesey) - stood awkwardly in its barrier and as the start was effected, laid on the outside of its barrier and as result was very slow to begin. Co-trainer, Mr J. Dunn was advised that a warning had been placed on the gelding in relation to its barrier manners.

LITTLE MISS RICH (C. Murray) - when questioned in relation to the mare's performance, rider explained that it had to work hard in the early stages of the event to obtain a forward position and that combined with a step up in class contributed to LITTLE MISS RICH's performance. A post-race veterinary examination revealed no visible abnormalities.

RACE 9: MAGIC 89.9 & 5CC LEADERS IN LOCAL BENCHMARK 68 HANDICAP - 1350 Metres

EXALTED TRAVELLER (B. Price) - raced keenly in the early and middle stages of the event.

DIAMONDS ARE (K. Crowther) - began awkwardly and was slow to begin.

ONEMORE MARSHALL (D. Caboche) - began awkwardly and was slow to begin.

AXECAPITAL (NZ) (A. Jordsjo) - held up rounding the home turn between the 400m and 250m.
