RACE 1: TAB MAIDEN PLATE - 1200 Metres

KEMI (A. Jordsjo) - crowded and checked shortly after the start between SUCCOUR and HALF A DRAM, which jumped awkwardly and shifted out. Held up for clear racing room between the 350m and 200m behind SUCCOUR and MELANIE'S JOY.

MR MAVAHEEDY (C. Murray) - a post-race veterinary examination revealed no visible abnormalities.

SEAFARING (NZ) (J. Toeroek) - laid in early in the straight.

TOMMY TOMATO (A. Livesey) - raced keen in the early and middle stages of the event. Raced wide rounding the home turn. Rider reported the gelding hung out for the majority of the race.

HALF A DRAM (J. Eaton) - began awkwardly and shifted out.

RACE 2: MATRIX SOLAR SOLUTIONS HANDICAP - 1500 Metres

FIORADA LAD (S. Logan) - became fractious whilst being saddled. Underwent a pre-race veterinary examination and was found to have lacerations to all limbs and to be lame in multiple legs (3/5) and therefore deemed unsuitable to race. Acting on this advice the gelding was declared a late scratching by order of Stewards at 12.35 pm.

SIR TOOP (E. Wong) - began awkwardly. Raced keen in the early stages of the event.

IMBIBE (B. Vorster) - laid out when placed under pressure in the straight.

MONEY OR THE BOX (J. Toeroek) - began awkwardly.



RACE 3: TRIMBOLI SERVICES HANDICAP - 2100 Metres

MORTY (A. Livesey) - raced keen in the early stages of the event. Raced wide without cover from the 1500m. When questioned in regards to the tactics adopted on the gelding rider explained that she was instructed to ride the horse where comfortable and to make a move three wide from the 800m. She said the horse jumped well and initially obtained a nice position between CRYPTO CURRENCY and REBEL LEE; however, approaching the winning post on the first occasion she became a little tight and lost ground. She added that from the 1700m the gelding travelled nicely; however, approaching the 1600m she was forced into the three wide position by BLACK SYRAH, which shifted out, and thereafter she remained wide without cover.

HYPERCANE (E. Wong) - underwent a pre-race veterinary examination after arriving at the barriers and was deemed suitable to race.

TOYETIC (B. Price) - rider reported that the gelding felt short in its action on pulling up. A post-race veterinary examination revealed no visible abnormalities.

BLACK SYRAH (D. Tourneur) - began awkwardly and lost ground.

REBEL LEE (J. Holder) - began awkwardly.

AKTOLGALI (J. Maund) - raced keen in the early and middle stages of the event.

RACE 4: ADELAIDE PLAINS BLOODSTOCK HANDICAP - 1700 Metres

EAGLELOU (J. Potter) - after being placed in the barriers became fractious and kicked out. Underwent a pre-race veterinary examination and was found to have lacerations to the near hind cannon and to be lame the near hind leg (3/5) and was therefore deemed unsuitable to race. Acting on this advice EAGLELOU was declared a late scratching by order of Stewards at 2.03 pm. Co-trainer, Mr D. Magro, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

CARRY THE MUSKET (E. Wong) - raced wide from the 700m. A post-race veterinary examination revealed no visible abnormalities.

AMMO AMOR (T. Voorham) - rider dropped her right rein momentarily near the 200m.

MANDIRIGMA (S. Logan) - laid out under pressure in the straight.

RACE 5: BRONWEN DARRALL MEMORIAL HANDICAP - 1200 Metres

SOMEWATT FABULOUS (J. Toeroek) - rider reported that on pulling up he had concerns with the mare's action. A post-race veterinary examination revealed no visible abnormalities.

STARSONGARI (T. Voorham) - shortly after passing the 400m had to steady away from the heels of STREET HUSTLER, which shifted out and crowded STARSONGARI onto the heels of MISS LANGTRY, resulting in STARSONGARI then having to be checked.

STREET HUSTLER (D. Tourneur) – after being placed in the barriers became fractious and reared. Underwent a pre-race veterinary examination and was deemed suitable to race. Trainer, Ms K. Byrnes, was advised that a warning had been placed on the mare's barrier manners. Laid out under pressure in the straight. Rider was found guilty to a charge of careless riding under AR131(a) in that shortly after the 400m he shifted out when insufficiently clear of STARSONGARI, resulting on that horse being crowded onto MISS LANGTRY and having to be checked. Rider was suspended from riding in races for a period to commence midnight Monday, 26 December 2022 and to conclude midnight Saturday, 31 December 2022, a period of four meetings.

FIVE POCKET (J. Eaton) - laid out under pressure in the straight.



TERBIUM (T. Voorham) - raced keen in the early and middle stages.



RACE 6: COOPERS BREWERY HANDICAP - 1200 Metres (cont'd)

CALLA DREAM (L. Neindorf) - hung out badly throughout the event and proved difficult to ride. A post-race veterinary examination revealed abrasions to the inside of both cheeks. Co-trainer, Mr R. Daniel, was advised that a warning had been placed on the mare's racing manners.

SPARKUP (B. Price) - had to be restrained approaching the winning post, when improving into restricted room behind TERBIUM and METRO LEGEND.

HASSLEFREE (A. Jordsjo) - raced wide for the majority of the event.

SUPER CONTENDER (GB) (D. Tourneur) - raced wide without cover for the majority of the event.

RACE 7: SANDERS FODDER HANDICAP - 1500 Metres

FRANKEL STAR (J. Opperman) - held up from the 400m until near the 150m behind LORD WONDER (NZ) and to the inside of I'M KENNY.

EAGLES FOREVER (T. Voorham) - laid out when placed under pressure over the concluding 200m.

I'M KENNY (L. Neindorf) – when questioned in regards to the tactics adopted on the gelding, rider explaind that he was instructed to be positive out of the barriers and if possible lead; however, he was also advised that I'M KEENY was fresh and may fire up, but, the trainer said that he would expect the gelding to drop the bit after reaching the lead. L. Neindorf added that after beginning well he attempted to find the lead; however, it became apparent that EAGLES FOREVER on his inside also wanted to lead. He said that he attempted on a couple of occasions to move forward ahead of EAGLES FOREVER, however, on every occasion EAGLES FOREVER kicked to maintain the lead, therefore he felt it was in the best interest of I'M KENNY to take a position to the outside of EAGLES FOREVER rather than continue to push forward and do too much work to gain the lead.

DANCING STREAM (E. Wong) – raced wide without cover for the majority of the event. Shifted in near the 800m when insufficiently clear of SMART CHARGE resulting in that horse having to be restrained. Rider severely reprimanded under AR131(a) for careless riding. A post-race veterinary examination revealed the mare to be lame in the off foreleg (2/5).

LORD WONDER (NZ) (J. Holder) - held up between the 400m and approaching the 150m behind EAGLES FOREVER. Laid out over the concluding 150m when placed under pressure.

SMART CHARGE (R. Hurdle) - had to be steadied near the 800m when crowded by DANCING STREAM, which shifted in when insufficiently clear. Lost its near hind plate during the event.

PUISSANCE DUSOLEIL (J. Maund) - underwent a pre-race veterinary examination as it had not raced in over twelve months and was deemed suitable to race.

SUGGESTIVE MISS (B. Vorster) - held up from between the 400m and 150m behind LORD WONDER (NZ).

RACE 8: IRONGATE AUSTRALIA HANDICAP - 1500 Metres

MY MATE SONNY (C. Rawiller) - raced keen in the early and middle stages of the event. Hung in when placed under pressure in the straight.

TEXAN WINDSTORM (E. Wong) – raced three wide without cover for the majority of the event. A post-race veterinary examination revealed no visible abnormalities.

BLOOD SWEAT TEARS (B. Vorster) - lost its off hind plate during the event.

DISAGREEABLE MISS (J. Eaton) - slow into stride in the early stages of the event.



RACE 9: HOLDFAST INSURANCE BROKERS HANDICAP - 1100 Metres

ANJOPIN (S. Logan) – bucked shortly after the start and continued to do so for some distance. Consequently the gelding was restrained out of the race. A post-race veterinary examination revealed bilateral neck muscle soreness. Co-trainer, Mrs S. Jaensch, was advised that a Veterinary Clearance was required prior to a future jump-out, trial or race start and the gelding would also be required to trial to the Stewards satisfaction in an Official Barrier Trial prior to racing.

JAAZEB (L. Neindorf) - between the 700m and 600m was bumped on several occasions by L'IL PIPER, which when racing keen, shifted out to avoid the heels of ZARACE, in an attempt to gain clear running.

ZARACE (A. Livesey) - rider reported that the gelding raced keen in the early stages of the event.

JUSTAKIDD (J. Holder) - acting on a confirmed phone call from trainer, Mr S. Cahill, advising that the gelding was found to have a laceration to the off foreleg prior to being loaded on the float, JUSTAKIDD was declare a late scratching by order of the Stewards at 1.45 pm. Mr Cahill was advised that a Veterinary Clearance was required prior to a future jump-out, trial or race start.

L'IL PIPER (R. Hurdle) – rider explained that between the 700m and 600m the mare raced very keen and had to be checked away from the heels of ZARACE. He added that the mare continued to race keen and shifted out into a narrow run bumping JAAZEB on several occasions prior to being checked again off of the heels of JAAZEB.

NORTHERN SUPERSTAR (J. Eaton) - laid out under pressure in the straight.
