RACE 1: LETCHER MORONEY CHARTERED ACCOUNTANTS MAIDEN HANDICAP - 1000 Metres

VON GEORGE (S. Fawke) - jumped away awkwardly. Raced greenly throughout the event. A post-race veterinary examination revealed no visible abnormalities.

ARTY MISS (B. Price) – rider explained that the mare travelled well in the early and middle stages of the event; however, did not let down from the 600m. A post-race veterinary examination revealed the mare to be lame in the off hind leg (2/5). Trainer, Ms J. Stoetzer, was advised that a Veterinary Clearance was required prior to a future jump-out, trial or race start.

RACE 1: LETCHER MORONEY CHARTERED ACCOUNTANTS MAIDEN HANDICAP - 1000 Metres (cont'd)

BUILDING CASTLES (R. Milne) - difficult to load. Co-trainer, Mr J. Dunn, was advised that a warning had been placed on the mare.

TANE TOA (NZ) (E. Wong) - raced keenly in the middle stages of the event.

BEANHUGGED (K. Sardelic) - rider explained that the gelding never travelled throughout the event. A post-race veterinary examination revealed an old wound to the off hind hock. Co-trainers, Ms J. Branford & Ms H. Dorward, were advised that a warning had been placed on the gelding for being uncompetitive.

REBEL ATTACK (A. Jordsjo) - jumped away awkwardly and was slow into stride. Raced greenly in the early stages.

RACE 2: DK QUARRIES MAIDEN PLATE - 1350 Metres

The start of this event was delayed approximately five minutes.

A FEW GOOD MEN (D. Caboche) – became fractious in the barriers and became cast. Underwent a pre-race veterinary examination and was found to have a laceration to the poll and to be lame in the off hind leg (4/5) and therefore was deemed unsuitable to race. Acting on this advice Stewards declared A FEW GOOD MEN a late scratching at 1.01 pm. Trainer, Mr D. Carrison, was advised that the gelding was now required to complete an Approval to Race jump-out or Official Barrier Trial to the satisfaction of Stewards prior to a accepting for a future race. Mr Carrison was further advised that a Veterinary Clearance was required prior to a future jump-out, trial or race start.

RED FEATS (F. Atkinson) - Rider reported that the gelding laid out throughout the event.

FORGIVING (B. Price) - laid out in the straight.

LEMON TART (S. Fawke) - laid out in the straight.

TIAMAT (R. Milnes) - underwent a pre-race veterinary examination on arrival on course as it had raced at Strathalbyn on Wednesday, 14 December 2022 and was deemed suitable to race. Laid in, in the straight.

RACE 3: CARLTON UNITED BREWERY MAIDEN PLATE - 1350 Metres

LEVEE (A. Jordsjo) - laid out in the straight. Rider reported that the gelding raced greenly throughout the event.

NATION HERO (A. Livesey) - tightened shortly after the start between POCKET PENNY and VARIARA, which shifted out.

SWIFT TERCEL (E. Wong) - got its head up whilst being restrained in the vicinity of the 1000m.

VARIARA (S. Fawke) - jumped away awkwardly and shortly after the start shifted out and tightened NATION HERO.

POCKET PENNY (J. Doyle) - jumped away awkwardly. Rider explained the mare raced keenly in the early and middle stages; however, did not let down from the 600m and was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

SHEMA (D. Caboche) - held up from approaching the 400m until the entrance to the straight. Laid out in the straight.

RACE 4: RIDING FOR THE DISABLED BENCHMARK 54 HANDICAP - 1350 Metres

AKUBRA BLACK (J. Doyle) - lost its position shortly after the start when tightened between BUT BEAUTIFUL, which shifted in, and HE'S ABEL, which shifted out.





ORIEDOS (S. Callow) - jumped away awkwardly and shifted in. Laid in, in the straight.

THE ALBION (NZ) (F. Atkinson) - laid out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

PROUD MARY (A. Livesey) - jumped away awkwardly and shifted out.

BUT BEAUTIFUL (B. Price) - on jumping away shifted in and away from ORIEDOS, tightening the running of AKUBRA BLACK.

HE'S ABEL (R. Milnes) – on jumping away shifted out and away from PROUD MARY tightening the running of AKUBRA BLACK. Held up for clear running from the entrance to the straight until the vicinity of the 150m.

RACE 5: AVIS PORT LINCOLN BENCHMARK 54 HANDICAP- 1350 Metres

DANTELA (NZ) (B. Wong) - laid in, in the straight.

THE MASTER (S. Callow) - got its head down as the start was effected and as a result jumped away awkwardly. Raced keenly in the early and middle stages of the event. Rider accidentally dropped her whip in the vicinity of the 50m.

BONIFACE (NZ) (E. Wong) - laid out in the straight.

ONWARD (S. Fawke) - underwent a pre-race veterinary examination and was deemed suitable to race. A post-race veterinary examination revealed no visible abnormalities.

HARDASHIAN (B. Price) - a post-race veterinary examination revealed no visible abnormalities.

MISS PARMIGIANA (R. Milnes) – rider reported that her saddle slipped back in the vicinity of the 600m placing her at a disadvantage for the remainder of the event.

Correct weight for this event was delayed to allow S. Callow (THE MASTER) to view the vision of the start.

RACE 6: GRAEME BIGNELL MEMORIAL BENCHMARK 76 HANDICAP - 1000 Metres

HEKA EXPRESS (F. Atkinson) – jumped away awkwardly unbalancing its rider for a short distance. Slow to begin.

DEXTER YOU DEVIL (H. Yuen) - slow to begin.

SPANISH HEIRLOOM (A. Livesey) - jumped away awkwardly, shifted out and contacted STRAWBERRY SWING.

STRAWBERRY SWING (S. Fawke) - riders permitted S. Fawke to ride the mare 0.5 kg over its allocated weight of 54.0 kg. Jumped away awkwardly, shifted in and contacted SPANISH HEIRLOOM.

MAIDEN GRACE (J. Doyle) - jumped away awkwardly. Raced wide without cover throughout the event. Laid out in the straight.

RACE 7: MITRE 10 PORT LINCOLN BENCHMARK 58 HANDICAP - 1750 Metres

SINO WITNESS (J. Doyle) - a post-race veterinary examination revealed no visible abnormalities.

GIVEPEACE A CHANCE (K. Sardelic) - raced keenly in the early and middle stages of the event.

VANCOUVER VELVET (B. Wong) - laid in, in the straight.

MISS HENDRIX (T. Voorham) - jumped away awkwardly.



RACE 8: THE PRAWN STORE BENCHMARK 64 HANDICAP - 1250 Metres

ARTFUL AMBITION (K. Sardelic) - jumped away awkwardly and as a result was slow to begin.

MESSERSCHMIT (T. Voorham) - held up for clear running approaching the finish and was unable to be tested to the line.

CROWNED KING (E. Wong) - reared on jumping away.

PERFECT ZED (J. Doyle) - inside the 200m was taken wider on the track by SPINOLA BAY. Rider was reminded of her obligations under AR131(b) to ride her mounts out to the finish of the event.

SPINOLA BAY (D. Caboche) - laid out in the straight. Inside the 200m hung out taking PERFECT ZED wider on the track.

SEGAL (S. Fawke) - jumped away awkwardly.

RACE 9: M&M GROUP BENCHMARK 54 HANDICAP - 1210 Metres

TALLU (K. Sardelic) - approaching the finish improved onto the heels of ISA SECRET.

COMPARDY (T. Voorham) - held up from near the 400m until the entrance to the straight.

VIRTUE (NZ) (E. Wong) - jumped away awkwardly. Raced keenly in the early and middle stages of the event.

NORDIC LASS (B. Price) - laid in, in the straight. In the vicinity of the 75m was obliged to be straightened when it shifted in onto the heels of COMPARDY.

ODDSOCK (A. Jordsjo) - near the 1100m commenced to buck. Trainer, Mr T. Montgomerie, was advised that the mare was now required to complete an Official Barrier Trial to the satisfaction of Stewards prior to a future race start.
