Racing SA Ltd Stipendiary Stewards' Report

Report on Race Meeting held at Morphettville Racecourse by the South Australian Jockey Club on Friday, 16 December 2022

TRACK: Good 4 (Track with some give in it)

RAIL: Out 3 metres entire

WEATHER: Fine

RACE 1: FURPHY MAIDEN PLATE - 1100 Metres

INOTELL (S. Fawke) - contacted on jumping away.

MASTER AT ARMS (J. Toeroek) - shifted out on jumping away and contacted INOTELL. Raced keenly in the early and middle stages of the event. Raced wide without cover throughout the event. Laid out rounding the home turn.

SIR ARMINIUS (R. Hurdle) - raced keenly in the early and middle stages of the event. Held up from near the 500m until the entrance to the straight.

RACE 2: CROSER CLASS 2 HANDICAP - 1100 Metres

VERSETTO (D. Tourneur) - raced fiercely in the early and middle stages of the event. Near the 200m had to be steadied when disappointed for a tight run between TEQUILA SUNSET and MIDNIGHT RUSH, which shifted in slightly.

HONGBAO (B. Vorster) - raced keenly in the early and middle stages of the event.

TEQUILA SUNSET (J. Holder) - laid out rounding the home turn.

MIDNIGHT RUSH (J. Toeroek) – raced wide without throughout the event. Laid out in the early stages of the straight. Approaching the 200m commenced to lay in and then shifted in onto VERSETTO, which had to be steadied when tightened onto TEQUILA SUNSET. Rider was severely reprimanded under AR131(a) and advised, in future, to take greater care when shifting ground.

GRANDMA GAIL (L. Neindorf) - raced keenly in the early and middle stages of the event. Raced in restricted room between the heels of HONGBAO and TEQUILA SUNSET, which shifted in slightly over the concluding 50m.

MORPHETT ROAD (A. Jordsjo) - rider reported that the gelding was inclined to lay in throughout the event and was awkward in its action on pulling up. A post-race veterinary examination revealed no visible abnormalities.



RACE 3: BIG SCREEN VIDEO THREE-YEAR-OLD MAIDEN PLATE - 1200 Metres

The start of this event was delayed approximately one minute.

KETCHIKAN (S. Fawke) – fractious in its barrier after being loaded. Underwent a pre-race veterinary examination which revealed abrasions to the gelding's upper lip and gum and was deemed unsuitable to race. Acting on this advice KETCHIKAN was declared a late scratching by order of Stewards at 4.41 pm. Trainer, Mr R. Balfour was advised that the gelding was now required to prove tractable in an Official Barrier Trial or Approval to Race jump-out prior to a future race.

LORD BENTLEY (T. Voorham) - shifted out abruptly on jumping away onto TOBIWASHI.

PARSONAGE LANE (F. Atkinson) - hung out rounding the home turn and under pressure in the straight. Rider reported that the gelding laid out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

SOAMES (T. Pannell) - raced wide without cover throughout the event.

TAPINFORPAR (L. Neindorf) – shifted out on jumping away onto DEVINE ASSASSIN. Near the 1100m shifted in when insufficiently clear onto WHATSANAMEGEORGE, which was forced to take hold to avoid the gelding's heels. Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence, at the expiry of his current suspension, on midnight on Wednesday, 28 December 2022 and to conclude at midnight Saturday, 7 January 2022, a period of 5 meetings. In determining penalty, Stewards took into account L. Neindorf's current suspension and his guilty plea. Laid out under pressure in the early stages of the straight. Laid in under pressure from near the 200m. Near the 150m shifted in onto WANDJINA GAL, which had to take hold to avoid the heels of the gelding. Rider pleaded guilty to a further charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence midnight Wednesday, 28 December 2022 and to conclude midnight Sunday, 8 January 2022, a period of 6 meetings. Stewards ordered that both suspensions from this race are to be served concurrently.

WHATSANAMEGEORGE (J. Toeroek) - near the 1100m was forced to take hold to avoid the heels of TAPINFORPAR, which shifted in. Thereafter raced keenly during the middle stages of the event.

DEVINE ASSASSIN (J. Holder) – lost its position on jumping away when tightened onto SOAMES by TAPINFORPAR. Laid out rounding the home turn. A post-race veterinary examination revealed no visible abnormalities.

SPEC RAIDER (J. Potter) - inconvenienced on jumping away when contacted by TOSEN WATER.

TOBIWASHI (A. Livesey) - hampered on jumping away when tightened onto TOSEN WATER by LORD BENTLEY.

TOSEN WATER (E. Wong) - hampered on jumping away when tightened by SPEC RAIDER onto TOBIWASHI. Raced keenly in the early and middle stages of the event. Near the 1000m had to be steadied when WANDJINA GAL shifted in.

WANDJINA GAL (S. Callow) - near the 1100m shifted in onto TOSEN WATER, which had to be steadied. Rider was severely reprimanded under AR131(a) and advised, in future, to take greater care when shifting ground. Near the 150m was forced to take hold to avoid the heels of TAPINFORPAR, which shifted in.

RACE 4: TOTAL DRAIN CLEANING SERVICES MAIDEN PLATE - 1600 Metres

GMORK (NZ) (T. Pannell) - contacted on jumping away. A post-race veterinary examination revealed the gelding to be lame in the off hind leg (1/5). Trainer, Mr M. Hickmott was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

QUIETLY SPOKEN (NZ) (R. Hurdle) - contacted on jumping away.

SPIRIT ABOVE (J. Holder) - shifted in on jumping away and bumped QUIETLY SPOKEN (NZ). Raced keenly in the early and middle stages of the event.

STAY AT HOME (B. Vorster) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 4: TOTAL DRAIN CLEANING SERVICES MAIDEN PLATE - 1600 Metres (cont'd)

SUPERB TIME (C. Munro) – raced wide without cover throughout the event. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100m and was fined \$100. In determining penalty Stewards had regard for the totality of the use of the whip by C. Munro and noted that she did not use it the final 100m of the event.

CHARLESFORT (F. Atkinson) - jumped away awkwardly. Raced keenly in the early and middle stages of the event.

IKNOWHATYOUREDOING (J. Toeroek) - jumped away awkwardly.

MAGIC AND MORE (T. Voorham) – rider reported that the gelding raced greenly throughout the event. A post-race veterinary examination revealed the gelding to be lame in the near foreleg (3/5). Co-trainers, Mr L. Macdonald and Mr A. Gluyas were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

FRUSCIANTE (S. Fawke) - shifted out on jumping away onto GMORK (NZ).

ENCHANTING EAGLE (B. Wong) - raced keenly in the early and middle stages of the event.

RACE 5: AZCON HOMES / VEEVERS PAINTING & DECORATING CLASS 2 HANDICAP - 1600 Metres

KACIGA (D. Tootell (Snr)) - slow to begin.

IN THE DARKNESS (NZ) (J. Eaton) - raced wide without cover throughout the event.

LIGHTS OF BROADWAY (J. Holder) - rider reported that the gelding became awkward in its action when placed under pressure at the entrance to the straight. A post-race veterinary examination revealed the mare to be lame in the near foreleg (1/5). Co-trainers, Mr L. Macdonald and Mr A. Gluyas was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

JUST JAZZ (E. Wong) - raced keenly in the early and middle stages of the event.

RACE 6: CANADIAN CLUB BENCHMARK 58 HANDICAP - 1800 Metres

LORD OF DARKNESS (NZ) (A. Lindsay) - inconvenienced on jumping away when its hind quarters were turned out after being contacted by MUFFLA. Raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

MUFFLA (B. Vorster) - shifted out on jumping away and contacted LORD OF DARKNESS (NZ).

MONSEAGLE (L. Neindorf) - inclined to lay out under pressure in the straight.

JACK'S A CRACKER (J. Potter) - which raced on Wednesday, 14 December 2022, underwent a pre-race veterinary examination and was deemed suitable to race. A post-race veterinary examination revealed the gelding to be lame in the off hind leg (1/5). Trainer, Mr G. Young was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

SEMYORKA (S. Fawke) - laid out under pressure in the straight.

RACE 7: STURDIE BENCHMARK 56 HANDICAP - 1050 Metres

THE TRANCE FACTOR (A. Livesey) - slow to begin. Held up from the entrance to the straight until inside the 200m when awkwardly placed between the heels of RIZSKI and MAGIC DELTA and then had difficulty obtaining clear ground until the 50m.

VALHALLA FELLA (T. Pannell) – near the 900m raced in restricted room and then stepped a section of the track when awkwardly placed to the inside of MAGIC DELTA. Raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed the gelding to be lame in the off hind leg (2/5). Trainer, Ms K. Evans was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

RACE 7: STURDIE BENCHMARK 56 HANDICAP - 1050 Metres (cont'd)

CORK HARBOUR (B. Price) - jumped away awkwardly and shifted in onto GENERAL MINT. Laid out under pressure in the straight.

GENERAL MINT (J. Potter) - contacted on jumping away.

MAGIC DELTA (J. Doyle) - near the 900m shifted in slightly onto VALHALLA FELLA.

RACE 8: WHITE CLAW BENCHMARK 58 HANDICAP - 1200 Metres

MAGIC PHANTOM (B. Wong) - raced keenly in the early and middle stages of the event. Laid out rounding the home turn and under pressure in the straight.

KAYSERI (NZ) (D. Tourneur) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

WINE FROM TEARS (F. Atkinson) - a post-race veterinary examination revealed the mare to be lame in the near hind leg (2/5). Trainer, Mr C. Bieg was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

EXCELSA (J. Maund) - raced keenly in the early stages of the event.

TAVIKAT (NZ) (R. Hurdle) - lost its off fore plate during the event.

ICE GHOST (T. Pannell) – held up from the 500m until the entrance to the straight. A post-race veterinary examination revealed no visible abnormalities

FOUR WINDS (B. Vorster) - raced wide without cover throughout the event.


