RACE 1: PFD FOODS MAIDEN PLATE - 1200 Metres

FAMILY ADDITION (T. Pannell) - was examined by the Club's Veterinary Surgeon on arrival on the course who reported that the gelding had turned a plate and injured its near fore hoof and therefore would be unsuitable to race. Acting on this advice Stewards declared FAMILY ADDITION a late scratching at 10.43 am. First aid administered. Trainer, Mr M. Huxtable, was advised that a Veterinary Clearance was required prior to a future jump-out, trial or race start.

VARIARA (A. Livesey) - momentarily held up at the entrance to the straight when awkwardly placed on the heels of SHOSANNA, which laid out, and as a result was obliged to alter course to the inside of that mare to obtain clear ground.

PLEASERS (C. Murray) - flipped over in the mounting yard. Examined by the Club's Veterinary Surgeon in the mounting yard, and then again on arrival at the barriers and deemed suitable to race. Raced keenly in the middle stages. A post-race veterinary examination revealed the mare to be exhibiting signs of heat stress. First aid administered. Trainer, Mr S. Bates, was advised that a Veterinary Clearance was required prior to a future jump-out, trial or race start.

SHOSANNA (K. Crowther) - rolled out rounding the home turn. Laid in under pressure in the straight.

RACE 2: CHALK HILL THREE-YEARS-OLD FILLIES MAIDEN PLATE - 1100 Metres

BUGATTI GOLD (S. Callow) - jumped away awkwardly.

CARARADA (J. Holder) - inclined to lay in under pressure in the straight.



RACE 2: CHALK HILL THREE-YEARS-OLD FILLIES MAIDEN PLATE - 1100 Metres (cont'd)

THROEVA (D. Caboche) - got loose in the parade ring and broke through a perimeter fence. Examined by the Club's Veterinary Surgeon who reported the filly to be lame in the near hind leg (2/5) and therefore would be unsuitable to race. Acting on this advice Stewards declared THROEVA to be a late scratching at 12.45 pm. Trainer, Mr J. Hyam, was advised that a Veterinary Clearance was required prior to a future jump-out, trial or race start.

RACE 3: THE JUNCTION HANDICAP - 1600 Metres

The start of this event was delayed approximately four minutes.

HOPON HARRY (J. Holder) – turned its off fore plate en route to the barrier and required farrier attention. Underwent a pre-race veterinary examination and was deemed suitable to race.

RACE 4: NEW YEARS EVE AT MORPHETTVILLE - SATURDAY DECEMBER 31ST HANDICAP - 1050 Metres

HALLOWED GROUND (K. Crowther) – jumped away awkwardly and shortly after was inconvenienced when its hindquarters were contacted by JEAN VALJEAN. Raced keenly in the early and middle stages of the event. Rider explained that the gelding travelled well in the early stages; however, was inclined to lay out rounding the home turn and then was disappointing when placed under pressure in the straight. She added that the gelding did not give her the same feel it had during trackwork and in its trial, and for this reason she had not persisted with riding HALLOWED GROUND out over the concluding stages. A post-race veterinary examination revealed no visible abnormalities.

LARKHAM (C. Rawiller) - laid in under pressure in the straight.

JEAN VALJEAN (B. Price) - jumped away awkwardly and shifted out onto HALLOWED GROUND. Laid out rounding the home turn. A post-race veterinary examination revealed the gelding to have the thumps. First aid administered.

RACE 5: ADELAIDE GALVANISING INDUSTRIES HANDICAP - 1600 Metres

The start of this event was delayed approximately two minutes.

FOX GEM (E. Wong) - slow to begin. Disappointed at the entrance to the straight when attempting a run between WHISKEY 'N' WOMEN and DAZZLING PROSPECT, which shifted out slightly, and as a result was obliged to alter course to the inside of that gelding to obtain clear ground.

LORD WONDER (NZ) (B. Price) - raced keenly in the middle stages of the event.

RECREANT (K. Crowther) - refused to load. Late scratching at 2.45 pm. Trainer, Mr D. Dodson, was advised that the gelding would now be required to load without delay in an Official Barrier Trial prior to accepting for a future race.

WHISKEY 'N' WOMEN (T. Pannell) - raced keenly in the early and middle stages of the event.

DAZZLING PROSPECT (J. Maund) - shifted out slightly rounding the home turn.

SEAFARING (NZ) (S. Logan) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 6: THOMAS FARMS SUPPORTING SAROA HANDICAP - 1100 Metres

OUR HEIDI (K. Crowther) - shifted out on jumping away contacting COMMANDER MEROO.

JAAZEB (B. Vorster) - inclined to lay in under pressure in the straight.

RACE 6: THOMAS FARMS SUPPORTING SAROA HANDICAP - 1100 Metres (cont'd)

COMMANDER MEROO (T. Pannell) - contacted on jumping away. Raced keenly in the early and middle stages of the event.

JUSTAKIDD (J. Holder) - stood flat-footed and was slow to begin. A post-race veterinary examination revealed no visible abnormalities.

BRAZANO (B. Price) - contacted on jumping away. Raced keenly in the early and middle stages of the event.

WILLASTON (A. Livesey) - inclined to lay in under pressure in the straight.

MISS MIDUKI (E. Wong) - laid out over the concluding 100m.

DUCHESS NICCI (D. Caboche) - Stewards permitted D. Caboche to ride the mare 0.5 kg over its allotted weight of 54.0 kg. Shifted out on jumping away onto BRAZANO.

RACE 7: GRAND SYNDICATES HANDICAP - 1100 Metres

TAN TAT BEAU (E. Wong) - slow to begin. Near the 800m shifted out onto INDIAN GAZELLE, which was inconvenienced. Rider reminded of his obligations when shifting ground. Had difficulty obtaining clear ground from the entrance to the straight until near the 300m. A post-race veterinary examination revealed no visible abnormalities.

CLASSY BANNER (T. Voorham) - stood flat-footed and was slow to begin. Laid out rounding the home turn. Rider reported that the gelding was inclined to hang out throughout the event.

DANISH FORTUNE (C. Rawiller) - had difficulty obtaining clear ground from the entrance to the straight until near the 200m.

BAJAN BELLE (A. Livesey) - following the declaration of acceptances trainer, Mr R. Balfour, made a gear application to add ear muffs to the mare's race gear. Stewards acceded this request and acting under AR206(2) fined Mr Balfour \$200. Laid out under pressure in the straight.

ONIKA (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

THE TRANCE FACTOR (J. Holder) - jumped away awkwardly.

INDIAN GAZELLE (E. Annells) - jumped away awkwardly. Near the 800m was inconvenienced when TAN TAT BEAU shifted out.

RACE 8: FLEURIEU MILK COMPANY HANDICAP - 2022 Metres

BUSKER'S BALLAD (C. Rawiller) - inconvenienced on jumping away when KYSHAKA shifted out. Shifted about under pressure in the straight.

BADONKIDONK (K. Crowther) - rider explained that the gelding travelled well in the early and middle stages; however, had not let down when placed under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

BALLROOM DANCER (B. Price) - taken out on jumping away onto ALPINE BEAU by STREET CULTURE.

KYSHAKA (T. Voorham) - jumped away awkwardly and shifted out onto BUSKER'S BALLAD.

AUSSIE SOJOURN (B. Vorster) - jumped away awkwardly. Raced keenly in the early and middle stages. Raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

CARRY THE MUSKET (E. Wong) - laid in under pressure in the straight. A post-race veterinary examination revealed a lower than expected recovery rate.

RACE 8: FLEURIEU MILK COMPANY HANDICAP - 2022 Metres (cont'd)

STREET CULTURE (A. Livesey) - jumped away awkwardly and shifted out onto BALLROOM DANCER.

UNDERSTATEMENT (J. Toeroek) - rider reported that he had become concerned with the gelding's action on pulling up. A post-race veterinary examination revealed the gelding to be lame in the off hind leg (2/5). Trainer, Mr S. Gower, was advised that a Veterinary Clearance was required prior to a future jump-out, trial or race start.

ALPINE BEAU (J. Maund) - inconvenienced on jumping away when contacted by BALLROOM DANCER.

RACE 9: ARAMIS VINEYARDS HANDICAP - 1200 Metres

INSPIRED SUN (S. Logan) - jumped away awkwardly. Inside the 300m was disappointed when attempting a tight run between the heels of WONDERWOMEN and RISING LEGEND, and was obliged to alter course to the outside of WONDERWOMEN near the 200m to obtain clear ground.

KENYAN WONDER (T. Pannell) - slow to begin.

RISING LEGEND (E. Boyd) - raced keenly in the early and middle stages of the event.

TUPOLEU (J. Toeroek) - rider reported that the gelding over-raced in the lead and had not responded to his riding when placed under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

ZACOUVER (NZ) (T. Voorham) - lost its near fore plate during the event. A post-race veterinary examination revealed no visible abnormalities.

TWICE FORGOTTEN (D. Caboche) - Stewards permitted D. Caboche to ride the mare 0.5 kg over its allotted weight of 54.0 kg.


