Report on Race Meeting held at Naracoorte
Racecourse by the Naracoorte Racing Club on
Thursday, 29 December 2022

RACE 1: HAYNES ENGINEERING MAIDEN HANDICAP - 1100 Metres

The start of this event was delayed approximately one minute.

SOXTOBEYOU (C. Rawiller) - underwent a pre-race veterinary examination on arrival on course, as it had not raced since February 2020 and was deemed suitable to race. A post-race veterinary examination revealed the gelding to be lame in the off hind leg (2/5). Trainer, Mr G. Lynch was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

ALBLAZER (S. Fawke) - jumped away awkwardly and as a result was slow to begin.

LADY WAIRUA (NZ) (T. Voorham) - jumped away awkwardly.

COMANCHE QUEEN (E. Annells) - proved difficult to leave the mounting yard, was hesitant to proceed to the start and dislodged its rider on a number of occasions who was uninjured in either incident. Trainer, Mr S. McIntyre was advised that a warning had been placed on the mare in relation to its pre-race behaviour. Slow into stride.

KEEP SWINGING (H. Yuen) - approximately one hour following the declaration of acceptances Trainer, Ms R. Day made a gear application to add a cross over nose band and remove a kyneton nose band from the mare's race gear. Stewards acceded to this request and reprimanded Ms Day under AR206(2). Underwent a pre-race veterinary examination on arrival on course, as it had not raced since 5 December 2021 and was deemed suitable to race. Proved difficult en route to the barriers and dislodged its rider on a number of occasions who was uninjured in the incidents. Trainer, Mr R. Day was advised that a warning had been placed on the mare in relation to its pre-race behaviour. Jumped away very awkwardly and for a number of strides after, rider was awkward in the saddle.



RACE 1: HAYNES ENGINEERING MAIDEN HANDICAP - 1100 Metres (cont'd)

NANCY MAY (B. Wong) - jumped away awkwardly and was slow to begin. From near the 300m until approaching the 100m when placed under pressure got its head up and carried it awkwardly.

RACE 2: HENSCHKE INDUSTRIES MAIDEN PLATE - 1430 Metres

RAIDAWAY (C. Murray) - underwent a pre-race veterinary examination on arrival at the barriers and was deemed suitable to race. Slow to begin. A post-race veterinary examination revealed the gelding has shifted its near fore plate during the event.

SWISS TIME (J. Eaton) - hung in from near the 400m for the remainder of the event.

THE PENSKE FILE (D. Tourneur) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100m and was fined \$100. In determining penalty Stewards had regard for the totality of the use of the whip by D. Tourneur and noted that he used it on five occasions over the final 100m of the event.

PRIVATE JET (J. Opperman) - laid out rounding the home turn.

FORTUNATE FRED (E. Annells) - jumped away awkwardly.

RACE 3: NARACOORTE HOTEL BENCHMARK 68 HANDICAP - 1430 Metres

BOMBER'S KISS (C. Murray) - a post-race veterinary examination revealed no visible abnormalities.

ARCHERY BUTTS (C. Rawiller) - raced keenly in the lead with blinkers applied for the first time.

I'LL BE GONE (J. Eaton) - slow to begin and was slow to muster speed in the early stages of the event. Rider explained that the gelding would be suited to racing over further distances. A post-race veterinary examination revealed no visible abnormalities.

BRONSKI (E. Annells) - held up for clear running from the 400m until the entrance to the straight.

CORAGGIO (K. Walters) - held up for clear running from the 400m until near the 200m.

RACE 4: NARACOORTE FREIGHT CENTRE CLASS TWO HANDICAP - 1430 Metres

CALL IT A HUNCH (J. Lorensini) - near the 400m raced in restricted room and was tightened between UP, which rolled in and WONGABELLE.

STAR LYRIC (T. Voorham) - slow into stride. Rider explained that it was her intention to be more forward on the mare; however, after being slightly slow to begin and slow into stride she allowed STAR LYRIC to settle where comfortable. She added that the mare travelled well during the event and finished the race off well. A post-race veterinary examination revealed the gelding to be lame in the off hind leg (2/5). Co-trainer, Mr J. Jaensch was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

FRENCH BISHOP (E. Boyd) - raced keenly in the early and middle stages of the event. Near the 400m was restrained when awkwardly placed on the heels of CALL IT A HUNCH.

DROVER'S YARN (E. Annells) - raced wide without cover throughout the event.

RACE 5: ENVIRO TEC BENCHMARK 62 HANDICAP - 1000 Metres

KENT STREET (L. Williams) - jumped away awkwardly. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100m and was fined \$200. In determining penalty Stewards had regard for the totality of the use of the whip by L. Williams and noted that he used it on ten occasions over the final 100m of the event.





RACE 5: ENVIRO TEC BENCHMARK 62 HANDICAP - 1000 Metres (cont'd)

CLUB PUNTER (C. Murray) - raced keenly in the early stages of the event. Rider explained that the gelding would derive benefit from the run. A post-race veterinary examination revealed no visible abnormalities.

ROSE OF SEBRING (H. Grace) - rider explained that the mare did not let down as he had anticipated.

ALLGO (K. Walters) - on jumping away bumped MISS GATSBY.

MISS GATSBY (D. Caboche) - jumped away awkwardly, shifted out and bumped ALLGO.

ARACHNATTACK (H. Yuen) - dislodged its rider en route to the barriers and galloped free at a solid tempo for some distance. Underwent a pre-race veterinary examination and was deemed unsuitable to race. Acting on this advice ARACHNATTACK was declared a late scratching at 3.11 pm. H. Yuen was examined by First Care Medical personnel following the event and was passed fit to fulfil her remaining engagements.

RACE 6: NARACOORTE RECYCLABLES BENCHMARK 62 HANDICAP - 2000 Metres

BLACK SYRAH (D. Tourneur) - shortly after the start was restrained and shifted in.

DUKE OF BEDFORD (NZ) (J. Lorensini) - held up for a short distance near the 400m. Near the 200m when attempting a tight run between AIR TIME and RED HOT CHILLYPINS (NZ), which both shifted ground slightly, commenced to lay in and was obliged to be steadied and shifted out in an attempt to gain clear running. Shortly after continued to shift out and took IF YOU LEAVE (NZ) out wider on the track.

VICTORY BANDIT (E. Finnegan) - slow to begin. Shortly after shifted in, in an attempt to gain cover. A post-race veterinary examination revealed no visible abnormalities.

THE FIRE TRAP (C. Murray) - over raced in the early stages.

DUKE OF ANJOU (T. Voorham) - raced wide without cover throughout.

DARKEN UP (NZ) (K. Walters) - approaching the finish stumbled and dislodged its rider. K. Walters was examined by First Care Medical personnel following the event and declared unfit to ride. K. Walters was advised that she would require a Medical Clearance prior engaging in any form of riding again. K. Walters submitted a medical clearance to the Stewards on Friday, 30 December 2022.

IF YOU LEAVE (NZ) (S. Fawke) - shortly after the start was restrained and shifted in. Over raced in the early and middle stages. Held up for clear running from the 400m until approaching the 100m. Near the 200m was awkwardly placed on the heels of DUKE OF BEDFORD (NZ), which was being steadied, shifted out and was obliged to shift out wider with that gelding. Approaching the 100m shifted to the inside of DUKE OF BEDFORD (NZ), in an attempt to gain clear ground.

RACE 7: SPORTSPOWER NARACOORTE BENCHMARK 52 HANDICAP - 1200 Metres

The start of this event was delayed approximately five minutes owing to the late rider change for LAST DREAM (NZ).

PALE ALE (J. Lorensini) - near the 200m bumped with RICHD, which was hanging in.

WARMINSTER (C. Murray) - inside the 800m was awkwardly placed between the heels of PALE ALE and RICHD for a short distance. A post-race veterinary examination revealed no visible abnormalities.

ASK FOR MORE (H. Yuen) - on jumping away lost its position when tightened onto WARMINSTER as RICHD shifted in.



RACE 7: SPORTSPower NARACOORTE BENCHMARK 52 HANDICAP - 1200 Metres (cont'd)

RICHEd (H. Grace) - jumped away awkwardly and shifted in onto ASK FOR MORE, which lost its position. Hung in throughout. Near the 300m rider dropped his whip. Near the 200m when hanging in bumped PALE ALE. A post-race veterinary examination revealed the gelding to be lame in the off hind leg (3/5). Trainer, Mr G. Lynch was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

GRAVITY (T. Voorham) - jumped away awkwardly.

GENERAL

Stewards inquired into the reasons Apprentice, Ben Price failed to fulfil his three riding engagements for the meeting. After considering his explanation and also the explanation provided by his master, Trainer, Mr. W. Clarken, Stewards deemed that Mr. Clarken was the person responsible for B. Price not fulfilling his riding engagements due to him being required at the jump outs and fined him \$100 under AR127(2).
