Racing SA Ltd Stipendiary Stewards' Report

Report on Race Meeting held at Gawler Racecourse by the Gawler & Barossa Jockey Club on Saturday, 7 January 2023



TRACK: Good 4

(Track with some give in it)

RACINGSA

RAIL: Out 2 metres 800m to 400m, true remainder.

WEATHER: Hot

RACE 1: MANDI WILSON RESIN ART HANDICAP - 1500 Metres

VARIARA (A. Livesey) - a post-race veterinary examination revealed no visible abnormalities.

FLYWAY (B. Price) – rider reported that the gelding never travelled during the event and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

NABBED (T. Pannell) - held up from near the 600m until near the 200m. When questioned in relation to his riding of the mare, in particular his decision to shift off the rail near the 600m, rider explained that he was of the opinion that SINO WITNESS would not take him into the race and he may have become held up on that gelding's back if he had continued to maintain his position on the rail, and for that reason he had elected to shift out in an attempt to follow IMPERIAL SEAL into the race. Approaching the 400m he was aware that IMPERIAL SEAL had commenced to lay out and attempted to improve to the inside of that gelding; however, it rolled back in shortly after, resulting in him having difficulty in obtaining clear ground until near the 200m. He added that the mare had finished the event off fairly.

IMPERIAL SEAL (J. Holder) - raced keenly in the early and middle stages of the event. Laid out rounding the home turn.

SINO WITNESS (J. Potter) - rider reported that the gelding raced greenly during the event.

TIGER QUEEN (S. Fawke) - knuckled on jumping away. Laid out under pressure in the straight.

DECIBELLES (D. Caboche) – raced wide without cover throughout the event. Rider reported that the mare never travelled and in his opinion had choked down. Lost its near hind plate during the event. A post-race veterinary examination revealed a slow recovery rate.

RACE 2: PURE WINE CO HANDICAP - 1200 Metres

MISS LANGTRY (S. Logan) - rider reported that the mare did not feel comfortable in its action during the event. A post-race veterinary examination revealed no visible abnormalities.



RACE 2: PURE WINE CO HANDICAP - 1200 Metres (cont'd)

STARSONGARI (T. Voorham) - rider reported that the mare travelled well in the early and middle stages of the event; however, had not let down as she had anticipated when placed under pressure in the straight and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

KENYAN WONDER (T. Pannell) - raced keenly in the early and middle stages of the event.

LIANNE (E. Boyd) - inconvenienced on jumping away.

SASSY MANEUVER (B. Price) – jumped away awkwardly and shifted in onto LIANNE. Lost its near fore plate during the event

RACE 3: COOPERS BREWERY HANDICAP - 1200 Metres

BOLD STAR (K. Crowther) – was examined by the Club's Veterinary Surgeon on arrival at the barriers who reported that the gelding was lame in the near foreleg (2/5) and therefore deemed unsuitable to race. Acting on this advice Stewards withdrew BOLD STAR at 1.26 pm. Co-trainers, Mr G. Richards & Mr D. Moyle, were advised that a Veterinary Clearance was required prior to a future jump-out, trial or race start.

EXTRA TIME (J. Holder) - approaching the 200m was inconvenienced when taken wider by DEXTER YOU DEVIL.

TERBIUM (T. Voorham) - jumped away awkwardly. Near the 900m shifted out slightly inconveniencing PICARGO. Held up from the entrance to the straight until approaching the 200m. Rider reported that after obtaining clear ground the gelding did not respond as she had anticipated and was disappointing to the finish. A post-race veterinary examination revealed the gelding to be lame in the off hind leg (2/5). Trainer, Mr P. Stokes, was advised that a Veterinary Clearance was required prior to a future jump-out, trial or race start.

DEXTER YOU DEVIL (J. Opperman) - slow to begin. Shifted out approaching the 200m taking EXTRA TIME wider.

PICARGO (A. Livesey) - inconvenienced near the 900m when TERBIUM shifted out slightly.

RACE 4: SANDERS FODDER HANDICAP - 1200 Metres

DEEP POINT (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

MIDNIGHT RUSH (A. Livesey) – a post-race veterinary examination revealed the gelding to have been galloped on and lame in the off hind leg (2/5) with multiple abrasions. Co-trainer, Mr R. Jolly & Miss C. Jolly, were advised that a Veterinary Clearance was required prior to a future jump-out, trial or race start.

WHATSANAMEGEORGE (J. Toeroek) - raced keenly in the middle stages of the event.

OUR SHINING STAR (B. Price) - raced keenly in the early stages whilst being restrained. Laid out under pressure in the straight.

SIR TOOP (E. Wong) - jumped away awkwardly. Inclined to lay in under pressure in the straight. Lost its near hind plate during the event.

SOAMES (J. Holder) – co-trainer, Mr D. Clarken, advised Stewards prior to the event of a change of tactics in that he would instruct the rider to attempt to settle back with cover from the wide barrier draw. Settled back with cover.



RACE 5: FAB HATS BY OKSANA C HANDICAP - 1700 Metres

DIAMONDS ARE (A. Livesey) - slow to begin. Raced keenly in the middle stages of the event.

RACE 5: FAB HATS BY OKSANA C HANDICAP - 1700 Metres (cont'd)

FESTIVAL OF LIGHT (J. Potter) - had difficulty obtaining clear ground from near the 400m until approaching the 200m.

BUNJIL (T. Pannell) – rider explained that the gelding had sweated up significantly pre-race. He added that the gelding travelled well during the event; however, had failed to let down and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

RACE 6: KINGSFORD HOTEL HANDICAP - 2100 Metres

DISAGREEABLE MISS (B. Price) - laid in under pressure in the straight.

STREET CULTURE (A. Livesey) – shifted out on jumping away onto RED SEQUOIA. Rider reported that the gelding did not travel in the manner it had at its most recent starts and was disappointing when placed under pressure in the straight. A post-race veterinary examination revealed the gelding to be lame in the near hind leg (3/5). Trainer, Ms N. Irwin, was advised that a Veterinary Clearance was required prior to a future jump-out, trial or race start.

WHEELS (NZ) (J. Holder) – near the 1700m shifted in abruptly away from AUSSIE SOJOURN and made contact with the running rail, became unbalanced and lost its action for a number of strides.

RED SEQUOIA (J. Potter) – inconvenienced on jumping away when tightened between STREET CULTURE, which shifted out, and AUSSIE SOJOURN, which shifted in slightly. Near the 150m had to momentarily steady and alter course to the outside of LORD WONDER (NZ), which had commenced to give ground.

LORD WONDER (NZ) (T. Pannell) - raced wide without cover throughout the event.

AUSSIE SOJOURN (D. Tourneur) – jumped away awkwardly and shifted in onto RED SEQUOIA. Raced keenly in the early and middle stages of the event.

RACE 7: LJ HOOKER HANDICAP - 1200 Metres

CAPRICORN RIDGE (K. Crowther) - inconvenienced on jumping away when tightened between TRYGVE, which shifted out, and THE LADIES MAN, which shifted in.

MR MARATHON MAN (GB) (B. Price) – had difficulty obtaining clear ground from near the 500m until the entrance to the straight.

SECRET WAR (E. Wong) - laid out under pressure in the straight.

TRYGVE (T. Voorham) - shifted out on jumping away onto CAPRICORN RIDGE.

MR WHITACRE (D. Caboche) - slow to begin.

THE LADIES MAN (D. Tourneur) - shifted in on jumping away onto CAPRICORN RIDGE.

RACE 8: CONTRACT ENGINEERING HANDICAP - 1500 Metres

SPLASH SOME CASH (A. Lindsay) – rider explained that she was instructed to obtain a position on pace; however, after being a touch slow to begin the gelding was unable to muster early speed despite her efforts, and as a result she had settled further back than she had anticipated. She added that when placed under pressure on straightening she had expected SPLASH SOME CASH to respond better than it did.

HEIR OF TAVISTOCK (NZ) (J. Opperman) – a post-race veterinary examination revealed no visible abnormalities.



GRINZINGER ALLEE (NZ) (E. Finnegan) – hampered on jumping away and lost its position when FOX D'OR was taken in onto the gelding. Laid out rounding the home turn and under pressure in the straight. Rider reported that the gelding changed lead legs on a number of occasions during the event and felt uncomfortable in its action on pulling up. A post-race veterinary examination revealed no visible abnormalities.

RACE 8: CONTRACT ENGINEERING HANDICAP - 1500 Metres (cont'd)

ANNIKA (B. Price) - shifted in abruptly on jumping away onto FOX D'OR.

OBI (A. Livesey) - raced keenly in the early and middle stages of the event.

STAR ESPRESSO (K. Crowther) – had to be momentarily steadied near the 100m when it improved onto the heels of ANNIKA and was obliged to alter course to that mare's inside to obtain clear ground.

FOX D'OR (J. Eaton) – jumped away awkwardly and shortly after the rider was forced to take hold and lose its position when ANNIKA shifted in abruptly.

RACE 9: HOLDFAST INSURANCE BROKERS HANDICAP - 1100 Metres

JAAZEB (T. Voorham) - jumped away awkwardly. Laid out under pressure in the straight.

DEVIL'S RAIN (J. Holder) – stable advised Stewards prior to the event of a change of tactics in that the rider would be instructed to have the gelding settle where comfortable rather than settle back as had been the case in its most recent starts. Settled midfield. Held up from near the 500m until the entrance to the straight. Laid out under pressure in the straight.

HUNTLEY LADY (K. Crowther) – hampered on jumping away. Laid out from near the 600m until near the 300m.

SYNCRETISM (T. Pannell) - rider explained that the filly travelled extremely well during the event; however, when placed under pressure approaching the 400m failed to respond to his riding and was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

MISS MIDUKI (E. Wong) - inclined to lay in under pressure in the straight.

ISA SECRET (J. Eaton) – jumped away awkwardly.

TEA RAV (NZ) (D. Tootell (Snr)) - shifted in on jumping away onto HUNTLEY LADY.
