

# Racing SA Ltd Stipendiary Stewards' Report

Report on Race Meeting held at Gawler Racecourse  
by the Gawler & Barossa Jockey Club on Saturday,  
21 January 2023

TRACK: Good 4 (Track with some give in it)

RAIL: Out 4 metres 800 metres to 400 metres, out 2 metres remainder

WEATHER: Fine

RACE 1: 4 WAYS FRESH PRODUCE PLATE - 1100 Metres

ARAMOSO (K. Crowther) - raced fiercely and greenly throughout the event. Hung out rounding the home turn and under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

HARLEY'N'ROSE (L. Neindorf) - inclined to lay in under pressure in the straight.

OFF THE CUFF (B. Vorster) - raced keenly in the early stages of the event.

RACE 2: COOPERS BREWERY HANDICAP - 1500 Metres

The start of this event was delayed approximately one minute.

TEST THE LAW (J. Opperman) - slow to begin. Shortly after the entrance to the straight was inconvenienced as COOL THE JETS rolled out. Thereafter had difficulty obtaining clear ground until inside the 200m.

LIDDER VALLEY (L. Neindorf) - after being loaded got its near hind leg up on the barrier structure. Underwent a pre-race veterinary examination and was deemed suitable to race. A post-race veterinary examination revealed no visible abnormalities.

IMBIBE (B. Vorster) - raced keenly in the early and middle stages.

WHATSANAMEGEORGE (J. Toeroek) - rider reported that the gelding hung out throughout the event.

COOL THE JETS (D. Tourneur) - shortly after the entrance to the straight rolled out onto TEST THE LAW.

OUR SELECTION (NZ) (S. Logan) - raced wide without cover from the 1100m.

SOAMES (R. Hurdle) - from its wide barrier was restrained and shift in, in attempt to gain cover.



### RACE 3: DARE & JOHNSON HANDICAP – 1200 Metres

HERE COMES LENNI (NZ) (L. Neindorf) – underwent a pre-race veterinary examination as it had not raced since 31 January 2021 and was deemed suitable to race.

MUNSTER (NZ) (J. Eaton) – following the event Trainer, Mr M. Hickmott reported that the gelding made abnormal respiratory noises.

SECRET WAR (E. Wong) – rider was dislodged in the mounting yard. E. Wong was examined by First Care Medical personnel and was passed fit to fulfil his remaining engagements. Laid out under pressure in the straight.

### RACE 4: HOLDFAST INSURANCE BROKERS MAIDEN PLATE – 1100 Metres

The start of this event was delayed approximately one minute.

HOOD RAT (NZ) (R. Hurdle) – jumped away awkwardly, shifted out and bumped PEARL ADIOS.

PEARL ADIOS (J. Holder) – on jumping away bumped HOOD RAT (NZ), which shifted out. Rider explained in relation to the gelding's performance that it travelled well in the early and middle stages; however, from the 200m was disappointing. He added that the gelding may benefit from racing over further distances and with blinkers applied. A post-race veterinary examination revealed no visible abnormalities.

THE CREED (D. Tourneur) – shortly after the start shifted out onto EISHAA, which was severely hampered. At the entrance to the straight was inconvenienced when taken out onto LOTTO FIGHT by FUNOFTHEFAIR.

FUNOFTHEFAIR (E. Wong) – inside the 800m was obliged to be eased when tightened onto AMBELLO as LEGGY PEGGY, which was hanging out, shifted out. At the entrance to the straight shifted out and away from SIXTEEN REASONS onto THE CREED.

LADY DE LUNE (J. Eaton) – shortly after the start was inconvenienced when tightened onto TIFFANY VALENTINE as LOTTO FIGHT was taken out.

LEGGY PEGGY (E. Finnegan) – Trainer, Mr J. MacMillan was reprimanded under AR65 for failing to produce the Thoroughbred Identification Card. The horse was permitted to start as it was able to be identified from records held by Stewards. Jumped away awkwardly. Raced keenly and hung out throughout the event. Inside the 800m when hanging out, shifted out onto FUNOFTHEFAIR. Rider reported in relation to the mare's performance that she had limited control in the steering of the mare and it did not feel comfortable in its action. A post-race veterinary examination revealed the mare to be lame in the near hind leg (2/5). Trainer, Mr J. Macmillan was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

EISHAA (L. Neindorf) – shortly after the start was hampered and lost its position when tightened onto LOTTO FIGHT as THE CREED shifted out.

TIFFANY VALENTINE (S. Logan) – at the entrance to the straight was inconvenienced when taken wider by LOTTO FIGHT, which was taken out. Near the 200m was obliged to alter course to the inside of LOTTO FIGHT.

ICE SYMPHONY (J. Toeroek) – laid out under pressure in the straight.

LOTTO FIGHT (B. Vorster) – shortly after the start was severely hampered when tightened onto LADY DE LUNE as EISHAA was taken out. At the entrance to the straight was inconvenienced and taken wider by THE CREED. Near the 200m shifted out.

Correct weight for this event was delayed to allow rider, B. Voster (LOTTO FIGHT), placed fifth, to view the vision in the straight. After doing so, B. Voster (LOTTO FIGHT) lodged a protest against D. Tourneur (THE CREED) being placed fourth, alleging interference at the entrance to the straight. After considering the evidence, acting on their own observations and viewing the official vision, Stewards dismissed the protest.



## RACE 5: CONTRACT ENGINEERING HANDICAP - 1500 Metres

IN THE DARKNESS (NZ) (J. Eaton) - held up for clear running from the 400m until near the 200m when racing between BRANDERS RULE and VAN ROY. Rider reported that the mare was slow to muster speed in the early stages of the event despite her efforts and therefore she was unable to lead in the event as she had intended.

PITRAIN (E. Finnegan) - contacted a perimeter fence on exiting the mounting yard. Underwent a pre-race veterinary examination and was deemed suitable to race. Slow to begin.

CARRY THE MUSKET (E. Wong) - lost its near fore plate en route to the barriers and was required to be re-shod on arrival at the barriers. Underwent a pre-race veterinary examination and was deemed suitable to race. Inside the 200m when attempting a tight run to the inside of ONEMORE MARSHALL, which rolled in, was obliged to be steadied for a number of strides and thereafter was held up for clear running until inside the 100m.

FORAOISE (A. Livesey) - a post-race veterinary examination revealed no visible abnormalities.

HALIFAX ROAD (A. Jordsjo) - raced wide without cover throughout the event.

TANAAWOL (NZ) (B. Vorster) - slow to begin. Laid in under pressure in the straight.

## RACE 6: COMBINED BUS SERVICES HANDICAP - 1200 Metres

The start of this event was delayed approximately two minutes.

EXALTED TRAVELLER (C. Rawiller) - jumped away awkwardly and shifted in.

JAAZEB (T. Voorham) - had to be re-saddled on arrival at the barriers. Rider reported in relation to the gelding's performance that it travelled well in the early and middle stages; however, when asked for an effort failed to respond to her riding and raced flat to the finish. A post-race veterinary examination revealed no visible abnormalities.

HASSLEFREE (S. Logan) - jumped away awkwardly and shifted out.

EAST INDIAMAN (J. Eaton) - after being loaded got its near hind leg up on the barrier structure. Underwent a pre-race veterinary examination and was deemed suitable to race.

RIALTOR (S. Tomlinson) - shifted about under pressure in the straight.


VERSETTO (C. Murray) - underwent a pre-race veterinary examination on arrival at the barriers and was deemed suitable to race. Raced keenly in the early stages of the event. After being crossed near the 800m commenced to over race when being restrained. Near the 150m was obliged to shift out to alter course when racing in restricted room to the inside of RIALTOR, which was inclined to shift about. Inside the 100m shifted out when awkwardly placed on the heels of EAST INDIAMAN in an attempt to gain clear running.

CLASSY BANNER (B. Vorster) - on jumping away lost its position as HASSLEFREE shifted out and EXALTED TRAVELLER shifted in.

ONEHUNDRED PERCENT (J. Holder) - raced keenly in the early and middle stages of the event. Laid out under pressure in the straight.

SASSY MANEUVER (B. Price) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

## RACE 7: GAWLER HI-BEAM CAR WASH 2023 BUNG FRITZ CUP - 2100 Metres



DARLAMAX (B. Vorster) - a post-race veterinary examination revealed the gelding to be lame in the off hind leg (2/5) and small laceration to its off hind leg. First aid administered. Trainer, Mr A. Homann was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.



RACE 7: GAWLER HI-BEAM CAR WASH 2023 BUNG FRITZ CUP - 2100 Metres (cont'd)

GRINZINGER ALLEE (NZ) (E. Finnegan) - Trainer, Ms K. Mckerlie was reprimanded under AR65 for failing to produce the Thoroughbred Identification Card. The horse was permitted to start as it was able to be identified from records held by Stewards. Jumped away awkwardly and as a result was slow to begin.

DISAGREEABLE MISS (B. Price) - rider reported that the mare was not suited to the tempo of the event. A post-race veterinary examination revealed the mare to be lame in the off foreleg (2/5). Trainer, Mr M. Huxtable was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

REBEL LEE (J. Holder) - laid in under pressure in the straight. Rider reported that the mare was not suited to the tempo of the event. A post-race veterinary examination revealed no visible abnormalities.

BUNDLE OF FUN (T. Pannell) - laid out under pressure in the straight.

KYSHAKA (T. Voorham) - rider reported that the mare never travelled during the event and that she was disappointed with its effort in the run.

RACE 8: KINGSFORD HOTEL / ULTRA TUNE GAWLER HANDICAP - 1300 Metres

The start of this event was delayed approximately one minute.

HYPERCANE (E. Wong) - raced keenly in the early and middle stages of the event.

PLATFORM (NZ) (D. Tournour) - lost its off fore plate en route to the barriers and was required to be re-shod on arrival at the barriers. Underwent a pre-race veterinary examination and was deemed suitable to race. Raced wide without cover from the 1100m. Raced keenly in the early and middle stages of the event. Approaching the 400m rolled in onto I NEED A DRINK.

GETOUTTHEWAY (R. Hurdle) - rider was reminded of his obligations under AR131(b) to ensure he rides his mounts out to the finish. Rider reported that the gelding hung in throughout the event.

HENTY (J. Toeroek) - hung out rounding the home turn and under pressure in the straight. Rider explained in relation to the gelding's performance that it raced plain in the event. He added that his intention were to settle more forward; however, he was unable to do so. He further added that HENTY hung out in the straight and was difficult to ride out; however, on pulling up it seemed to have recovered well. A post-race veterinary examination revealed no visible abnormalities.

DIAMONDS ARE (K. Crowther) - slow to begin.

FOX D'OR (J. Eaton) - approaching the 400m rolled out onto I NEED A DRINK and from shortly thereafter was held up for clear running until near the 300m. A post-race veterinary examination revealed the gelding to be lame in the near foreleg (2/5). Trainer, Mr D. McLeod was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

I NEED A DRINK (B. Vorster) - approaching the 400m was obliged to be eased when tightened between FOX D'OR and PLATFORM (NZ), which both shifted ground. A post-race veterinary examination revealed no visible abnormalities.

RACE 9: ADELAIDE PLAINS BLOODSTOCK HANDICAP - 1100 Metres

BAJAN BELLE (J. Holder) - hung out under pressure in the straight. Rider reported that the mare may have jarred up in the event and did not stretch out. A post-race veterinary examination revealed no visible abnormalities.

MESSERSCHMITT (A. Livesey) - shortly after the start was inconvenienced, obliged to be steadied and lost its position when tightened onto MISS MIDUKI by MELMAC which shifted out.

MY RUBY (S. Tomlinson) - jumped away awkwardly. At the entrance to the straight was obliged to shift to the inside of BAJAN BELLE, which was hanging out and shifted out. A post-race veterinary examination revealed no visible abnormalities.

RACE 9: ADELAIDE PLAINS BLOODSTOCK HANDICAP – 1100 Metres (cont'd)

AMANI FARASI (B. Price) – a post-race veterinary examination revealed no visible abnormalities.

SET THE BAR LOW (T. Voorham) - jumped away awkwardly, shifted out and bumped SADLER'S SONG. A post-race veterinary examination revealed no visible abnormalities.

MELMAC (B. Vorster) – jumped away awkwardly and shifted out onto MESSERSCHMITT.

STORM VOYAGER (R. Hurdle) – raced wide without cover throughout the event.

ISA SECRET (J. Eaton) – jumped away awkwardly.

SADLER'S SONG (A. Jordsjo) – on jumping away bumped SET THE BAR LOW, which shifted out.

ARCHERY BUTTS (C. Rawiller) – acting on advice from trainer, Mr. G Lynch, that the gelding had struck its head whilst being loaded and therefore was unsuitable to start Stewards declared ARCHERY BUTTS a late scratching at 1:47pm. Mr Lynch was advised a veterinary clearance is required prior to a future jump-out, trial or race.
