Racing SA Ltd Stipendiary Stewards' Report

Report on Race Meeting held at Kingscote Racecourse by the Kangaroo Island Racing Club on Saturday, 21 January 2023



Stewards: E. Scott (A/Chairman), P. Ryan (HT) & C. Deakin (F) (Stewards), H. Matthews (Cadet

Steward), L. Martin (Deputy Steward), Dr B. Agnew (Veterinary Surgeon)

TRACK: Good 4 (Track with some give in it)

RAIL: True

<u>WEATHER</u>: Overcast

RACE 1: CENTURY 21 MAIDEN PLATE - 1050 Metres

BARBADSON (J. Doyle) - near the 100m became awkwardly placed on heels of SOXTOBEYOU, which shifted in slightly and had to be steadied. Rider reported that the horse raced greenly in the straight.

SOXTOBEYOU (S. Fawke) - jumped away awkwardly.

GREY FOLLY (F. Atkinson) - slow to begin.

NISKIE LATANIE (H. Yuen) - rider explained that she lost her off side rein near the 100 metres for a short distance and regained it shortly thereafter.

RACE 2: INGRAM'S HOME TIMBER AND HARDWARE BENCHMARK 52 TROPHY RACE - 1050 Metres

HEY MICHAEL (J. Potter) – shortly after being loaded became fractious in its barrier. Underwent a pre-race veterinary examination which revealed the gelding to be lame in the near hind leg (2/5) and abrasions to its cannon and hock and was deemed unsuitable to race. First aid administered. Acting on this advice HEY MICHAEL was declared a late scratching by order of Stewards at 1.40 pm. Stewards ordered all money invested on HEY MICHAEL prior to the time of withdrawal be subject to the deductions of 20 cents in the dollar for a win and 16 cents in the dollar for a place. Trainer, Ms N. Irwin was advised that the gelding must perform to the Stewards' satisfaction in an Official Barrier Trial or Approval Jump Out and was further advised that a Veterinary Clearance would be required prior to a future approval jump-out or trial.

UTAH JOE (D. Tootell (Snr)) - slow to begin.

ARCHIE'S A STAR (F. Atkinson) - rider reported that the gelding did not handle today's track conditions.

WILLIAM'S QUEST (J. Doyle) - rider reported that the gelding hung out in the straight.

RACE 3: AMA SECURITY BENCHMARK 56 HANDICAP - 1215 Metres

CONNERMARA ROSE (D. Tootell (Snr)) - slow to begin.

BOLT I AM (R. Milnes) - jumped away awkwardly and as a result was slow to begin.

TAIPAN TOMMY (C. Munro) - near the 400m had to be momentarily steadied when CAITLIN'S ANGEL rolled in. Near the 200m was disappointed for a run between CAITLIN'S ANGEL and SELF SUFFICIENT and had to shift in to obtain clear running.

CAITLIN'S ANGEL (J. Potter) - near the 400m rolled in.

WICKED SCANDAL (F. Atkinson) - underwent a pre-race veterinary examination on arrival on course and was deemed suitable to race.

SELF SUFFICIENT (S. Fawke) - raced keenly in the middle stages of the event.

JUMPING BEAN (M. Vassallo) – slow into stride. A post-race veterinary examination revealed the mare to be lame in the near hind leg (3/5). Trainer, Mr G. Lynch was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

RACE 4: SEALINK BENCHMARK 62 HANDICAP - 1360 Metres

STRADARI (R. Milnes) - jumped away awkwardly and shifted in onto SHE'S FULL OF IT.

MAGNOSSIVA (C. Munro) – approaching the finish when improving had to be steadied to avoid the heels of ALPHAEUS. Shortly after the finish brushed slightly with SUNNY GREEN to its inside, was taken out slightly and clipped the heels of ALPHAEUS, which rolled in slightly, knuckled and dislodged its rider. As no rider or horse was solely to blame, Stewards deemed this a racing incident and took no further action. A post-race veterinary examination revealed no visible abnormalities. C. Munro was examined by the First Care Medical personnel and was passed fit to fulfil her remaining engagements. Stewards deemed it impractical for C. Munro to weigh in as she was being examined by First Care Medical personnel. Acting under AR208(3), the stewards were satisfied C. Munro weighed out correctly and that she carried the correct weight during the event and therefore correct weight was declared.

SHE'S FULL OF IT (E. Annells) - on jumping away tightened onto A MIDNIGHT SHADOW by STRADARI and lost its position.

RACE 5: TERRY WHITE CHEMMART BENCHMARK 52 TROPHY RACE - 1360 Metres

EQUAL BALANCE (C. Munro) - laid in, in the straight.

WINE O'CLOCK (NZ) (J. Doyle) - when questioned in relation to the gelding's disappointing performance, rider explained that the gelding never travelled and proved disappointing. A post-race veterinary examination revealed the gelding to be lame in the near foreleg (3/5). Trainer, Mr B. Campbell was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

INKA DINKA (J. Potter) - slow to begin.

PRINCESS SALLY (M. Vassallo) - slow to begin.

HURRICANE SONNY (B. Wong) - underwent a pre-race veterinary examination on arrival on course and was deemed suitable to race. A post-race veterinary examination revealed no visible abnormalities.

RACE 6: DUDLEY WINES BENCHMARK 56 HANDICAP - 1750 Metres

DON'T DISMISS (D. Tootell (Snr)) - jumped away awkwardly and shifted out onto PUISSANCE DUSOLEIL. D. Tootell was reminded of his obligations under AR131(b) in relation to riding his mount out to the finish.

PUISSANCE DUSOLEIL (S. Fawke) - hampered on jumping away by DON'T DISMISS, which shifted out.

EPAULETTE PRINCE (S. Metcalfe) - raced keenly in the early stages of the event when being restrained. A post-race veterinary examination revealed no visible abnormalities.
