Report on Race Meeting held at Ceduna Racecourse by the Ceduna Racing Club on Saturday, 28 January 2023

RACE 1: WIKINSON PLUMBING/TERRY WHITE CHEMMART CEDUNA/WCT RURAL CEDUNA/DEMPSEY'S FEED & SADDLERY MAIDEN PLATE - 1000 Metres

SPANISH COURAGE (R. Milnes) - raced greenly in the straight.

PRIMED MELODY (C. Munro) - hung out rounding the home turn.

RACE 2: TOYOTA AUSTRALIA FEATURE SPRINT BENCHMARK 58 TROPHY - 1000 Metres

FLUFFY BUNNY FEET (B. Wong) - shortly after jumping away bucked and dislodged its rider. A post-race veterinary examination revealed no visible abnormalities. Trainer, Mr T. Montgomerie, was advised that the mare would now be required to perform to the satisfaction of Stewards in an Official Barrier Trial prior to a future race start. B. Wong was examined by the First Care Medical personnel and required ongoing assessment before being cleared to ride.

RACE 3: LETCHER MORONEY / MIDSEC FINANCIAL ADVISORS BENCHMARK 64 HANDICAP - 1200 Metres

Following the running of Race 3 B. Wong was passed fit to fulfil her remaining engagements.

RACE 4: ON THE RUN / VITERRA AUSTRALIA MAIDEN PLATE - 1300 Metres

LACHLAN CASTLE (J. Doyle) - rider reported that the gelding raced greenly in the straight.

RED FEATS (C. Munro) - jumped away awkwardly.

SIR DALAPENA (B. Wong) - rider explained that the gelding hung in throughout the event and proved difficult to ride. Trainer, Ms T. Kropej, was advised that a warning had been placed on the gelding in relation to its racing manners.

RACE 4: ON THE RUN / VITERRA AUSTRALIA MAIDEN PLATE - 1300 Metres (cont'd)

LENTINO (F. Atkinson) - jumped away awkwardly. Rider reported that her saddle slipped slightly after jumping away. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: VITERRA BENCHMARK 52 TROPHY RACE - 1300 Metres

GOODARCHIE (R. Milnes) - rider reported that the gelding hung in, in the straight.

BEAU DAN (E. Annells) - a post-race veterinary examination revealed no visible abnormalities.

TAJAVEDO (C. Munro) - rider was reminded of her obligations under AR131(b) in riding her mounts out to the finish.

CUT TO PIECES (F. Atkinson) – on jumping away stumbled and dislodged its rider. A post-race veterinary examination revealed no visible abnormalities. F. Atkinson was examined by the First Care Medical personnel and was passed fit to fulfil her remaining engagements.

Correct weight for this event was delayed to allow Stewards to view the vision of the start. After viewing the vision, taking evidence from the Starter and F. Atkinson (CUT TO PIECES) Stewards were comfortably satisfied that CUT TO PIECES was not denied a fair start and correct weight was declared.

RACE 6: MCEVOY TRANSPORT / EYRE PREMIX CONCRETE BENCHMARK 56 HANDICAP - 1400 Metres

ONWARD (S. Fawke) – underwent a pre-race veterinary examination on arrival on course and was deemed suitable to start. Jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

RACE 7: CEDUNA FORESHORE HOTEL CEDUNA CUP - 1600 Metres

FESTIVAL OF LIGHT (B. Wong) - laid out in the straight.

WHITCHETY GRUB (S. Fawke) - on arrival at the barriers underwent a pre-race veterinary examination and was deemed suitable to start.

SHOWBAG (J. Doyle) - a post-race veterinary examination revealed no visible abnormalities.

RACE 8: ON THE RUN BENCHMARK 52 TROPHY RACE - 1600 Metres

LANCER (B. Wong) - rounding the home turn was momentarily held up behind NEAR MAGIC and shifted out to obtain clear running.

LEAN THY ARMS (NZ) (J. Doyle) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

Correct weight for this event was delayed to allow J. Doyle (LEAN THY ARMS (NZ)) to view the vision of the start. After taking evidence from Starter and viewing the vision Stewards were satisfied that LEAN THY ARMS (NZ) was not denied a fair start and correct weight was declared.
