RACE 1: THOMAS FARMS HANDICAP - 1000 Metres

DUBENENKO (T. Voorham) - jumped away awkwardly and was slow to begin.

HARLEEN (L. Riordan) - laid out from approaching the 600m until the entrance to the straight.

## RACE 2: CROSER THREE-YEAR-OLD MAIDEN PLATE - 1250 Metres

CALL ME AL (L. Neindorf) - hung out and raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

CAPTAIN JOOLIAN (K. Crowther) - inconvenienced on jumping away when taken in onto EISHAA by MIDNIGHT DEVIL. Raced fiercely in the early and middle stages of the event and near the 700m shifted out and contacted DIVINE BREW. A post-race veterinary examination revealed no visible abnormalities.

DIVINE BREW (E. Wong) - near the 700m was inconvenienced when contacted and taken wider by CAPTAIN JOOLIAN. Raced wide without cover throughout the event.

HOOD RAT (NZ) (J. Opperman) - jumped away awkwardly. Rider reported that the gelding hung out in the straight and felt uncomfortable on pulling up. A post-race veterinary examination revealed no visible abnormalities.

JAJITTA BUG (J. Potter) - kicked by another runner at the barriers. Underwent a pre-race veterinary examination and was deemed suitable to start. Near the 1000m had to be steadied for a number of strides when it improved onto the heels of LUCIA MARIA. Near the 50m had to be momentarily steadied and alter course to obtain clear ground.



#### RACE 2: CROSER THREE-YEAR-OLD MAIDEN PLATE - 1250 Metres (cont'd)

MIDNIGHT DEVIL (L. Riordan) - shifted in on jumping away onto CAPTAIN JOOLIAN.

CARARADA (J. Holder) - laid in under pressure in the straight.

EISHAA (S. Callow) - lost its position on jumping away when tightened onto JAJITTA BUG by CAPTAIN JOOLIAN. Raced keenly in the early and middle stages of the event.

KUITPO KISS (S. Logan) - a post-race veterinary examination revealed a slower than expected recovery.

ROSE RING (B. Vorster) - laid out under pressure over the concluding 200m.

#### RACE 3: ADELAIDE GALVANISING INDUSTRIES HANDICAP - 2400 Metres

The start of this event was delayed by approximately two minutes.

WOLF PRINCE (A. Jordsjo) - jumped away awkwardly.

GMORK (NZ) (B. Price) – a post-race veterinary examination revealed the gelding to be lame in the off foreleg (3/5). Trainer, Mr M. Hickmott, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

ABERLADY (S. Logan) - reluctant to proceed to the barriers. Trainer, Mr A. Homann, was advised that that a warning had been placed on the mare in relation to its pre-race behaviour.

#### RACE 4: G.H. MUMM HANDICAP - 1950 Metres

GRINZINGER ALLEE (NZ) (S. Logan) - slow to begin.

EAGLES FOREVER (J. Opperman) - awkward and slow to begin. A post-race veterinary examination revealed no visible abnormalities.

DIXIE WHISTLER (L. Neindorf) - laid out rounding the home turn and under pressure in the straight.

RISING RENOWN (NZ) (T. Pannell) – stable representative, Mr S. Theodore, advised Stewards prior to the event of a change of tactics in that they would instruct the rider to attempt to settle further back with cover. Settled midfield with cover. Awkward to begin. A post-race veterinary examination revealed no visible abnormalities

# RACE 5: GRAND SYNDICATES HANDICAP - 1400 Metres

ZOIST (B. Vorster) - approaching the 100m had to be momentarily steadied when HERE COMES LENNI (NZ) shifted in slightly.

HERE COMES LENNI (NZ) (L. Neindorf) - approaching the 100m shifted in slightly onto ZOIST.

SASKATOON (J. Toeroek) – lost its off fore plate in the parade ring prior to the event and required farrier attention. Underwent a pre-race veterinary examination and was deemed suitable to start.

ALSVIOR (J. Maund) - jumped away awkwardly and was slow to begin.

# RACE 6: CAM CROESE BUCKS HANDICAP - 1000 Metres

ALLEBOOM (S. Tomlinson) - rider reported that the gelding made excess respiratory noise on pulling up. A post-race veterinary examination revealed the gelding to be lame in the off hind leg (3/5). Co-trainers, Mr R. Jolly & Miss C. Jolly, were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

### RACE 6: CAM CROESE BUCKS HANDICAP - 1000 Metres (cont'd)

ALPHA FLIGHT (J. Toeroek) - rider explained that the gelding was under pressure early in the race, was one-paced to the finish and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

#### RACE 7: TAB ADELAIDE CUP DAY - MONDAY MARCH 13TH HANDICAP - 1550 Metres

YULONG PATROL (IRE) (J. Opperman) - inside the 300m was disappointed when attempting a tight run to the inside of EXALTED TRAVELLER and near the 200m was obliged to alter course to the outside of that gelding to obtain clear ground.

DOMINUS (NZ) (E. Wong) - shifted in on jumping away on to SHINSEKI. Raced keenly in the early and middle stages of the event. Held up from the 600m until the entrance to the straight.

EAGLELOU (J. Potter) - shifted out on jumping away onto SHINSEKI. Near the 200m shifted in slightly onto WHISKEY 'N' WOMEN. Rider was reminded of his obligations to keep his mounts straight in future.

SHINSEKI (A. Livesey) - hampered on jumping away and lost its position when tightened between DOMINUS (NZ) and EAGLELOU. A post-race veterinary examination revealed no visible abnormalities.

WHISKEY 'N' WOMEN (B. Vorster) - near the 200m had to be steadied momentarily when EAGLELOU shifted in slightly.

LITTLEBITFUNNY (S. Metcalfe) – slow to begin. Raced wide without cover throughout the event. A post-race veterinary examination revealed a slower than expected recovery.

#### RACE 8: HAPPY 50TH BIRTHDAY FOX HANDICAP - 1000 Metres

OUR HEIDI (S. Tomlinson) - raced wide without cover throughout the event.

QEYAADY (B. Price) - following the declaration of acceptances Trainer, Mr M. Hickmott, made a request on raceday to add a cross-over noseband to the gelding's race gear. Stewards acceded to this request and acting under AR206(2) fined Mr Hickmott \$500. Laid out under pressure in the straight.

LORD VARYS (S. Fawke) - jumped away awkwardly.

ZARACE (A. Livesey) - a post-race veterinary examination revealed a slower than expected recovery.

RUSTY HALO (J. Holder) - began awkwardly.

DANTREE (T. Voorham) - a post-race veterinary examination revealed no visible abnormalities.

Correct weight was delayed to allow Stewards to view the vision in the straight.

# RACE 9: THE JUNCTION HANDICAP - 1250 Metres

SECRET WAR (E. Wong) - hung out severely in the straight. A post-race veterinary examination revealed the gelding to be lame in the off foreleg (1/5). Co-trainers, Mr G. and Mrs N. Searle, and Mrs B. Callanan, were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

IMPOSSIBLE ACTION (J. Toeroek) - approaching the finish raced in restricted room between FIXATED and SECRET WAR, which was hanging out.

FIXATED (L. Williams) - inconvenienced rounding the home turn and shortly after entering the straight when brushed and taken wider by SECRET WAR. Accidentally dropped his whip near the 300m.

# RACE 9: THE JUNCTION HANDICAP - 1250 Metres (cont'd)

LAFARGUE (L. Riordan) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100m and was fined \$300. In determining penalty Stewards had regard for the totality of the use of the whip by L. Riordan and noted that he used his whip on 14 occasions over the final 100m of the race.

TAHNEE TRADITION (C. Murray) - fractious in the barrier. Underwent a pre-race veterinary examination and was deemed suitable to start.

MAGICLANE (A. Livesey) - awkward and slow to begin.
