RACE 1: TAB ADELAIDE CUP DAY - MONDAY MARCH 13TH HANDICAP - 1050 Metres

SIYATA (GB) (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

MISS MUCINNI (L. Neindorf) - raced keenly in the early and middle stages of the event.

ELSA'S PRIDE (J. Eaton) - hung in under pressure in the straight. Rider explained in relation to the mare's performance that it travelled well in the early and middle stages of the event; however, did not let down as she had anticipated, was inclined to hang in and was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

MY RUBY (J. Toeroek) - held up for clear running from the 400m until approaching the 100m when racing between MADAME BOLLI and ELSA'S PRIDE, which was hanging in. When questioned in relation to his riding of the mare over the concluding 100m, J. Toeroek explained that in his opinion there was a tight run between MADAME BOLLI and ELSA'S PRIDE; however, he was mindful of the racing manners of ELSA'S PRIDE and therefore he elected not to attempt that run given the proximity to the winning post. He added that in his opinion the mare would have finished in the same position regardless. Rider was advised in future circumstances to ensure he rides in a manner that does not invite question. Rider was reprimanded under AR131(b) for failing to ride his mount out to the finish.

ALOTAFUN (T. Voorham) - underwent a pre-race veterinary examination on arrival on course as it had not raced since December 2020 and was deemed suitable to race. Raced keenly in the early and middle stages of the event. Hung in under pressure in the straight. Near the 100m was obliged to alter course to the inside of STARLITE VALLEY.

RACE 2: FURPHY HANDICAP - 1200 Metres

The start of this event was delayed approximately three minutes to avoid a clash with an interstate event (Newcastle).



RACE 2: FURPHY HANDICAP - 1200 Metres (cont'd)

SPIN THE REWARD (L. McNeil) - jumped away awkwardly, shifted in and bumped SILENT SURRENTE.

BELLINGER (L. Lafferty) - laid out under pressure in the straight.

JET JITSU (B. Vorster) - near the 900m was severely hampered and lost its position when tightened onto SPIN THE REWARD as LOPE DE WOLF was taken in by SHEZ BETTY which shifted in when insufficiently clear. A post-race veterinary examination revealed no visible abnormalities.

LOPE DE WOLF (J. Toeroek) - near the 900m was inconvenienced and taken in onto JET JITSU by SHEZ BETTY, which shifted in when insufficiently clear.

SILENT SURRENTE (B. Price) - on jumping away was bumped by SPIN THE REWARD.

KENYAN WONDER (J. Opperman) – shortly after the start raced in restricted room between JET JITSU and SPIN THE REWARD for a short distance.

SHEZ BETTY (A. Livesey) - near the 900m shifted in when insufficiently clear onto LOPE DE WOLF, which was inconvenienced and taken in onto JET JITSU, which was severely hampered and lost its position when tightened onto SPIN THE REWARD. Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence at midnight on Saturday, 18 February 2023 and expire at midnight on Sunday, 26 February 2023, a period of four meetings. In determining penalty, Stewards took into account A. Livesey's record and her guilty plea. Hung in under pressure in the early part of the straight.

RACE 3: CHALK HILL WINES HANDICAP - 1100 Metres

KUSU (S. Tomlinson) - jumped away awkwardly. Over raced in the early and middle stages of the event.

MERCHANT BOSS (D. Tourneur) – jumped away very awkwardly and made contact with the inside of its barrier and as a result was slow to begin. Rider reported that it was his intention to settle further forward; however, he was unable to do so due to the way the gelding began. Over raced in the early and middle stages of the event.

FAR FROM DISCREET (L. Neindorf) - a post-race veterinary examination revealed no visible abnormalities.

PRETTY RELIABLE (NZ) (B. Vorster) - on jumping away lost its position when tightened onto MERCHANT BOSS as I'M A DEXSTAR shifted out. Hung out from the 600m and was awkwardly placed to the inside of OUT OF AFLICA from the 600m until the 400m. A post-race veterinary examination revealed no visible abnormalities.

FLASHY CZARINA (A. Livesey) - over raced in the early stages when being restrained.

SIXTEEN REASONS (T. Pannell) - slow to begin.

I'M A DEXSTAR (T. Voorham) - jumped away awkwardly and shifted out onto PRETTY RELIABLE (NZ).

RACE 4: BRIAN & VAL MACEY, HAPPY 67TH WEDDING ANNIVERSARY HANDICAP - 1050 Metres

EXTRA MILE (S. Tomlinson) - on jumping away lost its position when tightened between JAAZEB and HONGBAO, which both shifted ground. Laid in under pressure in the straight.

HONGBAO (B. Vorster) - jumped away awkwardly and shifted out onto EXTRA MILE. Held up for clear running from the entrance to the straight until near the 250m when racing between MCKEEVER and JAAZEB.

SEA WITNESS (A. Livesey) - jumped away awkwardly and was slow to begin. A post-race veterinary examination revealed no visible abnormalities.

RACE 4: BRIAN & VAL MACEY, HAPPY 67TH WEDDING ANNIVERSARY HANDICAP - 1050 Metres (cont'd)

MCKEEVER (J. Holder) - jumped away awkwardly

MANAGE THE CYCLE (E. Wong) - rider reported that the horse did not feel comfortable in its action during the event. A post-race veterinary examination revealed no visible abnormalities.

ZARACE (T. Voorham) - jumped away awkwardly and shifted out. Held up for clear running from the 400m until the 200m when racing between JAAZEB and SEA WITNESS and was obliged to shift out in an attempt to gain clear ground.

RACE 5: LIVE IN THE NOW FOUNDATION HANDICAP - 1200 Metres

DESIGNER CHEF (B. Price) - jumped away awkwardly. Approaching the 200m was disappointed when attempting a tight run between TERBIUM and ASTON RAPOVA, which rolled out. Thereafter became held up until the 100m and was obliged to shift out to obtain clear running.

ASTON RAPOVA (J. Toeroek) - raced keenly in the early and middle stages of the event. Approaching the 200m rolled out.

PICARGO (A. Livesey) - laid in under pressure in the straight.

KENTUCKY CASANOVA (L. Lafferty) - laid out under pressure in the straight. Near the 100m shifted out taking WONDERWOMEN wider. Rider was reminded of her obligations under AR131(a) and advised to keep her mounts straight when they commence to shift ground.

SMUGGLING (J. Potter) - a post-race veterinary examination revealed no visible abnormalities.

MORIALTA (J. Opperman) - jumped away awkwardly.

WONDERWOMEN (B. Vorster) - jumped away awkwardly.

Correct weight was delayed to allow B. Vorster (WONDERWOMEN) placed second to view the vision in the straight.

RACE 6: FLEURIEU MILK COMPANY HANDICAP - 1100 Metres

BAMYAN BUDDHA (J. Opperman) - raced wide without cover in the early stages. A post-race veterinary examination revealed no visible abnormalities.

HELLO LADIES (L. Lafferty) - jumped away awkwardly.

RUN AND TELL (S. Callow) – a post-race veterinary examination revealed the gelding to be lame in the near hind leg (2/5). Trainer, Mr J. O'Connor was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

ENDLESSLY (S. Tomlinson) - laid out under pressure in the straight.

HUNTLEY LADY (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

RACE 7: PREMIER'S PLATE (FORMERLY BIRTHDAY CUP) - 2019 Metres

The start of this event way delayed approximately three minutes to avoid a clash with an interstate event (Gold Coast).

TRALEE ROSE (NZ) (J. Holder) - rider explained in relation to the mare's performance that it travelled well during the early and middle stages; however, when asked to improve from near the 500m, TRALEE ROSE (NZ) failed to respond to his riding and was disappointing to the finish. A post-race veterinary examination revealed a haematoma on its off side shoulder. Trainer, Mr S. Wilde was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

RACE 7: PREMIER'S PLATE (FORMERLY BIRTHDAY CUP) - 2019 Metres (cont'd)

FAROOQ (J. Opperman) - difficult to load. Trainer, Ms S. Murphy was advised that a warning had been placed on the gelding in relation to its racing manners.

STARS OF CARRUM (H. Grace) - laid in under pressure in the straight.

WYCLIF (GB) (L. Riordan) - rider reported that the gelding did not feel comfortable in its action during the event. A post-race veterinary examination revealed no visible abnormalities.

THE MAP (J. Toeroek) - approaching the finish was awkwardly placed on the heels of FAROOQ and was obliged to be steadied.

BUSKER'S BALLAD (A. Livesey) - jumped away awkwardly. Raced keenly in the middle stages of the event.

RACE 8: GRAND SYNDICATES HANDICAP - 1600 Metres

The start of this event was delayed approximately two minutes to avoid a clash with an interstate event (Gold Coast).

HERE COMES LENNI (NZ) (B. Price) - held up for clear running from approaching the 400m until near the 300m.

PEWTER (T. Voorham) - on jumping away lost its position when tightened onto FAMOUS PRINCE by EQUAL BALANCE which shifted in.

BELMONT AVENUE (IRE) (B. Vorster) - rider explained that the gelding travelled well during the event; however, when asked for an effort inside the 600m, failed to respond to his riding, did not let down and was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

LAST GIRL LOVE (L. Riordan) - slow to begin.

BLOOD SWEAT TEARS (E. Boyd) - raced wide and without cover from the 1000m. Laid out in the straight. Lost its near hind plate during the event.

FAMOUS PRINCE (S. Logan) - jumped away awkwardly. Hung out from the 600m until shortly after the entrance to the straight. A post-race veterinary examination revealed no visible abnormalities.

SANTELMO FUEGO (J. Eaton) - contacted a perimeter fence on exiting the mounting yard. Underwent a pre-race veterinary examination on arrival at the barriers and was deemed suitable to race.

EQUAL BALANCE (S. Metcalfe) - jumped away awkwardly and shifted in onto PEWTER.

RACE 9: SKYCITY HANDICAP - 1800 Metres

BELLMAN (NZ) (C. Rawiller) - jumped away awkwardly and shifted out onto HALIFAX ROAD which was inconvenienced. Near the 800m shifted out taking HALIFAX ROAD out onto MORE SUGAR, which was inconvenienced. Rider was reminded of his obligations under AR131(a) and advised to take greater care when shifting ground in future. Rider reported that the saddle slipped back shortly after the start. A post-race veterinary examination revealed no visible abnormalities.

DIAMONDS ARE (E. Wong) - slow to begin approximately two to three lengths.

WHEELS (NZ) (L. Lafferty) – slow to begin approximately two to three lengths. Approaching the finish was obliged to be steadied when tightened onto GOOD GIRL BELLA as APPLIED shifted out. A post-race veterinary examination revealed no visible abnormalities.

GOOD GIRL BELLA (J. Opperman) - over raced in the early stages.



HALIFAX ROAD (A. Jordsjo) - On jumping away was inconvenienced when tightened onto MORE SUGAR by BELLMAN (NZ) which shifted out. Near the 800m was taken wider by BELLMAN (NZ) which shifted out, onto MORE SUGAR.

MORE SUGAR (B. Price) - raced wide and without cover from inside the 1000m. Near the 800m was inconvenienced as HALIFAX ROAD was taken out by BELLMAN (NZ) which shifted out.

SEAFARING (NZ) (H. Grace) - underwent a pre-race veterinary examination on arrival on course as it raced at Gawler on Wednesday, 8 February 2023 and was deemed suitable to race.

SHEMA (L. Neindorf) - underwent a pre-race veterinary examination on arrival on course as it raced at Gawler on Wednesday, 8 February 2023 and was deemed suitable to race.

APPLIED (D. Tourneur) – approaching the finish shifted out onto WHEELS (NZ), which was obliged to be steadied. Rider was severely reprimanded under AR131(a) and advised to take greater care in future.

YOUNG LARS (E. Boyd) - jumped away awkwardly and was slow to begin. Near the 1000m was awkwardly placed on the heels of BELLMAN (NZ) for a short distance.
