RACE 1: PPHS BENCHMARK 68 HANDICAP - 1200 Metres

TONY MONTANA (C. Tootell) - slow to begin and to muster early speed. Near the 150m was disappointed for a run on the inside of REYNAIRE and had to be checked. Continued to be awkwardly placed on the heels of REYNAIRE until near the 50m, clipped its heels, became unbalanced and checked again. Rider was advised she needs to make better decisions when attempting to improve inside a horse and in this case she persisted for the run, far too long, rather than restraining when it was clear the run was not going to eventuate. Due to her relative inexperience no direct action was taken other than to issue Apprentice C Tootell with a reprimanded under AR131(a) for careless riding.

REYNAIRE (J. Eaton) - rounding the home turn shifted out and briefly allowed a run for TONY MONTANA; however, shortly after shifted back in and closed that run, resulting in TONY MONTANA being disappointed for the run. Rider was reminded of her obligations under AR131(a) and advised to exercise more care in similar situations. Near the 50m TONY MONTANA clipped the heels of REYNAIRE resulting in REYNAIRE becoming unbalanced.

RACE 2: MIDFIELDS MAIDEN PLATE - 1000 Metres

HALF BACK DARCY (J. Maund) - refused to load. Acting on a report from the Starter, Stewards declared the gelding a late scratching at 1.34 pm. Co-trainer, Mr J. Hickmott was advised the gelding was now required to load without delay in an Official Barrier Trial prior to a future race.



RACE 2: MIDFIELDS MAIDEN PLATE - 1000 Metres (cont'd)

MISTER HENDERSHOT (B. Price) - near the 750m had to be eased when tightened between FAVASHEM and JEWEL DE LUNE, which was taken in by UNCHAINED LAD.

SIR ARMINIUS - refused to parade to the start. Stewards declared the gelding a late scratching at 1:29 pm. Trainer, Mr S. Cahill was advised that a warning had been placed on the gelding in relation to its pre-race manners.

UNCHAINED LAD (R. Milnes) - began awkwardly with its head up. Near the 750m shifted in onto JEWEL DE LUNE when insufficiently clear and tightened that horse in onto MISTER HENDERSHOT, which had to be eased. Rider was reprimanded under AR131(a) for careless riding and advised, in future, to take greater care when shifting ground.

WIRREALPA (H. Grace) - began awkwardly and shifted out. A post-race veterinary examination revealed no visible abnormalities.

FAVASHEM (J. Doyle) - laid in under pressure in the straight.

TERODIA (J. Potter) - began awkwardly and shifted out.

JEWEL DE LUNE (J. Eaton) - near the 750m was tightened between MISTER HENDERSHOT and UNCHAINED LAD, which shifted in.

RACE 3: TASCO PETROLEUM MAIDEN HANDICAP - 1430 Metres

POORME ASHOT (B. Price) - raced keen in the early and middle stages of the event. Between the 400m and 350m was held up behind SHAMROCK CLOVER, which was weakening.

LADY DE LUNE (K. Crowther) - raced three wide without cover for the majority of the event.

COLDENKIM (H. Grace) - slow to begin.

LADY OF SPLENDOUR (B. Wong) - underwent a pre-race veterinary examination on arrival on course as it raced at Bordertown on Sunday, 5 February 2023 and was deemed suitable to race.

JOHNNY CIGAR (E. Finnegan) - slow to begin. Raced wide throughout the event.

SHAMROCK CLOVER (J. Maund) - raced keen with its head up in the early and middle stages of the event and weakened noticeably from the 400m. A post-race veterinary examination revealed no visible abnormalities.

RACE 4: TRANS AUSTRALIAN CLASS ONE PLATE - 2000 Metres

DUKE OF ANJOU (B. Price) - near the 1700m drifted in, tightened QUIETLY SPOKEN (NZ) and then was shifted out to relieve the crowding and raced wide rounding the first turn.

KOOLATAH (NZ) (K. Crowther) - bumped at the start by JAJA DING DONG and in turn shifted in and bumped ZED LEPELIN.


PAINT THIS CITY (A. Jordsjo) - raced wide from the 1000m.

QUIETLY SPOKEN (NZ) (H. Grace) - raced keen in the early stages of the event. Near the 1700m was momentarily tightened by DUKE OF ANJOU. A post-race veterinary examination revealed no visible abnormalities.

JAJA DING DONG (J. Eaton) - began awkwardly, shifted in and bumped KOOLATAH (NZ) in onto ZED LEPELIN.

RAIDAWAY (C. Murray) - underwent a pre-race veterinary examination at the barriers and was found to be lame in the near foreleg (1/5) and was deemed unsuitable to race. Acting on this advice RAIDAWAY was declared a late scratching by order of Stewards at 2.44 pm. Trainer, Mr T. Gilcrist was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

ZED LEPELIN (C. Jones) - bumped at the start by KOOLATAH (NZ).



RACE 5: COOPERS RATING 0 - 58 HANDICAP - 1100 Metres

TWO ODD SOX (C. Tootell) - raced keen in the early and middle stages of the event. Near the 150m was held up behind EXALTED QUEEN and IN THE SUN and shifted in to obtain a clear run.

ARCHWAY TO HEAVEN (D Tootell (Snr)) - was eased near the 750m when racing between TWO ODD SOX and BOOK LAUNCH.

IN THE SUN (B. Wong) - bumped by INDIAN GAZELLE near the 150m.

INDIAN GAZELLE (B. Price) - shifted out near the 150m and bumped IN THE SUN.

MONTRE (S. Callow) - underwent a pre-race veterinary examination on arrival on course and was deemed suitable to race. When questioned in relation to the tactics in today's event, rider explained that from the wide gate she was instructed to take hold and obtain cover. A post-race veterinary examination revealed no visible abnormalities.

RACE 6: DIGIORGIO FAMILY WINES BENCHMARK 54 HANDICAP - 1200 Metres

REAL ROY (C. Murray) - shifted out to improve near the 200m.

FINAL CHANCE (D Tootell (Snr)) - slow to begin. Near the 200m became awkwardly placed on the heels of REAL ROY, which shifted out to improve. Near the 100m was tightened and had to be eased between REAL ROY and GEANDGE, which shifted in when insufficiently clear.

RANGER CEE JAY (C. Jones) - slow to begin.

TITAN I AM (J. Opperman) - raced keen in the early and middle stages of the event.

LET'S ATOM (B. Price) - raced keen in the middle stages of the event and near the 800m became awkwardly placed on the heels of TITAN I AM.

SUNNY GREEN (H. Grace) - when questioned in relation to the horse's performance, rider explained the mare never travelled and in his opinion was not suited to tight track and as a result performed poorly. A post-race veterinary examination revealed no visible abnormalities.

WILD TYCOON (D. Tournour) - began awkwardly. Shortly after the start shifted out and tightened OUR ELLIE ROSE (NZ) onto ARCHIE'S A STAR, which had to be steadied.

GEANDGE (J. Doyle) - raced wide throughout the event. Near the 100m shifted in when insufficiently clear onto FINAL CHANCE, which was tightened onto REAL ROY. Rider was severely reprimanded under AR131(a) for careless riding and advised to make a far better effort, in future, to relieve the pressure.

ARCHIE'S A STAR (A. Jordsjo) - underwent a pre-race veterinary examination on arrival on course and was deemed suitable to race. Shortly after the start had to be steadied when awkwardly placed on the heels of OUR ELLIE ROSE (NZ), which was taken out by WILD TYCOON.

RACE 7: MINIJUMBUK NARACOORTE CUP - 2000 Metres

THRILL KILL (C. Murray) - raced keen in the early stages of the event. Held up from the 450m until near the 350m behind DR DEE DEE.

WILD WILLY (J. Opperman) - a post-race veterinary examination revealed no visible abnormalities.

DOES IT (NZ) (J. Toeroek) - rider reported the gelding jarred up during the event and felt sore post-race. A post-race veterinary examination revealed the gelding to be lame in the near foreleg (3/5). Co-trainers, Mr R. Jolly and Ms C. Jolly were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

HASTA LA FIORENTE (E. Finnegan) - rider reported the gelding felt sore behind. A post-race veterinary examination revealed no visible abnormalities.



RACE 7: MINIJUMBUK NARACOORTE CUP - 2000 Metres (cont'd)

NASEEB (T. Voorham) - raced wide without cover for the majority of the event.

SESAR (B. Price) - raced keen in the early and middle stages of the event. Raced wide from the 850m. Laid in under pressure in the straight.

HAPPY ATOM (J. Eaton) - rider reported that the mare hung in throughout the event.

RACE 8: SE MOTOR COMPANIES BENCHMARK 58 HANDICAP - 1430 Metres

HASTA LA MISSILE (D. Tourneur) - raced keen in the early and middle stages of the event. Shifted out near the 250m to obtain a run and momentarily tightened CONNERMARA ROSE onto BATTLE MASTER. Approaching the 200m had to be steadied when awkwardly placed close to the heels of DUO PERNA which shifted out.

BYWONNER (F. Atkinson) - raced keen in the early and middle stages of the event.

DUO PERNA (H. Grace) - shifted out approaching the 200m when not quite clear of HASTA LA MISSILE which was steadied. Rider was severely reprimanded under AR131(a) for careless riding and advised to take more care, in future.

BATTLE MASTER (J. Potter) - raced keen in the early and middle stages of the event.
