Report on Race Meeting held at Port Lincoln Racecourse by the Port Lincoln Racing Club on Sunday, 19 February 2023

RACE 1: PORT LINCOLN CUP FASHIONS AT THE RACES MAIDEN HANDICAP (1) - 1350 Metres

TOORAK BLAZE (B. Wong) - fractious in its barrier. Trainer, B. Hull was advised that a warning had been placed on the gelding in relation to its barrier manners. Raced wide without cover throughout the event.

HONEY PERFECTION (K. Crowther) - raced green in the early stages of the event and shifted in abruptly. Continued to race green in the straight and brushed the rail on a couple of occasions.

COASTAL CRUZ (B. Wong) – put its head down as the start was effected and as a result lost considerable ground. Tailed the field for the remainder of the event and finished a distant last. A post-race veterinary examination revealed no visible abnormalities. Co-trainer, Mr J. Dunn was advised that a warning had been placed on the gelding in relation to its racing manners.

LOOKS LIKE A LADY (T. Voorham) - raced green rounding the home turn.

I'M A MILLENNIAL (E. Wong) – stood flat footed at the start, lost considerable ground and then bucked. The gelding was restrained shortly after and took no further competitive part in the event. A post-race veterinary examination revealed the gelding to be lame in the off hind leg (2/5). Firstly, Co-trainer, Mr J. Dunn was advised that a Veterinary Clearance would be required prior to a future jump-out or trial and secondly that the gelding must perform to the Stewards' satisfaction in an Official Barrier Trial prior to a future race.

LENTINO (B. Price) - slow to begin.



Correct weight was delayed to allow Stewards the opportunity to review the vision of the start in relation to COASTAL CRUZ and I'M A MILLENNIAL beginning poorly. After reviewing the vision, Stewards determined both horses to be starters in accordance with AR204.

RACE 2: MITRE 10 MAIDEN HANDICAP (2) - 1350 Metres

DANORO PRINCE (C. Murray) - difficult to load. Trainer, Mrs S. Williams was advised that a warning had been placed on the gelding in relation to its pre-race behaviour.

FOR BOOG'S SAKE (D. Caboche) – began awkwardly, shifted out and bumped RIGHT TURN. A post-race veterinary examination revealed no visible abnormalities.

CLUB RAIDER (A. Jordsjo) - raced wide without cover until near the 400m.

FOX DUNNETT (S. Tomlinson) - began awkwardly, shifted in and bumped SWIFT TERCEL.

SIR DALAPENA (S. Callow) - bumped at the start by ALMARHOE on its inside.

ALMARHOE (B. Wong) - began awkwardly, shifted out and bumped SIR DALAPENA.

FUNNY LEGS (J. Doyle) - near the 1000m laid in and tightened SWIFT TERCEL. Laid in under pressure in the straight.

RIGHT TURN (F. Atkinson) – buffeted at the start and lost ground between FOR BOOG'S SAKE, which shifted out and SWIFT TERCEL, which was taken in by FOX DUNNETT. Near the 300m was eased and shifted in across the heels of SWIFT TERCEL. Rider reported as a consequence of the start the gelding raced further back then intended and then failed to travel throughout the event. A post-race veterinary examination revealed no visible abnormalities.

SWIFT TERCEL (R. Milnes) - buffeted at the start between FOX DUNNETT, which shifted in and RIGHT TURN, which was taken out by FOR BOOG'S SAKE. Near the 1000m raced tight on the inside of FUNNY LEGS.

RACE 3: Q MECHANICAL MAIDEN PLATE - 1000 Metres

AYLLA'S PRIDE (S. Callow) - slow to begin and lost further ground when bumped by ROC THE WOLF (NZ).

KUBLAI (C. Murray) - rounding the home turn near the 400m was bumped by CYGNUS ATRATUS, which shifted out.

CYGNUS ATRATUS (D. Caboche) - shifted out near the 400m and bumped KUBLAI.

LOOKING AT YOU KID (B. Price) - rider was dislodged in the parade ring. B. Price was examined by the First Care Medical Personnel and was passed fit to fulfil his remaining engagements.

MURIWAI (T. Voorham) - raced green around the home turn and shifted out.

ROC THE WOLF (NZ) (K. Crowther) - began awkwardly, shifted out and bumped AYLLA'S PRIDE.

RUCARA (B. Wong) - had its tongue tie re-fitted upon arrival at the barriers. Became awkward near the 800m and dipped on a couple of occasions. Raced wide without cover throughout the event. A post-race veterinary examination revealed the gelding to be lame in the off foreleg (2/5). Trainer, Mr M. White was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

REBEL ATTACK (A. Jordsjo) - began awkwardly and lost ground.

RACE 4: EP SEAFOODS BENCHMARK 80 HANDICAP - 1000 Metres

MESSERSCHMITT (E. Wong) – held up for clear racing room between the 400m and 250m behind FALLOW and TRYGVE.

STRAWBERRY SWING (R. Milnes) - raced wide without cover for the majority of the event.

MARINA (H. Yuen) - raced wide without cover for the majority of the event.

RIVERSIDE ROCK (D. Caboche) - slow to begin.



RACE 5: THE PRAWN STORE RATING 0 - 54 HANDICAP (1) - 1250 Metres

MR WHITACRE (K. Crowther) - very slow to begin. Trainer, Mrs S. Williams was advised that a warning had been placed on the gelding in relation to its starting manners. Rider reported that the gelding failed to respond to her riding throughout the event and seemed disinterested. A post-race veterinary examination revealed no visible abnormalities. Trainer, Mrs S. Williams explained the gelding had worked well prior to today's event and appeared happy within itself and as such she was disappointed in its performance. Mrs Williams was requested to report any veterinary matters that may arise in the coming days that may have affected MR WHITACRE's performance in today's event.

TURF TAPPER (E. Wong) - re-saddle on arrival at the barriers. Laid in, in the straight and proved difficult to ride.

KURIMUZON (C. Murray) - raced wide without cover for the majority of the event.

ALKAAMEL (B. Price) – got its near hind leg up on the barrier partition just prior to the start being effected and had to be backed out of the gates to be inspected. Underwent a pre-race veterinary examination and was deemed suitable to race.

HARDASHIAN (F. Atkinson) – disappointed for a run near the 100m on the inside of PERFECT VOYAGE. Over the final 100m was restrained and was unable to be tested to the line. Rider explained that the gelding was off the bridle for the majority of the event; however, when placed under pressure on straightening, she was surprised in the manner that the gelding improved so quickly onto the heels of PERFECT VOYAGE and thereafter she awkwardly placed and unable to improve.

RACE 6: LETCHER MORONEY RATING 0 - 54 HANDICAP (2) - 1250 Metres

PRESCIENT (S. Tomlinson) - began awkwardly, shifted out and bumped ICE HUNT. Laid out under pressure in the straight.

ANGRY ANT (E. Wong) - when questioned the rider explained near the 800m the gelding changed legs, became unbalanced and lost ground.

REGAL ROCKET (C. Murray) - rider reported when he placed the gelding under pressure he became concerned with respiratory noises and as such he did not ride REGAL ROCKET out to the line. A post-race veterinary examination revealed a slow post-race recovery.

DAY FOR IT (NZ) (K. Crowther) – near the 800m when racing keen, became awkwardly placed on the heels of ANGRY ANT and got its head up when being restrained.

ICE HUNT (J. Doyle) - bumped at the start by PRESCIENT, got its head up and lost ground.

RACE 7: BUTTERFIELD FARMS DIRECT BENCHMARK 54 HANDICAP - 1000 Metres

EXPRESS MASTER (NZ) (D. Caboche) - had its tongue tie changed on arrival at the barriers. Trainer, Mr D. Carrison was fined \$100 under AR206(1) for using a tongue tie which was not approved under the National Equipment Register.

FRENCH ROCK (R. Milnes) – tightened at the start between SOMETHING FOXY and OPAL BEACH, which shifted out. Near the 200m had to be checked away from the heels of MAIDEN GRACE, which when hanging shifted out.

ROCK HARD (F. Atkinson) – a post-race veterinary examination revealed a slow post-race recovery. Trainer Mr. B. J. Cozamanis representing his father Mr B Cozamanis was reminded of his obligations in regards to ensuring a horse is in a fit condition under AR105(1)(a).



OPAL BEACH (K. Crowther) - began awkwardly, shifted out and tightened FRENCH ROCK onto SOMETHING FOXY.

STRIP CLUB (J. Doyle) - began awkwardly and shifted out.

RACE 7: BUTTERFIELD FARMS DIRECT BENCHMARK 54 HANDICAP - 1000 Metres (cont'd)

THE ALBION (NZ) (S. Callow) – hung out rounding the home turn and proved difficult to ride. Near the 150m was bumped by MAIDEN GRACE and taken out onto STAR PARFAIT.

WATERHEAD (S. Tomlinson) - hung out rounding the home turn.

STAR PARFAIT (E. Wong) - near the 150m was taken out by MAIDEN GRACE, which was bumped by THE ALBION (NZ).

MAIDEN GRACE (B. Wong) – shifted out near the 200m whilst hanging and tightened FRENCH ROCK which had to checked. Near the 150m shifted out and bumped THE ALBION (NZ) onto STAR PARFAIT. A post-race veterinary examination revealed the gelding to be lame in the near foreleg (4/5). Trainer, Mr T. Jolly was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race. Mr Jolly advised Stewards that the mare would now be retired.

RACE 8: MCDONALD'S PENINSULA CUP - 1750 Metres

GRINZINGER STAR (NZ) (C. Munro) - had its tongue tie re-fitted on arrival at the barriers.

RED DYNAMO (NZ) (R. Milnes) – hung in from the 700m. Co-trainer, Mr J. Dunn was advised that a warning had been placed on the gelding in relation to its racing manners.

SHINSEKI (B. Price) – had to be re-saddled on arrival at the barriers. Rider reported the gelding felt awkward in its action. A post-race veterinary examination revealed no visible abnormalities.

FORAOISE (S. Callow) - had its tongue tie re-fitted on arrival at the barriers.

FEARLESS AL (E. Wong) - reared at the start and lost ground. Approaching the 200m was severely checked when tightened by VANCOUVER VELVET, which was taken in by GIVEPEACE A CHANCE.

ONEMORE MARSHALL (D. Caboche) - raced keen in the early and middle stages of the event.

VANCOUVER VELVET (B. Wong) – raced keen in the early and middle stages of the event. Held up for clear racing room from the 450m until the 250m. Approaching the 200m was tightened for room on the inside of GIVEPEACE A CHANCE, had to be steadied and in turn tightened FEARLESS AL on its inside.

HOUSE SPOUSE (NZ) (E. Boyd) - laid in under pressure in the straight.

LEFTRIGHTGOODNITE (F. Atkinson) – had to be re-saddled on arrival at the barriers. Near the 600m raced tight on the inside of AHSO. A post-race veterinary examination revealed no visible abnormalities.

GIVEPEACE A CHANCE (J. Doyle) – rider pleaded guilty to a charge of careless riding under AR131(a) in that she allowed her mount to shift in approaching the 200m when insufficiently clear of VANCOUVER VELVET and tightened that horse in onto FEARLESS AL, which had to be checked. J. Doyle was suspended from riding in races for a period to commence midnight Sunday, 19 February 2023 and to conclude midnight Sunday, 26 February 2023, a period of three meetings. In determining penalty, Stewards took into account J. Doyle's very good record and her guilty plea.

RACE 9: EP TEMPERATURE CONTROL BENCHMARK 62 HANDICAP - 1350 Metres

EXALTED TRAVELLER (B. Wong) - began awkwardly with its head up.

SHORT STORIES (C. Murray) - reared at the start and lost ground.

VON GEORGE (E. Boyd) – raced awkwardly with its head up in the early stages of the event. Near the 350m became awkwardly placed on the inside of PAULO PACE.
