RACE 1: FURPHY HANDICAP - 1600 Metres

BLAZERRO (S. Tomlinson) - rider explained that the gelding travelled well in the early and middle stages of the event; however, when asked for an effort failed to respond to his riding and did not finish the race off. He added in his opinion BLAZERRO may have come to the end of its preparation. Lost its near fore plate during the event. A post-race veterinary examination revealed a slower than expected recovery.

THRILL KILL (C. Murray) - slow to begin. Laid out under pressure in the straight.

HERE COMES LENNI (NZ) (D. Tourneur) – at the entrance to the straight shifted out in an attempt to improve and in doing so contacted ALSVIOR, which held its line, resulting in HERE COMES LENNI (NZ) having difficulty obtain clear ground for a short distance.

ALSVIOR (J. Maund) - inconvenienced when contacted by HERE COMES LENNI (NZ) at the entrance to the straight.

DISAGREEABLE MISS (J. Eaton)- slow to begin.

RACE 2: FLEURIEU MILK COMPANY HANDICAP - 1100 Metres

OUTLAWS REVENGE (C. Rawiller) - laid in under pressure in the straight. Lost its off fore plate during the event.

PARSIFAL (NZ) (L. Neindorf) - laid in under pressure in the straight. Rider was reminded of his obligations under AR131(b) to ride his mounts out to the end of the race.

RACE 2: FLEURIEU MILK COMPANY HANDICAP - 1100 Metres (cont'd)

ANOTHER AWARD (T. Voorham) - jumped away awkwardly and shifted out. Raced keenly in the early and middle stages of the event. Laid out rounding the home turn. Lost its near hind plate during the event.

ZORRO'S DREAM (M. Lloyd) - raced wide without cover throughout the event.

RACE 3: QUAYCLEAN THREE-YEAR-OLD MAIDEN PLATE - 1100 Metres

FLYIN' FOR US (C. Murray) - near the 30m was brushed by PINCHBECK, and then laid back in and continued to brush PINCHBECK.

KARAKA KIWI (NZ) (J. Maund) - shifted in on jumping away and contacted PARTY PRINCESS.

LINES OF GLORY (S. Tomlinson) - shifted out on jumping away onto CARARADA.

PINCHBECK (S. Metcalfe) - laid out over the concluding 100m of the event and near the 30m shifted out slightly and brushed FLYIN' FOR US, which then laid back and continued to brush with the gelding.

WEATHER GOD (J. Toeroek) - shifted in on jumping away and had to momentarily be steadied off of the heels of FLYIN' FOR US. Raced keenly in the early and middle stages of the event. Lost its off fore plate during the event.

WHISKY SOUR (L. Neindorf) - Stewards acceded to a request from Trainer, Mr D. Carrison, that the gelding be permitted to wear pre-race ear muffs. Jumped away awkwardly and shifted out contacting ZEBEDEE SPRINGS. Rider reported that he had become concerned with the gelding's action behind from the entrance to the straight and for this reason did not ride it out to the finish. A post-race veterinary examination revealed no visible abnormalities. On Monday, 27 February 2023 trainer, Mr D. Carrison, advised Stewards that on return to his stable the gelding had a laceration and minor swelling to its off foreleg. He advised that it is the stable's intention to continue with its preparation.

CARARADA (L. Lafferty) - rider was given permission to ride the gelding at 54.0kg rather than her minimum riding weight of 53.0kg. L. Lafferty was advised of the requirements in South Australia to claim down to her minimum riding weight. Brushed on jumping away.

PARTY PRINCESS (T. Voorham) - contacted on jumping away. Held up from near the 300m until near the 200m.

ROSE RING (A. Jordsjo) - raced wide without cover throughout the event. Near the 700m was inconvenienced when taken wider by SOOREEDA. Near the 100m laid in slightly onto SOOREEDA. A post-race veterinary examination revealed no visible abnormalities.

SOOREEDA (E. Finnegan) – near the 700m shifted out and away from FLYIN' FOR US onto ROSE RING. Near the 100m had to be momentarily steadied and alter course when ROSE RING laid in slightly.

ZEBEDEE SPRINGS (B. Price) - contacted on jumping away. Raced greenly in the straight. A post-race veterinary examination revealed no visible abnormalities.

RICH LADY (M. Lloyd) - raced keenly in the early and middle stages of the event.

Correct weight for this event was delayed to allow C. Murray (FLYIN' FOR US) to view the vision in the straight. After doing so C. Murray lodged an objection against PINCHBECK (S. Metcalfe) being declared the third placegetter on the grounds of alleged interference over the concluding 100m of the event. After considering the evidence, viewing the vision and acting on their own observations Stewards dismissed the protest.



RACE 4: TAB ADELAIDE CUP DAY - MONDAY MARCH 13TH HANDICAP - 2000 Metres

WESTERN SUN (C.Murray) - raced wide without cover throughout the event.

RACE 4: TAB ADELAIDE CUP DAY - MONDAY MARCH 13TH HANDICAP - 2000 Metres (cont'd)

DIXIE WHISTLER (M. Lloyd) - near the 1800m shifted in onto SANTELMO FUEGO, which had to be steadied. Rider was reprimanded under AR131(a) for careless riding. Laid out rounding the home turn and under pressure in the straight.

SANTELMO FUEGO (J. Eaton) – near the 1800m had to be steadied when DIXIE WHISTLER shifted in. Had difficulty obtaining clear ground from near the 300m and approaching the 200m became held up for a short distance.

WHEELS (NZ) (T. Pannell) - slow to begin.

CLASSIC HOLLY (T. Voorham) - a post-race veterinary examination revealed no visible abnormalities.

RACE 5: PIKE & JOYCE HANDICAP - 1600 Metres

IMPOSING SUSPECT (NZ) (C. Hefel) - held up from near the 400m until near the 300m.

FAMILY ADDITION (L. Lafferty) – a post-race veterinary examination revealed the gelding to be lame in the off hind leg (2/5). Trainer, Mr M. Huxtable, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

PERLUBIE BEACH (J. Eaton) - laid out under pressure in the straight.

SWAMP VIXEN (J. Toeroek) - near the 1000m improved onto the heels of FAMILY ADDITION and had to be steadied for a number of strides.

SEAFARING (NZ) (H. Grace) - laid out under pressure in the straight.

TWICE FORGOTTEN (D. Caboche) - raced keenly in the early and middle stages of the event.

RACE 6: GRAND SYNDICATES HANDICAP - 1200 Metres

The start of this event was delayed approximately three minutes to avoid a clash with an interstate event.

OUR AUGUST ROSE (C. Hefel) - hampered on jumping away when tightened onto TEA RAV (NZ) by STARLITE REBEL.

SHEZ BETTY (S. Tomlinson) - shifted in on jumping away onto DASH IT. Raced wide without cover throughout the event.

STAR ESPRESSO (M. Lloyd) - hampered on jumping away. A post-race veterinary examination revealed a slower than expected recovery.

WHENTHEDEELINGSDUN (S. Logan) - turned its head as the start was effected and as a result was slow to begin. Rider reported that due to the mare stepping away slow she had settled further back than she had anticipated.

STORM VOYAGER (L. Neindorf) - near the 150m shifted out onto IRASCIBLE MISS, which was inconvenienced. Rider reminded of his obligations when shifting ground.

WINE FROM TEARS (J. Toeroek) - underwent a pre-race veterinary examination and was deemed suitable to start. A post-race veterinary examination revealed no visible abnormalities.

DASH IT (T. Voorham) - inconvenienced on jumping away.

IRASCIBLE MISS (T. Nugent) - shifted out on jumping away onto STAR ESPRESSO. Near the 150m was inconvenienced when tightened onto WHENTHEDEELINGSDUN by STORM VOYAGER which shifted out. A post-race veterinary examination revealed no visible abnormalities.

RACE 6: GRAND SYNDICATES HANDICAP - 1200 Metres (cont'd)

STARLITE REBEL (J. Potter) - shifted out on jumping away onto OUR AUGUST ROSE. Raced keenly in the early and middle stages of the event.

Correct weight was delayed to allow S. Logan (WHENTHEDEELINGSDUN) and trainer, Mr D. Jolly, to view the vision of the start.

RACE 7: GLEN DOROL'S 50TH BIRTHDAY IN DIVA BAR HANDICAP - 1050 Metres

HONGBAO (C. Rawiller) - a post-race veterinary examination revealed a slower than expected recovery.

JEAN VALJEAN (B. Price) - rider reported that the gelding raced flat. A post-race veterinary examination revealed no visible abnormalities.

JAAZEB (L. Neindorf) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

HELLO LADIES (J. Opperman) - held up from the entrance to the straight until near the 200m.

NALEIGH (J. Potter) - had difficulty obtaining clear ground from near the 400m until inside the 100m.

ZARACE (T. Pannell) – near the 800m shifted out and away from MISS EUROZONE onto SPORTS CHOICE.

SHIRSHOV (J. Toeroek) - had its head down as the start was effected and as a result jumped away awkwardly and was slow to begin. Raced keenly in the early and middle stages of the event. Had difficulty obtaining clear ground from the entrance to the straight until near the 200m.

MISS EUROZONE (E. Finnegan) - laid out onto ZARACE near the 800m. Continued to lay out for the remainder of the event.

SPORTS CHOICE (C. Hefel) - near the 800m had to be steadied when ZARACE was taken out into its running line.

RACE 8: LORD REIMS STAKES - 2600 Metres

STAFFORD'S LAD (J. Noske) – approaching the 200m shifted out abruptly to the outside of TEAM CAPTAIN (IRE). When questioned in relation to his reasoning for doing so rider explained that he had formed the opinion that the run between THE MAP and TEAM CAPTAIN (IRE) may close due to both runners commencing to shift ground slightly and felt rather than persist he would be better suited in shifting to the outside of TEAM CAPTAIN (IRE) to ensure he had clear ground to the finish.

FAROOQ (J. Opperman) - a post-race veterinary examination revealed no visible abnormalities.

SEBONNA (C. Murray) - laid in under pressure in the straight.

CLEVER MAN (B. Price) - raced wide without cover throughout the event. Rider explained that he was unable to obtain cover during the event and that the gelding was off the bridle throughout. He added that in his opinion CLEVER MAN may have come to the end of its preparation. A post-race veterinary examination revealed no visible abnormalities.

THE MAP (J. Toeroek) - rider explained that the mare travelled well throughout the event; however, when asked for an effort at the entrance to the straight it did not let down as anticipated and was disappointing to the finish. A post-race veterinary examination revealed a slower than expected recovery.

RACE 9: SKYCITY HANDICAP - 1200 Metres

The start of this event was delayed by approximately five minutes.

MONTEPULCIANO (S. Tomlinson) - inside the 300m was disappointed when attempting a run between TWO TIME TWICE, which shifted out slightly, and PIVOTAL FORCE, which laid in, resulting in the gelding being unable to obtain clear ground for several strides.

LOVE MAGIC (J. Opperman) - near the 900m had to be steadied when forced to race in restricted room between the heels of MONTEPULCIANO, which shifted out slightly at the same time as PIVOTAL FORCE shifted in.

BAMYAN BUDDHA (C. Rawiller) - raced wide without cover throughout the event, and was inclined to shift about under pressure in the straight.

TONY MONTANA (T. Pannell) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

TWO TIMES TWICE (S. Logan) – inconvenienced on jumping away. Raced keenly in the early and middle stages of the event. Had difficulty obtaining clear ground from near the 400m until inside the 200m.

LORD MORTON (B. Price) - shifted in on jumping away onto TWO TIMES TWICE.

MASTER AT ARMS (NZ) (J. Toeroek) - had difficulty obtaining clear ground from near the 400m until the 100m.

TALES OF CONFLICT (C. Murray) – fractious in the barriers after being loaded and became cast. Underwent a pre-race veterinary examination and was deemed unsuitable to race. Acting on this advice Stewards declared TALES OF CONFLICT a late scratching at 5.24pm. Co-trainers, Mr G. Richards & Mr D. Moyle, were advised that the gelding would now be required to complete an Official Barrier Trial to the satisfaction of Stewards prior to a future race start. Mr Richards & Mr Moyle were further advised that a Veterinary Clearance would be required prior to a future jumpout, trial or race start.

FLIGHT DECK (NZ) (L. Neindorf) - which was in an adjoining stall to TALES OF CONFLICT underwent a pre-race veterinary examination and was deemed suitable to race. Rider was examined by the First Care Medical personnel and was passed fit to fulfil his engagement.

PIVOTAL FORCE (M	I. Lloyd) - laid ir	n throughout the event

Apprentice B. Price failed to provide his winning rides book prior to weighing out for his first ride of the day and was reprimanded under AR143(12)(b). In addition, B. Price was reminded of his obligations and cautioned under AR229(i)(h) in relation to making false or misleading statements.

RACE 9: PFD FOODS HANDICAP - 1400 Metres

TONGSAI BOSS - Trainer, Mr J Hyam, advised Stewards on Friday 24 February 2023, that an inspection by his stable veterinarian failed to reveal any abnormalities. He further added the stable will continue on with the geldings preparation.
