Racing SA Ltd Stipendiary Stewards' Report

Report on Race Meeting held at Penong Racecourse by the Penong Racing Club on Saturday, 11 March 2023



Stewards: C. Deakin (A/Chairman), B. Jarman (MT) (Cadet Steward) P. Dearman (F) & G.

TRACK: Dirt/Good (More loosened surface than fast, some kickback may be evident)

RAIL: True

WEATHER: Fine

RACE 1: CHEETHAM SALT / LETCHER AND MORONEY / CBAS BENCHMARK 52 TROPHY - 1000 Metres

ALCANNABIE (H. Yuen) - difficult to load. Trainer, Mr T. Haddy, was advised that a warning had been placed on the mare.

REAL ROY (S. Fawke) - jumped away awkwardly and as a result was slow to begin. Laid in, in the straight. Rider explained that the gelding never travelled during the event, and when placed under pressure from the 400m failed to respond to his riding. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: HELEN MAHAR MEMORIAL MAIDEN PLATE - 1200 Metres

TYPAR (H. Yuen) - jumped away awkwardly and as a result was slow into stride. Laid out under pressure in the straight. Rider was reprimanded under AR132(7)(i) in that she used her whip in consecutive strides.

RACE 3: ILUKA / KALARI / WEST COAST FUEL BENCHMARK 56 HANDICAP - 1200 Metres

GEANDGE (S. Fawke) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100m and was fined \$200. In determining penalty Stewards had regard for the totality of the use of the whip by S. Fawke and noted that he used it on twelve occasions over the final 100m of the event.

RACE 4: PENONG FAR WEST FARMERS CUP - 1600 Metres

ABLE WARRIOR (Z. Lloyd) - laid in, in the straight. Rider accidentally dropped her whip near the 300m.

RACE 5: GRA / PENONG HOTEL BENCHMARK 52 TROPHY - 1400 Metres

SPANISH COURAGE (Z. Lloyd) - laid in throughout the event.

PRINCESS SALLY (S. Fawke) - rider explained that the mare travelled well in the early and middle stages of the event; however, failed to let down in the straight. A post-race veterinary examination revealed no visible abnormalities.
