Report on Race Meeting held at Port Lincoln Racecourse by the Kimba Racing Club on Sunday, 19 March 2023

RACE 1: VENNING BROS KIMBA & VENNINGS AUTO ELECTRICS MAIDEN PLATE - 1000

A FEW GOOD MEN (D. Caboche) - shortly after the start shifted out onto LEMON TART.

ALWAYS SOMETIMES (S. Fawke) - stable employee, Mr W. Hornhardt, and Trainers representative Mr S. Drewitt, were advised that the Elastoplast bandage applied to the gelding's near hind leg is required to be stitched in accordance with the National Gear Register.

JUSTEDEE (S. Tomlinson) - shortly after the start shifted in onto LEMON TART.

LEVEE (Z. Lloyd) - raced wide without cover throughout the event.

TANE TOA (NZ) (R. Milnes) - laid out under pressure in the straight.

LEMON TART (B. Price) - shortly after the start lost its position when tightened between A FEW GOOD MEN and JUSTEDEE, which both shifted ground.

RACE 2: ELDERS INSURANCE BENCHMARK 78 HANDICAP - 1210 Metres

The start of this event was delayed approximately one minute owning to a delay with an interstate race.



RACE 2: ELDERS INSURANCE BENCHMARK 78 HANDICAP - 1210 Metres (cont'd)

AS I PLEASE (S. Tomlinson) – jumped away awkwardly. Raced keenly in the early and middle stages of the event. Near the 150m rider stopped riding. Rider reported that the gelding raced greenly and awkwardly during the event, may not have handled the track layout, and did not feel comfortable in its action. A post-race veterinary examination revealed the mare to be lame in the off hind leg (2/5). Co-trainers, Mr J. Dunn and Ms K. Bishop, were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

BRAMFIELD (R. Pearson) – underwent a pre-race veterinary examination on arrival on course as it had not raced since April 2022 and was deemed suitable to start. Inside the 1000m dipped, shifted out and became awkward on the heels of TRYGVE. Trainer, Mr D. Carrison, was advised that the Elastoplast applied to the mare's leg was required to be stitched in accordance with the National Gear Register.

MESSERSCHMIT (R. Milnes) - raced wide without cover in the early stages of the event.

RACE 3: THE MARINA HOTEL BENCHMARK 54 HANDICAP - 1210 Metres

CALL ME HERBIE (A. Livesey) - rider reported that she was obliged to settle further back in the event due to the gelding's barrier draw and the early formation of the field.

PRESCIENT (Z. Lloyd) - co-trainer, Mrs J. Branford, reported to Stewards that the gelding was lame in the off foreleg prior to being loaded on the float and would be unfit to race. Acting on this advice Stewards declared PRESCIENT a late scratching at 12.10 pm. Mrs J. Branford was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

DAY FOR IT (NZ) (S. Tomlinson) – at the entrance to the straight, when laying out, shifted out onto THE MASTER, which was obliged to be steadied. Rider reported that the gelding laid out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

PERFECT ZED (K. Crowther) - on arrival at the barriers underwent a pre-race veterinary examination and was deemed suitable to start. A post-race veterinary examination revealed no visible abnormalities.

THE MASTER (D. Caboche) - at the entrance to the straight was obliged to be steadied when tightened onto PERFECT ZED as DAY FOR IT (NZ), which was laying out, shifted out. Thereafter, was held up for clear running between DAY FOR IT (NZ) and CELERITATE REGEM until approaching the 100m where it shifted in, in an attempt to obtain clear running.

I'M OH SO PRETTY (B. Wong) - slow to begin.

VON GEORGE (H. Yuen) – over-raced in the early and middle stages of the event and between the 900m and 600m was awkwardly placed on the heels of CELERITATE REGEM and lost ground when being restrained. A post-race veterinary examination revealed the gelding to have gotten its tongue over the bit.

Following this event rider, R. Milnes, was examined by the First Care Medical personnel who reported that she had been stung by a bee. After continuing assessment R. Milnes was ruled unfit to ride in the next race and would be reassessed on a race by race basis.

RACE 4: RITOBY ENGINEERING BENCHMARK 58 HANDICAP - 1000 Metres

STRAWBERRY SWING (Z. Lloyd) - inclined to lay in under pressure in the straight.

EXPRESS MASTER (NZ) (C. Murray) - shortly after the start was hampered when tightened onto FREE WILMA by LADY SILVAIR.

CEECEETEEVEE (R. Pearson) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

LADY SILVAIR (C. Munro) - kicked by another runner behind the barriers. Underwent a pre-race veterinary examination and was deemed suitable to start. Shortly after the start shifted in onto EXPRESS MASTER (NZ).

RACE 4: RITOBY ENGINEERING BENCHMARK 58 HANDICAP - 1000 Metres (cont'd)

OPAL BEACH (S. Fawke) - shortly after the start bumped with FREE WILMA.

FREE WILMA (A. Livesey) - shortly after the start was hampered when tightened between OPAL BEACH and EXPRESS MASTER (NZ), which was taken in.

R. Milnes was re-examined by the First Care Medical personnel and was passed fit to fulfil her remaining engagements.

RACE 5: WEST COAST BITUMEN BENCHMARK 62 HANDICAP - 1350 Metres

EXALTED TRAVELLER (A. Livesey) - laid in under pressure in the straight.

DIAMONDS ARE (Z. Lloyd) - slow to begin.

HE'S ABEL (R. Milnes) - inside the 400m was awkwardly placed on the heels of BARON OF BEDFORD (NZ), which had commenced to weaken, for a number of strides and as a result lost ground.

BARON OF BEDFORD (NZ) (B. Price) – near the 1000m rolled in onto ARTFUL AMBITION. Weakened from near the 500m. Rider explained that the gelding travelled well in the early and middle stages; however, when asked for an effort near the 600m the gelding failed to respond to his riding and weakened quickly from the 500m. A post-race veterinary examination revealed a slower than expected recovery and a laceration to the off hind pastern.

ARTFUL AMBITION (C. Munro) – over-raced in the early and middle stages and near the 1000m had to be eased when awkwardly placed on the heels of BARON OF BEDFORD (NZ), which rolled in

ONWARD (B. Wong) - underwent a pre-race veterinary examination on arrival on course and was deemed suitable to start. A post-race veterinary examination revealed no visible abnormalities.

RACE 6: EP LIVESTOCK & REAL ESTATE CLASS TWO HANDICAP - 1350 Metres

The start of this event was delayed approximately one minute.

KUBLAI (C. Murray) - hung in under pressure in the straight. Rider explained that he had become concerned with the gelding's action over the concluding stages of the event, and for this reason had elected not to ride KUBLAI out in his normal manner. A post-race veterinary examination revealed no visible abnormalities.

DANTELA (NZ) (B. Price) - slow to begin.

ORIEDOS (A. Livesey) - slow to begin. Approaching the 1000m was obliged to be restrained when awkwardly placed on the heels of BEAU DAN.

SON OF AKEED (B. Wong) - raced keenly in the early and middle stages.

TALLU (C. Munro) - approaching the 1000m laid in and shifted in onto BEAU DAN, which was obliged to be eased momentarily.

REGAL ROCKET (Z. Lloyd) - required to have it tongue tie refitted on arrival at the barriers.

AYLLA'S PRIDE (S. Fawke) – Stewards permitted S. Fawke to ride the gelding 0.5kg over its allocated weight of 54.0kg. Rider explained in relation to the gelding's improved performance that it travelled well in the early stages; however, was under hard riding from the 800m and was ridden aggressively from that point on and finished the event off strongly. Trainer, Mrs A. Harder, explained in relation to the gelding's improved performance that this preparation she was able to work the gelding consistently due to the track maintenance being finished and therefore having consistent access to all facilities. She added that AYLLA'S PRIDE benefitted from its first two runs back in this preparation, and also was better suited to racing over the greater distance. She stated that it was her expectation that AYLLA'S PRIDE would run well in today's event and be right in the mix come the finish.

RACE 6: EP LIVESTOCK & REAL ESTATE CLASS TWO HANDICAP - 1350 Metres (cont'd)

BEAU DAN (H. Yuen) - approaching the 1000m was obliged to be eased momentarily as TALLU shifted in.

RACE 7: MCDONALD FAMILY 110TH KIMBA CUP - 1960 Metres

The start of this event was delayed approximately two minutes initially due to an interstate delay.

GRINZINGER STAR (NZ) (C. Munro) - slow to begin. Raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

MIDNIGHT BRAWLER (NZ) (C. Murray) - laid out under pressure in the straight.

DEXTER YOU DEVIL (K. Crowther) - slow to begin. Approaching the 1000m bumped with VANCOUVER VELVET on a number of occasions.

GRINZINGER ALLEE (NZ) (B. Price) - rider was reminded of his obligations in relation to AR132(7)(a)(i) in not using the whip in consecutive strides.

AHSO (B. Wong) - approaching the 200m attempted a tight run to the inside of ONEMORE MARSHALL which was weakening, and was obliged to be steadied and shift out.

VANCOUVER VELVET (A. Livesey) - approaching the 1000m bumped with DEXTER YOU DEVIL on a number of occasions.

HOUSE SPOUSE (NZ) (E. Boyd) - inclined to lay in under pressure in the straight.

ONEMORE MARSHALL (D. Caboche) - a post-race veterinary examination revealed no visible abnormalities.

NEAR MAGIC (S. Fawke) - Stewards permitted S. Fawke to ride the gelding 0.5kg over its allocated weight of 54.0kg. Slow to begin.

CLUB RAIDER (H. Yuen) – fractious in the barrier after being loaded. Underwent a pre-race veterinary examination and found to have a laceration to its off hind stifle and therefore was deemed unsuitable to start. Acting on this advice Stewards declared CLUB RAIDER a late scratching at 4:35pm. Trainer, Mrs A. Harder, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start. Mrs Harder was also advised that a warning had been placed on the gelding in relation to its barrier manners.

RACE 8: LIENERT ENGINEERING 'BUD' WOOLFORD MEMORIAL BENCHMARK 58 HANDICAP - 1750 Metres

SHINSEKI (A. Livesey) - hung in under pressure in the straight.

FEARLESS AL (R. Pearson) - jumped away awkwardly. Near the 1400m rider dropped her whip. Near the 1100m, when being restrained off the heels of TIAMAT, shifted in onto SHEMA.

YEAH YEAH NAH (D. Caboche) – rider explained in relation to the mare's poor performance that it travelled well in the early and middle stages of the event; however, from the 800m was off the bridle and commenced to weaken despite his efforts. He added that YEAH YEAH NAH did not feel comfortable in its action. A post-race veterinary examination revealed the mare to be lame in the near foreleg (2/5). Trainer, Mr D. Carrison, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start. Mr Carrison advised that the mare would now be spelled.

SHEMA (S. Tomlinson) - near the 1100m raced in restricted room between FEARLESS AL, which rolled in, and ROYAL LANDING, was obliged to be restrained and as a result became awkward for a number of strides.

RACE 8: LIENERT ENGINEERING 'BUD' WOOLFORD MEMORIAL BENCHMARK 58 HANDICAP - 1750 Metres (cont'd)

OUR JOURNEYMAN (R. Milnes) – co-trainer, Mr J. Dunn, advised Stewards that he had failed to scratch the gelding by the required time. Stewards withdrew OUR JOURNEYMAN at 9.00am. Mr Dunn explained that when he withdrew ANGRY ANT prior to scratching time he understood he had also scratched OUR JOURNEYMAN; however, after some time he was notified that the gelding was remained in the field and immediately contacted the Stewards. Mr Dunn pleaded guilty to a charge under LR19.1 and the Training partnership was fined \$100. In assessing penalty Stewards took into account that the failure to scratch the gelding cost the first emergency a start in the event. Stewards also noted that this was Mr Dunn's first offence under this rule.

ROYAL LANDING (E. Boyd) - near the 1100m raced in restricted room to the inside of SHEMA, which was taken in, and was awkwardly placed for a number of strides. Near the 1000m dipped.

SHOWBAG (J. Doyle) - raced wide without cover. Rider reported that the gelding made abnormal respiratory noises. A post-race veterinary examination revealed no visible abnormalities.
