

Racing SA Ltd Stipendiary Stewards' Report

Report on Race Meeting held at Morphetville Parks
Racecourse by the South Australian Jockey Club on
Saturday, 18 March 2023

TRACK: Good 4 (Track with some give in it)

RAIL: Out 6 metres 1000 metres to Winning Post, out 3 metres remainder

WEATHER: Fine

RACE 1: ADELAIDE GALVANISING INDUSTRIES HANDICAP - 2250 Metres

DIXIE WHISTLER (L. Neindorf) - laid out rounding the home turn and under pressure in the straight.

ANOTHER FREE GLASS (S. Payne) - a post-race veterinary examination revealed the gelding to be lame in the near foreleg (2/5). Co-trainers, Ms S. & Mr J. Jaensch were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

HAPPY ATOM (E. Finnegan) - stood flat footed and was slow to begin. Laid in under pressure over the concluding 600m of the event.

STOCKED AND LOADED (NZ) (K. Crowther) - laid out under pressure in the straight.

RACE 2: PETER ELBERG FUNERALS HANDICAP - 1550 Metres

The start of this event was delayed approximately two minutes as a result of LOOKS LIKE A LADY requiring a pre-race veterinary examination.

LOOKS LIKE A LADY (L. Lafferty) - fractious in its barrier after being loaded. Underwent a pre-race veterinary examination and was deemed suitable to race. Co-trainers, Mr G. Richards and Mr D. Moyle were advised that a warning had been placed on the filly in relation to its barrier manners. Raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

MAGICLANE (D. Caboche) - raced keenly in the early and middle stages of the event.

QUEBECOIS (J. Eaton) - jumped away awkwardly and was slow to begin.

WHOSEZOU (A. Livesey) - raced keenly in the early and middle stages of the event. Had difficulty obtaining clear ground over the concluding 50m of the event when PORT ROYAL shifted out slightly into its running line.

SOARLIKEANEAGLE (S. Fawke) - slow to begin. Unable to obtain clear ground over the concluding 200m of the event.



RACE 3: THOMAS FARMS HANDICAP - 1000 Metres

The start of this event was delayed approximately one minute to avoid a clash with an interstate event.

DARING MOVE (J. Toeroek) - laid out under pressure in the straight.

RACE 4: PFD FOODS MAIDEN PLATE - 1250 Metres

FANTASTIC HOST (D. Caboche) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

LINES OF GLORY (K. Crowther) - shortly after the start had to be steadied when tightened between VEE ROD (NZ) AND FANTASTIC HOST, which both shifted ground slightly. A post-race veterinary examination revealed no visible abnormalities.

PINCHBECK (S. Metcalfe) - raced keenly in the early and middle stages of the event.

BREEZE BENDER (J. Maund) - raced fiercely in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities. Trainer, Mr J. O'Loughlin was advised that the mare would be required to complete an Official Barrier Trial to the satisfaction of Stewards prior to accepting for a future race.

WHO'S AFRAID (S. Fawke) - laid out under pressure in the straight.

RACE 5: QUAYCLEAN HANDICAP - 1000 Metres

WINNING REVOLUTION (L. Lafferty) - raced keenly in the early and middle stages of the event. Laid out under pressure in the straight.

REALTIN (S. Tomlinson) - hung in throughout the event. A post-race veterinary examination revealed no visible abnormalities.

ROXY BLUE (J. Potter) - laid out over the concluding 150m.

VAMPIRE SLAYER (J. Opperman) - near the 150m altered course to the outside of ROXY BLUE to obtain clear ground when that mare rolled in slightly.

LAMOREE (J. Toeroek) - laid out under pressure in the straight.

STREET HUSTLER (D. Tourneur) - rider was reminded of his obligations under AR131(b) in relation to riding his mounts out to the finish.

YIP YIP YIP (A. Livesey) - jumped away awkwardly and was slow into stride.

RACE 6: GRAND SYNDICATES HANDICAP - 1250 Metres

JENKINS (G. Lo) - laid out under pressure over the concluding 100m.

LOVE MAGIC (J. Holder) - had difficulty obtaining clear ground from the entrance to the straight until inside the 300m.

STARLITE VALLEY (C. Jones) - near the 1000m shifted in onto DECIBELLES, which was forced to steady and got its head up when it improved onto that mare's heels. Rider was reprimanded under AR131(a) and advised, in future, to make a greater effort to keep her mounts straight.

SIAMESE (L. Lafferty) - laid out making the turn near the 600m.

SIXFOOTONE (E. Finnegan) - late scratching by order of the Stewards at 11.00am acting on confirmed advice from Trainer, Mr J. Macmillan that the horse had an elevated temperature and would be unfit to race.





RACE 6: GRAND SYNDICATES HANDICAP - 1250 METRES (cont'd)

BARBALINE (K. Crowther) - shifted in shortly after the start and had to be steadied off the heels of TWO TIMES TWICE, which shifted out slightly. Raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

JOURNEY TO PETRA (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

DECIBELLES (A. Livesey) - raced wide without cover throughout the event. Raced keenly in the early and middle stages of the event and near the 1000m improved onto the heels of STARLITE VALLEY, which shifted in, had to be steadied and in doing so got its head up for a number of strides.

RACE 7: FLEURIEU MILK COMPANY HANDICAP - 1400 Metres

KIKI EXPRESS (D. Tourneur) - raced wide without cover throughout the event.

MORE REWARD (T. Pannell) - near the 500m commenced to shift out to improve and in doing so took KARAKA KIWI (NZ) out onto HOLMES, which was forced to check when taken out across the heels of SHARMA PRINCESS (NZ). Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence at the conclusion of his current suspension, that being Saturday, 25 March 2023 and to conclude midnight Friday, 31 March 2023, a period of three meetings.

PRINCE TIKEA (L. Neindorf) - slow to begin. Had difficulty obtaining clear ground from the entrance to the straight until inside the 200m.

CLUB PUNTER (C. Murray) - hampered on jumping away when tightened onto HOLMES by PARTY PRINCESS. Raced keenly in the early and middle stages of the event.

MY MALOO (J. Toeroek) - inside the 300m became awkwardly placed on the heels of CLUB PUNTER for a short distance and had to alter course to obtain clear ground.

PIIINK BEAUTY (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

ARUGAMAMA (T. Voorham) - raced keenly in the early and middle stages of the event. Near the 200m shifted out and then had to take hold to avoid the heels of PARTY PRINCESS, which shifted in slightly.

PARTY PRINCESS (J. Holder) - shifted in on jumping away onto CLUB PUNTER.

PRETTY RELIABLE (NZ) (E. Boyd) - held up from near the 400m until approaching the 200m.

SHARMA PRINCESS (NZ) (D. Caboche) - following the declaration of acceptances Trainer, Mr L. Cadzow made a gear application to add blinkers to the filly's race gear. Stewards acceded to this request and acting under AR206(2) fined Mr Cadzow \$200. Raced wide without cover throughout the event.

HOLMES (L. Lafferty) - inconvenienced on jumping away when taken in by CLUB PUNTER. Near the 500m was forced to check when taken out across the heels of SHARMA PRINCESS (NZ) by KARAKA KIWI (NZ), which had been taken out.

KARAKA KIWI (NZ) (J. Maund) - hampered shortly after the start and lost its position when HOLMES was taken in to its running line. Near the 500m was taken out onto HOLMES by MORE REWARD.

RACE 8: THE JUNCTION HANDICAP - 1400 Metres

ALSVIOR (J. Opperman) - slow to begin.

MUNSTER (NZ) (B. Price) - raced keenly in the early and middle stages of the event.

CHICAGO STORM (S. Tomlinson) - near the 700m dipped for no apparent reason.

RACE 8: THE JUNCTION HANDICAP - 1400 Metres (con't)

PERFECT COMMAND (J. Toeroek) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

AMBIDAZZLE (E. Wong) - a post-race veterinary examination revealed no visible abnormalities.

NICAJON (T. Pannell) - held up from near the 500m until inside the 300m.

RACE 9: FURPHY HANDICAP - 1000 Metres

The start of this event was delayed approximately three minutes.

EL SALTO (J. Holder) - inclined to lay in under pressure in the straight.

PEDWAY (S. Payne) - bucked for a number of strides shortly after the start and lost ground. Co-trainer, Mr R. Daniel was advised that the gelding must perform to the Stewards' satisfaction with a race day saddle in an Official Barrier Trial prior to a future race. A post-race veterinary examination revealed no visible abnormalities.

MANAGE THE CYCLE (E. Wong) - had difficulty obtaining clear ground from the entrance to the straight until near the 150m.

NALEIGH (J. Potter) - slow to begin and shortly after was inconvenienced when SAMESYN shifted out. A post-race veterinary examination revealed the mare to be lame in the near foreleg (1/5). Trainer, Mr G. Kluske was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

MISS EUROZONE (E. Finnegan) - a post-race veterinary examination revealed no visible abnormalities.

MISS REMSKI (C. Murray) - raced keenly in the early and middle stages of the event.
