Report on Race Meeting held at Streaky Bay Racecourse by the Streaky Bay Racing Club on Saturday, 25 March 2023

RACE 1: BAZ MCGILVRAY MEMORIAL MAIDEN PLATE - 1000 Metres

FUNNY LEGS (B. Wong) - arrived late on course owing to transport difficulties. Stewards declared FUNNY LEGS a late scratching by order of Stewards at 12.47 pm. Stewards ordered that all monies invested on FUNNY LEGS be refunded and that all successful wagers be subject to the deductions of 21c in the dollar for the win and 22c in the dollar for a place.

INFANTRY MAN (S. Fawke) – on jumping away was hampered when tightened onto TYPAR by POCKET PENNY and lost its position. Rider explained in relation to the disappointing performance that the gelding was not suited to the track conditions.

POCKET PENNY (S. Metcalfe) - jumped away awkwardly and shifted out onto INFANTRY MAN.

RACE 2: LETCHER AND MORONEY CHARTERED ACCOUNTANTS & YOUR FINANCIAL EDGE BENCHMARK 62 HANDICAP - 1000 Metres

TELEPORTATION (S. Metcalfe) - hung out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 3: CLEARWATER COVE ESTATE BENCHMARK 54 TROPHY - 1200 Metres

GOODARCHIE (R. Milnes) – rider dislodged on return to the mounting yard, and the gelding was unable to be recaptured for some time. Rider was examined by the First Care Medical personnel and was passed fit to fulfil her remaining engagements. A post-race veterinary examination revealed the gelding to be lame in both hind legs (2/5) and to have minor abrasions. Trainer, Mr S. Drewitt, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.



RACE 3: CLEARWATER COVE ESTATE BENCHMARK 54 TROPHY - 1200 Metres (cont'd)

REGAL ROCKET (C. Munro) - reared on jumping away dislodging its rider. Rider was examined the First Care Medical personnel and ruled unfit to fulfil her remaining engagements.

Correct weight was delayed to allow Stewards and co-trainer, Ms J. Branford, to view the vision of the start. After doing so Ms Branford made a submission that REGAL ROCKET had been denied a fair start. After considering evidence provided by Starter, Mr G. Woods, Ms Branford and rider C. Munro, viewing the vision and acting on their own observations Stewards declared REGAL ROCKET a non-runner in accordance with AR204 as they were of the opinion that the gelding had been denied a fair start. Stewards ordered that all monies invested on REGAL ROCKET be refunded and that all successful wagers be subject to the deductions of 10c in the dollar for the win and 10c in the dollar for a place.

As R. Milnes was unable to regain her saddle in a reasonable time frame due to her mount escaping the course Stewards declared correct weight under AR203(3)(c).

RACE 4: STREAKY BAY HOTEL 3H BENCHMARK 62 HANDICAP - 1350 Metres

BARON OF BEDFORD (NZ) (S. Fawke) – as no apprentice rider was available Stewards permitted S. Fawke to ride the gelding.

CATALINA BLUE (D. Tootell (Snr)) - held up for clear running for the entirety of the straight between BAY OF ANGELS and ALKAAMEL, and as a result was untested to the line. A post-race veterinary examination revealed no visible abnormalities.

ALKAAMEL (B. Wong) - slow to begin.

HARDASHIAN (Z. Lloyd) - lost its off hind plate en route to the barriers and required to be reshod. Underwent a pre-race veterinary examination and was deemed suitable to start. Slow to begin.

RACE 5: XXXX & STREAKY BAY COMMUNITY HOTEL STREAKY BAY CUP - 1800 Metres

KALAMON (S. Metcalfe) – when questioned regarding the tactics adopted in today's event rider explained that as she was jumping from a wide barrier she elected to race wide in the early stages of the event where she was of the opinion the track was firmer. She added that the gelding had dropped the bit near the 600m and she had elected to shift out on the home turn hoping the gelding would appreciate the firmer part of the track.

CHONCAPE (Z. Lloyd) - laid out under pressure in the straight.

ABLE WARRIOR (H. Yuen) - slow to begin.

RIGHT TURN (S. Fawke) - a post-race veterinary examination revealed the gelding to be lame in both fore legs (1/5). Trainer, Mr B. J. Cozamanis, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

RACE 6: QUALITY WOOL, RODEO BY THE SEA & ROB MONTGOMERIE RATING 0 - 54 HANDICAP - 1800 Metres

ECLAIR RHYTHM (NZ) (S. Fawke) - inconvenienced on jumping away when tightened onto CLUB RAIDER by BEERS ON BILL. When questioned in relation to the gelding's disappointing performance rider explained that the gelding travelled well in the early and middle stages; however, when asked for an effort failed to respond to his riding and proved disappointing. A post-race veterinary examination revealed no visible abnormalities.

BEERS ON BILL (S. Metcalfe) - jumped away awkwardly and shifted in onto ÉCLAIR RHYTHM (NZ).

RACE 6: QUALITY WOOL, RODEO BY THE SEA & ROB MONTGOMERIE RATING 0 - 54 HANDICAP - 1800 Metres (cont'd)

CLUB RAIDER (D. Tootell (Snr)) - inconvenienced on jumping away when taken in by ÉCLAIR RHYTHM (NZ).
