RACE 1: FURPHY HANDICAP - 1550 Metres

LIKELY SUSPECT (NZ) (D. Yendall) - laid in under pressure in the straight. Near the 200m had to ease to the outside of EAGLELOU to obtain clear ground.

VEE ROD (NZ) (L. Neindorf) - lost its near fore plate during the event. Rider reported that the gelding raced flat and was one pace to the finish. Rider was reminded of his obligations under AR131(b) to ride his mounts out to finish.

JUST JAZZ (R. Pearson) - raced keenly in the early and middle stages of the event. Laid out under pressure in the straight.

KING OF AVALON (NZ) (W. Price) - slow to begin.

CALL ME HERBIE (A. Livesey) - raced keenly in the early and middle stages of the event.

RACE 2: TAB GOODWOOD CARNIVAL AT MORPHETTVILLE (APRIL 29 - MAY 20TH) HANDICAP - 1250 Metres

LOVE MAGIC (J. Holder) - jumped away awkwardly and was slow into stride. Rider reported that the gelding did not feel comfortable in its action in the straight. A post-race veterinary examination revealed the gelding to be lame in the off foreleg (2/5). Trainer, Ms K. Mooney was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

RACE 2: TAB GOODWOOD CARNIVAL AT MORPHETTVILLE (APRIL 29 - MAY 20TH) HANDICAP - 1250 Metres (cont'd)

SIXFOOTONE (E. Finnegan) - near the 1000m shifted in onto TOSEN WATER, which had to be steadied when racing keenly. Rider was reprimanded under AR131(a) and advised, in future, to ensure she is sufficiently clear prior to shifting ground.

CULLEN SKINK (L. Neindorf) - shifted out on jumping away onto TOAST THE DEEL. Raced wide without cover throughout the event. Approaching the finish had to be steadied when tightened between SEPORIA, which shifted out slightly at the same time DELIGHTFUL SHECKY laid in.

DELIGHTFUL SHECKY (D. Holland) - laid in under pressure over the concluding 100m.

CHARLESFORT (T. Voorham) - raced wide without cover throughout the event.

TOAST THE DEEL (B. Price) - contacted on jumping away.

TOSEN WATER (E. Wong) – raced keenly in the early and middle stages whilst being restrained. A post-race veterinary examination revealed no visible abnormalities.

RACE 3: CROSER HANDICAP - 1950 Metres

RITRATTO (L. Neindorf) - raced keenly in the early and middle stages of the event.

DESIGNS (T. Pannell) - held up from near the 400m until approaching the 300m.

GRINZINGER ALLEE (NZ) (W. Price) - laid out under pressure in the straight.

ICHIBANSAN (J. Holder) - raced keenly in the early and middle stages of the event. Rider reported that the gelding was disappointing and in his opinion may benefit from a freshen up. A post-race veterinary examination revealed no visible abnormalities.

RIALTOR (S. Tomlinson) - rider explained that the gelding did not relax as it had at its previous start, failed to travel and did not let down as he had hoped. A post-race veterinary examination revealed no visible abnormalities.

THRILL KILL (T. Voorham) - fractious in its float en route to course. Underwent a pre-race veterinary examination on arrival on course, which revealed a deep laceration to its offside hock and was deemed unsuitable to race. First aid administered. Acting on this advice THRILL KILL was declared a late scratching by order of Stewards at 10.34am. Trainer, Mr P. Hardacre was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

TRUMPSTA (G. Lo) - inclined to lay in under pressure in the straight.

AZALY (B. Melham) - held up from inside the 600m until the entrance to the straight.

KAILASH (IRE) (D. Yendall) - raced keenly in the middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

SILENT SURRENTE (B. Price) - raced keenly in the early and middle stages of the event.

SALUTE THE STARS (K. Crowther) - had difficulty obtaining clear ground from near the 500m and near the 300m became held up until it was able to ease across the heels of SILENT SURRENTE approaching the 100m.

NEVA DOUBT US (S. Logan) - fractious in its float en route to course. Underwent a pre-race veterinary examination on arrival on course, which revealed a laceration to its forehead and was deemed unsuitable to race. Acting on this advice NEVA DOUBT US was declared a late scratching by order of Stewards at 11.08am. Trainer, Mr G. Young was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.



RACE 4: PETER ELBERG FUNERALS HANDICAP - 1550 Metres

MORTY (E. Wong) - raced keenly in the early and middle stages of the event. Near the 800m shifted out and elected to roll forward to obtain a position closer to the speed.

UNLACED (NZ) (J. Eaton) - slow to begin. Rider reported that it was her intention to settle on pace; however, she was unable to do so due to the mare jumping away poorly. A post-race veterinary examination revealed no visible abnormalities.

ANGASTON (J. Holder) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: GRAND SYNDICATES HANDICAP (HEAT 9 AUTUMN SERIES) - 1400 Metres

TEXAN WINDSTORM (A. Livesey) - raced fiercely in the early and middle stages of the event. Laid in under pressure in the straight. A post-race veterinary examination revealed a poor post-race recovery and severe thumps. First aid administered. Trainer, Mr J. Macmillan was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

CLASSY BANNER (K. Crowther) - raced wide without cover throughout the event.

WOLFBURN (G. Lo) - rider reported that the gelding hung out throughout the event.

MOTELL (J. Opperman) - jumped away awkwardly.

AMBIDAZZLE (E. Wong) - near the 1300m shifted in and contacted DAWNBURST, which had been taken out. Inclined to shift about under pressure in the straight.

CATESBY (E. Finnegan) - a post-race veterinary examination revealed no visible abnormalities.

DAWNBURST (S. Payne) - near the 1300m was hampered and became unbalanced when taken out by FALAISE onto AMBIDAZZLE, which was shifting in.

FALAISE (S. Tomlinson) - near the 1300m shifted out and away from LAKE TITICACA onto DAWNBURST. Held up from near the 500m until near the 200m.

LEON'S SHOUT (T. Voorham) - held up from the 400m until near the 200m. Rider reported that the gelding was on and off the bridle throughout the event and did not let down as she had anticipated. A post-race veterinary examination revealed no visible abnormalities.

BENZ BARON (J. Holder) - jumped away awkwardly.

PIIINK BEAUTY (S. Logan) - rider reported that the filly raced flat and she had become concerned with its action on pulling up. A post-race veterinary examination revealed no visible abnormalities.

LAKE TITICACA (T. Pannell) - held up from the 500m until approaching the 200m.

TURFITT (J. Bowditch) - held up from near the 400m until inside the 300m.

RACE 6: H C NITSCHKE STAKES - 1400 Metres

The start of this event was delayed approximately one minute to avoid a clash with an interstate event.

TEST THE LAW (J. Opperman) - inconvenienced when contacted on jumping away. Raced keenly in the early and middle stages of the event. Near the 1000m shifted out and contacted I'M A DEXSTAR.

ROYAL MERCHANT (D. Yendall) - shifted out on jumping away onto CASTE. Held up from approaching the 400m until near the 300m and then had difficulty obtaining clear ground until near the 200m.

PRAIRIE FLOWER (W. Price) - inconvenienced on jumping away when CASTE was taken out into its running line.

RACE 6: H C NITSCHKE STAKES - 1400 Metres (cont'd)

CASTE (J. Toeroek) - shortly after the start was taken out by ROYAL MERCHANT.

BILLIE BRONX (C. Murray) - a post-race veterinary examination revealed no visible abnormalities.

PAMPUNI (D. Holland) – inconvenienced when contacted on jumping away. Held up from the entrance to the straight until near the 200m and then had difficulty obtaining clear ground for the remainder of the event.

MISS GALORE (NZ) (J. Holder) - laid out rounding the home turn.

BOOGNISH (L. Neindorf) - shifted in on jumping away and bumped TEST THE LAW.

TAPINFORPAR (T. Pannell) - jumped away awkwardly. Raced wide without cover throughout the event.

SIXTEEN REASONS (B. Price) - jumped away awkwardly. Held up from the entrance to the straight until near the 200m when awkwardly placed between the heels of BOOGNISH and BILLIE BRONX. Near the 150m was obliged to ease and alter course to the outside of BOOGNISH, which shifted in.

CLUB PUNTER (J. Eaton) - shifted out on jumping away and contacted PAMPUNI.

I'M A DEXSTAR (J. Bowditch) – near the 1000m was inconvenienced when its hind quarters were contacted by TEST THE LAW. Near the 700m was momentarily unbalanced when it shifted in and contacted TEST THE LAW.

RACE 7: CITY OF ADELAIDE HANDICAP - 1400 Metres

The start of this event was delayed approximately two minutes initially to avoid a clash with an interstate event and then due to the bridle needing to be replaced on BALLYNORA.

AYRTON (NZ) (B. Melham) - Co-trainer, Mr M. Price advised Stewards prior to the event of a change of tactics in that he would instruct his rider to attempt to settle further back due its wide barrier draw. Settled back. Near the 200m commenced to shift out onto SASKATOON, which was taken out onto LORD VLADIVOSTOK (NZ). Rider was advised to make a greater effort to keep his mounts straight in future.

NONAME LANE (T. Pannell) - lost its near hind plate during the event. Rider explained that the gelding travelled well in the early and middle stages; however, when asked to improve inside the 600m failed to respond to his riding, commenced to weaken quickly from approaching the 400m and was disappointing the finish. A post-race veterinary examination revealed the gelding to be lame in the near hind leg (2/5). Co-trainers, Mr. W. Clarken and Ms N. O'Shea were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

LORD VLADIVOSTOK (NZ) (B. Price) - contacted on jumped away. Near the 500m had to be steadied and alter course when it improved onto the heels of NONAME LANE, which had commenced to give ground. Held up at the entrance to the straight. Near the 200m altered course into a tight run between SASKATOON and CHICAGO STORM. Approaching the 100m had to be steadied and lost its position when CHICAGO STORM shifted in slightly at the same time as SASKATOON was taken out slightly by AYRTON (NZ).

MY KHALIFA (L. Neindorf) - jumped away awkwardly, shifted in and contacted LAKE'S FOLLY.

SASKATOON (J. Toeroek) - jumped away awkwardly, shifted out and contacted LORD VLADIVOSTOK (NZ). Raced keenly in the early and middle stages of the event.

LAKE'S FOLLY (J. Eaton) - jumped away awkwardly, shifted out and contacted MY KHALIFA.

CHICAGO STORM (J. Holder) - raced wide without cover throughout the event. Near the 200m commenced to shift in slightly onto LORD VLADIVOSTOK (NZ). Rider was advised to make a greater effort to keep his mounts straight in future.

RACE 7: CITY OF ADELAIDE HANDICAP - 1400 Metres (cont'd)

PUDDING (NZ) (K. Crowther) - raced keenly in the early stages of the event. Near the 1000m had to be steadied when it improved onto the heels of REGALO DI GAETANO. Had to be steadied inside the 50m when racing behind MORVADA, which had commenced to give ground and shift about.

LAST GIRL LOVE (D. Holland) - jumped away awkwardly.

BALLYNORA (J. Bowditch) - had its bridle replaced on arrival at the barriers. Slow to begin. A post-race veterinary examination revealed signs of heat stress. First aid administered. Trainer, Mr P. Stokes was advised that a Veterinary Clearance would be required prior to a future jumpout, trial or race.

RACE 8: REDELVA STAKES (TO BE RUN ON THE MAIN TRACK) - 1100 Metres

The start of this event was delayed approximately three minutes to avoid a clash with an interstate event.

SEVEN VEILS (D. Yendall) - shifted out shortly after jumping away onto ROCKSTAR MEGGSY.

MISS ROSEIANO (W. Price) - near the 900m shifted in abruptly for no apparent reason onto LADY DI DI. Laid out under pressure in the straight. Near the 200m shifted out slightly onto DOULL.

DOULL (T. Pannell) - inside the 200m shifted out and away from MISS ROSEIANO into the running line of WANGO AWARD. A post-race veterinary examination revealed that the colt's off hind leg had been mildly galloped on.

PRESS DOWN (C. Murray) - shifted out under pressure in the straight.

HOPE AT HAND (J. Holder) – near the 900m was taken in onto ZUFASTA by LADY DI DI, which had been taken in. Held up from near the 250m until approaching the 100m.

HELL HOUND (B. Price) - inconvenienced when contacted by LADY DI DI on jumping away. Had difficulty obtaining clear ground from the entrance to the straight. Near the 200m became awkwardly placed on the heels of GREY RIVER until near the 100m.

ROCKSTAR MEGGSY (J. Bowditch) – slow to begin and shortly after was inconvenienced when SEVEN VEILS shifted out. Had difficulty obtaining clear ground form inside the 300m until approaching the 100m. A post-race veterinary examination revealed signs of heat stress. First aid administered. Trainer, Mr J. O'Connor was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

WANGO AWARD (D. Tourneur) - had difficulty obtaining clear ground in the straight. Approaching the 100m had to be steadied and altered course when DOULL shifted out and away from MISS ROSEIANO, into its running line.

PRANCE 'N' DANCE (J. Eaton) - jumped away awkwardly.

LADY DI DI (T. Voorham) - jumped away awkwardly, shifted out and contacted HELL HOUND. Near the 900m was inconvenienced when taken in onto HOPE AT HAND by MISS ROSEIANO, which shifted in abruptly. A post-race veterinary examination revealed no visible abnormalities.

ZUFASTA (J. Toeroek) – near the 900m was inconvenienced and contacted the running rail when HOPE AT HAND was taken in.

RACE 9: R N IRWIN STAKES (TO BE RUN ON THE MAIN TRACK) - 1100 Metres

IN THE BOAT (D. Yendall) – rider explained that the gelding travelled well in the early and middle stages; however, when asked for an effort, failed to respond to his riding and was disappointing to the finish. A post-race veterinary examination revealed the gelding to be lame in the off hind leg (2/5) and the thumps – heat stress related. Trainer, Mr L. Smith was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

RACE 9: R N IRWIN STAKES (TO BE RUN ON THE MAIN TRACK) - 1100 Metres (cont'd)

GENERAL BEAU (J. Bowditch) - lost its near hind plate during the event.

SHAMINO (K. Crowther) - slow to begin. A post-race veterinary examination revealed signs of tying up. Trainer, Mr P. Stokes was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

LARIMER STREET (J. Toeroek) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

MANHATTEN TIMES (L. Neindorf) – slow to begin. Stewards questioned Co-Trainer, Mr L. Macdonald due to the gelding's significant drift in betting. Mr Macdonald advised that MANHATTAN TIMES had been in work approximately 12 weeks and had worked well on Tuesday in its final gallop in the lead up to today's event. He added that the stable was disappointed with how the gelding performed in today's event and he could offer no explanation as to why it had drifted substantially in the market. A post-race veterinary examination revealed no visible abnormalities.

QUEMAN (J. Potter) - raced keenly in the early and middle stages of the event.

SERADESS (D. Holland) – near the 700m became awkwardly placed on the heels of IN THE BOAT for a number of strides and as a result shifted out in an attempt to move MILEVA, which held its line, resulting in the mare remaining awkwardly placed on the heels for a short distance. From the entrance to the straight was forced to race in restricted room between the heels of IN THE BOAT and MILEVA and was only able to obtain clear ground approaching the 100m. Laid in under pressure over the concluding 50m.

ANOTHER AWARD (J. Holder) - reared on jumping away.

GAZE GRISE (W. Price) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

RACE 10: MURRAY AND BARB STEWART'S 65TH ANNIVERSARY MEMORIAL HANDICAP (TO BE RUN ON THE MAIN TRACK) - 1000 Metres

LARKHAM (A. Livesey) - a post-race veterinary examination revealed no visible abnormalities.

PRAIRIE FIRE (E. Wong) – raced keenly in the early and middle stages of the event and near the 800m was forced to steady when MR HAVE A CHAT shifted into its running line.

THE MAGISTRATE (T. Voorham) - raced fiercely in the early and middle stages of the event. Near the 700m shifted out into SECRET WAR, which had to be steadied when tightened onto ENDLESSLY.

SECRET WAR (J. Maund) - jumped away awkwardly.

MR HAVE A CHAT (S. Logan) - near the 800m shifted into the running line of PRAIRIE FIRE, which was forced to steady. Rider was severely reprimanded under AR131(a) and advised to take greater care when shifting ground in future. Laid in under pressure in the straight.

XTRAVAGANT STAR (B. Melham) - raced fiercely in the early and middle stages of the event. Near the 700m became awkwardly placed on the heels of ROXY BLUE. A post-race veterinary examination revealed no visible abnormalities. Stable advised that they would recommend that the filly be retired.

ENDLESSLY (G. Lo) - raced wide without cover throughout the event.

CHOSEN BLONDE (C. Jones) - raced wide without cover throughout the event.

ROXY BLUE (J. Potter) - raced wide without cover throughout the event.

SHOOTING FOR STARS (B. Price) - jumped away awkwardly. Momentarily held up in the vicinity of the 300m.
