RACE 1: ADELAIDE GALVANISING INDUSTRIES HANDICAP - 1200 Metres

RANGER FRANK (J. Potter) - raced keenly in the middle stages of the event, and from near the 500m became held up and was untested to the line.

WAY TO GO PAULA (B. Allen) – jumped away awkwardly and was slow to begin. Rider reported that he had intended to settle a touch closer; however, he was unable to do so due to the mare jumping away awkwardly. He added that WAY TO GO PAULA required some encouragement in the early stages to motivate it to travel. He further explained that it had travelled fairly during the event, and when asked for an effort only responded moderately. Lost its near fore plate during the event.

STRAWBERRY SWING (S. Tomlinson) – awkward and slow to begin. Had difficulty obtaining clear ground from the entrance to the straight until near the 200m when he was able to ease to the outside of LAKEHURST to obtain clear ground. Rider reported that it was his intention to lead the event; however, after being slow to begin he was unable to do so and was obliged to settle behind the leaders.

BLUE GLASS (E. Finnegan) - jumped away awkwardly.

PIVOTAL FORCE (C. Jones) - laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

LAKEHURST (L. Neindorf) - raced keenly in the early and middle stages of the event.



RACE 2: SKYCITY HANDICAP - 1600 Metres

PRINCE JOFRA (A. Livesey) – laid out from near the 200m and near the 100m allowed her mount to shift out contacting WHEELS (NZ), resulting in the gelding's hindquarters being turned shifting further out onto WHEELS (NZ). Rider was reprimanded and advised in future to make a greater effort to keep her mounts straight. Rider explained that she was instructed to take up a forward position, and if there was no speed from outside her that she may lead the event. She added that the gelding had not travelled as well as it had when she had ridden it previously and when ASHIM (FR) improved around her near the 1200m she did not feel she had the horse underneath her to persist and hold him out, and for this reason she elected to restrain and allow him to cross. A post-race veterinary examination revealed no visible abnormalities.

PERFECT ROUTE (S. Tomlinson) - rider reported that the gelding never travelled comfortably, and when placed under pressure near the 600m failed to respond to his riding and commenced to weaken from the event of its own accord. A post-race veterinary examination revealed no visible abnormalities. The stable advised that they would recommend that the gelding now be retired.

WHEELS (NZ) (J. Holder) - slow to begin. Shortly after entering the straight was reluctant to improve into a tight run between PRINCE JOFRA and ZOULAH, and approaching the 100m, shortly after obtaining that run, was hampered when tightened onto ZOULAH by PRINCE JOFRA, which shifted out.

ASHIM (FR) (J. Allen) - jumped away awkwardly.

FROST YOURSELF (C. Williams) - rider reported that the mare travelled well in the early and middle stages of the event; however, when placed under pressure at the entrance to the straight it had only responded fairly. He added that on pulling up and return to scales FROST YOURSELF felt lethargic. A post-race veterinary examination revealed no visible abnormalities.

Correct weight was delayed to allow J. Holder (WHEELS (NZ)), placed fourth, to view the vision in the straight.

RACE 3: THE JUNCTION HANDICAP - 1100 Metres

OH MO (J. Opperman) - slow to begin. Lost its off fore plate during the event.

ASTON RAPOVA (T. Voorham) - slow to begin.

KEEP READING (S. Tomlinson) - laid in under pressure in the straight.

CALLA DREAM (R. Hurdle) - hung out rounding the home turn. A post-race veterinary examination revealed no visible abnormalities.

EXTRA MILE (J. Toeroek) - inclined to lay in under pressure in the straight.

SILVER ON RED (L. Neindorf) - a post-race veterinary examination revealed no visible abnormalities.

LEGLESS LADY (J. Holder) - jumped away awkwardly.

RACE 4: VALE DEAN HOLLAND HANDICAP - 1100 Metres

RUSHAWAY LAD (D. Oliver) - hampered on jumping away when contacted by MR MARATHON MAN.

STARLITE VALLEY (C. Jones) - shifted out on jumping away onto SAMESYN. Inconvenienced rounding the home turn when taken wider by SABERMETRIC, which was taken out. Laid in under pressure in the straight, and near the 250m shifted in onto SABERMETRIC, which had to be eased when tightened onto MANAGET THE CYCLE. Rider was reminded of her obligations when her mounts commence to shift.

MR MARATHON MAN (GB) (B. Price) - shifted out on jumping away onto RUSHAWAY LAD.

RACE 4: VALE DEAN HOLLAND HANDICAP - 1100 Metres (cont'd)

MANAGE THE CYCLE (J. Holder) - rounding the home turn was obliged to alter course to the inside of SABERMETRIC, which had been taken out. Had difficulty obtaining clear ground until inside the 200m.

SABERMETRIC (L. Neindorf) - inconvenienced rounding he home turn when taken wider by EVENING BRIDE. A post-race veterinary examination revealed no visible abnormalities.

SUPERACE (NZ) (T. Voorham) – rider reported that the gelding raced keenly in the early and middle stages of the event; however, when asked for an effort it commenced to hang out and became awkward in its action, and for this reason she had not ridden SUPERACE (NZ) out in her normal manner. A post-race veterinary examination revealed lacerations to the near hind leg and that the gelding had bled from one nostril. Co-trainer, Mr J. Dodgson, was advised that SUPERACE (NZ) would be required to gallop 1000m in the presence of a Steward prior to accepting for a future jump-out, trial or race in accordance with AR79(8). Mr Dodgson advised that he would recommend that the gelding now be retired. Mr Dodgson was further advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

EVENING BRIDE (S. Clipperton) - rounding the home turn became awkward in its action and shifted out onto SABERMETRIC. A post-race veterinary examination revealed no visible abnormalities.

SAMESYN (K. Crowther) - inconvenienced on jumping away.

RACE 5: BREEDERS' STAKES - 1200 Metres

The start of this event was delayed approximately four minutes.

HARLEY'N'ROSE (L. Neindorf) - shifted about under pressure in the straight.

AIR ASSAULT (J. Holder) - raced keenly in the early and middle stages of the race.

CAUSATION (C. Newitt) - raced keenly in the early and middle stages of the race.

STUPENDOUS (T. Voorham) - refused to load. Acting on this advice Stewards declared STUPENDOUS a late scratching at 1.40pm. Trainer, Mr C. Bieg, was advised that the filly would now be required to load without delay in an Official Barrier Trial prior to a future race start.

RACE 6: THOMAS FARMS HANDICAP - 1200 Metres

PONTEDERA (NZ) (B. Price) - held up from the 450m until the entrance to the straight.

CHILL WITH TEEJAY (S. Tomlinson) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

AIGUILETTE (J. Allen) - when questioned in relation to the significant betting support for the gelding, trainer, Mr J. Macmillan, could offer no explanation other than the gear change of the addition of blinkers and a change in rider. He added that he had not supported AIGUILETTE and had not encouraged the gelding's owners to do so.

PERFECT COMMAND (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

KENYAN WONDER (W. Price) - raced keenly in the early and middle stages of the event.

RACE 7: PORT ADELAIDE CUP - 2500 Metres

The start of this event was delayed approximately three minutes to avoid a clash with an interstate event.

HORRIFYING (NZ) (C. Williams) - lost its near fore plate during the event.

RACE 7: PORT ADELAIDE CUP - 2500 Metres (cont'd)

CAPTAIN ENVIOUS (NZ) (D. Yendall) - at the entrance to the straight shifted out into the running line of LONG ARM (IRE). Rider was severely reprimanded and advised to take greater care when shifting ground in future.

LONG ARM (IRE) (J. Allen) - at the entrance to the straight had to be steadied to avoid the heels of CAPTAIN ENVIOUS (NZ), which shifted out at the same time as LONG ARM (IRE) laid in. Continued to lay in under pressure in the straight.

SEBONNA (C. Murray) - trainer, Mr P. Hardacre, advised Stewards prior to the event of a change of tactics in that he would instruct the rider to attempt to settle midfield if possible. Settled back. Jumped away awkwardly and shortly after was unable to maintain its position when tightened between CAPTAIN ENVIOUS (NZ), which shifted out slightly, and CLEVER MAN, which shifted in slightly.

SUPAGIRL (IRE) (C. Newitt) - jumped away awkwardly.

VERIMLI (FR) (J. Eaton) – rider reported that the gelding had only travelled fairly and when asked for an effort failed to let down as she had anticipated. A post-race veterinary examination revealed no visible abnormalities.

SMILING ASSASSIN (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

SALUTE THE STARS (E. Finnegan) - raced wide without cover throughout the event.

RACE 8: CHAIRMAN'S STAKES - 2000 Metres

The start of this event was delayed approximately two minutes to avoid a clash with an interstate event.

SUIZURO (C. Newitt) - laid out rounding the home turn and in the straight.

RED SUN SENSATION (C. Williams) - shifted in on jumping away and contacted KARAKA KIWI (NZ), resulting in C. Williams becoming extremely unbalanced in the saddle.

THIRSTY GUEST (R. Hurdle) – rider explained that he was forced to go back on the gelding from the wide barrier. He added that as the field increased the tempo from near the 1000m he was unable to sprint with them initially and he was one-paced to the finish. A post-race veterinary examination revealed the gelding to be lame near foreleg (2/5). Co-trainers, Mr D. Clarken & Ms O. MacGillivray, were advised that a Veterinary Clearance would be required prior to a future jumpout, trial or race start.

SUPERSTOCK (NZ) (J. Noonan) - a post-race veterinary examination revealed no visible abnormalities.

VERIFIER (NZ) (J. Allen) - inclined to lay in under pressure in the straight.

KARAKA KIWI (NZ) (J. Holder) - shifted out on jumping away and contacted RED SUN SENSATION.

SIR KINGSFORD (K. Crowther) - contacted on jumping away. Rider explained that she had been instructed to lead; however, after obtaining that position the gelding commenced to race keenly and did not settle until near the 800m. She added that as a result SIR KINGSFORD gave ground when placed under pressure and she recommended that the gelding would be better suited without winkers.

RICH RESULT (T. Voorham) - jumped away awkwardly and shifted out onto SIR KINGSFORD. Raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed the filly to be lame in the near foreleg (3/5). Co-trainers, Messrs J. & C. Ledger, were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

RACE 9: GRAND SYNDICATES AUSTRALASIAN OAKS - 2000 Metres

SHE'S FIT (C. Williams) - rider reported that the filly laid in when placed under pressure in the straight.

ARTS (S. Clipperton) - inconvenienced on jumping away when tightened onto AS TIME GOES BY by ARUGAMAMA. Raced keenly in the early stages of the event. Rider reported that the filly travelled well in the early and middle stages of the event; however, when placed under pressure near the 700m did not respond to his riding and had weakened from the event. He added that in his opinion it may have come to the end of its preparation. A post-race veterinary examination revealed no visible abnormalities.

AS TIME GOES BY (J. Toeroek) - hampered and lost its position on jumping away when ARTS was taken out into its running line. Rider reported that as a consequence of the start, he was obliged to settle a touch further back than he had hoped. He added that the filly had only travelled fairly and when asked for an effort was one-paced to the finish. A post-race veterinary examination revealed no visible abnormalities.

RUNNING ON TIME (NZ) (D. Oliver) - rider reported that the filly may have come to the end of its preparation. A post-race veterinary examination revealed no visible abnormalities.

MORE REWARD (T. Pannell) - rider explained that it was not his intention to lead; however, given the early formation of the field he elected to allow his mount to continue to stride forward and take up the lead rather than be trapped wide. He added that the filly hung out from near the 600m and failed to respond to his riding. A post-race veterinary examination revealed no visible abnormalities.

KILLIAKO (B. Allen) - rider explained that the filly put in an awkward stride near the 1700m and from that point on did not travel during the event and was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

ARUGAMAMA (L. Neindorf) - inconvenienced on jumping away when tightened onto ARTS by MOYA LASS. Rider reported that in his opinion the filly may have come to the end of its preparation. A post-race veterinary examination revealed no visible abnormalities.

PARTY PRINCESS (J. Holder) - inclined to lay in under pressure in the straight.

PROSCENIUM ARCH (NZ) (K. Crowther) – stable advised Stewards prior to the event that they would instruct the rider to attempt to settle more forward in today's event. Settled forward of midfield.

WHAKAMANA (J. Noonan) – stable advised Stewards prior to the event that they would instruct the rider to attempt to settle more forward in today's event. Settled midfield.

STARIANNE (D. Yendall) – stable advised Stewards prior to the event that they would instruct the rider to attempt to settle more forward in today's event. Settled midfield.

MOYA LASS (C. Newitt) - shifted out on jumping away onto ARUGAMAMA.

RACE 10: THE FOTOBASE GROUP HANDICAP - 1600 Metres

LI'L HANK (S. Tomlinson) - rider explained that the gelding was not suited by the slow tempo and when the speed went into the race near the 600m LI'L HANK did not respond to his riding and was disappointing to the finish. A post-trace veterinary examination revealed no visible abnormalities.

IMPOSING SUSPECT (NZ) (C. Murray) - laid out under pressure in the straight.

MASTER AT ARMS (NZ) (J. Toeroek) - raced keenly in the middle stages of the event.

LOMAX (S. Payne) - held up from the entrance to the straight until near the 200m.

GARRIRE (L. Neindorf) - raced fiercely in the early and middle stages of the event.
