# RACE 1: SKYCITY HANDICAP - 2014 Metres

RITRATTO (S. Tomlinson) - lost its near fore plate near the 600m. Raced wide without cover throughout the event.

AITCH D'AMICO (T. Pannell) – rider explained that in his opinion the gelding did not handle today's track conditions. A post-race veterinary examination revealed no visible abnormalities.

SILENT SURRENTE (B. Price) - raced keenly in the early and middle stages of the event.

FIRST IMMORTAL (C. Williams) - inclined to shift about under pressure in the straight.

KING'S CROSSING (NZ) (J. Mott) – required its tongue-tie to be adjusted on arrival at the barriers. Rider explained that the gelding travelled well in the early and middle stages of the event; however, when placed under pressure failed to respond to his riding and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

# RACE 2: THOMAS FARMS HANDICAP - 1600 Metres

REGALO DI GAETANO (S. Tomlinson) - a post-race veterinary examination revealed no visible abnormalities.

MY KHALIFA (T. Pannell) - rider reported that in his opinion the gelding was not suited by the slow pace in today's event. A post-race veterinary examination revealed no visible abnormalities.

CASHIN' CHEX (NZ) (A. Livesey) - raced keenly in the middle stages of the event.



# RACE 2: THOMAS FARMS HANDICAP - 1600 Metres (cont'd)

LITTLE RICH BOY (S. Logan) - laid out under pressure in the straight.

#### RACE 3: PETALUMA HANDICAP - 1050 Metres

CELSIUS STAR (S. Tomlinson) - laid out under pressure in the straight.

SEA WITNESS (L. Meech) - rider explained that the gelding travelled well in the early and middle stages of the event; however, when placed under pressure did not respond to her riding and weakened from the event of its own accord. She added that in her opinion it would benefit from the run. A post-race veterinary examination revealed the gelding to be lame in the near foreleg (3/5). Trainer, Mr B. Cozamanis, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

LE DERRIERE (B. Melham) - rider was reminded of his obligations under AR131(b) in riding his mounts out to the finish of the race.

MANAGE THE CYCLE (J. Holder) - held up near the 400m until the entrance to the straight.

EXOPIPI (Z. Spain) - rider reported that the mare was reluctant to take up a position outside of other runners in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

JUSTAKIDD (J. Mott) - slow to begin.

BORN TO RUN (NZ) (R. Hurdle) - fractious after being loaded and struck its head in the barriers. Underwent a pre-race veterinary examination and was deemed unsuitable to start. Acting on this advice Stewards declared BORN TO RUN (NZ) a late scratching at 12.59pm. Trainer, Mr C. Bieg, was advised that a warning had been placed on the mare.

STORM VOYAGER (T. Pannell) - near the 300m was inconvenienced when LE DERRIERE shifted out and away from CELSIUS STAR.

# RACE 4: D C MCKAY STAKES - 1100 Metres

ZOUTORI (C. Williams) - jumped away awkwardly. Had difficulty obtaining clear ground in the straight. Rider reported that the gelding was never fully tested. A post-race veterinary examination revealed no visible abnormalities.

FREE OF DEBT (T. Voorham) - a post-race veterinary examination revealed no visible abnormalities.

SHAMINO (K. Crowther) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

#### RACE 5: WITHOUT FEAR STAKES - 1050 Metres

PUTANOTHERCOININ (J. Toeroek) – became awkward in its action for a short distance near the 800m. A post-race veterinary examination revealed the gelding to be lame in the off foreleg (2/5). Co-trainers, Mr R. Jolly and Miss C. Jolly, were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

TROPOPAUSE (C. Jones) - slow to begin. Laid in under pressure over the concluding 200m. A post-race veterinary examination revealed no visible abnormalities.

REMEDIES (B. Melham) - rider reported that the filly had never travelled and raced flat throughout the event. A post-race veterinary examination revealed no visible abnormalities.

CHILLED (M. Dee) - near the 700m had to be steadied when CAUSATION shifted in.

IPHIMEDIA (C. Williams) - required to be resaddled on arrival at the barriers. Rider reported that his saddle shifted back slightly on jumping away.

# RACE 5: WITHOUT FEAR STAKES - 1050 Metres (cont'd)

ACAPPELLA MOON (L. Meech) - raced wide without cover throughout the event.

HARLEEN (T. Voorham) - a post-race veterinary examination revealed no visible abnormalities.

CAUSATION (T. Pannell) - near the 700m shifted in onto CHILLED, which had to be steadied. Rider was reprimanded under AR131(a) for careless riding.

LUNASHA (Z. Spain) - rider reported that in his opinion the filly did not handle the track condition. A post-race veterinary examination revealed no visible abnormalities.

DOWN LOW (J. Childs) - laid out over the concluding 200m of the event.

# RACE 6: QUEEN OF THE SOUTH STAKES - 1600 Metres

SILENT SOVEREIGN (T. Pannell) - raced keenly in the early and middle stages of the event and near the 1200m had to be momentarily steadied when MY WHISPER shifted in.

MY WHISPER (J. Allen) - raced wide without cover throughout the event.

BELLE PLAISIR (NZ) (B. Melham) - momentarily held up rounding the home turn.

DYNASTIES (D. Oliver) - laid in under pressure in the straight and inside the 100m had difficulty obtaining clear ground. A post-race veterinary examination revealed no visible abnormalities.

SPARKLE (JPN) (C. Williams) - rider reported that the mare travelled well in the early and middle stages; however, when asked for an effort did not respond to his riding and in his opinion was not suited by the track condition. A post-race veterinary examination revealed no visible abnormalities.

MISS YOU ELLA (USA) (J. Toeroek) - rider reported that the mare travelled well in the early and middle stages; however, had not let down as he had anticipated and in his opinion would take benefit from the run. A post-race veterinary examination revealed no visible abnormalities.

RICHGINA (D. Tourneur) - contacted on jumping away.

LAST GIRL LOVE (Z. Spain) - slow to begin.

DELICIOUS TYCOON (J. Holder) – jumped away awkwardly and shifted out contacting RICHGINA. Raced keenly in the early and middle stages and got its head up on several occasions.

WALTZ ON BY (L. Meech) - raced keenly in the early and middle stages of the event.

CASTE (M. Dee) - reared on jumping away. Held up from the 500m until inside the 300m.

# RACE 7: FURPHY ROBERT SANGSTER STAKES - 1200 Metres

BELLA NIPOTINA (B. Melham) - approaching the finish was inconvenienced when taken in by ZAPATEO.

ROCH'N' HORSE (NZ) (J. Mott) – raced wide without cover throughout the event. Rider reported that in his opinion the mare did not handle the track condition. A post-race veterinary examination revealed no visible abnormalities.

MARABI (B. Allen) – rider reported that the mare did not handle the track condition. A post-race veterinary examination revealed no visible abnormalities.

ZAPATEO (D. Oliver) - raced keenly in the early stages whilst being restrained. Had difficulty obtaining clear ground from the 500m until the 200m.

SEPTEMBER RUN (C. Williams) - raced wide without cover throughout the event. Rider reported that in his opinion the mare was not suited by the track condition.

# RACE 7: FURPHY ROBERT SANGSTER STAKES - 1200 Metres (cont'd)

ESPIONA (M. Dee) - jumped away awkwardly and was slow to begin. Laid out rounding the home turn and under pressure in the straight.

CHAIN OF LIGHTNING (L. Nolen) - raced keenly in the early and middle stages of the event. Had difficulty obtaining clear ground from near the 300m until approaching the 100m.

LITERARY MAGNATE (D. Yendall) - rider reported that the mare was disappointing and pulled up quickly after passing the winning post. A post-race veterinary examination revealed no visible abnormalities.

DIAMONDS (T. Voorham) - slow to begin. Held up from near the 300m until near the 200m when it was able to ease across the heels of runners.

# RACE 8: TAB TOBIN BRONZE STAKES - 1200 Metres

The start of this event was rescheduled to 4.07pm owing to a request from Sky Channel.

PRESS DOWN (C. Murray) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

SHUFFLE DANCER (W. Egan) - jumped away awkwardly and shifted in on to LITTLE MISS KUBI, and then was hampered when it continued to bump with that runner for a number of strides.

SHE DANCES (L. Meech) - slipped behind on jumping away.

SEVEN VEILS (J. Allen) - at the entrance to the straight shifted in slightly and contacted HOPE AT HAND.

ROYAL MERCHANT (M. Dee) - inconvenienced on jumping away when tightened onto LITTLE MISS KUBI by SWEETENED.

LITTLE MISS KUBI (J. Toeroek) - hampered on jumping away when tightened between ROYAL MERCHANT, which was taken out, and SHUFFLE DANCER, which shifted in. Rider reported the filly slipped behind on jumping away and made excess respiratory noise over the concluding stages and on pulling up. He added that in his opinion the filly had choked down. A post-race veterinary examination revealed it shifted its near hind plate.

HOPE AT HAND (J. Holder) – at the entrance to the straight was inconvenienced when contacted by SEVEN VEILS, which shifted in, and then was disappointed for a run between that filly and SWEETENED and was obliged to alter course approaching the 200m to obtain clear ground.

SWEETENED (C. Williams) - jumped away awkwardly and shifted out bumping ROYAL MERCHANT. A post-race veterinary examination revealed no visible abnormalities.

# RACE 9: GRAND SYNDICATES HANDICAP - 1200 Metres

JACKS ON ICE (J. Toeroek) - laid out under pressure over the concluding 100m.

SIYATA (GB) (B. Price) – jumped away awkwardly. Near the 1000m was inconvenienced when tightened between DELIGHTFULSHECKY, which shifted out at the same time as HATEECH shifted in. Raced fiercely in the middle stages.

CHARLESFORT (T. Voorham) - laid in under pressure in the straight.

SMILING FROM ABOVE (A. Livesey) – a post-race veterinary examination revealed the mare to be lame in the off foreleg (2/5). Trainer, Ms D. Stra, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

STRAWBERRY SWING (Z. Spain) - a post-race veterinary examination revealed no visible abnormalities.

MAGICOURT (K. Crowther) - slow to begin.





TOAST THE DEEL (T. Pannell) - held up rounding the home turn until inside the 300m. Laid out under pressure in the straight.

HATEECH (J. Opperman) - rider reported that he had become concerned with the mare's action over the concluding stages of the event. A post-race veterinary examination revealed no visible abnormalities.

SAMESYN (L. Meech) - approaching the finish had to be momentarily steadied when TOAST THE DEEL shifted out into its running line.

GRANDMA GAIL (A. Jordsjo) - raced keenly in the early and middle stages. Raced wide without cover throughout the event. When questioned in relation to her instructions in this event rider explained that she had been instructed to obtain a midfield position with cover; however, the mare jumped away extremely well and then commenced to race fiercely and she was unable to restrain to find that position, Trainer, Mr C. Reardon, confirmed that the instructions were to settle behind midfield with cover.
