TRACK: Soft 7 (Rain affected track that will chop out)

Downgraded to Heavy 8 at 2.37pm retrospective to Race 4

(Rain affected track that horses will get into)

Downgraded to Heavy 9 at 3.12pm retrospective to Race 5

(Wet track getting into a squelchy area)

RAIL: Out 8 metres 800m to 400m, out 5 metres remainder.

RACE 1: TRIMBOLI SERVICES MAIDEN PLATE - 1500 Metres

BARDOUTES (R. Hurdle) - rider explained that in his opinion the gelding may be suited by the addition of blinkers to its race day gear. A post-race veterinary examination revealed no visible abnormalities.

THE PENSKE FILE (D. Tourneur) - rider explained that the gelding laid in badly over the concluding stages, and as he was aware that BARDOUTES was racing back to his inside he was unable to ride his mount out in his normal manner over the concluding stages.

WHYS (A. Livesey) - rider reported that the gelding laid in under pressure in the straight.

CRIMSON VINE (NZ) (T. Voorham) - rider reported that her mount began awkwardly, and as a result settled further back than intended.

IVA DREAM (J. Holder) - rider reported that the filly over-raced in the early stages of the event, and was disappointing and did not respond to his riding when placed under pressure. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: KINGSFORD HOTEL MAIDEN PLATE - 1100 Metres

MR RODMAN (NZ) (S. Payne) - began awkwardly and lost ground as a result.

RANGER'S LINE (C. Murray) - near the 800m shifted in taking VELVET STAR in onto TENTERK which had to be steadied. Rider was reprimanded and advised to take greater care when shifting in future.

TENTERK (S. Tomlinson) - raced keenly in the early and middle stages of the event, and near the 800m had to be eased when tightened for room between ARCTIC FLORA and VELVET STAR, which was taken in by RANGER'S LINE, which shifted in.

PROVEN CORRECT (J. Holder) - rider reported that the gelding began only fairly and as a result settled further back than intended, as it had at its only other previous start. He further explained that when placed under pressure PROVEN CORRECT responded well to his riding and finished the race off well. He added that in his opinion the gelding would be better suited in races over longer distance than in today's event. A post-race veterinary examination revealed no visible abnormalities.

RACE 3: IRONGATE AUSTRALIA MAIDEN PLATE - 2100 Metres

OH SHOW (J. Eaton) - began awkwardly.

REBEL CADEAU (A. Jordsjo) - rider was reminded of her obligation to ride her mounts out fully to the end of the race.

SURVEY LANE (B. Wong) - near the 400m shifted in before being straightened by its rider. Rider was advised to exercise greater care when her mounts commence to shift ground in future.

FOXY EAGLE (F. Atkinson) - rider reported that the mare hung in, in the straight.

HUSSLING (A. Livesey) - began awkwardly.

VOILA LA VALSE (C. Tootell) - near the 400m had to be steadied when racing in restricted room to the inside of SURVEY LANE, which shifted in before being straightened by its rider.

BLACK MARMALADE (NZ) (B. Price) - laid out under pressure from near the 500m to approaching the 200m.

FLUEY'S CHOICE (S. Payne) - began awkwardly.

RACE 4: WOLF BLASS WINES RASCALS CUP BENCHMARK 58 HANDICAP - 2100 Metres

TOYETIC (H. Yuen) - held up rounding the home turn. Near the 1700m, when laying in, shifted in onto RAPID RIDE, which had to be checked. Rider was severely reprimanded and advised that in similar circumstances she would be expected to make a far greater effort to keep her mounts straight.

THE MINIVAN (R. Hurdle) - near the 1700m had to be steadied to avoid the heels of RAPID RIDE, which had also been steadied. Near the 300m had to be steadied to avoid the heels of BELLAVARDO (NZ), which shifted out. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer, Mr G. Young, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

COWLEY'S CREEK (R. Pearson) - approaching the winning post on the first occasions shifted in onto RAPID RIDE, which got its head up when being eased to avoid heels. Rider was reprimanded and advised in future to ensure she was clear of other runners prior to shifting ground.

BELLAVARDO (NZ) (D. Tourneur) - near the 1700m had to be steadied to avoid the heels of RAPID RIDE, which had been tightened for room and checked. Near the 300m shifted out onto THE MINIVAN, which had to be steadied. Rider was reprimanded and advised in future to ensure he was clear to shift ground in future.

RACE 4: WOLF BLASS WINES RASCALS CUP BENCHMARK 58 HANDICAP - 2100 Metres (cont'd)

RAPID RIDE (J. Eaton) - approaching the winning post on the first occasion got its head up when having to be eased to avoid the heels of COWLEY'S CREEK, which shifted in. Near the 1700m had to be checked when tightened for room by TOYETIC, which shifted in when laying in. Rider reported that the gelding gave ground quickly in the straight and did not respond to her riding when placed under pressure. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: WOLF BLASS WINES MUSEUM CLASS ONE HANDICAP - 1200 Metres

TEQUILA SUNSET (B. Wong) - rider could offer no explanation for the mare's poor performance. A post-race veterinary examination revealed no visible abnormalities.

MISS MIDUKI (S. Fawke) – rider reported that the mare laid out under pressure in the straight. Rider weighed in 0.5kg in excess of his allotted weight and was severely reprimanded under AR211. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100m and was severely reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by S. Fawke and noted that he used it on five occasions over the final 100m of the event.

STARLITE REBEL (C. Tootell) - slow to begin. Over-raced in the early stages of the event. When improving near the 100m had to be steadied to avoid the heels of TEQUILA SUNSET.

RACE 6: WOLF BLASS ADELAIDE HILLS WINE BAR HAHNDORF BENCHMARK 58 HANDICAP - 1200 Metres

MAGIC PHANTOM (B. Wong) - near the 100m was hampered and steadied to avoid the heels of SIR LEAPALOT, which shifted out under pressure.

SIXFOOTONE (T. Pannell) – rider reported that the horse did not handle today's track conditions. A post-race veterinary examination revealed no visible abnormalities.

SIR LEAPALOT (J. Doyle) – began awkwardly and shifted out hampering FIZIQUE. Laid out under pressure in the straight.

BAJAN BELLE (A. Livesey) – acting on confirmed advice from Trainer, Mr R. Balfour, that the mare was lame in the near foreleg and would be unsuitable to race Stewards declared BAJAN BELLE a late scratching at 9.32am. Mr Balfour was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

DANCING STREAM (H. Yuen) - over-raced in the early stages of the event.

ALL BEANS (S. Fawke) - a post-race veterinary examination revealed the gelding to have bled from both nostrils. Trainer, Mr J. Pickering, was advised that as this was the gelding's first bi-lateral bleed it would now be suspended from racing for a period of three months in accordance with AR79(4) and would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future trial or race.

FIZIQUE (C. Jones) - hampered on jumping away when contacted by SIR LEAPALOT, which began awkwardly and shifted out.

RACE 7: COOPERS BREWERY RATING 0-58 HANDICAP - 1500 Metres

MR COYNE (S. Tomlinson) - near the 1000m shifted out onto SO BLUCKY, which had to be steadied. Rider was reprimanded under AR131(a) for careless riding.

FIGHT FOR FREEDOM (J. Holder) - raced keenly in the early and middle stages of the event.



RACE 7: COOPERS BREWERY RATING 0-58 HANDICAP - 1500 Metres (cont'd)

LYNDA'S LEGACY (J. Doyle) - lost its off fore plate during the event. A post-race veterinary examination revealed the filly to be lame in the off foreleg (4/5). Co-trainers, Mr G. Lesnikowski and Mr R. Hannemann, were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

FIAMETTE (R. Hurdle) - slow to begin.

MAGICLANE (S. Fawke) - slow to begin.

SO BLUCKY (J. Eaton) - over-raced in the early stages of the event.

VEGAS DESTINY (NZ) (R. Pearson) – stood flat-footed as the start was affected and lost considerable ground. Trainer, Mr T. Day, was advised that a warning had been placed on the gelding. Rider reported that the gelding did not feel comfortable in its action. A post-race veterinary examination revealed no visible abnormalities.
