## RACE 1: MJ GELDART DESIGNER JEWELLER MAIDEN HANDICAP - 1200 Metres

The start of this event was delayed approximately three minutes owing to the photo finish camera malfunctioning.

ONELOLLY'SENUFF (C. Murray) - held up for clear running from the 500m until the 300m. Raced greenly in the straight.

WEALTHY GIRL (B. Wong) - jumped away awkwardly.

RED FEATS (A. Jordsjo) - slow to begin.

## RACE 2: MICK HAMMILL TRANSPORT MAIDEN PLATE - 1498 Metres

INNER SANCTUM (J. Potter) - laid out from the 400m until the 200m.

GLACIES HEART (C. Tootell) - laid out in the straight.

## RACE 3: PORT AUGUSTA ISUZU BENCHMARK 56 HANDICAP - 1498 Metres

DIVINA SHOW (NZ) (C. Murray) - rider reported that the mare never travelled throughout the event. A post-race veterinary examination revealed no visible abnormalities.

DESSERT TIME (S. Fawke) - slow to begin.

DINGABLEDINGA (D. Caboche) - jumped away awkwardly. Laid out in the straight.

FLYWAY (J. Potter) - following the declaration of acceptances trainer, Mr S. Westover, made a gear application to add a tongue-tie to the gelding's gear. Stewards acceded to this request and acting under AR206(2) fined Mr Westover \$200.



RACE 3: PORT AUGUSTA ISUZU BENCHMARK 56 HANDICAP - 1498 Metres (cont'd)

JUST JAZZ (R. Milnes) - laid out in the straight. Rider reported that the mare was inclined to lay out throughout the event.

MELMAC (A. Jordsjo) - laid out from the 500m. Rider reported that the gelding was inclined to lay out throughout the event.

RACE 4: D & G TYRES BENCHMARK 56 HANDICAP - 1867 Metres

CONQUEST OF TEARS (S. Fawke) - Stewards permitted S. Fawke to ride the mare 0.5kg over its allocated weight of 54.0kg. Underwent a pre-race veterinary examination on arrival at the barriers and was deemed suitable to start. Slow to begin.

RACE 5: PFD FOOD SERVICES RATING 0-52 HANDICAP - 1200 Metres

LAKEHURST (R. Milnes) - laid in, in the early stages of the event. In the vicinity of the 1000m shifted in and away from GULINGI tightening the running of CASE CLOSED.

RICHED (S. Fawke) - raced greenly throughout the event. In the vicinity of the 900m shifted in and became awkwardly placed on the heels of VARIARA for a short distance.

BROMELIA (NZ) (H. Yuen) - slow to begin.

CASE CLOSED (C. Tootell) - in the vicinity of the 1000m had to be steadied to avoid the heels of LAKEHURST, which shifted in and away from GULINGI.

TOUGH LASSIE (F. Atkinson) - a post-race veterinary examination revealed no visible abnormalities.

RACE 6: NORTHPOINT PORT AUGUSTA FLYING DOCTOR CUP BENCHMARK 64 HANDICAP - 1100 Metres

MYSTICANO (H. Yuen) - a post-race veterinary examination revealed the gelding to be lame in the near foreleg (4/5). First aid administered. Co-trainer, Mr D. Magro, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

JIMMY DA DOZER (J. Potter) - inside the 400m rolled in and inconvenienced THE CASSINI.

THE CASSINI (C. Murray) - jumped away awkwardly, shifted in and bumped VIVA LA VIDA. Inside the 400m had to be steadied when tightened by JIMMY DA DOZER, which rolled in.

MENDOORAN (S. Fawke) - a post-race veterinary examination revealed no visible abnormalities.


VIVA LA VIDA (B. Wong) - on jumping away shifted out and bumped THE CASSINI.

RACE 7: ROSSIGNS & MULTI PRINT RATING 0-54 HANDICAP - 1396 Metres

TALLU (C. Murray) - rider reported that the gelding raced keenly in the early stages of the event.

ONE MORE GRANDY (J. Potter) - fractious in the barriers after being loaded. Underwent a pre-race veterinary examination and was deemed suitable to start. Rider explained that the mare travelled well throughout the event; however, when placed under pressure was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

MAGICLANE (A. Livesey) - laid out rounding the home turn.



MELINKE (F. Atkinson) - underwent a veterinary examination on arrival on course which revealed the gelding to be lame in the near hind leg (4/5) and therefore be unsuitable to start. Acting on this advice Stewards declared MELINKE a late scratching 11.49am. Co-trainer, Mrs Jaensch was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

RACE 7: ROSSIGNS & MULTI PRINT RATING 0-54 HANDICAP - 1396 Metres (cont'd)

ALKAAMEL (H. Yuen) - at the entrance to the straight rider elected to shift in to obtain clear running. Laid out under pressure approaching the finish.

CAITLIN'S ANGEL (S. Fawke) - Stewards permitted S. Fawke to ride the mare 0.5kg over its allocated weight of 54.0kg.

SHE'S FULL OF IT (D. Caboche) - Stewards permitted D. Caboche to ride the mare 0.5kg over its allocated weight of 54.0kg. Laid in, in the straight.

Prior to the first race Stewards were advise by the Judge that the photo finish system was malfunctioning and would be unavailable for the day. Acting under AR214 the placings for each race were determined by the Judge and all races were manually timed.
