Report on Race Meeting held at Port Augusta
Racecourse by the Port Augusta Racing Club on
Sunday, 9 July 2023

RACE 1: AUGUSTA AUTOMALL BENCHMARK 58 HANDICAP - 1600 Metres

TRANSZAM (C. Murray) - near the 150m dislodged its rider. A post-race veterinary examination revealed no visible abnormalities. Rider C. Murray was examined by the First Care Medical personnel and transported to hospital for further assessment and observation. An inquiry into this incident was adjourned to a time and place to be fixed to allow C. Murray to be present.

KID KINGDOM (A. Jordsjo) - slow to begin.

Due to the delay following the incident in this race the start times of Race 2 and 3 were amended.

RACE 2: CENTURY 21 PORT AUGUSTA MAIDEN PLATE - 1600 Metres

Due to the delay following Race 1 this event was rescheduled to start at 1.02pm.

INNER SANCTUM (J. Potter) - rider could offer no explanation for the gelding's disappointing performance. A post-race veterinary examination revealed no visible abnormalities.

BARBADSON (F. Atkinson) - raced keenly in the early stages of the event.

PHORCYS (NZ) (C. Murray) - underwent a pre-race veterinary examination on arrival on course and was found to have swelling to the near fore tendon and therefore was deemed unsuitable to start. Acting on this advice Stewards declared PHORCYS (NZ) a late scratching at 11.36am. Trainer, Mr R. Atkinson, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

ROYAL LANDING (C. Tootell) - jumped away awkwardly.



RACE 3: XXXX MAIDEN HANDICAP - 1100 Metres

Due to the delay following Race 1 this event was rescheduled to start at 1.30pm.

EMMOOKI MAGIC (D. Caboche) – Stewards permitted D. Caboche to ride the filly 0.5kg over its allocated weight of 54.0kg. Underwent a pre-race veterinary examination on arrival at the barriers and deemed suitable to start.

SOLE SILENCE (A. Livesey) – a post-race veterinary examination revealed no visible abnormalities.

TENTATIVE BID (F. Atkinson) – hung out throughout the event and proved difficult to ride. A post-race veterinary examination revealed no visible abnormalities. Trainer, Mr R. Atkinson, was advised that a warning had been placed on the filly in relation to its racing manner.

RACE 4: CAREER CO CLASS 2 HANDICAP - 1396 Metres

SUPER SHARP (H. Yuen) – shifted out on jumping away and bumped with STAKE A CLAIM.

BIEN CUIT (B. Wong) – jumped away awkwardly and as a result was slow to begin. Near the 1000m bumped the inside running rail.

MAGICLANE (A. Livesey) – acting on confirmed advice from trainer, Ms K. McKerlie, that the mare had a stone bruise to its off fore hoof and would be unsuitable to start Stewards declared MAGICLANE a late scratching at 8.30am. Ms McKerlie was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

STAKE A CLAIM (A. Jordsjo) – on jumping away bumped with SUPER SHARP, which shifted out.

RACE 5: MAX SERVICES RATING 0-54 HANDICAP - 1498 Metres

OBELOS (GB) (A. Jordsjo) – raced keenly in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

SMART STYLE (B. Wong) – jumped away awkwardly and as a result was slow to begin.

RACE 6: PA & CI MARTIN PTY LTD RATING 0-54 HANDICAP - 1100 Metres

BLUE LUNA (H. Yuen) – a post-race veterinary examination revealed the gelding to be making abnormal respiratory noises. Co-trainer, Mrs N. Searle, was advised that the results of an endoscopy and a Veterinary Clearance would be required prior to a future jump-out, trial or race start.


RICHEDE (C. Rawiller) – Stewards permitted C. Rawiller to ride the gelding 0.5kg over its allocated weight of 59.0kg as no other suitable rider was available. Rider pleaded guilty to a charge under AR190(3) and was fined \$200. Rider explained that the gelding hung in, in the straight and proved difficult to ride out and as a result was unable to be fully tested over the concluding stages when awkwardly placed on the heels of WANDERING EYE.

WANDERING EYE (B. Wong) – laid out in the straight.

MENDOORAN (D. Caboche) – slow to begin. Raced keenly in the early and middle stages of the event. Held up for clear running from the 400m until inside the 100m.

CASE CLOSED (C. Tootell) – jumped away awkwardly and as a result was slow to begin.

RACE 7: CITY OF PORT AUGUSTA CUP - 2300 Metres



SHINY ROCK (C. Rawiller) – hung out in the straight and proved difficult to ride over the concluding stages. A post-race veterinary examination revealed no visible abnormalities. Trainer, Mr G. Lynch, was advised that a warning had been placed on the gelding in relation to its racing manners.

RACE 7: CITY OF PORT AUGUSTA CUP - 2300 Metres (cont'd)

GRINZINGER ALLEE (NZ) (J. Potter) - a post-race veterinary examination revealed no visible abnormalities.

BADISS (A. Livesey) - passing the winning post on the first occasion became awkwardly placed on the heels of RITRATTO, got its head up when being restrained and raced ungenerously for a short distance.

MOJO CLASSIC (A. Jordsjo) - laid in, in the straight.

RACE 8: ADELAIDE GALVANISING INDUSTRIES BENCHMARK 66 HANDICAP - 1200 Metres

CLASSY BANNER (C. Tootell) - Stewards permitted apprentice C. Tootell to replace rider C. Murray as there was no senior rider available to ride the gelding.

SANDSATION (C. Rawiller) - laid out under pressure in the straight.

SO SILENT (A. Jordsjo) - underwent a pre-race veterinary examination on arrival at the barriers and was deemed suitable to start.

DJANGO EXPRESS (A. Livesey) - slow to begin. Near the 600m shifted out onto JUSTEDEE. Rider was reprimanded and advised to make a greater effort to ensure she was sufficiently clear when shifting ground in future.

JUSTEDEE (D. Caboche) - near the 600m was hampered when DJANGO EXPRESS shifted out. Inside the 100m was disappointed for a run between DJANGO EXPRESS and SANDSATION, and shifted out to obtain clear running.
