

## RACE 1: COMMERCIAL HOSPITALITY SERVICES GELDINGS & ENTIRES MAIDEN PLATE- 1200 Metres

The start of this event was delayed approximately two minutes.

CALL IT QUITS (L. Neindorf) – hampered on jumping away and lost its position when tightened onto MY BOY JETT by SNIPERS NIGHTMARE. Raced greenly in the straight.

GROGU (C. Jones) – jumped away awkwardly, shifted out and contacted SPITFIRE SUN. Rider reported that the gelding had only travelled fairly in the early and middle stages and when placed under pressure did not stretch out as she had anticipated. She added that in her opinion GROGU may be better suited on a firmer surface. A post-race veterinary examination revealed no visible abnormalities.



MY BOY JETT (R. Hurdle) - raced wide without cover throughout the event.

#### RACE 1: COMMERCIAL HOSPITALITY SERVICES GELDINGS & ENTIRES MAIDEN PLATE- 1200 Metres (cont'd)

SEVEN SHOTS (K. Crowther) - laid in under pressure in the straight.

SNIPERS NIGHTMARE (J. Holder) – difficult to load. Trainer, Mr B. Bogarts was advised that a warning had been placed on the gelding in relation to its pre-race behaviour. Shifted in on jumping away onto CALL IT QUITS. Hung out rounding the home turn and under pressure in the straight.

SPITFIRE SUN (R. Milnes) - contacted on jumping away.

### RACE 2: GAWLER ARMS HOTEL FILLIES & MARES MAIDEN PLATE - 1200 Metres

ANDAMOOKA (R. Milnes) – raced keenly in the early and middle stages of the event. Inconvenienced near the 200m when contacted by INAGURATE. Rider explained that the mare raced keenly in the early and middles stages of the event; however, did not respond when placed under pressure at the entrance to the straight. She added that in her opinion the mare would be better suited on a firmer track. A post-race veterinary examination revealed no visible abnormalities.

GADIDAE (J. Holder) - hung out rounding the home turn and under pressure in the straight.

INAGURATE (S. Fawke) – in the vicinity of the 200m shifted out to improve and in doing so brushed with ANDAMOOKA.

WANDJINA GAL (T. Voorham) - had difficulty obtaining clear ground from the entrance to the straight until near the 100m. Inclined to lay in under pressure in the straight.

RACE 3: HOLDFAST INSURANCE BROKERS CLASS ONE PLATE - 2112 Metres

BELMONT AVENUE (IRE) (J. Opperman) - jumped away awkwardly, shifted out and contacted HOSTESS SUSIE.

JAJITTA BUG (J. Potter) - raced keenly in the early and middle stages of the event.

JOPHIEL (NZ) (J. Holder) - contacted on jumping away.

BONJOUR BLUE (K. Crowther) - jumped away awkwardly, shifted out and brushed JOPHIEL (NZ).

HOSTESS SUSIE (S. Payne) - inconvenienced on jumping away when contacted by BELMONT AVENUE (IRE).

RITZ (S. Logan) - laid out under pressure in the straight.

BLACK MARMALADE (NZ) (B. Price) – raced wide without cover from the 1200m. When questioned in relation to his tactics in the middle stages, in particular near the 1000m, and whether he had an option to improve and attempt to hold the favourite, BELMONT AVENUE (IRE), in a pocket, rider explained that he had been aware of the position of BELMONT AVENUE (IRE); however, felt that he had presented his horse too early at its most recent start and that he would be better suited maintaining his position in the hope that BELMONT AVENUE (IRE) might shift out to a position three wide, where he would be able to follow it into the race. He added that near the 800m when BELMONT AVENUE (IRE) shifted out, he was unable to obtain a position behind it and was obliged to race to the outside of that gelding.

# RACE 4: SANDERS FODDER CLASS ONE HANDICAP - 1100 Metres

The start of this event was delayed approximately 13 minutes owing to SEE YOU LATER NOW becoming cast in its barrier.



HOT ROD BOY (S. Payne) - jumped away awkwardly and shifted in abruptly onto JILLADORA. Hung in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

# RACE 4: SANDERS FODDER CLASS ONE HANDICAP - 1100 Metres (cont'd)

FOURTH POWER (B. Price) – rider reported that it was his intention to settle further forward; however, after beginning a touch slower than he had anticipated, he was required to settle further back.

MULHALL (S. Tomlinson) – laid out under pressure over the concluding 100m. Rider reported that the mare did not feel comfortable in its action on pulling up. A post-race veterinary examination revealed the filly to be lame in the near hind leg (2/5). Co-trainers, Mr R. Jolly and Miss C. Jolly, were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

JILLADORA (T. Voorham) - hampered on jumping away when taken in by HOT ROD BOY.

WILLASTON (J. Holder) – when Stewards questioned in relation to the strong support in betting for the gelding, Mr R. Balfour explained that the stable had not supported the gelding; however, they felt it was a very strong chance in the event given that it was down in grade and distance.

SEE YOU LATER NOW (S. Logan) – got down in the barrier and became cast after being loaded and dislodged its rider. Underwent a pre-race veterinary examination and was deemed unsuitable to race. Acting on this advice SEE YOU LATER NOW was declared a late scratching by order of Stewards at 2.33pm. Trainer, Mr D. Hewitt was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start. Mr Hewitt was further advised that the mare was now required to prove tractable in the barriers an Official Barrier Trial prior to a future race. S. Logan was examined by First Care Medical personnel and was declared unfit to fulfil her remaining engagement.

DR COPPER (A. Lai) – approaching the 100m improved onto the heels of MULHALL and was obliged to alter course to that mare's inside to obtain clear ground.

THE REGULAR SHOW (A. Jordsjo) - raced keenly in the early and middle stages of the event.

### RACE 5: LJ HOOKER PROPERTY SPECIALISTS / GAWLER & BAROSSA CLASS TWO HANDICAP - 1506 Metres

AHSO (R. Milnes) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

POOL PONY (J. Toeroek) - laid out under pressure in the straight.

SIPSMITH (B. Wong) - jumped away awkwardly.

ZERO INN (A. Jordsjo) – laid out under pressure in the straight. Rider explained that the mare travelled fairly in the early stages; however, when placed under pressure in the straight commenced to lay out and failed to respond to her riding. A post-race veterinary examination revealed no visible abnormalities.

ALPINE FUN (E. Finnegan) - Stewards permitted E. Finnegan to ride 0.5kg over its declared weight of 54.0kg.

INDY MAGIC (S. Fawke) - raced fiercely in the early and middle stages of the event.

TALES OF CONFLICT (J. Doyle) - raced fiercely in the early and middle stages of the event.

# RACE 6: PURE WINE CO BENCHMARK 58 HANDICAP - 1706 Metres

TRANSZAM (C. Jones) - slow to begin.

DELAYED ACTION (B. Price) - raced keenly in the early and middle stages of the event.



GETOUTTHEWAY (R. Hurdle) – a post-race veterinary examination revealed the gelding to be lame in the near foreleg (2/5). Trainer, Ms S. Nolan, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

## RACE 6: PURE WINE CO BENCHMARK 58 HANDICAP - 1706 Metres (cont'd)

EXOPIPI (D. Tourneur) - raced wide without cover throughout the event.

FIAMETTE (L. Neindorf) - slow to begin. Laid in under pressure in the straight.

ALLUSION (J. Holder) – had difficulty obtaining clear ground from near the 500m until near the 200m.

DON'T DISMISS (J. Potter) - raced keenly in the early and middle stages of the event.

## RACE 7: ADELAIDE PLAINS BLOODSTOCK BENCHMARK 58 HANDICAP - 1200 Metres

The start of this event was delayed approximately two minutes.

HASSLEFREE (R. Hurdle) - rider reported that he had not intended to settle in the lead; however, the gelding jumped away well and obtained that position of its own accord.

SIR LEAPALOT (R. Milnes) – got its leg up prior to breaking through the barrier structure and was quickly recaptured. Underwent a pre-race veterinary examination and was deemed unsuitable to race. Acting on this advice SIR LEAPALOT was declared a late scratching by order of Stewards at 4.15pm. Co-trainer, Mr G. Lesnikowski, was advised that a Veterinary Clearance would be required prior to a future jump-out or trial. He was further advised that the gelding would be required to prove tractable in either an Official Barrier Trial or Approval to Race Jump-out prior to accepting for a future race.

MCCAIN (L. Neindorf) - laid in under pressure in the straight.

DJANGO EXPRESS (K. Crowther) - stood flat-footed and was slow to begin. Trainer, Mr B. Davis, was advised that a warning had been placed on the gelding.

THE BIG FREEZE (J. Toeroek) - shifted about under pressure in the straight.

FINGOLFIN (NZ) (B. Price) - change of tactics - attempt to take settle to settle back from the wide barrier draw. Settled back with cover.

BAJAN BELLE (J. Holder) - laid out under pressure in the straight.

SEBAGO (C. Jones) – near the 1100m rolled in slightly onto RUSTYDUSTYSUNSHINE, which was forced to race in restricted room for a number of strides. A post-race veterinary examination revealed the gelding to have bled from both nostrils. Trainer, Mr A. Beswick, was advised that as this was the gelding's second bi-lateral bleed it was now ineligible to start in a race in accordance with AR79(6).

RUSTYDUSTYSUNSHINE (B. Wong) – in the vicinity of the 900m was forced to race in restricted room for a number of strides when awkwardly placed to the inside of SEBAGO Approaching the 400m became awkwardly placed on the heels of SEBAGO and was obliged to alter course to that gelding's outside to obtain clear ground.

SAND CAT (A. Jordsjo) - raced wide without cover throughout the event.

VALLEY RATTLER (J. Potter) - slow to begin.
