

Racing SA Ltd Stipendiary Stewards' Report

Report on Race Meeting held at Roxby Downs
Racecourse by the Roxy Downs & District Racing
Club on Saturday, 5 August 2023

RACE 1: DIXON MAIDEN PLATE - 1000 Metres

BROOKKONG (M. Henderson) - slow to begin. Laid out in the straight.

EMMOOKI MAGIC (L. Miller) - jumped away awkwardly. Laid in under pressure in the straight.

PAOLA (C. Reynolds) - following the declaration of acceptances, Trainer, Mr T. Montgomerie made a gear application to add blinkers to the mare's race gear. Stewards acceded to this request and acting under AR206(2) reprimanded Mr Montgomerie. Raced greenly throughout the event. Approaching the 800m when racing greenly shifted in and rider became unbalanced for a short distance. A post-race veterinary examination revealed the mare to be lame in the off hind leg (2/5). First aid administered. Trainer, Mr T. Montgomerie was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

POP 'N' PARK (NZ) (H. Yuen) - a post-race veterinary examination revealed no visible abnormalities.

RACE 2: ATG MAXIFLEX BENCHMARK 54 HANDICAP - 1000 Metres

RICHED (S. Fawke) - raced keenly in the early and middle stages of the event. Laid in, in the straight.

HEY MICHAEL (C. Tootell) - a post-race veterinary examination revealed the gelding had a laceration to its near hind leg consistent with being galloped on. First aid administered.

OAKFIELD GERONIMO (J. Doyle) - laid out in the straight. Rider was reminded of her obligations under AR131(a).

FINAL CHANCE (L. Miller) - Stewards permitted L. Miller to ride 0.5kg over its declared weight of 56.0kg.

RACE 3: MINE TECH ENGINEERING BENCHMARK 64 HANDICAP - 1200 Metres

PERFECT COMMAND (B. Wong) - jumped away very awkwardly and as a consequence rider lost use of her off side stirrup iron for a short distance. A post-race veterinary examination revealed no visible abnormalities.





RACE 3: MINE TECH ENGINEERING BENCHMARK 64 HANDICAP - 1200 Metres (cont'd)

REAL ROY (S. Fawke) - rider reported that the gelding did not handle today's track conditions. A post-race veterinary examination revealed no visible abnormalities.

ARCHWAY TO HEAVEN (L. Miller) - Stewards permitted L. Miller to ride 1.0kg over its declared weight of 55.5kg. Rider pleaded guilty to a charge under AR211(1) and was fined \$200.

RACE 4: NATIONAL JOCKEY TRUST BENCHMARK 58 HANDICAP - 1400 Metres

DIVINA SHOW (NZ) (J. Doyle) - approaching the 800m shifted in when insufficiently clear and took JUSTEDEE in onto SHE'S FULL OF IT. Rider was found guilty of a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence midnight Wednesday, 9 August 2023 and to conclude midnight Wednesday, 16 August 2023, a period of three meetings. In determining penalty, Stewards took into account J. Doyle's good record. A post-race veterinary examination revealed no visible abnormalities.

JUSTEDEE (S. Fawke) - approaching the 800m was taken in onto SHE'S FULL OF IT by DIVINA SHOW (NZ), which shifted in when insufficiently clear.

SHE'S FULL OF IT (A. Lai) - approaching the 800m was obliged to be steadied to avoid the heels of JUSTEDEE. A post-race veterinary examination revealed no visible abnormalities.

Correct weight was delayed to allow Trainer, Mrs P. Trenwith (THE LADIES MAN) placed second, to view the official photo finish.

RACE 5: BHP ROXBY DOWNS CUP - 1800 Metres

DROMEAS (L. Miller) - Stewards permitted L. Miller to ride 2.5kg over its declared weight of 55.0kg. A post-race veterinary examination revealed no visible abnormalities.

OBELOS (GB) (S. Fawke) - a post-race veterinary examination revealed no visible abnormalities.

RACE 6: KALARI QUBE LOGISTICS RATING 0 - 52 HANDICAP - 1400 Metres

MAGIC REWARD (L. Miller) - a post-race veterinary examination revealed no visible abnormalities.

BAY OF ANGELS (J. Doyle) - a post-race veterinary examination revealed no visible abnormalities.

GENERAL

Stewards inquired into an incident that occurred in the scales area following the running of Race 4. After taking evidence from the Clerk of Scales, Mrs F. Worrell, jockey's S. Fawke and J. Doyle were both fined \$200 under AR115(1)(a) for misconduct in that they both used inappropriate language towards each other after the running of Race 4.
