Racing SA Ltd Stipendiary Stewards' Report

Report on Race Meeting held at Balaklava Racecourse by the Balaklava Racing Club on Wednesday, 9 August 2023

RACE 1: SCHWEPPES ENTIRES & GELDINGS MAIDEN PLATE - 1050 Metres

The start of this event was delayed approximately four minutes.

CLARENCE (K. Crowther) - raced keenly in the early and middle stages of the event. Laid out under pressure in the straight and near the 150m shifted out onto SOAMES.

HAVOC (H. Yuen) – became fractious in its barrier, got down and became cast. Underwent a prerace veterinary examination and was deemed unsuitable to start. Acting on this advice Stewards declared HAVOC a late scratching at 12.45pm. Co-trainer, Mrs S. Jaensch, was advised that a Veterinary Clearance would be required prior to the gelding proving tractable in the barriers in an Official Barrier Trial prior to accepting for a future race.

SOAMES (A. Jordsjo) - near the 150m was inconvenienced when taken wider by CLARENCE.

WIRREALPA - acting on confirmed advice from trainer, Mr S. Cahill, that the gelding had slight swelling on its off fore knee and would be unfit to race Stewards declared WIRREALPA a late scratching at 7.45am. Mr Cahill was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

RACE 2: TAYLORS WINES NEW CELLAR DOOR MARES MAIDEN PLATE - 1050 Metres

CHILLI SEA (L. Neindorf) - a post-race veterinary examination revealed a slower than expected recovery.

KATINA JOY (R. Milnes) - jumped away awkwardly and then shortly after was inconvenienced when contacted by YIP YIP. Raced keenly in the early and middle stages of the event.

RACE 2: TAYLORS WINES NEW CELLAR DOOR MARES MAIDEN PLATE - 1050 Metres (cont'd)

LIPS DON'T LIE (K. Crowther) - slow to begin. Laid in under pressure in the straight.

MIGHTY EDGY (B. Wong) - raced wide without cover throughout the event. Laid out rounding the home turn, and then laid in under pressure in the straight.

RUBY RIVER (J. Opperman) - slow to begin.

YIP YIP (J. Holder) - jumped away awkwardly and shifted in contacting KATINA JOY. Rider reported that the mare travelled well; however, had not finished the race off as he had expected. A post-race veterinary examination revealed no visible abnormalities.

RACE 3: GAWLER SOUTH BAKERY MAIDEN PLATE - 1400 Metres

INNER SANCTUM (H. Yuen) - laid out rounding the home turn. Held up from the entrance to the straight until inside the 200m.

LITTLE CHICAGO (C. Reynolds) - raced wide without cover throughout the event. Inclined to shift about under pressure in the straight.

CHENIAH (C. Tootell) - had difficulty obtaining clear ground from the entrance to the straight until inside the 200m.

PETRA'S GIRL (K. Crowther) – rider reported that the mare never travelled, and when placed under pressure failed to respond to her riding. A post-race veterinary examination revealed the mare to be lame in the near hind leg (2/5). Trainer, Mr D. Bonetti, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

SPEC RAIDER (R. Milnes) - slow to begin. Near the 100m became awkwardly placed on the heels of SOCIAL GROUP and had to be steadied for a short distance. Rider was reprimanded under AR132(7)(a)(i) for using her whip in consecutive strides prior to the 100m.

VALENTINA CHARM (L. Neindorf) - a post-race veterinary examination revealed no visible abnormalities.

WIRRINYA (S. Tomlinson) - jumped away awkwardly and shifted out contacting GYPSY SPIRIT.

GYPSY SPIRIT (J. Opperman) - contacted on jumping away.

GO ARTIE (J. Toeroek) - raced keenly in the early and middle stages of the event.

RACE 4: LEON MACDONALD BENCHMARK 58 HANDICAP - 2200 Metres

CAMPOBASSO (NZ) (R. Milnes) - raced keenly in the early and middle stages of the event. Rider reported that the gelding over-raced in the early and middle stages and this may have been the reason that it didn't' finish off the race as she had expected. A post-race veterinary examination revealed no visible abnormalities.

BELLAVARDO (NZ) (L. Neindorf) - slow to begin.

HOSTESS SUSIE (S. Payne) - laid out under pressure in the straight. Rider reported that the gelding raced flat. A post-race veterinary examination revealed no visible abnormalities.

RAPID RIDE (A. Jordsjo) - a post-race veterinary examination revealed no visible abnormalities.

ITALIAN REDWOOD (NZ) (C. Jordan) - laid out under pressure in the straight.

RACE 5: ATLAS EVENT & PARTY HIRE RATING 0 - 56 HANDICAP - 1050 Metres

CLOSED VAULT (J. Toeroek) - a post-race veterinary examination revealed no visible abnormalities.

UTAH JOE (S. Logan) - raced keenly in the early and middle stages of the event.

SEND IT (H. Yuen) - stood flat-footed and was slow to begin. Trainer, Ms K. Byrnes, was advised that a warning had been placed on the mare.

RUSTYDUSTYSUNSHINE (R. Milnes) - rider reported that the mare was inclined to lay in under pressure in the straight.

MAGIC DELTA (C. Jordan) - laid out under pressure in the straight.

SUDDEN IMPACTS (E. Finnegan) – rider reported that the mare made excess respiratory noise during the event and on pulling up. A post-race veterinary examination revealed an abnormal upper respiratory noise. Trainer, Mr G. Young, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race, which included the results of an endoscope of the upper respiratory tract.

RACE 6: BALAKLAVA CUP 13TH SEPTEMBER FILLIES & MARES BENCHMARK 56 HANDICAP - 1400 Metres

KATIM'S CLUB (R. Milnes) - raced keenly in the early and middle stages of the event.

BRAZEN EAGLE (J. Maund) - raced wide without cover throughout the event. A post-race veterinary examination revealed that the mare had jarred up.

CHLOE'S DAY (A. Jordsjo) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

JIVE BABY (C. Reynolds) – jumped away awkwardly and was slow to begin. Hung out from the vicinity of the 1000m until the entrance to the straight. Laid out under pressure in the straight. Stewards questioned the rider in relation to her riding of the mare, in particular over the concluding 100m. She explained that she was unable to improve into the run between LOCHEND UMOSA and JUST JAZZ safely due to the fact that she was concerned that if she had let go of JIVE BABY's head and allowed it to stride that it would shift out and become awkwardly placed on the heels of JUST JAZZ. She added that even though she had a strong hold on the mare, inside the 50m it shifted out of its own accord and became awkwardly placed on the heels of JUST JAZZ.

BROMELIA (NZ) (H. Yuen) - jumped away awkwardly. Raced keenly in the early and middle stages of the event.

POUVOIR DE SOIE (D. Tourneur) - slow to begin.

RACE 7: HUMMER SA COLTS, GELDINGS & ENTIRES BENCHMARK 56 HANDICAP - 1400 Metres

LEBANESE TRADER (T. Pannell) - raced wide without cover throughout the event.

FOX DUNNETT (L. Neindorf) – slow to begin. Held up from the entrance to the straight until inside the 300m.

SUPER CONTENDER (GB) (C. Jordan) - a post-race veterinary examination revealed no visible abnormalities.

DESSERT TIME (S. Tomlinson) – raced wide without cover throughout the event and near the 1000m was inconvenienced when taken wider on the track by VINO DECASA NOSTRA (NZ). Rider reported that the gelding did not feel comfortable in its action throughout the event and for this reason he had not ridden DESSERT TIME out in the straight. A post-race veterinary examination revealed no visible abnormalities. Trainer, Mr J. Lynch, was advised that the gelding would now be required to be competitive in an Official Barrier Trial prior to accepting for a future race.

THE CASSINI (T. Voorham) - a post-race veterinary examination revealed no visible abnormalities.

RACE 7: HUMMER SA COLTS, GELDINGS & ENTIRES BENCHMARK 56 HANDICAP - 1400 Metres (cont'd)

TALES OF CONFLICT (J. Doyle) - held up from the entrance to the straight until inside the 400m. Laid out under pressure in the straight.

VINO DECASA NOSTRA (NZ) (S. Logan) - raced keenly in the early and middle stages of the event and near the 1000m shifted out onto DESSERT TIME, which was inconvenienced when taken wider on the track.

LOOK FOR OPTIONS (H. Yuen) - laid in under pressure in the straight.

APPLIED (D. Tourneur) - near the 250m was disappointed when attempting a run between LEBANESE TRADER, which shifted out slightly, and THE CASSINI, and as a result was obliged to alter course to obtain clear ground.
