

# Racing SA Ltd Stipendiary Stewards' Report



Report on Race Meeting held at Quorn Racecourse

On arrival on course Stewards inspected the track and formed the opinion that a section of the track near the 1200m was unsuitable to race on due to overnight rain. After consultation with riders, trainers and track staff Stewards acting under AR21(f)(ii) altered the race distances for Race 1 (1200m) and Race 2 (1200m) to 1100m. All race times were rescheduled and Race 1 commenced at 1.25pm.

RACE 1: TRANSCONTINENTAL HOTEL QUORN / BURY PLUMBING MAIDEN PLATE - 1100 Metres (Altered from 1200 Metres)

ALMARHOE (R. Milnes) - slow to begin.

ZILX (J. Doyle) - jumped away awkwardly.

WEALTHY GIRL (B. Wong) - became fractious in its barrier after being loaded. Underwent a pre-race veterinary examination and was deemed suitable to race. Near the 800m hung out and proved difficult to ride. Trainer, Mr C. Harrison was advised that a warning had been placed on the mare in relation to its racing and barrier manners.


RACE 2: SALTBUSH PASTORAL SERVICES / SKY TREK WILLOW SPRINGS PASTORAL BENCHMARK 58 HANDICAP - 1100 Metres (Altered from 1200 Metres)

MACCOMO (NZ) (C. Tootell) - jumped away awkwardly.

RICHED (M. Henderson) - laid in, in the straight.

RODNEY (B. Wong) - jumped away awkwardly.

MIZZ BEEBEEFF (R. Milnes) - jumped away awkwardly and as a result was slow to begin. Rider reported that the mare did not handle today's track condition.



Following the running of this event Stewards inspected the track and were satisfied that the track conditions had improved. No further race distances would be altered.

RACE 3: GLANVILLE HOTEL / JENMAR PTY LTD RATING 0 - 52 TROPHY - 1400 Metres

DON'T DISMISS (A. Lai) - jumped away awkwardly, shifted out and bumped MULOFDUBAI.

MULOFDUBAI (B. Wong) - on jumping away bumped with DON'T DISMISS, which shifted out.

LADY DELIGHT (J. Doyle) - slow to begin.

RACE 4: T&C DISTRIBUTORS AUSTRALIA / FLINDERS GIN BENCHMARK 60 HANDICAP - 1400 Metres

FESTIVAL OF LIGHT (B. Wong) - laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

MARYMOUNT LASS (F. Atkinson) - rider reported that the gelding did not handle today's track condition.

DJANGO EXPRESS (C. Tootell) - stood flat footed as the start was effected and lost ground (approximately three to four lengths). Trainer, Mr B. Davis was advised that a warning had been placed on the gelding in relation to its barrier manners.

RACE 5: GJ GARDNER HOMES QUORN CUP (BENCHMARK 70 HANDICAP) - 1900 Metres

PROJECT GUTENBERG (NZ) (F. Atkinson) - jumped away awkwardly.

REX GOLIATH (J. Doyle) - altered course near the 200m when awkwardly placed on the heels of WHITCHETY GRUB.

WHITCHETY GRUB (B. Wong) - laid out under pressure in the straight.

SMART STYLE (C. Reynolds) - a post-race veterinary examination revealed no visible abnormalities.

RACE 6: HAWKER EARTHMOVING / BP HAWKER RATING 0 - 52 TROPHY - 1100 Metres

CASE CLOSED (J. Doyle) - jumped away awkwardly and as a result was slow to begin.

PRINCESS SALLY (A. Lai) - near the 800m appeared to dip and as a result lost ground.

GENERAL

RACE 5: GJ GARDNER HOMES QUORN CUP (BENCHMARK 70 HANDICAP) - 1900 Metres

Stewards questioned Mr T. Day, the Trainer of LETTEMGO and SMART STYLE in relation to both horses being incorrectly presented in Race 5. After taking evidence from Deputy Steward, D. Jonas it was established that the wrong saddles and saddle cloths had been placed on LETTEMGO and SMART STYLE. After considering all the evidence and Mr Day's explanation Stewards charged Mr Day under AR99(1)(b) for failing to present the correct horses to start in Race 5. Mr Day pleaded guilty and after considering all the mitigating factors was fined \$500.
