

# Racing SA Ltd Stipendiary Stewards' Report

Report on Race Meeting held at Port Augusta  
Racecourse by the Port Augusta Racing Club on  
Sunday, 27 August 2023

**RACE 1: ELDERS INSURANCE MAIDEN PLATE - 1100 Metres**

HOLLER HELP (A. Jordsjo) - laid in, in the straight.

MISS ELLAROSE (T. Voorham) - inside the 400m shifted out when insufficiently clear of TARAH'S JOY, which was obliged to be steadied when tightened onto HOLLER HELP. Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence midnight Saturday, 27 August 2023 to conclude midnight Wednesday, 6 September 2023, a period of three meetings.

TARAH'S JOY (S. Fawke) - raced keenly in the early and middle stages. Inside the 400m was tightened onto HOLLER HELP by MISS ELLAROSE, which shifted in, and was obliged to be steadied.

THE ARITHMETICIAN (D. Caboche) - Stewards permitted D. Caboche to ride the filly 0.5kg over its allocated weight of 54.0kg.

**RACE 2: PORT AUGUSTA REFRIGERATION MAIDEN PLATE - 1396 Metres**

GOLDEN AKEED (R. Hurdle) - over the concluding stages improved onto the heels of ZILX and was unable to be fully tested approaching the finish.

NAVY CODE (J. Potter) - a post-race veterinary clearance revealed no visible abnormalities.

TOMMY TOMATO (A. Lai) - in the vicinity of the 1200m shifted out and away from RED FEATS tightening the running of LEMON TART.

ZILX (J. Doyle) - slow to begin. Raced keenly in the early and middle stages of the event. Laid in, in the straight. Rider explained that her intentions were to be more forward in today's event; however, after missing the start she found herself further back than she had anticipated and the gelding then over-raced and laid in, in the straight.

CLASSY LILLY (S. Fawke) - approaching the 100m elected to shift to the outside of ZILX, which laid in.

LEMON TART (R. Milnes) - underwent a pre-race veterinary examination on arrival at the barriers and was deemed suitable to start. In the vicinity of the 1200m was tightened by TOMMY TOMATO, which shifted out. A post-race veterinary clearance revealed no visible abnormalities.



RACE 2: PORT AUGUSTA REFRIGERATION MAIDEN PLATE - 1396 Metres (cont'd)

SUGAR WITH THAT (A. Jordsjo) - jumped away awkwardly and shifted out.

WIRRINYA (H. Yuen) - jumped away awkwardly, shifted in and contacted CAVALLINO.

CAVALLINO (F. Atkinson) - contacted on jumping away.

Correct weight for this event was delayed to allow S. Fawke (CLASSY LILLY), placed fourth, to view the official vision. After doing so S. Fawke lodged an objections against ZILX (J. Doyle) being declared the second placegetter on the grounds of alleged interference in the straight. After considering the evidence, viewing the vision and acting on their own observations Stewards *dismissed* the objection.

RACE 3: DARRYL FULLERTON MEMORIAL RATING 0 - 54 HANDICAP - 1498 Metres

MARINA (R. Milnes) - rider explained that the gelding never travelled in the early stages of the event, was reluctant to race between other runners throughout the event and was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

THE CASSINI (T. Voorham) - raced keenly in the early stages of the event.

MAGICLANE (R. Hurdle) - underwent a pre-race veterinary examination on arrival at the barriers and was deemed suitable to start. Rider explained that the mare was always off the bridle and had to be encouraged to maintain its position with the field. He added that MAGICLANE laid out in the straight and he became concerned with its action over the concluding stages of the event. A post-race veterinary examination revealed the mare to be lame in the off foreleg (2/5). Co-trainers, Ms K. McKerlie & Mr W. Hornhardt, were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

DAVEEDO (B. Wong) - jumped away awkwardly and shifted out.

PRINCESS SALLY (S. Fawke) - Stewards permitted S. Fawke to ride the mare 0.5kg over its allocated weight of 54.0kg.

RACE 4: HAWKER EARTHMOVERS BENCHMARK 62 HANDICAP - 2200 Metres

SANDSATION (R. Milnes) - jumped away awkwardly. Rider explained that it was her intention to settle in the lead; however, after jumping away awkwardly she was obliged to settle further back than anticipated. A post-race veterinary examination revealed the mare to be lame in the near foreleg (2/5). Trainer, Mr M. White, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

FESTIVAL OF LIGHT (A. Jordsjo) - jumped away awkwardly and shifted in and bumped LUCILLE ROSE. Rider reprimanded under AR132(7)(a)(i) in that she used her whip in consecutive strides.

GULINGI (D. Caboche) - laid out throughout the event.

LUCILLE ROSE (H. Yuen) - slow to begin and bumped by FESTIVAL OF LIGHT.

RACE 5: PHILLIP KITTEL MEMORIAL BENCHMARK 56 HANDICAP - 1100 Metres

A THOUSAND DEGREES (D. Caboche) - jumped away awkwardly and as a result was slow to begin.

ZAKYBREE (J. Potter) - jumped away awkwardly, shifted in and hampered VIVA LA VIDA.

DUCHESS NICCI (S. Fawke) - reared on jumping away and as a result was slow to begin.

MAGIC DELTA (H. Yuen) - hung out in the straight and in the vicinity of the 200m took RUSTYDUSTYSUNSHINE wider.



RACE 5: PHILLIP KITTEL MEMORIAL BENCHMARK 56 HANDICAP - 1100 Metres (cont'd)

RUSTYDUSTYSUNSHINE (R. Milnes) - in the vicinity of the 200m elected to shift back to the inside of MAGIC DELTA to maintain its line to the finish.

VIVA LA VIDA (B. Wong) - jumped away awkwardly, shifted out and bumped ZAYBREE.

UNICORNY (F. Atkinson) - laid in under pressure in the straight.

RACE 6: BUDGET RENT A CAR PORT AUGUSTA & WHYALLA RATING 0 - 54 HANDICAP - 1200 Metres

WANDERING EYE (H. Yuen) - hung out throughout the event. A post-race veterinary examination revealed no visible abnormalities. Trainer, Mr C. Harrison, was advised that the gelding would now be required to complete an Official Barrier Trial to the satisfaction of Stewards prior to a future race start.

BROMELIA (NZ) (A. Jordsjo) - shortly after the start lost its position when tightened between WANDERING EYE and RIPPA BUZZ, which both shifted ground.

RACE 7: BRYAN (POPEYE) & LORRAINE HARBRIDGE MEMORIAL BENCHMARK 56 HANDICAP - 1600 Metres

CABINHO (NZ) (B. Wong) - change of tactics - attempt to settle further forward - settled outside leader. A post-race veterinary clearance revealed no visible abnormalities.

DJANGO EXPRESS (T. Voorham) - slow to begin. Laid out from the 600m.

ROYAL LANDING (J. Potter) - a post-race veterinary clearance revealed no visible abnormalities.

RUN ON (NZ) (H. Yuen) - rider explained that from the wide barrier she was caught wide throughout the event and the gelding was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

KID KINGDOM (A. Lai) - slow to begin. Laid in, in the early part of the straight.

WHITCHETY GRUB (S. Fawke) - jumped away awkwardly and shortly after the start lost its position when tightened between OCEANOGRAPHY (NZ) and FIZIQUE, which shifted out.

FIZIQUE (D. Caboche) - laid out from the 400m.
