INTERIM REPORT

RACE 1: ADELAIDE GALVANISING INDUSTRIES HANDICAP - 1550 Metres

PRINCE JOFRA (K. Hannan) - held up from near the 500m until approaching the 300m.

IMPOSSIBLE ACTION (J. Toeroek) - slow to begin. Rider explained that after being slow to begin the gelding never travelled, did not respond to his riding when asked for an effort and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

I'M KENNY (T. Childs) - inclined to lay out under pressure in the straight. Rider explained that the gelding travelled well in the early and middle stages of the event; however, when placed under pressure did not respond to her riding. A post-race veterinary examination revealed no visible abnormalities.

CARBONE (R. Hurdle) - raced keenly in the early and middle stages of the event.

RACE 2: SKYCITY HANDICAP - 1250 Metres

LORD VLADIVOSTOK (NZ) (T. Pannell) - inconvenienced on jumping away when tightened onto THE MAP by CHICAGO STORM. Laid out under pressure in the straight.



RACE 2: SKYCITY HANDICAP - 1250 Metres (cont'd)

CHICAGO STORM (S. Tomlinson) - shifted in on jumping away onto LORD VLADIVOSTOK (NZ). Raced keenly in the early and middle stages of the event. Held up from the vicinity of the 600m until approaching the 200m. Laid out under pressure over the concluding 100m.

SHALAMAN (J. Holder) - inside the 200m shifted in under riding onto RIVER NOIRE, which had to be steadied. Rider severely reprimanded. Laid out under pressure over the concluding 100m.

ALPINE FLYER (K. Hannan) - had difficulty obtaining clear ground until near the 200m when it was disappointed when attempting the same run as CHICAGO STORM, and as a result became held up until approaching the 100m.

THE MAP (L. Neindorf) - Stewards permitted L. Neindorf to ride the mare 0.5kg over its allocated weight of 54.0kg.

RIVER NOIRE (B. Price) – inside the 200m, as it commenced to weaken, had to be steadied when tightened between CHICAGO STORM, which shifted out marginally at the same time as SHALAMAN shifted in. Rider reported that the mare had only travelled fairly in the early stages and was under pressure from the vicinity of the 700m. He added that it was inclined to lay out in the straight and had not finished the event off. A post-race veterinary examination revealed no visible abnormalities.

RACE 3: TAB AUSTRALIAN TRAINERS TRUST HANDICAP - 1000 Metres

COVER STAR (S. Logan) - jumped away awkwardly. Inconvenienced on a number of occasions in the early and middle stages when contacted by GOLDEN DAY, which was laying out.

GOLDEN DAY (T. Pannell) - laid out in the early and middle stages and made contact with COVER STAR on a number of occasions. Continued to lay out for the remainder of the event. Rider reported that the mare was not suited by the pressure on his outside in the early and middle stages, and in his opinion this was the reason it had not finished its race off. A post-race veterinary examination revealed no visible abnormalities.

MADAM FURPHY (K. Hannan) – jumped away awkwardly. A post-race veterinary examination revealed the that the mare had bled from both nostrils. Co-trainers, Mr D. Magro and Ms A. Bush, were advised that as this was the mare's first bi-lateral bleed MADAM FURPHY would now be suspended from racing for a period of three months in accordance with AR79(4) and would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future trial or race.

CROWN MOSHE (T. Childs) - raced wide without cover throughout the event.

EVERLY (B. Price) - a post-race veterinary examination revealed no visible abnormalities.

RACE 4: TRIPLE M HANDICAP - 2400 Metres

The start of this event was delayed approximately three minutes owing to a delay with an interstate race.

THE NEPHEW (T. Pannell) - rider reported that the gelding raced flat throughout the event. A post-race veterinary examination revealed no visible abnormalities.

BOND STREET BEAU (NZ) (L. Neindorf) - Stewards permitted L. Neindorf to ride the gelding 0.5kg over its allocated weight of 54.0kg.

FOOTLIGHTS (NZ) (J. Opperman) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

BELLAVARDO (NZ) (T. Voorham) - laid in under pressure in the straight.



RACE 5: SPRING RACING CARNIVAL AT MORPHETTVILLE - (OCT. 14TH - NOV 11TH) HANDICAP - 1250 Metres

JAAZEB (K. Hannan) - shifted in and away from LAST WAR on jumping away onto TRES BELLE. Raced keenly in the early and middle stages of the event.

ICE SYMPHONY (S. Tomlinson) - raced fiercely in the early and middle stages of the event.

KILLIAKO (K. Crowther) - inconvenienced when rounding the home turn when taken wider by LAST WAR. Laid in under pressure in the straight. Lost its off hind plate during the event.

RUN LIKE HELL (J. Toeroek) - rider explained that the mare was not suited by the tempo in the early and middle stages of the event, which in his opinion proved detrimental to its chances. A post-race veterinary examination revealed no visible abnormalities.

TRES BELLE (J. Holder) - slow to begin and shortly after shifted in and away from JAAZEB and became awkwardly placed on the heels of KILLIAKO. Laid in under pressure in the straight.

LAST WAR (B. Price) - shifted in on jumping away onto JAAZEB. Hung out rounding the home turn taking KILLIAKO wider on the track. Lost its near fore plate during the event.

STAKE A CLAIM (S. Logan) - dipped for no apparent reason approaching the 800m.

Following this event K. Hannan was attended by the First Care Medical personnel and ruled unfit to fulfil her ride in the next race.

RACE 6: FURPHY HANDICAP - 1950 Metres

PROJECT GUTENBERG (NZ) (T. Childs) - inclined to lay out under pressure in the straight.

CROWN HARMONIUM (M. Julius) – laid out rounding the home turn and laid in under pressure in the straight. Rider explained that the mare travelled well in the early and middle stages; however, when placed under pressure from near the 500m failed to let down as she had anticipated, changed stride on a number of occasions and was disappointing to the finish. A post-race veterinary examination revealed a poor recovery.

CHARTIN (NZ) (A. Jordsjo) - near the 1600m was momentarily unbalanced when it laid out and contacted SEAFARING (NZ). A post-race veterinary examination revealed no visible abnormalities.

LEADER'S PRIDE (S. Logan) - raced keenly in the early stages of the event. In the vicinity of the 50m had to be momentarily steadied and alter course when it became awkwardly placed on the heels of CROWN HARMONIUM, which gave ground.

VINO DECASA NOSTRA (NZ) (L. Neindorf) - Stewards permitted L. Neindorf to ride the gelding 0.5kg over its allocated weight of 54.0kg.

Following this event K. Hannan was reassessed by the First Care Medical personnel and permitted to fulfil her remaining rides.

RACE 7: THE FOTOBASE GROUP HANDICAP - 1300 Metres

The start of this event was delayed approximately two minutes owing to a delay with an interstate race.

VERSETTO (C. Murray) - rider explained that the gelding was reluctant racing inside of other runners. A post-race veterinary examination revealed no visible abnormalities.

EASY BEAST (NZ) (S. Logan) - laid out under pressure in the straight.



RACE 7: THE FOTOBASE GROUP HANDICAP - 1300 Metres (cont'd)

STYLISH ENUFF (B. Price) – raced keenly in the early and middle stages of the event. Near the 700m became awkwardly placed on the heels of AIGUILETTE and shifted out taking AITCH D'AMICO wider. Rider explained that he was given no firm instructions other than to see how the gelding jumped away before finding a position. He added that he was also advised to attempt to find a position where the gelding could relax. He further added that the gelding got its head up on jumping away and was slow into stride resulting in him settling back with cover; however, STYLISH ENUFF raced fiercely in the early and middle stages. Trainer, Mr A. Purcell, confirmed the instructions however anticipated the gelding settling in a much more forward position than it had. A post-race veterinary examination revealed no visible abnormalities.

AITCH D'AMICO (T. Pannell) - inconvenienced near the 700m when contacted and taken wider by STYLISH ENUFF.

RACE 8: CROSER HANDICAP - 1000 Metres

ALPHA FLIGHT (S. Tomlinson) - shifted out on jumping away onto BARBADSON. Inclined to lay out under pressure in the straight.

LIBERTY BLUE (S. Cahill) - laid out throughout the event.

SEA WITNESS (J. Holder) - slow to begin.

BIG OPTION (J. Opperman) - raced wide without cover throughout the event.

ZARACE (T. Childs) – approaching the 100m shifted in to a tight run between ALPHA FLIGHT, which rolled out marginally, and SABERMETRIC, resulting in ZARACE being awkwardly placed for a number of strides prior to contacting SABERMETRIC and taking it wider. Stewards were of the opinion that there was insufficient room between ALPHA FLIGHT and SABERMETRIC to attempt the run, and as a result T. Childs was reprimanded and advised in future to ensure there was sufficient room prior to commencing to improve.

SABERMETRIC (L. Neindorf) - raced wide without cover throughout the event.

BARBADSON (D. Tourneur) - inconvenienced on jumping away when tightened onto OUTPOST by ALPHA FLIGHT.

RACE 9: GRAND SYNDICATES HANDICAP - 1400 Metres

YABADABADOO (NZ) (S. Tomlinson) - laid in under pressure in the straight.

ANGASTON (K. Hannan) - lost its off hind plate during the event.

FLYWAY (J. Toeroek) - jumped away awkwardly and was slow to begin. Had difficulty obtaining clear ground at the entrance to the straight.

HASSLEFREE (R. Hurdle) – rider reported that the gelding raced keenly in the early and middle stages, when placed under pressure at the entrance to the straight only responded for a short distance. He added that near the 200m he had become concerned when it shortened up in its action, and for that reason did not ride out in his usual manner. A post-race veterinary examination revealed no visible abnormalities.

CONNEMARA QUEEN (B. Price) - raced keenly in the early and middle stages of the event. Rider pleaded guilty to a charge under AR132(6)(b) in that he used his whip with an action that raised his arm above shoulder height and was fined \$100.

PRICILLA'S CHOICE (C. Murray) - jumped away awkwardly and was slow to begin.

GARRIRE (L. Neindorf) - raced keenly in the early and middle stages whilst being restrained.

STELLA NOTATION (D. Tourneur) - raced keenly in the early and middle stages whilst being restrained. A post-race veterinary examination revealed no visible abnormalities.

RACE 9: GRAND SYNDICATES HANDICAP - 1400 Metres (cont'd)

APPLIED (T. Voorham) - slow to begin.
