RACE 1: QUAYCLEAN HANDICAP- 1250 Metres

HARLEY'N'ROSE (L. Neindorf) - late scratching by order of the Stewards at 8.35am acting on confirmed advice from Co-trainer, Mr D. Moyle that the gelding was showing signs of the onset of a virus and would be unsuitable to race. Co-trainers, Mr G. Richards & Mr D. Moyle were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

HUGGLE TIME (J. Holder) - laid in under pressure in the straight.

OVERSTRIKE (J. Toeroek) - following the declaration of acceptances Trainer, Mr C. Bieg made a gear application to add winkers to the gelding's race gear. Stewards acceded to this request and acting under AR206(2) fined Mr Bieg \$200. Laid in under pressure in the straight.

TROPOPAUSE (R. Hurdle) - hampered on jumping away when tightened between NICISH and THE SECRET BLEND.

NICISH (C. Jones) - jumped away awkwardly and shifted out onto TROPOPAUSE.

THE SECRET BLEND (D. Tourneur) - jumped away awkwardly and shifted in onto TROPOPAUSE.

BURNING BRIGHT (T. Voorham) - raced keenly in the early and middle stages of the event.



RACE 2: TWILIGHT RACING AT MORPHETTVILLE OCTOBER 6TH HANDICAP - 1250 Metres

BULLS ON PARADE (J. Toeroek) - lost its near hind plate during the event. Raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed that the gelding had a minor laceration consistent with being galloped on. First aid administered.

DELIGHTFUL SHECKY (J. Holder) - held up from the entrance to the straight until inside the 300m when it altered course to obtain clear ground.

FOXY FEMME (D. Tourneur) - laid out under pressure in the straight and made contact with JOY MCCOY (NZ) on a number of occasions.

JOY MCCOY (NZ) (B. Price) – near the 700m became awkwardly placed on the heels of FOXY FEMME, shifted out and raced wide without cover for the remainder of the event. Inconvenienced on a number of occasions in the straight when contacted by FOXY FEMME, which laid out.

PRICILLA'S CHOICE (C. Murray) - laid out under pressure in the straight.

JIMMY DA DOZER (T. Voorham) - had to be re-saddle on arrival at the barriers.

LAST WAR (E. Finnegan) - Stewards permitted E. Finnegan to ride 0.5kg over its declared weight of 54.0kg. A post-race veterinary examination revealed no visible abnormalities.

CHEF MILITAIRE (A. Kelly) - raced keenly in the early and middle stages of the event. Held up from the entrance to the straight and near the 200m was disappointed when attempting a run between BULLS ON PARADE and VELVET STAR, which rolled out and was unable to be fully tested to the line.

RACE 3: FURPHY HANDICAP - 1400 Metres

DEEVINE (A. Livesey) - Change of tactics - attempt to take up a forward position in the event if possible. Horse led.

KATIM'S CLUB (C. Murray) - jumped away awkwardly.

WINE BARRON (NZ) (K. Hannan) - jumped away awkwardly and was slow into stride. Laid out over the concluding 600m of the event. Rider explained that it was her intention to settle behind the leaders in this event; however, after being slow to begin she found herself a touch further back than she had hoped. She added that at the entrance to the straight she elected to shift towards the middle of the track to a position where the winners of the first two races had come and although WINE BARRON (NZ) was competitive, did not finish its race off as she had anticipated.

MAY BE FATE (J. Opperman) - lost its off fore plate during the event.

LAGGAN (NZ) (L. McNeil) – raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed the gelding to be lame in the off hind leg (3/5). Trainer, Mr P. Kearney was advised that a Veterinary Clearance would be required prior to a future jumpout, trial or race.

RACE 4: SPRING RACING CARNIVAL AT MORPHETTVILLE - (OCT. 14TH - NOV 11TH) HANDICAP - 1550 Metres

RIALTOR (S. Tomlinson) - rider reported that the gelding had not let down as he had anticipated when asked for an effort and was disappointing to the finish. He added that in his opinion RIALTOR may have come to the end of its preparation. A post-race veterinary examination revealed no visible abnormalities.

ANGASTON (K. Hannan) - had difficulty obtaining clear ground from near the 300m and was not fully tested to the finish.



RACE 4: SPRING RACING CARNIVAL AT MORPHETTVILLE - (OCT. 14TH - NOV 11TH) HANDICAP - 1550 Metres (cont'd)

CONNEMARA QUEEN (B. Price) – rider reported that the gelding travelled well in the early and middle stages; however, was inclined to lay out rounding the home turn and did not finish the event off as he had anticipated. A post-race veterinary examination revealed the mare to be lame in the off foreleg (1/5). Co-trainers, Mr W. Clarken and Ms N. O'Shea were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

ALLUSION (J. Holder) - laid out under pressure in the straight. Near the 200m rider lost control of his whip for a short distance resulting in him becoming awkward in his riding action for a number of strides until he was able to re-gain control. Rider explained that although he was required to change his riding action for a short distance, he was of the opinion the gelding did not lose any momentum and finished the race off well.

RACE 5: ADELAIDE GALVANISING INDUSTRIES HANDICAP - 1250 Metres

KONG (A. Livesey) - raced keenly in the early and middle stages of the event.

ANNIHILATE (T. Voorham) - jumped away awkwardly and was slow into stride. Had difficulty obtaining clear ground from the entrance to the straight and then near the 100m became awkwardly placed on the heels of KONG for a short distance and was not fully tested to the finish.

TAN TAT BEAU (J. Opperman) - slow to begin.

KAYSERI (NZ) (S. Metcalfe) - jumped away awkwardly. Laid out rounding the home turn and under pressure in the straight.

JILLADORA (M. Collett) - raced keenly in the early and middle stages and wide without cover throughout the event.

RACE 6: DOMINANT HANDICAP - 1400 Metres

CLEVER MAN (H. Edgley) – prior to the race, Stewards questioned Trainer, Mr T. White due to the significant betting drift of this runner. Mr White explained that he was aware of the drift and felt that the initial price available was far too short given the gelding's record first up and over 1400m. He added that CLEVER MAN had an ideal preparation with no set backs and had not missed any work in the lead up to today's event. Jumped away awkwardly and shifted out. Inside the 100m shifted out into the running line of ADELAIDE ACE (NZ). Rider was reminded of her obligations when shifting ground and to straighten her mounts sooner once they commence to shift ground.

WRITE YOUR NAME (R. Hurdle) - held up for a short distance approaching the 200m.

ADELAIDE ACE (NZ) (B. Price) - held up from the entrance to the straight until approaching the 200m. Near the 50m was disappointed when attempting a run between EASY BEAST (NZ) and CLEVER MAN, which shifted out.

CHICAGO STORM (J. Holder) - shifted in on jumping away onto THE MAP.

SHOW SOME DECORUM (J. Toeroek) - raced keenly in the early and middle stages of the event. Held up from the entrance to the straight until near the 200m.

MORTY (K. Crowther) - hampered and lost its position on jumping away when tightened between CLEVER MAN, which shifted out and THE MAP, which was taken in. Laid in under pressure in the straight.

EN FRANCAIS (L. Neindorf) - Stewards permitted L. Neindorf to ride 0.5kg over its declared weight of 54.0kg.

THE MAP (A. Livesey) - inconvenienced on jumping away when taken in by CHICAGO STORM.



RACE 7: AIG SECURITY HANDICAP - 1950 Metres

CALL ME SHAMUS (S. Clarke) - a post-race veterinary examination revealed no visible abnormalities.

EUREKA'S VICTORY (C. Murray) - approaching the 200m laid in and brushed YESUGEI (NZ).

SIX FOOT SONG (S. Logan) - slow to begin.

FLIGHT DECK (NZ) (K. Hannan) - rider, K. Hannan could not claim her full allowance and was only able to claim 1.5kg of her 2.0kg her minimum riding weight. Rider was reprimanded under AR143(14). A post-race veterinary examination revealed no visible abnormalities.

VINO DECASA NOSTRA (NZ) (L. Neindorf) - Stewards permitted L. Neindorf to ride 0.5kg over its declared weight of 54.0kg. Raced keenly in the early and middle stages of the event.

YESUGEI (NZ) (A. Livesey) - approaching the 200m shifted out and brushed EUREKA'S VICTORY.

EM BRYAN (D. Tourneur) - slow to begin.

ICHIBANSAN (J. Holder) - got its leg up momentarily in the barrier structure after being loaded and was backed out. Underwent a pre-race veterinary examination and was deemed suitable to race. Laid out under pressure in the straight.

RACE 8: GRAND SYNDICATES HANDICAP - 1000 Metres

The start of this event was rescheduled to 4:38pm owing to a request from Sky Racing.

CALLA DREAM (K. Hannan) - jumped away awkwardly. Laid in under pressure in the straight. Rider explained that after being a touch awkward on jumping away she had encouraged the mare to take up a more forward position; however, it was unable to do so despite her efforts. She added that at the entrance to the straight it did not quicken as she had hoped; however, over the concluding stages had worked to the line fairly. She further added that on pulling on up she had become concerned with the mares action. A post-race veterinary examination revealed no visible abnormalities.

MAGNETIC EDGE (B. Price) - shortly after the start commenced to buck until near the 800m and lost considerable ground. Co-trainers, Mr J. Hickmott and Ms C. Riggs were advised that the gelding must perform to the Stewards' satisfaction in an Official Barrier Trial or jump-out prior to a future race.

OKAY TO PAY (S. Clarke) - a post-race veterinary examination revealed no visible abnormalities.

THE GOV (A. Livesey) - jumped away awkwardly. Approaching the 900m was inconvenienced when tightened between GRINZINGER PRINCE, which shifted out and away from SEA WITNESS and CALLA DREAM, which shifted in slightly.

RICH GINA (D. Tourneur) – near the 600m was inconvenienced when taken wider by GRINZINGER PRINCE.

LONRODEX (R. Hurdle) - shifted out on jumping away onto DARING MOVE. Laid out under pressure in the straight. Rider reported that the gelding was inclined to lay away from runners to its inside.

DARING MOVE (K. Crowther) - lost its position on jumping away when tightened onto RICH GINA by LONRODEX. A post-race veterinary examination revealed no visible abnormalities.

RACE 9: TRIPLE M HANDICAP - 1000 Metres

NOSTRYIA (K. Hannan) - jumped away awkwardly. Laid out under pressure in the straight.

ZARACE (T. Childs) - hampered on jumping away when tightened between VALAROC and AMANI FARASI. A post-race veterinary examination revealed no visible abnormalities.

IMMORTAL SPIRIT (D. Caboche) - jumped away awkwardly.





VALAROC (H. Edgley) - shifted out on jumping away onto ZARACE.

ZUFASTA (L. Neindorf) - laid out under pressure in the straight.

AMANI FARASI (S. Clarke) - jumped away awkwardly and shifted in onto ZARACE.

WAKANJEJA (K. Crowther) - raced keenly for a number of strides near the 700m when awkwardly placed between the heels of GRAND HOST, which shifted out slightly and VALAROC, which shifted in slightly. Laid out rounding the home turn.

LOTZA BUBBLES (C. Jones) - held up from near the 400m until near the 200m.

FLY THE LINE (C. Murray) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.
