# Racing SA Ltd Stipendiary Stewards' Report

RACE 1: SCOTT GROUP OF COMPANIES MAIDEN PLATE - 1550 Metres

I'M A FIGHTER (C. Jones) - rider reported the gelding failed to travel throughout the event and proved disappointing when placed under pressure.

SANDHILL REBEL (D. Caboche) - when questioned in relation to the riding tactics adopted on the gelding, in particular leading by a considerable distance, rider explained that he was instructed to be forward in the race given the lack of exposed speed. He added that after finding the lead he didn't expect to be so far forward, however, he wanted to be kind on the gelding given its past history in relation to its wind. He further added that after being placed under pressure from the 600m SANDHILL REBEL failed to respond and weakened noticeably from the 400m. A post-race veterinary examination revealed no visible abnormalities.

TSEGAY (J. Maund) - kicked by another runner behind the barriers. Underwent a pre-race veterinary examination and deemed unsuitable to race. Acting on this advice Stewards declared TSEGAY a late scratching at 1.15 pm. Trainer, Mr R. Nicholson, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

RACE 2: TAB RATING 0 - 58 HANDICAP - 1550 Metres

MUFFLA (S. Fawke) - laid out when placed under pressure in the straight.

MR POCKET (NZ) (T. Doyle) - slow to begin.



### RACE 2: TAB RATING 0 - 58 HANDICAP - 1550 Metres (cont'd)

STREUSEL (NZ) (C. Tootell) - slow into stride and tailed the field for the remainder of the event. A post-race veterinary examination revealed no visible abnormalities.

# RACE 3: JOHN FARTCH MEMORIAL MAIDEN PLATE - 900 Metres

BLOOMIN' CRAFTY (H. Yuen) - hampered near the 700m and had to be steadied away from the heels of BOMBISCUIT, which lost ground.

NEXTONE (K. Walters) - became fractious after being loaded in the barriers. Co-trainers, Messrs B. & K. Post, were advised that a warning had been placed on the gelding. A post-race veterinary examination revealed no visible abnormalities.

ASTRID'S COMET (T. Doyle) - slow to begin.

PRETENTIOUS DIVA (A. Livesey) - trainer, Mr D. Carrison, pleaded guilty to a charge under LR8.9.2 in that further to the provisions of AR165(1) the mare arrived late on the course and was fined \$100. Mr Carrison was further reprimanded under AR206(1) for failing to present the mare with blinkers as declared. Slow to begin. A post-race veterinary examination revealed no visible abnormalities.

BOMBISCUIT (C. Tootell) - raced greenly and near the 700m shifted in onto the heels of SANTASTICO, clipping that gelding's heels, stumbling and had to be severely checked. As a consequence BLOOMIN' CRAFTY, which was following, was hampered and had to be steadied.

COMANCHE QUEEN (S. Fawke) - became fractious after being loaded in the barriers and hit its head. Underwent a pre-race veterinary examination and was deemed unsuitable to start. Acting on this advice Stewards declared COMANCHE QUEEN a late scratching at 1.27pm. Trainer, Mr S. McIntyre, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

### RACE 4: QUICKMIX CONCRETE BENCHMARK 75 HANDICAP - 3150 Metres

FERAGO (H. Grace) - raced keen in the early and middle stages of the event. Near the 300m had to be checked when disappointed for a run between THISTLER and RIDER IN THE SNOW (FR). Rider was severely reprimanded for careless riding under AR131(a). Held up until near the 200m and was shifted wider to improve.

SMILING ASSASSIN (K. Crowther) - stood flat-footed at the start and lost considerable ground (5L). Co-trainers, Mr R. Daniel and Ms T. Stanbury, were advised that a warning had been placed on the gelding.

THISTLER (A. Livesey) - raced keen in the early and middle stages of the event.

CONQUEST OF TEARS (D. Caboche) - stood flat-footed at the start and lost considerable ground (4L). Trainer, Ms M. Ruberry, was advised that a warning had been placed on the mare.

## RACE 5: CARLTON DRAUGHT BENCHMARK 66 HANDICAP - 1300 Metres

MELISSA KATE (NZ) (C. Tootell) - slow to begin. Raced keen in the early and middle stages of the event.

ACTION IN CAIRNS (J. Opperman) – acting on a request from trainer, Mr M. O'Leary, ACTION IN CAIRNS was declared a late scratching at 2.45pm due to the upgrade of the track.

BOSSY BRITCHES (A. Livesey) - disappointed for a run near the 150m between MELISSA KATE (NZ) and AIGUILETTE, which shifted in under pressure. Held up for the remainder of the event.

AIGUILETTE (J. Maund) - shifted in under pressure and near the 150m tightened BOSSY BRITCHES, which was disappointed for a run. Rider was advised to exercise more care.

#### RACE 5: CARLTON DRAUGHT BENCHMARK 66 HANDICAP - 1300 Metres (cont'd)

DETNAW (K. Crowther) - raced keen in the early and middle stages of the event. Rider explained that the gelding was reluctant to shift out around the leader when placed under pressure in the straight.

PEACEMAKER (F. Atkinson) - held up between the 250m and 150m.

CARAK (C. Jones) - raced wide without cover for the majority of the event.

# RACE 6: MOUNT GAMBIER BREAST CANCER SUPPORT GROUP RATING 0 - 54 HANDICAP - 1400 Metres

MAYKSUMNOISE (H. Yuen) - shifted in near the 500m when not clear of PRINCESS SALLY, which shifted in at the same time, resulting in PRINCESS SALLY being tightened for room and having to be checked. Rider was severely reprimanded under AR131(a) for careless riding and advised to take greater care in similar circumstances.

EDNA DOREEN (D. Caboche) - post-race veterinary examination revealed no visible abnormalities.

PRINCESS SALLY (K. Crowther) - had to be checked near the 500m when awkwardly placed close to the heels of MAYKSUMNOISE, which shifted in.

SPENCER GULF (R. Milnes) - began awkwardly and lost ground.

# RACE 7: MOUNT GAMBIER PROSTATE SUPPORT GROUP RATING 0 - 56 HANDICAP - 1200 Metres

GALAXY TURF (H. Grace) - began awkwardly and lost ground.

OUR ELLIE ROSE (NZ) (K. Walters) – raced wide without cover for the majority of the event. Rider explained that the mare travelled well throughout the event; however, proved disappointing when placed under pressure. She added that in her opinion the mare may be in season. A post-race veterinary examination revealed no visible abnormalities; however, confirmed the mare to be in season.

BUNUMBURT (K. Crowther) - underwent a pre-race veterinary examination and was deemed suitable to start. Raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

REYNAIRE (H. Yuen) - began awkwardly and lost ground. Held up and unable to improve from the 550m until near the 200m.

LADY ANNABEL (NZ) (C. Tootell) - raced keen in the early and middle stages of the event.

LAST ZERPRISE (D. Caboche) - slow to begin.

GIALLO (T. Doyle) - raced keen in the early and middle stages of the event.


