RACE 1: SEACLIFF VILLAGE MAIDEN PLATE - 1000 Metres

AMBELLO (K. Hannan) - jumped away awkwardly. Raced keenly in the early and middle stages of the event. Laid out under pressure in the straight.

I TELL YA WHAT (T. Pannell) - jumped away awkwardly. Raced keenly in the early and middle stages.

KNIGHT DANCER (J. Toeroek) - raced wide without cover throughout the event. Inclined to lay in under pressure in the straight.

MORTGAGE MAN (J. Holder) - shifted in on jumping away onto SUNDOGG. A post-race veterinary examination revealed no visible abnormalities.

NASHO (J. Potter) - laid out under pressure in the straight.

OPPORTUNE CHANCE (R. Milnes) - raced wide without cover throughout the event. Inside the 200m improved onto the heels of I TELL YA WHAT, which shifted out, and was obliged to alter course to obtain clear ground.

SUNDOGG (R. Hurdle) - contacted on jumping away. Raced keenly in the early and middle stages of the event.

BONNY IMPACT (A. Livesey) - raced keenly in the early and middle stages of the event. Approaching the 100m rider lost the use of her off side rein for a short distance.



RACE 1: SEACLIFF VILLAGE MAIDEN PLATE - 1000 Metres (cont'd)

PRESTO DENARO (A. Kelly) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: GUINNESS ON GUINEAS DAY OCTOBER 14TH MAIDEN PLATE - 1000 Metres

NOVUS ACTUS (C. Munro) - a post-race veterinary examination revealed no visible abnormalities.

BONJOUR MON AMOUR (R. Milnes) - raced wide without cover throughout the event.

CHUCKAMICKY (S. Fawke) - raced greenly throughout the event. Made the turn near the 600m awkwardly, shifted out and lost ground.

HOLLANDAISE (R. Hurdle) - inside the 700m permitted his mount to shift in when insufficiently clear of ALIBIS, forcing that rider to take hold and in doing so shifted and contacted the running rail. Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence midnight Saturday, 14 October 2023 to conclude midnight Friday, 20 October 2023, a period of three meetings.

SIOUX WARRIOR (J. Holder) - became fractious in its barrier after being loaded, reared and struck its head. Underwent a pre-race veterinary examination and was deemed unsuitable to start. Acting on this advice Stewards declared SIOUX WARRIOR a late scratching at 2.47pm. Trainer, Mr J. Macmillan, was advised that the gelding would now be required to prove tractable in the barriers in an Official Barrier trial prior to a future race. J. Holder was examined by the First Care Medical personnel and ruled unfit to fulfil his remaining engagement.

SUGAR JAR (S. Logan) - a post-race veterinary examination revealed no visible abnormalities.

ALIBIS (D. Tourneur) - inside the 700m rider was forced to take hold and shifted in contacted the running rail when HOLLANDAISE shifted in. A post-race veterinary examination revealed the filly to be lame in the off hind leg (2/5). Trainer, Mr J. Hyam, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

INTACTO (J. Doyle) - jumped away awkwardly and was slow into stride.

STUPENDOUS (T. Voorham) - laid in under pressure in the straight.

ZARKANA (A. Kelly) - slow to begin. Laid out under pressure in the straight.

RACE 3: HOFBRAU ORIGINAL LAGER MAIDEN PLATE - 1250 Metres

BONA FIDE STAR (J. Doyle) - inconvenienced when contacted on jumping away. Inclined to lay out under pressure in the straight and had difficulty obtaining clear ground from the entrance to the straight until inside the 100m.

ON THE SCENT (A. Jordsjo) - inconvenienced on jumping away when tightened onto OVERSTRIKE by TROPOPAUSE.

OVERSTRIKE (J. Toeroek) - inconvenienced on jumping away when contacted by ON THE SCENT, which had been taken out.

TROPOPAUSE (R. Hurdle) - shifted out on jumping away onto ON THE SCENT. A post-race veterinary examination revealed no visible abnormalities.

TWO PERCENT ICE (F. Atkinson) - laid in under pressure in the straight.

ANGELIC APPEAL (C. Murray) - jumped away awkwardly and shifted out contacting BONA FIDE STAR. Inclined to shift about under pressure in the straight.

ESTEFAN (J. Potter) - a post-race veterinary examination revealed no visible abnormalities.





RACE 4: THE FOTOBASE GROUP BENCHMARK 58 HANDICAP - 1250 Metres

FRANKEL STAR (C. Munro) - a post-race veterinary examination revealed no visible abnormalities.

MCCAIN (H. Ingram) - laid in under pressure in the straight.

CROWN MINT (J. Doyle) - jumped away awkwardly and was slow into stride. Raced keenly in the early and middle stages of the event. Laid out under pressure in the straight.

CHARM SLINGA (NZ) (K. Hannan) - jumped away awkwardly and was slow to begin. Inside the 700m rider was forced to take hold to avoid the heels of INDY MAGIC, which shifted in.

INDY MAGIC (A. Livesey) - near the 700m shifted in when insufficiently clear of CHARM SLINGA (NZ), forcing that rider to take hold. Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence midnight Sunday, 8 October 2023 to conclude midnight Friday, 20 October 2023, a period of five meetings.

RIZSKI (A. Kelly) - a post-race veterinary examination revealed no visible abnormalities.

RACE 5: TRIPLE M BM 62 NMW-LYR HANDICAP - 1550 Metres

KING OF PHARAOHS (C. Murray) - near the 700m rider was forced to take hold when tightened onto TYITA by AL RANCHERO, which laid in. A post-race veterinary examination revealed no visible abnormalities.

AL RANCHERO (H. Yuen) - shifted out on jumping away onto DIRTY MIND (NZ). In the vicinity of the 700m initially commenced to shift in and then laid in contacting KING OF PHARAOHS, which was taken in onto TYITA. Rider was severely reprimanded under AR131(a) and was advised in future to make a greater effort to keep her mounts straight when the commence to shift ground. Continued to lay in for the remainder of the event.

DIRTY MIND (NZ) (A. Kelly) - inconvenienced on jumping away when contacted by AL RANCHERO. A post-race veterinary examination revealed no visible abnormalities.

TYITA (K. Hannan) - stood flat-footed and was slow to begin.

RACE 6: VILLAWOOD PROPERTIES CLASS ONE HANDICAP - 1000 Metres

LAKE AGAWAM (H. Edgley) - Stewards questioned the rider in relation to her instructions in today's event. She explained that she had been instructed to take up a position in the first half of the field; however, after jumping away well the gelding grabbed the bridle and given the formation of the field she elected to use her initiative and roll forward to obtain the lead. Mr D. Jolly confirmed the instructions in today's event were not to lead and were to take up a position forward of midfield.

LOTZA BUBBLES (K. Crowther) - laid in under pressure in the straight.

SASSY ANGEL (A. Livesey) - jumped away awkwardly and shortly after was inconvenienced when LAKE AGAWAM shifted out.

HAYZEE FANTAYZEE (R. Milnes) - held up from approaching the 200m until inside the 100m when awkwardly placed on the heels of SANTASTICO.

AIYAH (J. Potter) - a post-race veterinary examination revealed no visible abnormalities.

ROC THE WOLF (NZ) (C. Munro) - jumped away awkwardly and was slow into stride. A post-race veterinary examination revealed no visible abnormalities.



RACE 7: THOMAS FARMS RATING 0 - 58 HANDICAP - 1400 Metres

CALIBURN (C. Murray) - in the vicinity of the 1200m improved on to the heels of STAKE A CLAIM and had to be steadied. Held up from approaching the 400m until inside the 300m. Rider was reminded of his obligations in riding his mounts out to the end of the race in accordance with AR131(b). A post-race veterinary examination revealed no visible abnormalities.

DAZZLING PROSPECT (D. Tourneur) - near the 200m was inconvenienced when taken wider by TALES OF CONFLICT.

DELIGHTFUL SHECKY (T. Pannell) - raced wide without cover throughout the event.

PINCHBECK (S. Metcalfe) - laid in under pressure in the straight.

TALES OF CONFLICT (J. Doyle) - slow to begin. In the vicinity of the 200m shifted out to improve and in doing so brushed DAZZLING PROSPECT.

IN THE DARKNESS (NZ) (J. Opperman) - jumped away awkwardly.

COVERED CALL (B. Wong) - held up for a number of strides approaching the 300m.

RACE 8: GRAND SYNDICATES CLASS TWO HANDICAP - 1950 Metres

SOAMES (B. Price) - rider was reminded of his obligations in relation to using his whip in a manner which raised his arm above shoulder height in accordance with AR132(6)(b).

SOCIAL GROUP (K. Hannan) - had difficulty obtaining clear ground from the 300m until inside the 200m.

WHOSEZOU (A. Livesey) - a post-race veterinary examination revealed no visible abnormalities.

SMART STYLE (R. Milnes) - slow to begin.
